Proposed Boundaries of the Electoral Districts in the North Island and the South Island of New Zealand

THE Representation Commission, appointed in pursuance of section 2 of the Electoral Amendment Act, 1945, hereby publishes in accordance with the provisions of section 5 of the said Act, the proposed boundaries of the electoral districts in the North and the South Islands of New Zealand; and, further, gives notice that written objections to the same will be received by the undersigned, the Chairman of the Commission, at the office of the Surveyor-General, Government Buildings, Wellington, not later than noon on Monday, the 6th day of May, 1946, for consideration by the aforesaid Commission.

Maps of the proposed districts may be seen at the office of any City or Borough Council, County Council, Town Board, or Road Board; of the Chief Surveyor at Auckland, New Plymouth, Gisborne, Napier, Wellington, Blenheim, Nelson, Hokitika, Christchurch, Dunedin, and Invercargill; of the Chief Electoral Officer at Wellington; and of the Registrars of Electors throughout the Dominion.

HOBSON

All that area comprising the County of Mangonui, the County of Whangaroa, the County of Hokianga, the County of Hobson, the Borough of Kaitaia, the Borough of Dargaville, the Town District of Kaikohe, the Kerikeri, Okaihau, Waimate, Pakaraka, Kawakawa, Mataraua, and Tautoro Ridings of the County of Bay of Islands, the Mangakahia Riding of the County of Whangarei, and the Tokatoka, Ruawai, and Matakohe Ridings of the County of Otamatea, and including the Cavalli Islands, Stephenson's Island, and adjacent islands.

MARSDEN

All that area comprising the Borough of Whangarei, the Town District of Kamo, the Town District of Hikurangi, the Russell and Towai Ridings of the County of the Bay of Islands, the Mareretu, Wairau, Paparaoa, and Whakapirau Ridings of the County of Otamatea, the County of Whangarei, excluding Mangakahia Riding. Also the following groups of islands: Poor Knights, Hen and Chickens, and Mokohinau, and other adjacent islands.

RODNEY

All that area comprising the County of Rodney, the Town District of Helensville, the Town District of Warkworth, the Kaiwaka Riding of the County of Otamatea, the Kaukapakapa, Wainui, Mairatahi, Kumeu, Pukeatua, and Takapuna Ridings of the County of Waitemata, that part of the Birkenhead Riding of the County of Waitemata lying to the north of Pupuke Road, and that part of the Borough of Takapuna lying to the north-west of a line commencing at a point on the south-western boundary of the aforesaid borough in line with the north side of Karaka Street; thence to and along the aforesaid street, along Taharoto Road, and along Northcote Road to Lake Pupuke; thence along the southern shore of the aforesaid lake to and along The Promenade to the sea. Also including the following Islands: Kawau and Motuhora, and other adjacent islands.

WAITAKERE

All that area comprising the Waitakere, Waipareira, Waikumete, and Titirangi Ridings of the County of Waitemata, Pine Island, the Borough of New Lynn, the Town District of Glen Eden, the Town District of Henderson, and that part of the City of Auckland lying to the south of a line along the north-eastern boundaries of Lots 4 and 1 on D.P. 16351, being part of Allotment 62, Titirangi Parish, to and across Great North Road, along that road to the north-eastern boundary of Lot 71 on D.P. 177, being part of Allotments 14 and 15, Titirangi Parish, and along the north-eastern boundary of Lot 71 aforesaid to the mean high-water mark of Waitemata Harbour.

NORTH SHORE

All that area comprising the Borough of Devonport, that part of the Borough of Takapuna lying to the south-east of a line commencing at a point on the south-western boundary of the aforesaid borough in line with the north side of Karaka Street; thence to and along the aforesaid street, along Taharoto Road, and along Northcote Road to Lake Pupuke; thence along the southern shore of the aforesaid lake to and along The Promenade to the sea. Also that part of the Borough of Northcote lying to the east of a line commencing at a point on the western boundary of the aforesaid borough, being the south-eastern corner of Allotment 8, Takapuna Parish; thence along the production of the eastern boundary of the aforesaid allotment to Gladstone Road; thence easterly along Gladstone Road to and along Woodside Avenue, Onewa Road, and Church Street, to its intersection with a road on the right, opposite Faulkner Road; thence westerly along that road and the western boundary of Lot 24 of Allotment 51, Takapuna Parish, to the northern boundary of recreation reserve; thence easterly, and then southerly along the eastern boundary of the aforesaid recreation reserve to the Waitemata Harbour, including all wharves and extensions seaward.

PONSONBY

All that area comprising part of the City of Auckland, bounded by a line commencing at the intersection of Ponsonby Road and Franklin Road; thence along Ponsonby Road, Lincoln Street, and Richmond Road to Cox's Creek; thence along Cox's Creek to the bridge at West End Road; thence in a generally easterly direction along West End Road and the mean high-water mark of the Waitemata Harbour to Fanshawe Street; thence along Fanshawe Street, Beaumont Street, Victoria Street West, and Franklin Road to the point of commencement. Also all that area comprising the Borough of Birkenhead, that part of the Borough of Northcote lying to the west of a line along the eastern boundary of Allotment 7, Takapuna Parish, from the borough boundary to Gladstone Road; thence along Gladstone Road, Woodside Avenue, Onewa Road, and Church Street to its intersection with a road opposite Faulkner Road, and thence westerly along that road and the western boundary of Lot 24 of a subdivision of Allotment 51, Takapuna Parish, to the borough boundary, and that part of the Birkenhead Riding of the County of Waitemata lying to the south of Pupuke Road, including all wharves and extensions seaward.

AUCKLAND CITY

All that part of the City of Auckland, bounded by a line commencing at the intersection of Karangahape Road and Ponsonby Road; thence along Ponsonby Road, Hepburn Street, Barrie Street, Picton Street, Paget Street, Anglesea Street, and Heke Street to Franklin Road; thence along Franklin Road, Victoria Street West, and Beaumont Street to Fanshawe Street, and in a north-westerly direction along Fanshawe Street to the Waitemata Harbour; thence along the waterfront, including all wharves, to the eastern breakwater near Campbell's Point, and along that breakwater and the mean high-water mark of Waitemata Harbour to Tamaki Drive; thence along King's Drive, The Strand, and Gittos Street to Carlaw Park Avenue; thence along that avenue and along the north-western boundary of Carlaw Park to the Auckland Domain; thence along the western boundaries of the Auckland Domain and the Auckland Hospital Reserve to Park Road; thence along Park Road, Grafton Bridge, and Karangahape Road to the point of commencement, and including Little Barrier Island and Tiritiri Island; including all wharves and extensions seaward.

PARNELL

All that area comprising the Borough of Newmarket, part of the City of Auckland, part of the Borough of Mount Eden, part of the Borough of One Tree Hill, and part of the County of Eden, bounded by a line commencing at the intersection of Symonds Street and Karangahape Road; thence along Symonds Street, Mount Eden Road, Enfield Street, Normanby Road, and Olive Road to the Mount Eden Domain; thence along the generally north-eastern boundary of that Domain to Glenfell Road; thence along Glenfell Road, Mountain Road, and Owen's Road to Manukau Road; thence along Manukau Road, Clyde Street, and Wellington Street to Great South Road; thence along Great South Road and Dilworth Avenue to Remuera Road, and across Remuera Road to Arney Road; thence along Arney Road and Woodville Road to Hobson Bay; thence along the mean high-water mark of Hobson Bay and Judge's Bay across the railway to Tamaki Drive; thence along King's Drive, The Strand, and Gittos Street to Carlaw Park Avenue; thence along that avenue and along the north-western boundary of Carlaw Park to the Auckland Domain; thence along the western boundaries of the Auckland Domain and the Auckland Hospital Reserve to Park Road; thence along Park Road and Grafton Bridge to the point of commencement, including all wharves and extensions seaward.

ARCH HILL

All that area comprising part of the City of Auckland and part of the Borough of Mount Albert, bounded by a line commencing at the intersection of Ponsonby Road and Karangahape Road; thence along Karangahape Road to Symonds Street; thence along Symonds Street and New North Road to the first intersection of the last-mentioned road with Western Springs Road; thence along Western Springs Road and School Road to the southern boundary of Allotment 19 of Section 7, Suburbs of Auckland; thence along the southern and north-western boundaries of Allotment 19 aforesaid to Great North Road; thence along Great North Road, Surrey Crescent, Browning Street, Baildon Road, Selbourne Street, Allen Road, Dryden Street, Cockburn Street, and Farrar Street to Richmond Road; thence along Richmond Road, Lincoln Street, Ponsonby Road, and Franklin Road to Heke Street; thence along Heke Street, Anglesea Street, Paget Street, Picton Street, Barrie Street, and Hepburn Street to Ponsonby Road, and along Ponsonby Road to the point of commencement.

EDEN

All that area comprising part of the City of Auckland, part of the Borough of Mount Eden, and part of the Borough of Mount Albert, bounded by a line commencing at the intersection of Symonds Street and New North Road; thence along New North Road to Sandringham Road, along Sandringham Road to the North Auckland Main Trunk Railway, and along that railway to the footbridge near Kingsland Station; thence along Sandringham Road to Kowhai

Intermediate School, and along the south-western boundary of the school-grounds to Kowhai Street; thence along Kowhai Street to Raleigh Street, being the common boundary between the Borough of Mount Eden and the Borough of Mount Albert, and along that boundary to Balmoral Road; thence along Balmoral Road to St. Andrew's Road; thence along St. Andrew's Road, Merivale Avenue, The Drive, and Queen Mary Avenue to Manukau Road; thence along Manukau Road to Owen's Road; thence along Owen's Road, Mountain Road, and Glenfell Road to the Mount Eden Domain, and along the generally north-eastern boundary of the Domain to Normanby Road; thence along Normanby Road, Enfield Street, and Mount Eden Road to the point of commencement.

GREY LYNN

All that area comprising part of the City of Auckland and part of the Borough of Mount Albert, bounded by a line commencing at a point on the mean high-water mark of Waitemata Harbour at Point Chevalier; thence along the mean high-water mark of Waitemata Harbour to West End Road, and along that road to the bridge across Cox's Creek; thence along the middle of Cox's Creek to Richmond Road, and along Richmond Road to Farrar Street; thence along Farrar Street, Cockburn Street, Dryden Street, Allen Road, Selbourne Street, Baildon Road, Browning Street, Surrey Crescent, and Great North Road to the northernmost point of Allotment 19 of Section 7, Suburbs of Auckland; thence along the north-western and southern boundaries of Allotment 19 aforesaid to School Road; thence along School Road, Western Springs Road, and Asquith Avenue to the easternmost point of Allotment 172, Titirangi Parish; thence along the common boundary between the City of Auckland and the Borough of Mount Albert to a point in Oakley Stream in line with the north-eastern boundary of Lot 4 on D.P. 16351, being part of Allotment 62, Titirangi Parish; thence along the north-eastern boundaries of Lots 4 and 1 on D.P. 16351 aforesaid, to and across Great North Road, and along that road to the north-eastern boundary of Lot 71 on D.P. 177, being part of Allotments 14 and 15, Titirangi Parish; thence along the north-eastern boundary of Lot 71 aforesaid to the mean high-water mark of Waitemata Harbour, and along the mean high-water mark to the point of commencement, including all wharves and extensions seaward.

MOUNT ALBERT

All that area comprising part of the Borough of Mount Albert, bounded by a line commencing at the intersection of New North Road and Sandringham Road; thence along New North Road to its first intersection with Western Springs Road, and along Western Springs Road to the boundary of the Borough of Mount Albert; thence along the generally northern, western, southern, and eastern boundaries of the Borough of Mount Albert to Kowhai Street; thence along Kowhai Street to Kowhai Intermediate School, and along the south-western boundary of the school-grounds to Sandringham Road; thence along Sandringham Road to the footbridge near Kingsland Railway-station; thence along the North Auckland Main Trunk Railway to Sandringham Road, and along Sandringham Road to the point of commencement.

ROSKILL

All that area comprising parts of the City of Auckland, the Borough of Mount Eden, the Borough of Onehunga, and the County of Eden, bounded by a line commencing at a point on the common boundary of the City of Auckland and Mount Roskill Road District, County of Eden, at Duck Creek, Blockhouse Bay; thence along the western boundary of Mount Roskill Road District to the intersection of Oakley Creek with Richardson Road; thence along the southern and south-eastern boundary of the Borough of Mount Albert to Balmoral Road; thence along Balmoral Road, St. Andrew's Road, Merivale Avenue, The Drive, Selwyn Road, Pa Road, Mount Albert Road, to the north-east corner of Allotment 3, Section 13, Suburbs of Auckland; thence by the eastern boundary of Allotment 3 aforesaid, to and along Pleasant Street to the northern shore of Manukau Harbour; thence westerly along the northern shore of Manukau Harbour to the point of commencement, including all wharves and extensions seaward.

REMUERA

All that area comprising part of the City of Auckland, and parts of the boroughs of One Tree Hill and Ellerslie, bounded by a line commencing at the junction of Panmure and Great South Roads; thence along Panmure Road, Walpole Street, Mitchelson Street, Morrin Street, Ladies' Mile, Marua Road, and Michael's Avenue to the northern boundary of the Borough of Ellerslie; thence along the aforesaid borough boundary to the south-eastern corner of Allotment 34 of Section 12, Suburbs of Auckland; thence northerly along the eastern boundary of Allotment 34 aforesaid, to and along the northern boundaries of Block III of Allotments 25 and 34 aforesaid to Koraha Avenue; thence along Koraha Avenue, Remuera Road to Meadowbank Road; thence along the western boundary of Allotment 38A, District of Tamaki, to Purewa Creek; thence along Purewa Creek to that part of Waitemata Harbour known as Hobson Bay; thence along the southern shore of Hobson Bay, to and along

Woodville Road, Arney Road, across Remuera Road, to and along Dilworth Avenue, Great South Road, Wellington Street, Clyde Street, Manukau Road, and Claude Road to the western boundary of Cornwall Park; thence northerly along the western boundary of Cornwall Park, to and along Green Lane to the eastern boundary of Cornwall Park, to and along Waitapu Road to Wheturangi Road; thence along a right line, to and along Oswald's Road, to and along the south-eastern boundaries of Lots 4, 5, 6, 7, 8, and 9 on D.P. 19430, a right line across Te Kawa Road, along the south-eastern boundaries of Lot 10 on the said D.P. 19430, Lots 2 and 1 on S.O. 32147, Lots 1, 2, and 3 on D.P. 29025, a right line across part Allotment 16, to and along the south-eastern boundaries of Lots 4 and 5 on the said D.P. 29025, and along the north-eastern boundary of the last-mentioned lot to Campbell Road, the aforesaid lots being parts of Allotments 15 and 16, Section 12, Suburbs of Auckland; thence along Campbell Road and Great South Road to the point of commencement, including all wharves and extensions seaward.

ONEHUNGA

All that area comprising parts of the City of Auckland, boroughs of One Tree Hill and Onehunga, and part of the County of Eden, bounded by a line commencing at the junction of Panmure and Great South Roads, and thence along the Great South Road, Rockfield Road, and along the common boundary of Onehunga and One Tree Hill Boroughs to the northern shore of Manukau Harbour; thence along the boundary of the Borough of Onehunga to Pleasant Street; thence along Pleasant Street, to and along the common boundary of the Borough of Onehunga and Mount Roskill Road District of the County of Eden to Mount Albert Road; thence along Mount Albert Road, Pa Road, Selwyn Road, The Drive, Queen Mary Avenue, Manukau Road, Claude Street, and the north-western boundary of Cornwall Park to Green Lane; thence along Green Lane and north-eastern boundary of Cornwall Park to and along Waitapu Road to its intersection with Wheturangi Road; thence along a right line, to and along the north-eastern side of Oswald's Road, to and along the south-eastern boundaries of Lots 4, 5, 6, 7, 8, and 9 on D.P. 19430, a right line across Te Kawa Road, along the south-eastern boundaries of Lot 10 on the said D.P. 19430, Lots 2 and 1 on S.O. 32147, Lots 1, 2, and 3 on D.P. 29025, a right line across part Allotment 16, to and along the south-eastern boundaries of Lots 4 and 5 on the said D.P. 29025, along the north-eastern boundary of the last-mentioned lot to Campbell Road, the aforesaid lots being parts of Allotments 15 and 16, Section 12, Suburbs of Auckland; thence along Campbell Road and Great South Road to the point of commencement, including all wharves and extensions seaward.

TAMAKI

All that area comprising part of the City of Auckland, parts of boroughs of Ellerslie and One Tree Hill, and part of the County of Eden, bounded by a line commencing at Orakei Jetty on the southern shore of Waitemata Harbour, and thence along the southern shore of Waitemata Harbour and the western bank of Tamaki River to Waipuna Road; thence along Waipuna Road to the railway; thence south along the railway to the Great South Road near Ann's Bridge; thence westerly along the northern shore of Manukau Harbour to the common boundary of the boroughs of One Tree Hill and Onehunga; thence along that boundary, to and along Rockfield Road, to and along the Great South Road to Panmure Road; thence along Panmure Road, Walpole Street, Mitchelson Street, Morrin Street, Ladies' Mile, Marua Road, and Michael's Avenue to the northern boundary of the Borough of Ellerslie; thence along the aforesaid borough boundary to the south-eastern corner of Allotment 34 of Section 12, Suburbs of Auckland; thence northerly along the eastern boundary of Allotment 34 aforesaid to and along the northern boundaries of Block III of Allotments 25 and 34 aforesaid to Koraha Avenue; thence along Koraha Avenue, Remuera Road to Meadowbank Road; thence along the western boundary of Allotment 38A, District of Tamaki, to Purewa Creek; thence across Purewa Creek and along the aforesaid Creek to Hobson Bay, and along the southern shore of Waitemata Harbour to the point of commencement, including all wharves and extensions seaward.

OTAHUHU

All that area comprising the Borough of Otahuhu, the town districts of Howick and Papatoetoe, and part of the County of Manukau—namely, the Pakuranga, Mangere, Papatoetoe, and Turanga Ridings, and that part of Papakura Riding lying north-east of a line commencing at a point on the north-eastern boundary of the Borough of Manurewa where Oram's Road leaves the borough, and thence in a southerly direction along the borough boundary to Papakura Stream; thence easterly along Papakura Stream to a road forming the eastern boundary of Allotments 22 and 28 of Papakura Parish; thence in a southerly direction along this road to the riding boundary. Also that part of Mount Wellington Road District, County of Eden, south-east of a line following the railway from the Great South Road near Ann's Bridge to Waipuna Road; thence along Waipuna Road to Tamaki River, including all wharves and extensions seaward.

FRANKLIN

All that area comprising the boroughs of Manurewa, Papakura, and Pukekohe, the town districts of Tuakau and Waiuku, and part of the County of Franklin—namely, the Awhitu, Waipipi, Mauku, Waiuku, Pukekohe West, Pukekohe East, Karaka, and Drury Ridings, together with that part of Hunua Riding west of a line commencing on the northern boundary of the county at the south-eastern corner of Allotment 168, Hunua Parish; thence along the south-eastern boundary of Allotment 168, the north-eastern boundary of Allotment 179, the northern and eastern boundaries of Allotment 9, the northern and eastern boundaries of Allotment 13, and the eastern boundaries of Allotments 39 and 67, all of Hunua Parish, to the Tipakuri Stream, and along the Tipakuri Stream to the Maungawheau Stream, being the riding boundary. Also part of the County of Manukau, being parts of Wairoa and Papakura Ridings, bounded by a line along the southern county boundary from Manukau Harbour to the Wairoa River; thence along the Wairoa River to the Clevedon Bridge; thence south-westerly along a road from the bridge to Clevedon Hall; thence at first northerly, then westerly along the Clevedon-Brookby Road, to and along the riding boundary to the south-eastern corner of Allotment 28, Papakura Parish; thence along the eastern boundaries of Allotments 28 and 22, Papakura Parish, to and along the Papakura Stream to the boundary of the Borough of Manurewa; thence along the south-eastern and south-western boundaries of the Borough of Manurewa, to and along the northern boundary of Papakura Riding to the Manukau Harbour at Puhinui Creek.

RAGLAN

All that area comprising the boroughs of Huntly and Ngaruawahia, the County of Raglan, the Hamilton, Newcastle, Tuhikaramea, and Rukuhia Ridings of the County of Waipa, and those parts of the Taupiri, Rototuna, and Ruakara Ridings of the County of Waikato lying west of a line commencing at the junction of the Mangawara Stream and the Waikato River; thence along Mangawara Stream, the Komakorau Stream, to and along the main Taupiri-Orini Road to the intersection of Waring's Road; thence along Waring's Road, Henry's Road, Komakorau Stream, and the branch nearest Komakorau School to the main Taupiri-Gordonton Road; thence along the main Taupiri-Gordonton Road and Bankiers Road to Horsham Downs Road; thence along Horsham Downs Road to the dairy factory and along the road from the dairy factory to the main Gordonton-Hamilton Highway; thence along the Gordonton-Hamilton Main Highway to the northern boundary of Ruakura Riding, and along this riding boundary to and along Peach Grove Road to the northern boundary of the City of Hamilton, and along the city boundary to the Waikato River. Also that part of the City of Hamilton lying west of a line commencing at a point in Higgins Road at its intersection with the city boundary; thence northerly to and along Higgins Road, Killarney Road, Primrose Street, Massey Street, and Weka Street to a point in Weka Street in line with the production of the western boundary of Lot 22 of a subdivision of Allotment 8, Te Rapa Parish; thence along that line and the southern boundaries of the aforesaid Lot 22 and Lot 21 to Edgar Street; thence along Edgar Street, Lincoln Street, North Street, to and along the North Island Main Trunk Railway and Forest Lake Road, to and along a road forming the north-eastern boundary of Lot 13 of a subdivision of part Allotment 75, Pukete Parish, to the city boundary.

HAMILTON

All that area comprising all that part of the City of Hamilton lying to the east of a line commencing at a point in Higgins Road at its intersection with the city boundary; thence northerly to and along Higgins Road, Killarney Road, Primrose Street, Massey Street, Weka Street, to a point in Weka Street in line with the production of the western boundary of Lot 22 of a subdivision of Allotment 8, Te Rapa Parish; thence along that line and the southern boundaries of the aforesaid Lot 22 and Lot 21 to Edgar Street; thence along Edgar Street, Lincoln Street, North Street, to and along the North Island Main Trunk Railway and Forest Lake Road, to and along a road forming the north-eastern boundary of Lot 13 of a subdivision of part Allotment 75, Pukete Parish, to the city boundary.

HAUBAKI

All that area comprising the Borough of Thames, the Borough of Paeroa, the County of Great Barrier Island, the County of Coromandel, the County of Hauraki Plains, the Hastings, Totara, Puriri, and Hikutaia Ridings of the County of Thames, the Komata and Paeroa Ridings of the County of Ohinemuri, the Tahuna Riding of the County of Piako, that part of the Wairoa Riding of the County of Manukau lying to the east of a line along the Wairoa River from the southern boundary of the county to Clevedon Bridge; thence south-westerly along a road from the bridge to Clevedon Hall; thence northerly and then westerly along the Clevedon-Brookby Road to the Riding boundary, that part of the County of Franklin lying to the east of a line

Rural Section 7457 to and across the Main Point Road and railway, along Kennels Road, to and across Main North Road, along the southern boundary of Rural Section 9985, and that boundary-line produced to and across the South Island Main Trunk Railway, to and along the northern boundary-line of Meadow's Settlement, and that line produced to the sea. Also that part of the County of Geraldine lying south-west of a line commencing at the westernmost point of Geraldine Riding; thence along the north-western boundary of the Geraldine Riding to the confluence of the Hae Hae te Moana River and Leisman's Creek; thence along Dawe's Road, Rhubarb Road, Fern's Road, and its production across the Hae Hae te Moana River, and along MacDonald's Road, Bayley's Road, Rae's Road, Woodbury Road, across the Waihi River, to and along the Geraldine-Arundel Road, Orari Station Road, Racecourse Road, and the road passing through Reserve 1862 to the Orari River; thence along the aforesaid river to a point in line with the south-eastern boundary of Section 2 of Block X, Geraldine Survey District; thence along that line to Racecourse Road, along that road, to and along the road forming the south-eastern boundary of Section 3 of Block X aforesaid, to and along the Orari Station Road, Packham's Road, the Geraldine-Winchester Road, and a road forming the eastern boundaries of Rural Sections 4929 and 9090 of Block XIV, Geraldine Survey District, to and along Winchester Beach Road to the sea.

OAMARU

All that area comprising the County of Waihemo, the Borough of Oamaru, the Borough of Palmerston, the Borough of Waikouaiti, the Borough of Hampden, the Awamoko, Papakaio, Waiareka, Incholme, Kakanui, Otepopo, and Moeraki Ridings of the County of Waitaki, the Puketoi, Hyde, and Serpentine Ridings of the County of Maniototo, the Strath-Taieri and Deep Stream Ridings of the County of Taieri, and the Hawksbury and Merton Ridings of the County of Waikouaiti.

CHALMERS

All that area comprising the Blueskin and North-east Valley Ridings of the County of Waikouaiti, the Borough of Port Chalmers, the Borough of West Harbour, Quarantine Island and adjacent islands in Otago Harbour, and that part of the City of Dunedin lying to the north-east of a line from Opoho Creek along Union Street to Leith Street, along Leith Street, St. David Street, and Castle Street to Union Street, along Union Street to Queen Street, and along Queen Street, Park Street, Heriot Row, and Khyber Pass to the Town Belt; thence along a right line to the point where Tolcarne Avenue meets the Town Belt; thence along Tolcarne Avenue and Grendon Street to Highgate, along Highgate to Lynn Street, along Lynn Street and Balmacewen Road to Helensburg Road; thence in a generally north-westerly direction along Helensburg Road to Wakari Road and south-westerly along Wakari Road to the easternmost corner of Section 51, Wakari Survey District; thence along the north-eastern boundary of Section 51 aforesaid to the boundary of the City of Dunedin.

ST. KILDA

All that area comprising the County of Peninsula, the Borough of St. Kilda, and that part of the City of Dunedin and reclaimed land lying to the south-east of a line in a generally north-easterly direction along Hillherd Road, Lockerbie Street, Middleton Road, Easter Crescent, Holmes Right-of-way, Macandrew Road, King Edward Street, McBride Street, and Anderson's Bay Road to the intersection of the last-mentioned road with Cargill Road, and thence along a right line to the nearest point of the boundary of the City of Dunedin.

MORNINGTON

All that area comprising part of the City of Dunedin and reclaimed land bounded by a line commencing at a point on the waterfront at the junction of Rattray Street Wharf and Victoria Wharf; thence along Rattray Street Wharf, Rattray Street, MacLaggan Street, Serpentine Avenue, and Hawthorn Avenue to Jubilee Street; thence along Jubilee Street, Napier Street, Beaumont Road, Rosebery Street, Kenmore Road, and Pitcairn Street to the northern boundary of Lot 27 on Deeds Plan 347; thence along the northern boundary of Lot 27 aforesaid and the northern boundary of Lot 65 of Section 10, Lower Kaikorai Survey District, to Stone Street; thence along Stone Street to the Kaikorai Valley Road; thence along the Kaikorai Valley Road to the boundary of the City of Dunedin; thence in a generally southerly direction along the boundary of the City of Dunedin to Hillherd Road; thence in a generally north-easterly direction along Hillherd Road, Lockerbie Street, Middleton Road, Easter Crescent, Holmes Right-of-way, Macandrew Road, King Edward Street, McBride Street, and Anderson's Bay Road to the intersection of the last-mentioned road with Cargill Road; thence along a right line to the nearest point of the boundary of the City of Dunedin and in a north-easterly direction along the said boundary to a retaining-wall; thence in a generally northerly direction along the retaining-wall and along the boundary of the City of Dunedin to the point of commencement.

DUNEDIN CITY

All that part of the City of Dunedin, bounded by a line commencing at a point on the waterfront at the junction of Rattray Street Wharf and Victoria Wharf; thence north-easterly along the waterfront to the boat harbour; thence along the generally southern boundary of the boat harbour and along the waterfront to the point where the boundary of the City of Dunedin meets the boundary of the Borough of West Harbour at Black Jack's Point; thence along the common boundary of the City of Dunedin and the Borough of West Harbour to Opho Creek; thence along Union Street to Leith Street, along Leith Street, St. David Street, and Castle Street to Union Street, along Union Street to Queen Street, and along Queen Street, Park Street, Heriot Row, and Khyber Pass to the Town Belt; thence along a right line to the point where Tolcarne Avenue meets the Town Belt; thence along Tolcarne Avenue and Grendon Street to Highgate, along Highgate to Lynn Street, along Lynn Street and Balmacewen Road to Helensburg Road; thence in a generally north-westerly direction along Helensburg Road to Wakari Road, and south-westerly along Wakari Road to the easternmost corner of Section 51, Wakari Survey District; thence along the north-eastern boundary of Section 51 aforesaid to the boundary of the City of Dunedin; thence in a generally southerly direction along the boundary of the City of Dunedin to the Kaikorai Valley Road; thence along the Kaikorai Valley Road to Stone Street; thence along Stone Street to the northern boundary of Lot 65 of Section 10, Lower Kaikorai Survey District; thence along the northern boundary of Lot 65 aforesaid and the northern boundary of Lot 27 on Deeds Plan 347 to Pitcairn Street; thence along Pitcairn Street, Kenmure Road, Rosebery Street, Beaumont Road, Napier Street, and Jubilee Street to Hawthorn Avenue; thence along Hawthorn Avenue, Serpentine Avenue, Maclaggan Street, Rattray Street, and Rattray Street Wharf to the point of commencement.

CLUTHA

All that area comprising the County of Bruce, the Maungatua, Outram, Otokia, East Taieri, North Taieri, and Kaikorai Ridings of the County of Taieri, the Clutha, Richardson, and South Molyneux Ridings of the County of Clutha, the Waipori and Waitahuna Ridings of the County of Tuapeka lying to the south-east of the Tuapeka River, the Borough of Green Island, the Borough of Mosgiel, the Borough of Lawrence, the Borough of Milton, the Borough of Balclutha, and the Borough of Kaitangata.

CENTRAL OTAGO

All that area comprising the County of Vincent, the Wanaka Riding of the County of Lake, that part of the Arrow Riding of the County of Lake lying to the north of a line from Trig. Station C, Block 2, Knuckle Peak Survey District, to the source of Soho Creek, and thence northerly along the boundary of Soho Survey District to the riding boundary, the Lauder, St. Bathans, Idaburn, Gimmerburn, Mount Ida, and Kyeburn Ridings of the County of Maniototo, the Benger, Teviot, Crookston, Beaumont, Gabriels, and

Tapanui Ridings of the County of Tuapeka, that part of Browns Riding of the County of Tuapeka lying to the north-west of the Tuapeka River, that part of the Mataura Riding of the County of Southland lying to the south of a line along the road from Waikoikoi, through Maitland, East Chatton, and Chatton to Okapua Creek, and along Okapua Creek to the Mataura River, the Glenkenich, Waipahi, Clydevale, Pomahaka, and Clinton Ridings of the County of Clutha, the Borough of Naseby, the Borough of Cromwell, the Borough of Alexandra, the Borough of Roxburgh, the Borough of Tapanui, the Borough of Gore, and the Borough of Mataura.

INVERCARGILL

All that part of the City of Invercargill, bounded by a line commencing at the easternmost point of the City of Invercargill; thence in a southerly direction generally along the boundary of the City of Invercargill to the intersection of John Street and Saturn Road; thence in a westerly direction generally along John Street, Pomona Road, Martin Street, Elles Road, Janet Street, and the production of the last-mentioned street to the boundary of the City of Invercargill; thence along the generally southern, western, northern, and eastern boundaries of the City of Invercargill to the point of commencement.

AWARUA

All that area comprising the County of Stewart Island, the Wallacetown, Awarua, Waihopal, and Toetoes Ridings of the County of Southland, the MacLennan and Catlins Ridings of the County of Clutha, the Borough of Bluff, the Borough of South Invercargill, the Town District of Wyndham, that part of the City of Invercargill lying to the south of a line commencing at the intersection of John Street and Saturn Road, and proceeding in a generally westerly direction along John Street, Pomona Road, Martin Street, Elles Road, Janet Street, and the production of the last-mentioned street to the boundary of the City of Invercargill, and including Dog Island in Foveaux Strait.

WALLACE

All that area comprising the County of Fiord, the County of Wallace, the Oreti, Wakaia, Winton, and Hokonui Ridings of the County of Southland, that part of the Mataura Riding of the County of Southland lying to the north of a line along the road from Waikoikoi, through Maitland, East Chatton, and Chatton to Okapua Creek, and along Okapua Creek to the Mataura River, the Greenstone, Queenstown, and Kingston Ridings of the County of Lake, that part of the Arrow Riding of the County of Lake lying to the south of a line from Trig. Station C, Block 2, Knuckle Peak Survey District, to the source of Soho Creek, and thence northerly along the boundary of Soho Survey District to the riding boundary, the Borough of Riverton, the Borough of Winton, the Borough of Arrowtown, the Borough of Queenstown, Nightcaps Town District, Otautau Town District, Lumsden Town District, and Centre Island in Foveaux Strait.
