Notice of a Scheme of Development and Reconstruction in the Waikato River Basin and Adjacent Areas

PURSUANT to subsection (2) of section 29 of the Finance Act (No. 3), 1944, I, Robert Semple, the Minister of Works, hereby give notice of the nature of the work to be included in the scheme of development and reconstruction described in the First Schedule hereto, and that the approximate boundaries of the area hereby affected are as described in the Second Schedule hereto, such area being hereinafter referred to as "the area." This notice shall remain in force until the 30th day of September, 1956.

FIRST SCHEDULE

NATURE OF WORK

THE improvement of the lands and the development of the area for industrial, commercial, residential, and recreational purposes, including in particular the provision of:—

1. Land Development

(a) Farm development and improvement throughout the area, involving the subdivision of larger blocks of suitable land for closer (b) Soil conservation and river control works throughout the

area, including in particular :-

 Sand-dune-reclamation works and tree planting between the Waikato Heads and the Waiuku River:
 River control, channel improvement, and flood-protection works and willow clearing in the Waikato and Waipa Rivers and tributaries.

(c) Drainage improvements throughout the area, including drainage and reclamation of Lake Waikare, Rukuhia Swamp, Tuatuamoana Swamp, and other lands liable to flooding.

(d) Afforestation and utilization of forest products, being the development and expansion of forests generally in the area, with improved facilities for culture, control, and protection, particularly at Kaingaroa, Waiotapu, Pureora, and Maramarua, and works for the treatment and utilization of forest products.

2. Industrial

(a) The establishment of industrial areas and the provision and development of sites and buildings for industries generally in the area, and in particular at Hamilton.

(b) Mining: The further development of the coal-mining industry throughout the area, with expansion and improved methods of working at Wilton, Kimihia, Kemps, and Rotowaro.

(c) Establishment, development, and improvement of industries on reclaimed areas.

(d) Quarries Shingle-pits &c. Provision of materials recognized.

(d) Quarries, Shingle-pits, &c.: Provision of materials necessary for construction works and development of sources of supply and provision for storage.

(e) Establishment of industries utilizing forest products.

3. Commercial

(a) The establishment of commercial areas and the provision and development of sites and buildings for commerce in conjunction with residential and industrial areas.

(b) Expansion of commercial areas generally within the area, and particularly at Hamilton.

(c) Better provision for tourist and holiday traffic and accommodation generally within the area, including special facilities at the lakes formed in the Waikato River in connection with hydroelectric development, including a fishing lodge at Tokaanu.

4. Communications

- (1) Improvement of radio, telegraph, telephone, and postal services throughout the area, including:—
 - (a) New post-offices at Morrinsville, Matamata, Te Kuiti, Pukekohe, Te Awamutu, and generally in connection with industrial, commercial, and residential development:
 - (b) Garage, workshop, and store for Post and Telegraph Department, Hamilton.
- (2) Improvement of existing and provision of new airports,

- (2) Improvement of existing and provision of new airports, new runways, and new taxiways.

 (3) Harbours, &c.: Improvement of facilities for carriage of goods and passengers by water to, from, and within the area.

 (4) Arterial and Local Access: Improved and new arterial and local access within the area, including deviations, realignment, regrading, resurfacing works and bridges, where necessary, and in particular : particular :
- (a) Huntly By-pass, being a four-and-a-half mile length of new highway to avoid the Borough of Huntly:
 (b) Between Mercer and Rangiriri:
 (c) Between Hamilton and the following towns—namely, Te Kuiti, Cambridge, Raglan, and Kawhia:
 (d) Between Rotorua and Taupo:
 (e) Between Kihikihi and Arapuni:
 (f) Between Hangitiki and Waitomo Caves:
 (a) Improvements to northern, southern, and eastern outlets.

- (g) Improvements to northern, southern, and eastern outlets from Hamilton:

- from Hamilton:

 (h) Provision of footbridge on the existing road and rail bridge between Huntly and Huntly West:

 (i) New road links between the Cambridge-Taupo Main Highway at Tokoroa and the State hydro-electric schemes at Whakamaru, Maraetai, and Waipapa, and the works and townships connected therewith:

 (j) Street replanning, extension and improvements in the various municipalities, with provision of parking areas and road-transport terminals, including in the City of Hamilton elimination of level crossings and additional river crossings:
- river crossings:
 (k) Reconstruction of roads in the vicinity of Tokoroa to take heavy timber traffic.

- (5) Railways: Improved rail facilities for all classes of traffic, including:
 - (a) Rail link from Putaruru via Tokoroa and Atiamuri towards
 Taupo, involving reconstruction to Government railway
 standards of the Taupo Totara Timber Company's
 Tramway to the 19-mile peg and construction of new

Iranway to the 19-mine peg and construction of new line thence towards Taupo:

(b) Frankton Junction to Te Kuiti: Grade and curvature easements, involving deviation from existing alignment:

(c) Auckland-Frankton: Completion of duplication between Paerata and Ohinewai:

(d) Frankton Junction: Separation of goods and passenger traffic, with provision of new and more suitable buildings:
(e) Yard rearrangement and duplication of line from Frankton

through Hamilton to Ruakura, with elimination of level crossings and new double-track bridge over the Waikato.

(6) Public Transport: New and improved facilities for the transport of passengers and goods.

(a) Extension of utilities through new and existing residential,

commercial, and industrial areas, and in rural areas.

(b) Electricity: Construction of hydro-electric generating stations, utilizing the fall of the Waikato River between Lake Taupo and Cambridge, including construction of lakes at Karapiro, Waipapa, Maraetai, Whakamaru, Atiamuri, Ohakuri, Parariki, and at two other sites.

(c) Extension of transmission lines, construction of substations,

and other works necessary for distribution of electricity.

(d) Extensions and improvements of water-supply, gas-supply, sewerage, and storm-water systems generally in the area, and in particular in Hamilton City, and new sewerage scheme in Huntly Borough.

6. Subdivisional Development and Housing

(a) The development of areas for residential, commercial, (a) The development of areas for residential, commercial, industrial, and recreational purposes throughout the area, including the construction of dwellinghouses and other works provided for by the Housing Act, 1919, and other statutory authorities.

(b) The subdivision, regrouping, and improvement of lands affected by reclamation and drainage works in the area and better utilization thereof.

(c) The reconstruction and improvement of lands.

(c) The reconstruction and improvement, where necessary, of existing roads, streets, and bridges approaching developmental works.

(d) The removal and resiting of Tokaanu Township.

(e) Hostel for miners at Huntly.

7. Social and Cultural Services

(1) The provision of sites, buildings, and services there for social and cultural services, including:—

(a) New hospitals and ancillary buildings for the Waikato Hospital District at Hamilton, Te Kuiti, Huntly, Te Awamutu, and Putaruru, and new tuberculosis sanatorium:

Additions to Tokanui Mental Hospital: Soil Fertility Research Station in the vicinity of Hamilton:

(d) Animal Research Station Laboratory at Ruakura:
(e) The rebuilding of the primary school at Cambridge and the provision of two intermediate schools, the extension of the technical school, and the provision of a new secondary school and hostel at Hamilton:

(f) The provision of recreational and general amenity reserves in the vicinities of the lakes formed by the hydro-electric developments and at natural lakes and tourist resorts:

(g) Provision of town hall and cultural halls, community centre, showgrounds, baths, crematorium, improved parks, reserves, and playing fields for Hamilton City.

8. Defence

Construction and improvement of defence installations.

9. Public Administration

New facilities for Government and local administration, including :-

(a) Construction of a Government centre in Hamilton for the accommodation of various Departments and transaction

of public business:
(b) New police-stations.

SECOND SCHEDULE

APPROXIMATE BOUNDARIES OF AREA

ALL that area in the North Auckland, Auckland, Taranaki, and Wellington Land Districts, bounded by a line commencing at a point on the sea-coast on the production of the right line between Trigonometrical Station Bald Hill, Block XIII, Drury Survey District, and Trigonometrical Station 34, Kopukanui, Block XI, Awhitu Survey District; thence easterly generally to and along that line to the said Trigonometrical Station Bald Hill; thence north-easterly along a right line to Trigonometrical Station B 2, Block X, Drury Survey District; thence easterly along a right line to Trigonometrical Station 634, Block VII, Opaheke Survey District; thence northerly along a right line to Trigonometrical Station 1946, Block XIII, Wairoa Survey District; thence easterly along a right line to Trigonometrical Station Kohukohunui, Block IV, Orere Survey District; thence due east along a right line to the sea-coast on the Firth of Thames; thence southerly generally along the sea-coast to a point due north of Trigonometrical Station 86, Maungakawa, on the eastern boundary of Block XV, Piako Survey District; thence that area in the North Auckland, Auckland, Taranaki, and on the Firth of Thames; thence southerly generally along the seacoast to a point due north of Trigonometrical Station 86, Maungakawa, on the eastern boundary of Block XV, Piako Survey District; thence due south to the said Trigonometrical Station 86; thence southeasterly along a right line to Trigonometrical Station 1992, Block V, Waitoa Survey District; thence south-westerly along a right line to Trigonometrical Station 1993, Hangawera, on the southern boundary of Block IX, Waitoa Survey District; thence southeasterly generally along a right line to Trigonometrical Station Maungatapu, Block VII, Maungakawa Survey District, and a right line to Trigonometrical Station R on the southern boundary of Block XIV, Wairere Survey District; thence southerly along a right line to Trigonometrical Station Whakaaratamaiti, Block VII, Patetere North Survey District; thence south-easterly generally along a right line to Trigonometrical Station Ohinepuremu, Block VII, Patetere North-east Survey District, and a right line to Trigonometrical Station Wairua, Block XV, Tarawera Survey District; thence easterly generally along a right line to Trigonometrical Station Maratahia, Block XIV, Ruawahia Survey District, and a right line to Trigonometrical Station Tiri Tiri, Block III, Galatea Survey District; thence south-westerly generally along a right line to Trigonometrical Station Tiri Tiri, Block III, Heruiwi Survey District, and a right line to Trigonometrical Station Tiri Tiri, Block III, Heruiwi Survey District, and a right line to Trigonometrical Station Tihia, Block IX, Puketi Survey District; thence north-westerly along a right line to Trigonometrical Station Kakaramea, Block VIII, Puketi Survey District; and a right line to Trigonometrical Station Thia, Block IX, Puketi Survey District; thence north-westerly along a right line to Trigonometrical Station Fukemako, Block V, Hurakia Survey District, and a right line to Trigonometrical Station Ngapakoro, Block VIII, Maungamangero Survey District; thence northerly right line to Trigonometrical Station Tokapiko, Block VIII, Otanake Survey District, and a right line to Trigonometrical Station Ngapakoro, Block VIII, Maungamangero Survey District; thence northerly along a right line to Trigonometrical Station 1930, Block XIII, Pirongia Survey District; thence westerly along a right line through Trigonometrical Station Whakaongaonga 1933, Block XIV, Kawhia North Survey District, and the production of that line across Kawhia Harbour to the sea-coast; thence northerly generally along the sea-coast, crossing the mouths of all streams, rivers, inlets, estuaries, bays, harbours, outlets, ports, bights, and firths whatsoever, and their banks, beds, and waters to a point in line with the production of the right line between Trigonometrical Station Bald Hill, Block XIII, Drury Survey District, and Trigonometrical Station 34, Block XI, Awhitu Survey District, being the point of commencement.
