Amending a Proclamation defining the Middle-line of a Road in Blocks V, VII, XI, and XII, Belmont Survey District—viz., a Deviation of the Wellington-Paekakariki Centennial Main Highway

A PROCLAMATION **PURSUANT** to the Public Works Act, 1928, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, do hereby revoke so much of the Schedule to the Proclamation dated the ninth day of October, one thousand nine hundred and forty-five, and published in the New Zealand Gazette No. 63 of the eleventh day of the same month, at page 1264, defining the middle-line of a road in Blocks V, VII, XI, and XII, Belmont Survey District—viz., a deviation of the Wellington–Paekakariki Centennial Main Highway, as defines the middle-line of the said road between a point marked 0 miles on the plan marked P.W.D. 122329 referred to therein and a point on the said middle-line 3-6 chains north-east of the point marked 0 m. 50 chs. on the said plan, and in lieu thereof do hereby proclaim and declare that the middle-line of the said portion of road shall be as defined and set forth in the Schedule hereto; and I do also declare that this Proclamation shall affect only that land situated within the limits as defined on the plan marked P.W.D. 125120 referred to in the Schedule hereto.



3. SYSTEM OF SUPPLY

3. SYSTEM OF SUPPLY Bulk supply at a nominal pressure of 11,000 volts between phases shall be received from the State Hydro-electric Department's substation located at Ongarue, or from such other additional point or points of supply as may be mutually arranged between the Minister in Charge of the State Hydro-electric Department and the licensee. The system of supply shall be as described in paragraphs (a), (c), (d), (e), (f), and (j) of clause 21-01 of the Electrical Supply Regulations 1935. The system of supply authorized under para-graph (j) shall be a single conductor earth-return system. The primary-distribution voltages shall be 22,000 volts between phases and 11,000 volts between phases in the case of the three-phase extra-high pressure system of supply. 11,000 volts between con-ductors in the case of the two-wire extra-high pressure system of supply, and 11,000 volts between the conductor and earth in the case of the earth-return system of supply. The secondary-distribution voltage shall be 400 volts between phases and 230 volts between any phase and neutral in the case of the three-phase four-wire system of supply, 400 volts between outer conductors, and 230 volts between each outer conductor and the middle conductor in the case of the three-wire system of supply, and 230 volts between conductors in the case of the two-wire system of supply.

4. DURATION OF LICENSE

5. CHARGES FOR ELECTRICAL ENERGY

The charges for electrical energy shall not exceed 1s. per unit for lighting purposes and 6d. per unit for all other purposes; pro-vided that "lighting purposes" shall include electrical energy used for such purposes directly or indirectly from the source of supply except where used to charge a secondary battery for standby emergency lighting only; and, provided further, that if accounts are paid within fourteen days of due date the charges shall not exceed 10d, per unit for lighting nurposes and 4d per unit for such exceed 10d. per unit for lighting purposes and 41d. per unit for such other purposes.

other purposes. In the case of wholesale supply, the charge shall not exceed £16 per kilovolt-ampere of half-hourly maximum demand per annum, plus ½d. per unit. "Wholesale supply" for this purpose shall be held to be a supply in respect of which the consumer shall guarantee to pay not less than £180 per annum. The licensee may in the case of any supply make such minimum charge as may be authorized by regulation.

6. TIME FOR COMPLETION OF WORKS

PURSUANT to the powers conferred on it by the Control of Prices Emergency Regulations 1939,* the Price Tribunal, acting with the authority of the Minister of Industries and Commerce, doth hereby make the following Price Order :--

PRELIMINARY

This Order may be cited as Price Order No. 677, and shall come into force on the 18th day of April, 1947.
 (1) In this Order—

 "Assorted case lot" means a lot comprising different varieties of jams and consisting of five dozen 14 oz. containers, or two and a half dozen 28 oz. containers, or one dozen 6 lb. containers, or half-dozen 10 lb. containers, or two dozen 16 oz. jars:
 "Jam" means the product obtained by the processing of cane sugar and fruit of any kind or of different kinds (with or without the admixture of other substances), whether such product is sold or offered for sale as jam, or jelly, or conserve, or marmalade, or by any other name or description.

(2) Terms and expressions defined in the Control of Prices Emergency Regulations 1939,* when used in this Order, have the meanings severally assigned thereto by those regulations.

APPLICATION OF THIS ORDER

3. (1) Nothing in this Order applies with respect to any jam that is specially prepared by the manufacturer for the use of diabetics and is labelled accordingly.

(2) Except as provided in the last preceding subclause, this Order applies to all jam that is manufactured by H. J. Walton, Ltd., but does not apply to jam manufactured by any other manufacturer.

FIXING MAXIMUM PRICES OF GOODS TO WHICH THIS ORDER APPLIES Manufacturer's Prices

Any authority given by the Tribunal under this subclause may apply with respect to a specified lot or consignment of goods or may relate generally to all goods to which this Order applies sold by the retailer while the approval remains in force.
