THE RIGHT HON. W. NASH PRESIDING IN COUNCIL

PURSUANT to the Harbours Act, 1923, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby amend, as set forth in the Schedule hereto, the Order in Council dated the twenty-third day of December, one thousand nine hundred and forty-two, published in the *Gazette* of the twenty-third day of the same month at page 3172, licensing and permitting the Coromandel County Council to use and occupy parts of the foreshore and land below low-water mark in Coromandel County, for the purpose of maintaining wharves thereon.

All dues payable by irregular trading vessels shall be paid to the Treasurer of the Council, and the payments shall be made by the master or owner of the vessel upon the first application by the Treasurer of the Council.

"6 All passengers berthage dues shall be paid monthly on or before the seventh day of each month in accordance with a return which shall be furnished to the Treasurer of the Council from the books or records of the master or owner of the vessel which carried the passengers.

Separate consignment of goods shall be computed separately, and computing the whole of one firm's or persons' separately, and computing the whole of one firms of persons consignments in the lump or as a whole, as one consignment shall not be allowed, saving and excepting that when any firm or person ships or receives more than one package of goods on any one day by the same ship, then wharfage shall be charged on the total measurements of all the packages, and not separately.

Every person, firm, company, or corporate body whose goods remain in any wharf, shed, or on any of the wharves mentioned goods remain in any wharf, shed, or on any of the wharves mentioned in this Order in Council for more than one week from the date the said goods were placed therein or thereon shall pay to the Treasure of the Council (when called upon by the Council or wharfinger so to do) before receipt of such goods, storage for such goods as hereafter mentioned, that is to say : For each and every week or part of a week from the date the goods are first placed in the shed or on the wharf, double the rates set out in the wharfinger Sohedule. If any cargo remains on any of the wharves for a longer period than forty-eight hours, or where such cargo hinders the loading or unloading of any vessel, or is an impediment to the approaches, the Council, through the wharfinger or other so authorized person, may have such cargo removed at the expense of the owner, and the cost of such removal shall be payable by the owner previous to taking

PURSUANT to the Control of Prices Act, 1947, the Price Tribunal, acting with the authority of the Minister of Industries and Commerce, doth hereby make the following Price Order :---

This Order may be cited as Price Order No. 996, and shall come into force on the 5th day of May, 1949.
 In this Order—

"Flue-cured leaf" means leaf that has been treated in the kiln for at least three successive days immediately after picking for the purpose of yellowing, fixing colour, drying, and drying mid-ribs: "Air-dried leaf" means leaf other than flue-cured leaf.

APPLICATION OF THIS ORDER

3. This Order applies with respect to all raw-leaf tobacco grown in New Zealand during the 1948-49 season: Provided that the Tribunal may, in any case where it considers it proper so to do and subject to such conditions (if any) as it thinks fit, exempt any such tobacco from the operation of this Order.

FIXING AVERAGE PRICES OF RAW-LEAF TOBACCO TO WHICH THIS ORDER APPLIES

4. (1) The average price to be paid by any tobacco-manufacturer for raw-leaf tobacco to which this Order applies shall not be less than-

(a) For flue-cured leaf 2s. $5\frac{1}{2}$ d. per pound, (b) For air-dried leaf 2s. $2\frac{1}{2}$ d. per pound.

(b) For the purposes of this clause the weight of any raw-leaf tobacco shall be deemed to be its weight at the time and place of delivery by the grower to the manufacturer or to his agent in the district in which it is grown: Provided, however, that in any case where the grower and the manufacturer or his agent agree that the moisture-content of the leaf in any lot of tobacco is excessive, then for the purpose of calculating the value of the lot the weight of the lot shall be deemed to be reduced by a reasonable amount to make allowance for the excessive moisture.

allowance for the excessive moisture. 5. This Order shall be read subject to the provisions of the Board of Trade (Raw Tobacco Price) Regulations 1943.*
