*Proclaiming a Tribal District Under the Maori Social and Economic Advancement Act, 1945*

A PROCLAMATION

PURSUANT to section 6 of the Maori Social and Economic Advancement Act, 1945, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, do hereby declare the parts of New Zealand described in the Schedule hereto to be a tribal district for the purposes of the said Act, and do hereby assign to the said district the name Tuhoe-Manawaru Tribal District.

SCHEDULE

TUHOE-MANAWARU TRIBAL DISTRICT

ALL that area in the Auckland and Gisborne Land Districts, bounded by a line commencing at the south-eastern corner of Block VIII, Galatea Survey District; thence proceeding easterly along the southern boundaries of Blocks V, VI, and VII, Urewera Survey District, to the watershed between the Whakatane and Tauranga-Waimana Rivers; thence southerly along that watershed to the southern boundary of Urewera Survey District; thence easterly along that boundary and the southern boundary of Waioeka South Survey District to the western boundary of Tahora Block; thence southerly along that boundary to its intersection with a right line between Maungatapere and Maungapohatu Trig. Stations; thence westerly along that line to Maungapohatu Trig. Station; thence south-easterly along a right line in the direction of Puketapu Trig. Station to its intersection with the north-western boundary of Waipaoa Block; thence south-westerly along that north-western boundary, passing through Trig. Stations Koranga West and Pukepuke, to its intersection with a right line between Puketapu Trig. Station and the northernmost point of Lake Waikaremoana; thence westerly along that right line to Lake Waikaremoana and along a right line to Te Taumutu Trig. Station in Block XVI, Heruiwi Survey District; thence north-westerly along a right line to the southernmost corner of Waireporepo Block in Block X, Ahikereru Survey District; thence along the south-eastern boundary of that block to its north-eastern corner; thence along a right line to the south-eastern corner of Block VIII, Galatea Survey District, the point of commencement.

A PROCLAMATION

PURSUANT to section 6 of the Maori Social and Economic Advancement Act, 1945, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, do hereby vary the Proclamation made on the 18th day

of November, 1947, and published in the *Gazette* on the 8th day of January, 1948, at page 4, declaring certain parts of New Zealand to be a tribal district for the purposes of the said Act, by excluding from the Schedule thereto the description of the Southern Tuhoe Tribal District and substituting therefor the description appearing in the Schedule hereto.

SCHEDULE

SOUTHERN TUHOE TRIBAL DISTRICT

ALL that area in the Auckland Land District bounded by a line commencing at Putauaki (Mount Edgecumbe) Trig. Station in Block XIII, Rangitaiki Upper Survey District, and proceeding easterly along right lines to the north-eastern corner of Allotment 60H, Rangitaiki Parish in Block XV, Rangitaiki Upper Survey District, and to the north-eastern corner of Allotment 60D, Rangitaiki Parish; thence southerly along the eastern boundaries of Allotments 60D and 60C, Rangitaiki Parish, to the south-eastern corner of the said Allotment 60C; thence westerly along the southern boundary of that allotment to Tapapakiakia Trig. Station; thence south-westerly and south-easterly along right lines to Te Hiwera and Taumatamiri Trig. Stations in Block IV, Rangitaiki Lower Survey District; thence south-easterly along a right line in the direction of Kaipurapuna Trig. Station to its intersection with the eastern boundary of Block VIII, Rangitaiki Lower Survey District; thence southerly along the eastern boundaries of Blocks VIII, XII, and XVI, Rangitaiki Lower Survey District, and of Blocks IV and VIII, Galatea Survey District, to the south-eastern corner of the said Block VIII; thence south-westerly along a right line to the north-eastern corner of Waireporepo Block in Block XI, Ahikereru Survey District; thence along the south-eastern boundary of that block to its southernmost corner; thence along a right line to Te Taumutu Trig. Station in Block XVI, Heruiwi Survey District; thence westerly along a right line to Trig. Station Pukeroa in Block XI, Heruiwi Survey District; thence northerly along a right line in the direction of Tiritiri Trig. Station to the intersection with the production of a right line between Trig. Station 4 in Block VII, Heruiwi Survey District, and the southernmost point of Lot 9 on the plan numbered 21389, deposited in the office of the District Land Registrar at Auckland; thence westerly to and along that right line to the southernmost point of Lot 9 aforesaid; thence northerly along the eastern boundary of that lot to Ngapuketurua Trig. Station in Block VI, Heruiwi Survey District; thence northerly along a right line to Wairapukao Trig. Station in Block VI, Wheao Survey District; thence westerly along the southern boundaries of Kaingaroa 1A South and 1A North Blocks to the south-western corner of the last-mentioned block; thence northerly along the western boundary of the said 1A Block to its northernmost corner; thence along a right line to Trig. Station 38A in Block IX, Kaingaroa Survey District; thence easterly along a right line to Trig. Station H in Block V, Galatea Survey District; thence northerly along a right line to Putauaki Trig. Station, the point of commencement.

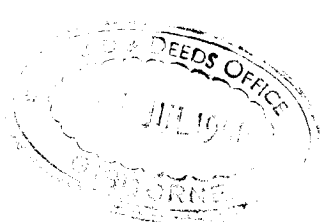

*Declaring Parts of a Tribal District to be Tribal Committee Areas Under the Maori Social and Economic Advancement Act, 1945*

PURSUANT to section 14 of the Maori Social and Economic Advancement Act, 1945, I, Ernest Bowyer Corbett, Minister of Maori Affairs, do hereby declare the parts of the tribal district described in the Schedule hereto to be tribal committee areas for the purposes of the said Act, and do hereby assign to each of the several areas the name appearing at the head of the description of each such area.

SCHEDULE

TUHOE-MANAWARU TRIBAL DISTRICT

*Manawaru Tribal Committee Area*

ALL that area bounded by a line commencing at the south-eastern corner of Block VIII, Galatea Survey District, and proceeding easterly along the southern boundaries of Blocks V, VI, and VII, Urewera Survey District, to the watershed between the Whakatane and Tauranga-Waimana Rivers; thence southerly along that watershed to Pawairoto Trig. Station in Block III, Ruatahuna Survey District; thence along a right line to Te Ranga-a-Taneiti Trig. Station in Block VI, Ruatahuna Survey District; thence south-westerly along a right line to the source of the Mangaorongo Stream, a tributary of the Whakatane River; thence north-westerly down that stream to its confluence with the Whakatane River; thence along a right line passing through Trig. Station 2125 (Whakaipu) in Block VII, Ahikereru Survey District, to the south-eastern boundary of the Ngati Whare Tribal Committee Area; thence north-easterly along that boundary to the south-eastern corner of Block VIII, Galatea Survey District, the point of commencement.

*Ruatahuna Tribal Committee Area*

All that area bounded by a line commencing at Trig. Station Te Taumutu in Block XVI, Heruiwi Survey District, being a point on the boundary of the Ngati Whare Tribal Committee Area; thence north-easterly along that boundary to its intersection with the production of a right line between the confluence of Mangaorongo Stream and Whakatane River and Trig. Station 2125 (Whakaipu); thence south-easterly along the said right line to the confluence of Mangaorongo Stream and Whakatane River, up the Mangaorongo Stream to its source and along a right line passing through Trig. Station Whakatakaa in Block II, Waikaremoana West Survey District, to its intersection with a right line between the northernmost point of Lake Waikaremoana and Trig. *Te Waiti - Huiarau Tribal Committee Area*

All that area bounded by a line commencing at Pawairoto Trig. Station in Block III, Ruatahuna Survey District, and proceeding northerly along the watershed between the Whakatane and Tauranga-Waimana Rivers to the southern boundary of Urewera Survey District; thence easterly along that boundary and the southern boundary of Waioeka South Survey District to the western boundary of Tahora Block; thence southerly along that boundary to its intersection with a right line between Mangatapere and Maungapohatu Trig. Stations; thence westerly along that line to Maungapohatu Trig. Station; thence south-easterly along a right line in the direction of Puketapu Trig. Station to its intersection with the north-western boundary of Waipaoa Block; thence south-westerly along that north-western boundary, passing through Trig. Stations Koranga West and Pukepuke, to its intersection with a right line between Puketapu Trig. Station and the northernmost point of Lake Waikaremoana; thence westerly along that right line to Lake Waikaremoana; thence south-westerly along a right line in the direction of Te Taumutu Trig. Station in Block XVI, Heruiwi Survey District, to its intersection with the production of a right line between the source of Mangaorongo Stream and Trig. Station Whakatakaa in Block II, Waikaremoana West Survey District; thence north-westerly along the last-mentioned right line to the source of Mangaorongo Stream; thence north-easterly along a right line to Trig. Station Te Ranga-a-Taneiti in Block VI, Ruatahuna Survey District, and a right line to Trig. Station Pawairoto, the point of commencement.

NOTES ON THE WEATHER FOR JUNE, 1950

**General.**—After the exceptionally mild conditions of the preceding month, June's weather, by contrast, appeared to be rather unpleasant. Although there was little settled weather, the conditions were, however, fairly typical of the winter season. Temperatures were, in fact, slightly above average. An unusual feature of the weather situation was the passage over the New Zealand area of the series of six wave depressions each of which had its origin near the coast of Queensland. A long spell of showery south-westerly weather made conditions very unpleasant in Southland until the final week.

On the whole it was a favourable month for farmers and stock is reported to be in good condition.

**Rainfall.**—Rainfall was above average in Marlborough, Southland and the Canterbury Plains. On the Kaikoura coast and in Southland where it was one of the wettest Junes in the last 40 years, totals were 2 or 3 times the average. Some local flooding occurred in Marlborough towards the end of the month. In the North Island also, rainfall exceeded the average, except in the region about and west of the Tararua Range and about the central portion of the Auckland Peninsula.

Lowest rainfalls occurred in Central Otago where several stations had monthly totals of under half an inch, the equivalent of about a third to the average amount.

**Temperatures.**—Except in parts of Canterbury, mean temperatures were above normal. The anomalies were generally small but in central and northern districts of the North Island they exceeded 2° F.

There was a moderate fall of snow over Southland on the 7th.

**Sunshine.**—There was a deficiency of over 20 hours in the month's sunshine over the Auckland Province and along the Kaikoura coast. Most of Canterbury had an excess of 20-30 hours, but over the remainder of the country the sunshine was near average.

**Weather Sequence.**—With a trough of low pressure lying across the North Island, the weather there remained very unsettled. For a start, conditions were better in the South Island due to the influence of a weak anticyclone.

A depression which passed rapidly across the Cook Strait region on the evening of the 2nd brought brief but heavy rain to the central provinces. An anticyclone then moved from the Tasman Sea across to the north of New Zealand.

From the 4th to the 7th unsettled westerly weather prevailed, pressures running high to the north but very low to the south. Except in sheltered eastern districts heavy showers were frequent throughout this period and thunder occurred in many places. Snow became widespread in the South Island on the 6th and winds rose to gale force as the main depression, which was very deep and extensive, crossed Campbell Island. When a secondary depression passed close to Southland a day later, its associated cold front swept rapidly northwards over the South Island accompanied by hail and thunder. It began to rain over Northland with the approach of a wave depression which had formed off the coast of Queensland.

This wave passed across Northland on the night of the 8th. Meanwhile a weak ridge had developed over the South Island where the weather had cleared except for showers on the Southland coast. A second wave deepened steadily and, moving rapidly south-eastwards, crossed the Wellington province on the night of the 10th.

On the 11th a ridge of high pressure extended across the Tasman Sea onto the Dominion. Since pressures remained low to the south-east, south-westerly conditions then prevailed. Cold showery weather continued in exposed districts, but it became fine and frosty over the greater part of the country.

Before the end of the month, yet another four depressions from the Queensland region were to pass over or close to New Zealand. The third of the series was weak. It passed North of North Cape on the 14th, rainfall being confined mainly to the Northland and Coromandel districts. There was a period of rain in the South Island on the 16th during the passage of a vigorous cold front associated with a depression far to the south. With barometers rising in the south, winds then turned more south-easterly.

During the passage of the fourth depression over North Cape on the 18th, rain extended, for a time, over the Auckland Province (except the southern part) and down the east coast to Banks Peninsula. Although cold, showery weather continued in Southland and South Otago, the 19th marked the beginning of a spell of settled weather over the greater part of the country. Temperatures remained cold and severe frosts occurred inland. In parts of the North Island the night of the 19th was the coldest for some years.

A few scattered showers on the 21st were associated with the passage of a weak cold front. On the same day the fifth of the Queensland depressions passed well to the north of the Dominion just as the sixth was beginning to form. An intense anticyclone, which has been over south-eastern Australia for more than a week, then crossed the Tasman Sea to New Zealand. Thus, on the 24th, came to an end the long spell of showery weather in Southland.

The sixth depression of the series followed a more southerly track than any of its predecessors. Deepening steadily it soon developed into a major storm which produced serious flooding in New South Wales as it moved down the Australian coast. Winds turned north-easterly in New Zealand on the 25th with the approach of the associated warm front. This front was preceded by a very extensive rain-band which reached Northland late on the 25th. Barometers fell steadily and rain gradually spread southwards over the whole country. When the original centre was still about 500 miles west of Auckland, a new centre formed east of Hawke's Bay early on the 28th. With a change to north-westerly winds in the north, rain became intermittent there, but the formation of a new centre intensified the rainfall in Wairarapa and Marlborough resulting in some local flooding in the latter district.

As the new centre moved away to the east on the 29th, the original centre travelled towards Westland where it slowly died away. The weather, however, remained generally unsettled due to the rapid advance of a new and vigorous depression in an east-north-eastward direction across from Tasmania. At the end of the month it was rapidly approaching Auckland.

## Names of Tax Evaders

THE following Schedules comprise the names of all persons (including companies) who, in respect of certain offences relating to taxation, have been convicted or who have been charged penal tax or penal charge during the year ended 31st March, 1950. *Government Service Tribunal.—Order No. 19*

In the matter of section 9 (e) of the Government Service Tribunal Act, 1948, and in the matter of an application dated the 15th day of June, 1950, duly lodged by the Chairman of the Public Service Commission.

THE Government Service Tribunal having heard and considered the application of the applicant doth hereby order:—

1. Principal Order No. 8 as from time to time heretofore amended shall be amended in manner following, that is to say:—

(a) Subject to the following provisions of this Order, all rates of remuneration including time and piece wages and overtime and other special payments prescribed in the said principal order shall be increased by an amount equal to 5 per cent. thereof.

(b) There shall be excluded from the scope of this Order such portion of the remuneration in each week of the employees affected by this Order as exceeds the amount of £7 in the case of adult male employees, and the amount of £4 15s. in the case of adult female employees and all junior workers.

(c) There shall also be excluded from the scope of this Order all allowances prescribed in any of the said principal orders in respect of tools, bicycles, motor-vehicles, protective or special clothing or special footwear.

(d) For the purposes of the Order a male employee who is entitled to be paid the minimum salary or wage prescribed for married male employees shall be deemed to be an "adult male employee" in receipt of that minimum salary wages.

(e) Subject to the provisions of the preceding clause (d) hereof, for the purposes of this Order a "junior employee" shall be deemed to be an employee of either sex who is under the age of twenty-one years.

(f) The increase provided for by this Order shall apply to the unexcluded portion of the prescribed minimum remuneration of each employee.

2. This Order is made for the purpose of conforming with the Interim General Wage Order made on the 10th day of June, 1950, by the Court of Arbitration pursuant to the Economic Stabilization Regulations 1950, and subject to the provisions of clause (d) of paragraph 1 hereof this Order shall be interpreted so as to give effect to the provisions of that Interim General Order as varied from time to time by the Court of Arbitration. Any such variation by the Court may be applied by the controlling authority to the application of this Order to employees so as to give general effect to the provisions of the Interim General Order as so varied.

3. This Order shall be deemed to have come into force on the 8th day of May, 1950.

PURSUANT to the Control of Prices Act, 1947, the Price Tribunal, acting with the authority of the Minister of Industries and Commerce, hereby makes the following Price Order:—

## PRELIMINARY

1. This Order may be cited as Price Order No. 1174, and shall come into force on the 20th day of July, 1950.
2. (1) Price Orders Nos. 747\* and 804† are hereby revoked.  
(2) The revocation of the said Orders shall not affect the liability of any person for any offence in relation thereto committed before the coming into force of this Order.
3. In this Order the expression "case" or "case-lot" means a lot consisting of four dozen tins of any one kind of condensed milk to which this Order applies, as packed by the manufacturer in a case or other container.

## APPLICATION OF THIS ORDER

4. This Order applies only with respect to condensed milk manufactured by New Zealand Products, Ltd., and marketed under the brands of "Highlander," "Nestles," and "Ideal."

## FIXING MAXIMUM PRICES OF CONDENSED MILK TO WHICH THIS ORDER APPLIES

*Manufacturer's Prices*

5. (1) Subject to the following provisions of this clause, the maximum prices that may be charged or received by the manufacturer for any condensed milk to which this Order applies that is sold by the manufacturer to a wholesaler shall be—

  - (b) By a discount of 2½ per cent. thereof where payment is made after seven days from the date of invoice but on or before the 20th day of the month following the month in which delivery is made to the wholesaler.
- (3) In respect of deliveries in quantities of not less than six cases to wholesalers carrying on business at Auckland, Gisborne, Napier, Hastings, New Plymouth, Hawera, Wanganui, Palmerston North, Wellington, Blenheim, Nelson, Westport, Greymouth, Hokitika, Christchurch, Timaru, Oamaru, Dunedin, or Invercargill, the maximum prices fixed by the foregoing provisions of this clause are fixed as for delivery (in accordance with the provisions of subclause (5) hereof) to the wholesaler's store at his place of business, or, at the option of the wholesaler, at the local depot of a common carrier nominated in that behalf by the wholesaler.
- (4) In respect of deliveries in quantities of not less than six cases to a wholesaler carrying on business elsewhere than at one of the cities or boroughs specified in the last preceding subclause, the maximum prices fixed by subclauses (1) and (2) hereof are fixed as for delivery (in accordance with the provisions of subclause (5) hereof) to the wholesaler's store or the depot of a common carrier in such one of the places specified in subclause (3) hereof as is nearest or most convenient of access to the wholesaler's place of business.
- (5) The references in subclauses (3) and (4) hereof to the delivery of any goods to which this Order applies shall be deemed to be references to delivery by sea (where the place of delivery is at a port) and, in any other case, shall be deemed to be references to delivery by sea at the port nearest or most convenient of access to the place of delivery, and thence by rail to the place of delivery.
- (6) Where any goods to which this Order applies are, by arrangement between the manufacturer and the wholesaler, delivered otherwise than in accordance with the last preceding subclause, the

wholesaler shall be liable for the payment of any transport charges incurred in excess of the charges that would have been incurred if delivery had been affected in accordance with that subclause.

BY-LAWS

1. INTERPRETATION

(1) THESE by-laws may be cited as the Waitakere Scenic Drive Heavy-traffic By-laws, 1950.

(2) If any such driver shall fail immediately to stop his vehicle when called upon as aforesaid he shall be guilty of an offence against these by-laws.

(3) Any driver of any vehicle who does not or is challenged with having not complied with the requirements of these by-laws shall, on the request of any authorized person or police officer, give information as to his name and address, and any other particulars required as to his identification and the name and address and other particulars of the owner of the vehicle.

(4) If such driver shall refuse to give any of the information required to be given by him in pursuance of these by-laws or shall give false information or shall withhold information so as to create a false impression, he shall be guilty of an offence against these by-laws.

(5) Any other person who, on the request of any authorized person or police officer, shall fail when required to give information which is in the power of such person to give, and which relates to any breach or alleged breach of these by-laws, shall be guilty of an offence against these by-laws.

4. OFFENCES AND PENALTY

(1) Every person who does, or causes or procures to be done, anything contrary to or otherwise than is provided by these by-laws, or who shall omit to do anything therein required to be done by him, shall be guilty of an offence.

(2) Every person guilty of an offence against these by-laws shall be liable for each such offence to a fine not exceeding £10 (ten pounds).

- (e) Professional tipsters, persons convicted of house-breaking or pocket picking, forgery, uttering or possessing counterfeit coin, theft, false pretences, receiving stolen goods, mischief, assault, or any offence or crime of any kind under the Crimes Act, 1908, and also idle and disorderly persons, rogues, and vagabonds, and incorrigible rogues convicted under the Police Offences Act, 1908, and persons convicted of an offence under the Gaming Act, 1908:
