WHEREAS the land described in the Schedule hereto has been duly set apart for Rabbit Board buildings : And whereas, in the opinion of the Governor-General, it is expedient to vest the said reserve in the Upper Pareora Rabbit Board :

BY virtue of the powers and authorities vested in me by section 34 of the Public Reserves, Domains, and National Parks Act, 1928, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, do hereby order and declare that the reserve for recreation in the North Auckland Land District described in the Schedule hereto shall be and the same is hereby brought under the operation of and declared to be subject to the provisions of Part II of the said Act, and such reserve shall hereafter form part of the Motutara Domain, and be managed, administered and dealt with as a public domain by the Motutara Domain Board.
