A PROCLAMATION

**I**N pursuance of the power and authority conferred upon me by section 9 of the Housing Act, 1919, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the area of Crown land described in the Schedule hereto shall be and the same is hereby set apart for the purpose of Part I of the said Act.

SCHEDULE

CANTERBURY LAND DISTRICT

ALL that area situated in the Borough of Ashburton, containing by admeasurement 1 acre 3 roods 24.4 perches, more or less, being Town Sections 358, 363, 364, 365, and parts of Town Sections 350, 351, 359, 360, 361, and 362, Township of Ashburton. As the same is more particularly delineated on the plan marked L. and S. 30/228/26A, deposited in the Head Office, Department of Lands and Survey, at Wellington, and thereon edged red. A PROCLAMATION

**B**Y virtue and in exercise of the powers and authorities conferred upon me by section 18 of the Forests Act, 1949, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, do hereby set apart the provisional State forest land described in the Schedule hereto as permanent State forest land.

SCHEDULE

WESTLAND LAND DISTRICT.—WESTLAND CONSERVANCY

ALL those areas in the Westland Land District, Westland County, containing by admeasurement 143 acres, more or less, and described generally as follows: All that area containing by admeasurement 106 acres, more or less, being part of Reserve No. 1685 (provisional State forest, *New Zealand Gazette* 1919, page 1285), situated in Blocks VII and XI, Bruce Bay Survey District, and bounded generally as follows: Towards the north-east by part of Reserve VII, aforesaid; towards the south and south-east by part of Reserve No. 1685 (permanent State forest, *New Zealand Gazette* 1933, page 10); towards the south-west by Section 786, Block XI, aforesaid, and by the north-eastern boundary of that section produced to the sea coast; and towards the north-west and north by the sea coast.

Also all that area containing by admeasurement 37 acres, more or less, being part of Reserve No. 1685 (provisional State forest, *New Zealand Gazette* 1919, page 1285), situated in Block VII, Bruce Bay Survey District, and bounded generally as follows: Towards the north-west by Section 2650, Block VII, aforesaid; towards the south-east and north-east by Hunts Beach Road, and towards the south-west by Section 890, Block XI, aforesaid, and part of Reserve No. 1685 (permanent State forest, *New Zealand Gazette* 1933, page 10); excluding therefrom a gravel reserve on Hunts Beach Road.

As the same are more particularly delineated on plan No. 138/23, deposited in the Head Office of the New Zealand Forest Service at Wellington, and thereon bordered red.

*Agreement for Grant of Easement in Favour of William Henry Early, of Arapae, Te Kuiti, Farmer, Over Land in the Waitomo County, Taken for a Quarry, Assented to.*

WHEREAS by an agreement dated the 7th day of December, 1948, William Henry Early, of Arapae, Te Kuiti, Farmer, has agreed to His Majesty the King taking under the Public Works Act, 1928, for a quarry, firstly, an area of approximately 11 acres 3 roods 5.3 perches, being parts Section 19, Block VI, Otago Survey District, and, secondly, an easement in perpetuity (the right to take and pipe water) over other part of the said Section 19 containing approximately 6 perches:

And whereas the said William Henry Early is entitled to receive compensation for the taking of the said land and easement:

And whereas the Minister of Works has agreed to grant to the said William Henry Early a right-of-way in a position to be mutually agreed upon over part of the land shown on S.O. plan 30654 (P.W.D. 106287), being part of the said Section 19 taken for a quarry by Proclamation dated the 25th day of April, 1940, and published in the *New Zealand Gazette* No. 41 of the 9th day of May, 1940, at page 1013, and over part of the said area of 11 acres 3 roods 5.3 perches, being part of the said Section 19, in part satisfaction of the compensation aforesaid and to provide a sum of money in satisfaction of the residue of the said compensation:

And whereas the said William Henry Early has agreed to accept such grant of easement and such sum of money in full satisfaction of the said compensation:

Now, therefore, the Minister of Works doth hereby give notice in pursuance of section 97 of the Public Works Act, 1928, that he assents to the agreement hereinbefore referred to.
