Proclaiming Maori Land to be Vested in His Majesty the King

[L.S.] B. C. FREYBERG, Governor-General A PROCLAMATION

PURSUANT to section 450 of the Maori Land Act, 1931, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the Maori land described in the Schedule hereto is vested in His Majesty the King.

SCHEDULE

ALL that piece of land containing 13 acres, more or less, called or known as Paengaroa North C No. 3B, situated in Block VII, Maketu Survey District. As the same is more particularly delineated on the plan marked M.L. 8572, deposited in the office of the Chief Surveyor at Auckland, and thereon edged red.

Given under the hand of His Excellency the Governor-General of the Dominion of New Zealand, and issued under the Seal of that Dominion, this 18th day of April, 1951.

Varying a Proclamation Proclaiming Tribal Districts Under the Maori Social and Economic Advancement Act, 1945

PURSUANT to section 6 of the Maori Social and Economic Advancement Act, 1945, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, do hereby vary the Proclamation made on the 19th day of April, 1947, and published in the New Zealand Gazette on the 24th day of April, 1947, at page 481, by deleting from the Schedule thereto the description of the Whangarei Tribal District and substituting therefor the description appearing in the Schedule hereto.

SCHEDULE

WHANGAREI TRIBAL DISTRICT

ALL that area in the North Auckland Land District bounded by a line commencing at a point in Block VIII, Russell Survey District, at the eastern end of the northern boundary of Whangaroa-Ngaiotonga No. 4F Block, being a point on the boundary of the Whangarei County; thence along that county boundary, being a line along the sea-coast, and including the adjacent islands known as the Hen and Chickens (Taranga and Marotiri), the Poor Knights, and all other adjacent islands to Bream Tail at the north-eastern

corner of Allotment 91, Parish of Waipu, the south-eastern boundary of the said Allotment 91, the south-eastern boundary of Allotment 330 of the said parish, a right line, being the production of the last-mentioned boundary, across a public road to the north-eastern boundary of Allotment 351, Waipu Parish, the northern and western boundaries of the allotment the northern houndaries of Allotment the northern houndaries of Allotment 326 and ary of Allotment 351, Waipu Parisi, the northern and western boundaries of that allotment, the northern boundaries of Allotments 336 and part 337a, a right line across a public road, the northern boundary of the other part of Allotment 337a and part Allotment 235, all of Waipu Parish, part of the northern boundary of Section 1, Block XI, Waipu Survey District, a right line across a public road, the northern boundary of the other part of the said Section 1, the north-western boundary of part Section 5, Block X, Waipu Survey District, a right line being the production of the southern end of the last-mentioned line being the production of the southern end of the last-mentioned boundary, across a public road to its south-eastern side, the north-western boundary of Sections part 5, 4, 3A, and 3, all of the said Block X, to the eastern side of a public road, a right line across the aforesaid Block X, part of the northern corner of Section 2 of the aforesaid Block X, part of the northern boundary of that section, a right line across another public road, the northern boundary of the other parts of the said Section 2, to and down the middle of the Piroa Stream, the south-western boundary of Waipu Parish, part of the south-western boundary of Ruarangi Parish, the south-eastern boundary of Waikiekie Parish, the south-eastern and south-western boundaries of Tauraroa Parish, crossing intervening roads, to a point in line with the north-western boundary of Allotment 166, Omaru Parish, a right line in the direction of the northern end of the last-mentioned boundary to the middle of the Mangonui River, down the middle of that river to its confluence with the Tauraroa Omaru Parish, a right line in the direction of the northern end of the last-mentioned boundary to the middle of the Mangonui River, down the middle of that river to its confluence with the Tauraroa River, up the middle of that river to a point in line with the production southward of the eastern boundary of Lot 44 on the plan numbered 8548, deposited in the office of the District Land Registrar at Auckland, being part of Walton's Grant; thence northerly generally along a right line to Trig. Station M 2, in Block X, Purua Survey District; thence north-westerly along a right line to Trig. Station L 1, Tautewhananga, in Block IX, Purua Survey District; thence westerly along a right line to the south-western corner of Section 8, Block XII, Mangakahia Survey District, and a right line to Trig. Station 40a, Tiratumutumu, in Block XI, Mangakahia Survey District; thence north-westerly along a right line to the eastern end of the northern boundary of the middle portion of Nukutawhiti Block; thence westerly along the northern boundary of that block to its intersection with the production of a right line between Trig. Station XXVI (Ngatitara) in Block XII, Punakitere Survey District, and Trig. Station XXVIA on the eastern boundary of Block XVI, Punakitere Survey District; thence northerly to and along the last-mentioned right line to Trig. Station XXVI aforesaid; thence south-easterly along a right line to the northern boundary of the Mangakowhara Block at its intersection with a right line between the south-eastern corner of Motatau No. 16a Block in Block VII, Motatau Survey District, and Trig. Station Z (Motatau) in Block XV, Motatau Survey District, being a point on the boundary of the Whangarei County: thence north-easterly and Block in Block VII, Motatau Survey District, and Trig. Station Z 1 (Motatau) in Block XV, Motatau Survey District, being a point on the boundary of the Whangarei County; thence north-easterly and northerly generally along that county boundary, being the northern boundary of the Mangakowhara Block, the western and northern boundaries of Section N.W. 13, Block XIII, Hukerenui Survey District, across a public road, the western boundaries of Sections 24 and 23, the northern boundary of 23, the eastern boundaries of 23 and 24, both of Block IX, Hukerenui Survey District, the northern boundaries of Sections 5, 4, and 3, Block XIII aforesaid, the western boundary of Section 32, Block X, Hukerenui Survey District, the south-western, western, and northern boundaries of Section 32, Block IX aforesaid, a right line bearing due north across a public road, the western and northern boundaries of Section 32, Block X aforesaid, across a public road, the western and northern boundaries of Sec across a public road, the western and northern boundaries of Section 51, the western boundaries of Sections 50 and 48, a right line tion 51, the western boundaries of Sections 50 and 48, a right line across a public road, the western and northern boundaries of Section 61, a right line across a public road, the northern boundaries of Sections 49 and 38, all of Block X, Hukerenui Survey District, part of the western boundary of Section 19, Block X aforesaid, and its production northward across the Whangarei-Kawakawa Main Highway, the northern side of that highway, across a public road intersecting Section 17, Block X aforesaid, the eastern side of that road, down the middle of the Ngaruawahine Stream, up the middle of the Waiting River the north-western boundary of Section 66. PURSUANT to section 6 of the Maori Social and Ecomonic Advancement Act, 1945, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, do hereby vary the Proclamation made on the 15th day of March, 1947, and published in the New Zealand Gazette on the 20th day of March, 1947, at page 323, declaring certain parts of New Zealand to be tribal districts for the purposes of the said Act, by deleting from the Schedule thereto, the description of the Kawakawa Tribal District and substituting therefor the description appearing in the Schedule hereto. appearing in the Schedule hereto.

KAWAKAWA TRIBAL DISTRICT

All that portion of the Bay of Islands County, bounded by a line commencing at Howe Point, in Block IX, Bay of Islands Survey District; thence easterly along a line to Motukokako on Piercy Island; thence southerly along a line, so as to include adjacent islands, to a point on the sea-coast on the northern boundary of Whangaroa Ngaiotonga No. 4F Block, and being a point on the boundary of the Bay of Islands County; thence westerly, southerly, and again westerly generally along that county boundary, being the northern and north-western boundaries of the said 4F Block, the north-western boundaries of Whangaroa-Ngaiotonga No. 4g Block, the north-eastern and western boundaries of the Tutaematai Block, the western boundaries of Sections 6 and 5, Block XII, Russell Survey District, the western and western boundaries of Punaruku Block, the north-western and southern boundaries of Paremata-Mokau Block, the western boundary of Section 3, Block IV, Hukerenui Survey District, the northern boundary of Section 11, Block IV aforesaid, and its production across a public road, the eastern, northern, and western boundaries of Section 11, Block III, Hukerenui Survey District, across a public road, the western boundaries of Sections 12 and 13, Block III aforesaid, and Sections 5 and 6, Block VII, Hukerenui Survey District, the northern and western boundaries of Section 3, the western boundary of Puhipuhi No. 4a 1 Block, the northern and part north-eastern boundaries of Section 65, Block VI aforesaid, the production north-easterly of the northern 65, Block VI aforesaid, the production north-easterly of the northern boundary of Section 66, Block VI aforesaid, a right line Survey District, the northern and western boundaries of Section 65, Block VI aforesaid, the production north-easterly of the northwestern boundary of Section 66, Block VI aforesaid, a right line across a public road, the north-western boundary of Section 66 aforesaid, the production of that boundary to the middle of the Waiotu River, the middle of that river and the Ngaruawahine Stream, the eastern side of a public road intersecting Section 17, Block X, Hukerenut Survey District, across that road, the northern of the Wangarai Kawakaya Main Highway, the production side of the Whangarei-Kawakawa Main Highway, the production northwards and the western boundary of Section 19, Block X afore-said, the northern boundaries of Sections 38 and 49, a right line across said, the northern boundaries of Sections 38 and 49, a right line across a public road, the northern and western boundaries of Section 61, a right line across a public road, the western boundaries of Sections 48 and 50, the northern and western boundaries of Section 51, the production of the last-mentioned boundary across a public road, the northern boundary of Section 52, all the aforesaid sections being of Block X, Hukerenui Survey District, a right line bearing due south across a public road, the northern, western, and southwestern boundaries of Section 32, Block IX, Hukerenui Survey District, the western boundary of Sections 3, 4, and 5, Block XIII, Hukerenui Survey District, the eastern boundaries of Sections 24 and 23, Block IX, aforesaid, the northern boundary of the said Section 23, the western boundaries of Sections 23 and 24 aforesaid, across a public road, the northern and part western boundaries of Section N.W. 13, Block XIII aforesaid, the northern boundary of the Mangakowhara Block to its intersection with a right line from Trig. Station Z 1 (Motatau) in Block XV aforesaid, to the south-eastern corner of Motatau No. 164 Block in Block VII, right line from Trig. Station Z I (Motatau) in Block XV anoresaut, to the south-eastern corner of Motatau No. 16a Block in Block VII, Motatau Survey District; thence north-westerly along a right line to Trig. Station XXVI (Ngatitara) in Block XII, Punakitere Survey District; thence north-easterly along a right line to the westernmost corner of Motatau No. 18 5B 3 Block in Block VI, Motatau most corner of Motatau No. Is 5s 3 Block in Block VI, Motatau Survey District; thence north-westerly along a right line to the westernmost corner of Section 13, Block IV, Punakitere Survey District; thence north-easterly along a right line to the northernmost corner of Motatau No. 3s Block and a right line to Trig. Station K in Block IX, Kawakawa Survey District; thence easterly along a right line to Trig. Station Y in Block XI, Kawakawa Survey District; thence north-easterly along a right line to the junction of the Whangae Road with the Oromahoe-Opua Road, in Block VIII, Kawakawa Survey District; thence easterly along a right line to the middle of the bridge at the mouth of the Whangae River; thence north-easterly to and along the south-eastern side of the thence north-easterly to and along the south-eastern side of the Opua-Whangarei Railway Reserve to the Opua Wharf; thence north-westerly along a right line to the north-eastern corner of Block IV, Kawakawa Survey District; thence north-easterly generally along the sea-coast, excluding Moturoa and other adjacent islands, to Howe Point, being the point of commencement.
