In pursuance and exercise of the power and authority conferred upon me by subsection (1) of section 8 of the Housing Amendment Act, 1940, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand, do hereby proclaim and declare the land described in the Schedule hereto, being land subject to the Housing Act, 1919, to be Crown land available for reservation under the Land Act, 1948.

Lands Reserved in the North Auckland, Wellington, Canterbury, and Otago Land Districts

HEREAS by section 167 of the Land Act, 1948, it is enacted that the Governor-General may from time to time set apart as a reserve, notwithstanding that the same may be then held under as a reserve, notwinstanting that the same may be then left dider pastoral lease or pastoral occupation licence, any Crown land for any purpose which, in his opinion, is desirable in the public interest, and notice thereof shall be published in the New Zealand Gazette. Now, therefore, I, Lieutenant-General Sir Bernard Cyril Freyberg, the Governor-General of the Dominion of New Zealand,
