Proposed Boundaries of the Electoral Districts in the North Island and the South Island of New Zealand

THE Representation Commission, appointed in pursuance of section 2 of the Electoral Amendment Act 1945, hereby publishes in accordance with the provisions of section 5 of the said Act, the proposed boundaries of the electoral districts in the North and South Islands of New Zealand; and, further, gives notice that written objections to the same will be received by the undersigned, the Chairman of the Commission, at the office of the Surveyor-General, Government Buildings, Wellington, not later than noon on Monday, the 10th day of March 1952, for consideration by the aforesaid Commission.

Maps of the proposed districts may be seen at the office of any City or Borough Council, County Council, Town Board, or Road Board; of the Chief Surveyor at Auckland, New Plymouth, Gisborne, Napier, Wellington, Blenheim, Nelson, Hokitika, Christchurch, Dunedin, and Invercargill; of the Chief Electoral Officer at Wellington; and of the Registrars of Electors throughout the Dominion.

HOBSON

ALL that area comprising the County of Mangonui, the County of Whangaroa, the County of Hokianga, the County of Bay of Islands, the County of Hobson, the Borough of Kaitaia, the Borough of Kaikohe, the Borough of Dargaville, Cavalli Islands, Stephenson's Island, and all other adjacent islands.

MARSDEN

All that area comprising the County of Whangarei, the Borough of Whangarei, the Town District of Hikurangi, the Town District of Kamo, the groups of islands known as Poor Knights, Hen and Chickens, and Mokohinau, and all other adjacent islands.

RODNEY

All that area comprising the County of Otamatea, the County of Rodney, the Borough of Helensville, the Borough of Henderson, the Town District of Warkworth, the Mairetahi, Kaukapakapa, Kumeu, Waitakere, and Waipareira Ridings of the County of Waitemata, and that part of the Waikumete Riding of the County of Waitemata lying to the north generally of Tiromoana Road, and including Kawau and Motuketekete Islands and other adjacent islands and all wharves and other extensions seaward.

A

WAITEMATA

All that area comprising the Wainui, Pukeatua, Takapuna, and Birkenhead Ridings of the County of Waitemata, the Borough of Birkenhead, the Borough of Northcote, and that part of the Borough of Takapuna lying to the west generally of a line commencing on the shore of the Waitemata Harbour at the southern end of Pupuke Road and proceeding northerly generally along Pupuke Road and Kowhai Road and its production to the shore of Lake Pupuke; thence along the generally western shore of that lake to the north-eastern boundary of Lot 7 of a subdivision of Allotment 87, Parish of Takapuna, being portion of Milford School Reserve; thence along that boundary to Otakou Road, along Otakou Road, Fenwick Avenue, and Kitchener Road to the bridge across Wairau Creek, down the left bank of Wairau Creek to and along the main highway, and again along the left bank of the Wairau Creek to the sea-coast and including Herald Island (formerly Pine Island) and all wharves and other extensions seaward.

NORTH SHORE

All that area comprising the Borough of Devonport and that part of the Borough of Takapuna lying generally to the east of a line commencing on the shore of the Waitemata Harbour at the southern end of Pupuke Road and proceeding northerly generally along Pupuke Road and Kowhai Road and its production to the shore of Lake Pupuke; thence along the generally western shore of that lake to the north-eastern boundary of Lot 7 of a subdivision of Allotment 87, Parish of Takapuna, being portion of Milford School Reserve; thence along that boundary to Otakou Road, along Otakou Road, Fenwick Avenue, and Kitchener Road to the bridge across Wairau Creek, down the left bank of Wairau Creek to and along the main highway and again along the left bank of the Wairau Creek to the sea-coast, and including all wharves and other extensions seaward.

TITIRANGI

All that area comprising the Borough of New Lynn, the Town District of Glen Eden, the Titirangi Riding of the County of Waitemata, that portion of the Waikumete Riding of the County of Waitemata lying generally to the south of Tiromoana Road; those parts of the City of Auckland and the Borough of Mount Albert bounded by a line commencing at the southern extremity of the eastern boundary of Allotment 75, Parish of Titirangi, on the shore of the Manukau Harbour; thence proceeding northerly along the boundary of the City of Auckland to Richardson Road and along Richardson Road to New North Road; thence south-westerly along New North Road to Oakley Stream; thence down Oakley Stream to the North Auckland Main Trunk Railway; thence westerly along that railway to and along Browne Street to the Great North Road; thence along the Great North Road to and along Victor Street to the eastern boundary of Kitchener Hamlet; thence along

that boundary and its production to the shore of Waitemata Harbour; thence north-westerly along the shore of that harbour to Whau River; thence southerly generally up the right bank of that river to and along the eastern boundaries of the Borough of New Lynn and the Titirangi Riding of the County of Waitemata to the shore of Manukau Harbour; thence easterly generally along the shore of that harbour to the point of commencement and including adjacent islands, wharves, and other extensions seaward.

PONSONBY

All that area comprising that part of the City of Auckland bounded by a line commencing at a point on the shore of Waitemata Harbour, being the northernmost corner of Lot 46 of a subdivision of Allotment 12 of Auckland Suburban Section 8; thence proceeding along the north-western side of Lot 46 aforesaid to and along Swift Avenue to and along the south-eastern boundaries of Lots 1, 4, and 6 of a subdivision of Allotment 12 aforesaid to the north-western end of Vine Street; thence along Vine Street to a point in line with the north-western end of Melford Street; thence along a right line to the said north-western end of Melford Street; thence to and along Seymour Street and Jervois Road to Ponsonby Road; thence along Ponsonby Road to and along the Great North Road, Surrey Crescent, and Old Mill Road to Motion's Creek; thence down the right bank of Motion's Creek to and along the shore of Waitemata Harbour to the point of commencement, and including the reclamation at Point Erin and all wharves and other extensions seaward.

AUCKLAND CENTRAL

All that area comprising those parts of the City of Auckland, the Borough of Newmarket, and the County of Eden bounded by a line commencing at the junction of Newton Road and Ponsonby Road; thence proceeding north-westerly generally along Ponsonby Road and Jervois Road to Seymour Street; thence along Seymour Street to the north-western end of Melford Street, along that end of Melford Street and its production to Vine Street, along Vine Street to its north-western end, along the south-eastern boundaries of Lots 6, 4, and 1 of a subdivision of Allotment 12 of Auckland Suburban Section 8, to and along Swift Avenue and the north-western side of Lot 46 of a subdivision of Allotment 12, aforesaid to the shore of Waitemata Harbour; thence easterly generally along that shore, including all wharves and other extensions seaward to the eastern breakwater near Campbell's Point, along that breakwater and the shore of Waitemata Harbour to Tamaki Drive, thence along King's Drive, The Strand, and Gittos Street to Carlaw Park Avenue; thence along that avenue and along the north-western boundary of Carlaw Park to the Auckland Domain; thence along the generally eastern boundary of the Auckland Domain to Carlton Road; thence westerly along Carlton Road to the eastern boundary of Lot 24 of a subdivision of Allotment 1 of Auckland Suburban Section No. 3; thence along the eastern boundary of the said Lot 24 and the eastern boundaries of Lots 21, 20, an unnumbered Lot, Lots 19, 18, 17, and 16 of the aforesaid subdivision, and along the south-eastern boundary of the last-mentioned Lot to Khyber Pass Road; thence westerly along Khyber Pass Road, Symonds Street, and Newton Road to Ponsonby Road, the point of commencement, and including Little Barrier Island, Tiritiri Island, Kermadec Islands, and all wharves and other extensions seaward.

GREY LYNN

All that area comprising those parts of the City of Auckland and the Borough of Mount Albert bounded by a line commencing at the bridge over Motion's Creek in Old Mill Road; thence proceeding easterly generally along Old Mill Road, Surrey Crescent, and Great North Road to a point between Hadlow Terrace and Commercial Road in line with the south-western boundary of Lot 1 of a subdivision of Allotment 17 of Auckland Suburban Section No. 5; thence to and along the south-western boundaries of the said Lot 1 and Lots 4 to 35 inclusive, of the aforesaid subdivision and the southern boundary of the last-mentioned lot to Commercial Road; thence along Commercial Road to the footbridge near the Kingsland Railway Station; thence south-westerly along the North Auckland Main Trunk Railway to and along the New North Road, Alexandra Avenue, Asquith Avenue, again New North Road, Lloyd Avenue West, again the North Auckland Main Trunk Railway, Woodward Road, and again New North Road to Oakley Stream; thence down Oakley Stream to the North Auckland Main Trunk Railway, and along that railway, Browne Street, the Great North Road, and Victor Street to the eastern boundary of Kitchener Hamlet; thence along that boundary and its production to the shore of Waitemata Harbour; thence north-easterly generally along the said shore to and up the left bank of Motion's Creek to the point of commencement, including all wharves and other extensions seaward.

REMUEA

All that area comprising those parts of the City of Auckland, the Borough of Newmarket, and the Borough of One Tree Hill bounded by a line commencing at the junction of The Strand and King's Drive; thence proceeding along The Strand and Gittos Street to Carlaw Park Avenue, thence along that avenue and along the north-western boundary of Carlaw Park to the Auckland Domain; thence along the generally eastern boundary of the Auckland Domain to Carlton Road; thence westerly along Carlton Road to the eastern boundary of Lot 24 of a subdivision of Allotment 1 of Auckland Suburban Section No. 3; thence along the eastern boundary of the said Lot 24 and the eastern boundaries of Lots 21, 20, an unnumbered Lot, Lots 19, 18, 17, and 16 of the aforesaid subdivision and along the south-eastern boundary of the last-mentioned Lot to Khyber Pass Road; thence easterly along Khyber Pass Road to the eastern boundary of Allotment 28 of Auckland Suburban Section No. 3; thence along the eastern

boundary of that Allotment to Secombe's Road, along Secombe's Road, Gillies Avenue, and Swinburne Pass to Broadway; thence southerly along Broadway and Manukau Road to Green Lane; thence easterly along Green Lane to the northern boundary of original Allotment 6 of Auckland Suburban Section No. 12 and along that boundary to Ladies' Mile; thence northerly along Ladies' Mile, Remuera Road, and Upland Road to a point in line with the north-western boundary of Lot 9 of a subdivision of Allotment 239 of Auckland Suburban Section No. 16; thence to and along that boundary and its production across Shore Road to the shore of Orakei Basin; thence northerly along the shore of Orakei Basin and westerly and northerly generally along the shores of Hobson Bay and Judge's Bay and across the railway to Tamaki Drive; thence along King's Drive to its junction with The Strand, the point of commencement, and including all wharves and other extensions seaward.

MOUNT ALBERT

All that area comprising those parts of the Borough of Mount Albert, the Borough of Mount Roskill, and the Borough of Mount Eden bounded by a line commencing at the junction of Lloyd Avenue West with New North Road; thence proceeding along New North Road and Asquith Avenue to Alexandra Avenue; thence along Alexandra Avenue to New North Road; thence north-easterly along New North Road to and along the North Auckland Main Trunk Railway to the footbridge near Kingsland Railway-station; thence to and easterly along Sandringham Road and along the generally south-western boundary of the Kowhai Intermediate School to Kowhai Street; thence southerly along Kowhai Street to and along the boundary of the Borough of Mount Eden to Balmoral Road; thence along Balmoral Road to Dominion Road; thence southerly along Dominion Road to Mount Albert Road; thence south-easterly along Mount Albert Road to the eastern boundary of Lot 72 of a subdivision of Allotment 86 of Auckland Suburban Section 10 and Allotment 47, Titirangi Parish; thence along the eastern boundaries of the said Lot 72 and Lots 73, 74, the abutment of a road, Lots 75, 76, 77, 78, 79, 80, and 81 of the aforesaid subdivision, across a drainage reserve, along the eastern boundaries of Lots 405, 406, 407, and 408, the abutment of a road, Lots 409 to 420 inclusive, 422, the abutment of a road, Lots 423 to 436 inclusive, all being Lots of a subdivision of Allotment 48, Titirangi Parish, and Allotment 9 of Auckland Suburban Section 13, thence south-westerly along the south-eastern boundary of Lot 436, aforesaid, across Summit Road, along the south-eastern boundaries of Lots 489, 494, and 495 of the last-mentioned subdivision, along the southern boundary of the said Lot 495, across Bristol Road, the southern boundaries of Lots 516, 519, 520, 523, across Winstone Road, Lots 367, 368, 369, 347, 348, and 349, of a subdivision of Allotment 49, Titirangi Parish, to Dominion Road; thence southerly along Dominion Road and Arkell Road to Cape Horn Road; thence easterly along Cape Horn Road to Waikowhai Road; thence south-westerly along Waikowhai Road to the shore of Manukau Harbour; thence westerly generally along that shore to the western boundary of the Borough of Mount Roskill; thence north-easterly generally along that Borough boundary to Richardson Road; thence north-westerly along Richardson Road and Woodward Road to the North Auckland Main Trunk Railway; thence north-easterly along that railway to Lloyd Avenue West; thence south-easterly along Lloyd Avenue West to New North Road, the point of commencement, and including all wharves and other extensions seaward.

EDEN

All that area comprising those parts of the City of Auckland, the Borough of Mount Eden, and the Borough of Mount Albert bounded by a line commencing at the junction of Newton Road and Great North Road; thence proceeding along Great North Road to a point between Hadlow Terrace and Commercial Road in line with the south-western boundary of Lot 1 of a subdivision of Allotment 17 of Auckland Suburban Section No. 5; thence to and along the south-western boundaries of the said Lot 1 and Lots 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 30, 31, 32, 33, 34, and 35 of the aforesaid subdivision and the southern boundary of the last-mentioned lot to Commercial Road; thence along Commercial Road and across the footbridge near Kingsland Railway Station to Sandringham Road; thence easterly along Sandringham Road to and along the generally south-western boundary of the Kowhai Intermediate School to Kowhai Street; thence southerly along Kowhai Street to and along the boundary of the Borough of Mount Eden to Balmoral Road; thence along Balmoral Road, Merivale Avenue, the Drive, and Queen Mary Avenue to Manukau Road; thence northerly along Manukau Road to Swinburne Pass; thence along Swinburne Pass, Gillies Avenue, and Secombe's Road to the eastern boundary of Allotment 28 of Auckland Suburban Section No. 3; thence along the eastern boundary of the said Allotment 28 to Khyber Pass Road; thence westerly along Khyber Pass Road, Symonds Street, and Newton Road to its junction with Great North Road to point of commencement.

TAMAKI

All that area comprising those parts of the City of Auckland and the Borough of Ellerslie bounded by a line commencing at the intersection of Lake Road and Marua Road; thence proceeding westerly along Marua Road to Ladies' Mile; thence northerly generally along Ladies' Mile, Remuera Road, and Upland Road to a point in line with the north-western boundary of Lot 9 of a subdivision of Allotment 239 of Auckland Suburban Section No. 16; thence to and along that boundary and its production across Shore Road to the shore of Orakei Basin; thence easterly and northerly generally along the shore of Orakei Basin and Whakatakataka Bay to Hobson Point; thence easterly generally along the shore of Waitemata Harbour to West Tamaki Head; thence southerly generally up the left bank of the Tamaki River to the southern boundary of Allotment 39, Parish of Waitemata, being a point on

the boundary of the City of Auckland; thence westerly along the boundary of the City of Auckland to Lake Road; thence along Lake Road to the point of commencement, including all wharves and other extensions seaward and the islands of Rangitoto, Motutapu, Waiheke, Ponui, Motukorea, Motuihe, Rakino, Otata, Pakato, Rotoroa, Pahiki, Karamurama, and the islands adjacent thereto.

ROSKILL

All that area comprising those parts of the Borough of Mount Roskill, the Borough of Mount Eden, the Borough of One Tree Hill, the Borough of Onehunga and the City of Auckland bounded by a line commencing at the intersection of Dominion Road and Balmoral Road; thence proceeding southerly along Dominion Road to Mount Albert Road; thence south-easterly along Mount Albert Road to the eastern boundary of Lot 72 of a subdivision of Allotment 86 of Auckland Suburban Section 10 and Allotment 47, Titirangi Parish; thence along the eastern boundaries of the said Lot 72 and Lots 73, 74, the abutment of a road, Lots 75 to 81 inclusive, of the aforesaid subdivision, across a drainage reserve, along the eastern boundaries of Lots 405 to 408 inclusive, the abutment of a road, Lots 409 to 420 inclusive, 422, the abutment of a road, Lots 423 to 436 inclusive, all being lots of a subdivision of Allotment 48, Titirangi Parish, and Allotment 9 of Auckland Suburban Section 13, thence south-westerly along the south-eastern boundary of Lot 436, aforesaid, across Somerset Road, along the south-eastern boundaries of Lots, 489, 494, and 495 of the last-mentioned subdivision, along the southern boundaries of the said Lot 495, across Bristol Road, the southern boundaries of Lots 516, 519, 520, 523, across Winstone Road, Lots 367, 368, 369, 347, 348, and 349, of a subdivision of Allotment 49, Titirangi Parish, to Dominion Road; thence southerly along Dominion Road and Arkell Road to Cape Horn Road; thence easterly along Cape Horn Road to Waikowhai Road; thence south-westerly along Waikowhai Road to the shore of Manukau Harbour; thence easterly generally along the shore of Manukau Harbour to Princes Street and along Princes Street to George Street; thence northerly generally along George Street, Quadrant Road, Auckland Road, and Manukau Road to the generally western boundary of One Tree Hill Domain, along that boundary and the western boundary of Cornwall Park to Green Lane; thence westerly along Green Lane, Manuaku Road, Queen Mary Avenue, The Drive, Merivale Avenue, Andrews Road, and Balmoral Road to the point of commencement, and including all wharves and other extensions seaward.

ONEHUNGA

All that area comprising those parts of the City of Auckland, the Borough of One Tree Hill, the Borough of Ellerslie and the Borough of Onehunga bounded by a line commencing at the western boundary of Cornwall Park and Green Lane; thence proceeding easterly along Green Lane to the northern boundary of original Allotment 6 of Auckland Suburban Section No. 12, and along that boundary to Ladies' Mile; thence south-easterly along Ladies' Mile, Marau Road, and Michaels Avenue to the Ellerslie-Panmure Highway; thence easterly along that highway to the south-eastern boundary of the Borough of Ellerslie; thence southerly generally along that borough boundary and the boundary of the Borough of Onehunga to Ann's Creek; thence westerly generally down the right bank of Ann's Creek and along the shore of Manukau Harbour to Princes Street; thence along Princes Street to George Street; thence northerly generally along George Street, Quadrant Road, Auckland Road, and Manuaku Road to the generally western boundary of One Tree Hill Domain, along that boundary and the western boundary of Cornwall Park to the point of commencement, and including all wharves and other extensions seaward.

OTAHUHU

All that area comprising the Borough of Otahuhu, the Town District of Howick, the Mount Wellington Road District, the Panmure Township Road District, the Pakaranga and Mangere Ridings of the County of Manukau, and that part of the Borough of Ellerslie bounded by Marua Road, Lake Road, the Ellerslie-Panmure Highway and Michaels Avenue and including all wharves and other extensions seaward.

MANUKAU

All that area comprising the Borough of Papatoetoe, the Borough of Manurewa, the Borough of Papakura, the Papatoetoe, Turanga, Papakura, and Wairoa Ridings of the County of Manukau, and the Drury and Hunua Ridings of the County of Franklin.

FRANKLIN

All that area comprising the Borough of Pukekohe, the Town District of Waiuku, the Town District of Tuakau, the Awhitu, Waipipi, Mauku, Waiuku, Karaka, Pukekohe East, Pukekohe West, and Mercer Ridings of the County of Franklin, the Port Waikato, Onewhero, Pukekawa, and Whangape Ridings of the County of Raglan, the Whangamarino Riding of the County of Waikato and that part of the Huntly Riding of the County of Waikato lying to the north of a line commencing at the intersection of the northern boundary of the Borough of Huntly and the eastern bank of the Waikato River; thence proceeding down the eastern bank of that river to and along the road passing through Allotment 26, Taupiri Parish, situated in Block XII, Rangiriri Survey District, and forming the generally southern boundaries of Allotments 397, 492, 497, 491, 388, 387, 368, 367, 364, 363, 362, and 366, Taupiri Parish; thence south-easterly along the road forming the north-eastern boundaries of Allotments 348i, 348ii, 348c, 348r, Taupiri Parish, along the north-eastern boundaries of Allotments 348e, 348d, 348c, 348b, 348a, Taupiri Parish, along the road forming the north-eastern boundaries of Subdivisions 1 and 2 of Lot 1 of a subdivision of Allotment 465, Taupiri Parish, Allotments 197, 199, part 6 of a subdivision of part Allotment 465, Allotments 202, 204, 206,

Lot 6 of part Allotment 465, passing through Allotments part 465, 324, 325, 326, and forming the southern boundary of Allotments 312 and 313, all of Taupiri Parish; thence along the road forming the north-eastern boundaries of Allotments 328, 436, 437, 438, and 439 Taupiri Parish to the Mangawara Stream.

RAGLAN

All that area comprising: the Borough of Huntly, the Borough of Ngaruawahia, the Te Akau, Pukemiro, Waingaro, Karamu, Whaingaroa, Karioi, and Raglan ridings of the County of Raglan, the Taupiri, Rototuna, and Ruakura Ridings of the County of Waikato, the Hamilton and Newcastle Ridings of the County of Waipa: that part of the City of Hamilton lying generally to the north-west of a line commencing at the intersection of Forest Lake Road and the western boundary of the City of Hamilton; thence proceeding north-easterly along Forest Lake Road to the Great South Road; thence south-easterly along that road to the Waikato River; thence down the middle of that river to the generally north-eastern boundary of the City of Hamilton; and that part of the Huntly Riding of the County of Waikato lying to the south of a line commencing at the intersection of the northern boundary of the Borough of Huntly and the eastern bank of the Waikato River; thence proceeding down the eastern bank of that river to and along the road passing through Allotment 26, Taupiri Parish, situated in Block XII, Rangiriri Survey District, and forming the generally southern boundaries of allotments 397, 492, 497, 491, 388, 387, 368, 367, 364, 363, 362, and 366, Taupiri Parish; thence south-easterly along the road forming the north-eastern boundaries of Allotments 348i, 348ii, 348c, 348r, Taupiri Parish, along the north-eastern boundaries of Allotments 348e, 348d, 348c, 348b, 348a, Taupiri Parish, along the road forming the north-eastern boundaries of subdivisions 1 and 2 of Lot 1 of a subdivision of Allotment 465, Taupiri Parish, Allotments 197, 199, Part 6 of a subdivision of part Allotment 465, Allotments 202, 204, 206, Lot 6 of part Allotment 465, passing through Allotments part 465, 324, 325, 326, and forming the southern boundary of Allotments 312 and 313, all of Taupiri Parish; thence along the road forming the north-eastern boundaries of Allotments 328, 436, 437, 438, and 439, Taupiri Parish, to the Mangawara Stream.

HAMILTON

All that area comprising the City of Hamilton excepting that part lying generally to the north-west of a line commencing at the intersection of Forest Lake Road and the western boundary of the City of Hamilton; thence proceeding north-easterly along Forest Lake Road to the Great South Road; thence south-easterly along that road to the Waikato River; thence down the middle of that river to the generally north-eastern boundary of the City of Hamilton.

HAURAKI

All that area comprising the Borough of Thames, the Borough of Paeroa, the Borough of Te Aroha, the County of Great Barrier Island, the County of Coromandel, the County of Hauraki Plains, the Hastings Totara, Puriri, and Hikutaia Ridings of the County of Thames, the Komata, Paeroa, and Mangaiti Ridings of the County of Ohinemuri, the Tahuna and Waitoa Ridings of the County of Piako, those parts of the Manawaru, Waihou, and Te Aroha Ridings of the County of Piako lying generally to the north of Diagonal Road, Shaftsbury Road, and Thompson's Track and also including Cuvier Island, Great Mercury Island, Whanganui Island, and other adjacent islands.

TAURANGA

All that area comprising part of the County of Waimairi and part of the City of Christchurch, bounded by a line commencing at the intersection of Papanui Road and Bealey Avenue; thence easterly along Bealey Avenue and London Street, northerly along Stanmore Road, and easterly along North Avon Road to the Avon River; thence north-easterly down the Avon River to Banks Avenue; thence north-westerly along Banks Avenue, northerly along North Parade and Marshland Road to Briggs Road; thence westerly along Briggs Road, southerly along Hills Road, and westerly generally along Kelly's Road to the city boundary; thence westerly generally along the city boundary to the intersection of Main North Road and Langdons Road; thence south-westerly along Main North Road and south-easterly along Papanui Road to Bealey Avenue the point of commencement.

CHRISTCHURCH CENTRAL

All that part of the City of Christchurch bounded by a line commencing at the intersection of Papanui Road and Bealey Avenue; thence easterly along Bealey Avenue and London Street, northerly along Stanmore Road and easterly along North Avon Road to the Avon River; thence north-easterly down the Avon River to Banks Avenue; thence north-westerly along Banks Avenue, easterly along McBratneys Road, southerly generally along Gayhurst Street, Gloucester Street North, Rochester Street, Worcester Street and Olliviers Road to Ferry Road; thence north-westerly along Ferry Road, High Street, St. Asaph Street, Manchester Street, Belfast Street, Colombo Street and St. Asaph Street to Hagley Avenue; thence northerly generally along Hagley Avenue, Rolleston Avenue, and Park Terrace to Carlton Mill Road; thence easterly along Carlton Mill Road to the intersection of Papanui Road and Bealey Avenue the point of commencement.

AVON

All that area comprising part of the County of Waimairi, part of the County of Heathcote, and part of the City of Christchurch bounded by a line commencing at the point where the northern boundary of the City of Christchurch meets the sea; thence southerly along the boundary of the City of Christchurch to the estuary of the Heathcote and Avon Rivers, and across that estuary to Point Gollan; thence westerly along the foreshore and the tram causeway to the Ferry Road Bridge across the Heathcote River; thence along the Heathcote River to Ferry Road opposite the northernmost point of Rural Section 120; thence along Ferry Road to Radley Street; thence along Radley Street to the Heathcote River and up that river to the Christchurch-Lyttelton Railway; thence along that railway to Ensors Road; thence along Ensors Road to Ferry Road; thence along Ferry Road to Olliviers Road; thence along Olliviers Road, Worcester Street, Rochester Street, Gloucester Street North, Gayhurst Street, McBratneys Road, Banks Avenue, North Parade and Marshland Road to Briggs Road; thence easterly generally along Briggs Road, Lake Road, Lake Terrace Road, Bottle Lake Road, Travis Road, Frosts Road, and Beach Road and its production to the low-water mark of the sea being the point of commencement.

SYDENHAM

All that part of the City of Christchurch bounded by a line commencing at the intersection of Ferry Road and Ensors Road; thence south-westerly generally along Ensors Road to and up the Heathcote River to Barrington Street; thence north-westerly generally along that street, Milton Street, Simeon Street, Bletsoe Avenue, Selwyn Street, and Moorhouse Avenue to the intersection of that avenue with Hagley Avenue; thence easterly generally along Hagley Avenue, St. Asaph Street, Colombo Street, Belfast Street, Manchester Street, St. Asaph Street, High Street, and Ferry Road to its intersection with Ensors Road the point of commencement.

RICCARTON

All that area comprising part of the Counties of Paparua, Waimairi, and Halswell, part of the City of Christchurch, and part of the Borough of Riccarton bounded by a line commencing at the intersection of Deans Avenue and Riccarton Road; thence westerly generally along Riccarton Road and Yaldhurst Road to its intersection with Carmen Road, being a point on the boundary of the Islington Riding of the County of Paparua; thence westerly generally along the northern boundary of that Riding to the northern corner or Reserve 2352; thence south-westerly along a closed road to the western corner of Reserve 2531; thence south-easterly along a closed road, Barters Road, and Marshes Road to Shand's Road; thence north-easterly along Shand's Road to the north-eastern boundary of Rural Section 2625; thence south-easterly generally along that boundary, the north-eastern boundary of Rural Section 2564, along Spring's Road, the north-eastern boundary of Rural Sections 1425 and 19057, to and along Halswell Junction Road, and along the north-western boundaries of Rural Sections 550, 2176, and 327 to and along the southern boundaries of Reserve 92, the western and southern boundaries of Rural Section 346, and along the road forming the south-western boundary of Rural Section 141 to Halswell Road; thence along Halswell Road, Henderson's Road, and the plantation and road reserve forming the southern boundaries of Rural Sections 5752, 1160, and 382 to the Heathcote River, to and along Barrington Street, Milton Street, Simeon Street, Bletsoe Avenue, Selwyn Street, Moorhouse Avenue, and Deans Avenue to its intersection with Riccarton Road being the point of commencement.

LYTTELTON

All that area comprising the Counties of Mount Herbert, Wairewa, Akaroa, and Chatham Islands, the Cashmere, Hillsborough, Heathcote Valley, and Mount Pleasant Ridings of the County of Heathcote, the Boroughs of Lyttelton and Akaroa, and

that part of the City of Christchurch lying to the south-east of the Ferry Road Bridge across the Heathcote River. Also that part of the City of Christchurch bounded by a line commencing at a point in Ferry Road opposite the northernmost point of Rural Section 120, in Block XVI, Christchurch Survey District; thence along Ferry Road to Radley Street, along that street to the Heathcote River and up that river to the Christchurch-Lyttelton Railway; thence along that railway to Ensors Road; thence south-westerly generally along Ensors Road, to and up the Heathcote River to the Tennyson Street Bridge, being a point on the boundary of the City of Christchurch; thence southerly and north-easterly generally along that boundary to a point in Ferry Road opposite the northern point of Rural Section 120 the point of commencement.

ASHBURTON

All that area comprising the existing Electoral District of Ashburton as described in the *New Zealand Gazette* of 1946, at page 882.

TIMARU

All that area bounded by a line commencing at a point on the sea-coast approximately half a mile south of Jack's Point on the production of the middle line of Ellis Road; thence proceeding to and along Ellis Road, Otupua Road, and the road forming the south-western boundaries of Rural Sections 10483, 10482, 15027, 12229, 16216, 14937, 18056, and 12462 to Ward's Road; thence northerly generally along Ward's Road, Coonor Road, the road forming the north-eastern boundaries of Rural Sections 15928, 14376, 15803, 15897, and 15699 in Block XVI, Pareora Survey District, to and along the road forming the eastern boundaries of Rural Sections 15497, 11524, 13606, 14773, and 17625 in the aforesaid Block to Brockley Road; thence along Brockley Road, to and along the middle of the road forming the north-eastern boundary of Rural Section 15930, intersecting Rural Section 10547, and forming the north-eastern boundaries of Rural Sections 23953 and 15761 to Levels Valley Road; thence easterly along Levels Valley Road, to and along the road forming the north-western boundary of Rural Section 4015, in Block VIII, Arowhenua Survey District, and passing through Rural Section 7457, to and across Main Point Road and the railway, and along Kennels Road to the Main North Road; thence across the Main North Road, to and along the southern boundary of Rural Section 9985 and that boundary produced to and across the South Island Main Trunk Railway; thence to and along the northern boundary of Meadows Settlement and that boundary produced to the sea-coast; thence southerly generally along the sea-coast to the point of commencement, and including all wharves and other extensions seaward.

WAIMATE

All that area comprising the Boroughs of Waimate, Geraldine, and Temuka, the Town District of Pleasant Point: the Counties of Mackenzie and Waimate: the Tengawai and Point Ridings of the County of Levels: that part of the County of Geraldine lying generally south-west of a line commencing at the westernmost point of Geraldine Riding; thence along the north-western boundary of Geraldine Riding to the confluence of the Hae Hae Te Moana River and Leisman's Creek; thence along Dawe's Road, Rhubarb Road, Fenn's Road, and its production across Hae Hae Te Moana River, and along MacDonald's Road, Bayley's Road, Rae's Road, Woodbury Road, across the Waihi River, to and along Bennetts Road, the Geraldine-Arundel Road, Orari Station Road, Racecourse Road, the road through Reserve 1862 and the production thereof to the Orari River; thence along the aforesaid river to a point in line with the south-eastern boundary of Section 2 of Block X, Geraldine Survey District; thence along that line to Racecourse Road, along that road, to and along the road forming the south-eastern boundary of Section 3, Block X, aforesaid, to and along the Orari Station Road, Packham's Road, the Geraldine-Winchester Road, and a road forming the eastern boundaries of Rural Sections 4929 and 9090, Block XIV, Geraldine Survey District, to and along Winchester-Beach Road to the sea-coast; those parts of the Otupua, Claremont, Waimataitai, and Seadown Ridings of the County of Levels lying generally to the south-west, west, and north of a line commencing at a point on the sea-coast approximately a half a mile south of Jacks Point on the production of the middle line of Ellis Road; thence proceeding to and along Ellis Road, Otupua Road, and the road forming the south-western boundaries of Rural Sections 10483, 10482, 15027, 12229, 16216, 14937, 18056, and 12462 to Ward's Road; thence northerly generally along Ward's Road and Coonor Road to its junction with the road forming the north-eastern boundary of Rural Section 15928, Block IV, Otaio Survey District, being a point on the boundary of the existing Electoral District of Timaru; thence northerly and easterly along the boundary of that district to the sea-coast; and that part of the County of Waitaki lying generally to the west and north-west of a line commencing at the confluence of the Otamatakau and Waitaki Rivers; thence proceeding up the Otamatakau River and Guffies Creek to and along the road to Mount Buster to the boundary of the Waitaki County.

OAMARU

All that area comprising the Boroughs of Oamaru, Hampden, Palmerston, and Waikouaiti, the Hawksbury and Merton Ridings of the County of Waikouaiti, that portion of the County of Waitaki lying to the east and south of a line commencing at the confluence of the Otamatakau (or Otemata) River and Waitaki River; thence proceeding up the Otamatakau River and Guffies Creek, to and along the road to Mount Buster to the boundary of the Waitaki County. Also that part of the Waihemo County lying to the south-east of a line commencing at a point on the boundary of the County of Waihemo being the south-eastern corner of Section 6, Block VIII, Dunback Survey District; thence generally northerly along the eastern and south-eastern boundaries of Section 6, aforesaid, the south-eastern

boundaries generally of Sections 5, 4, and 3, the north-eastern boundaries of Sections 3, 2, and 1 all of Block XI, Dunback Survey District, the north-eastern boundaries of Sections 8 and 7, Block VI, Dunback Survey District, and the south-western boundary of Section 2, Block VI, Waihemo Survey District, to and down Deepdell Creek to its confluence with the Shag River; thence up the Shag River to the road forming the north-western boundary of Section 10, Block III, Highlay Survey District; thence along that road forming the generally western boundaries of the said Section 10, Sections 13, 10, 9, and 4, Block VIII, Waihemo Survey District, to the south-western boundary of Run 255; thence along the south-western and northern boundaries of that run to the boundary of the County of Waihemo.

All that area comprising the Blueskin and North-east Valley Ridings of the County of Waikouaiti, the Boroughs of Port Chalmers and West Harbour, and that part of the City of Dunedin lying to the north-east of a line commencing at the outlet of the Leith Canal; thence up that canal to a point in line with the eastern extension of Frederick Street; thence along that extension, Frederick Street, Pitt Street, Heriot Row, and Khyber Pass and along the production of the middle line of Khyber Pass to Queens Drive; thence northerly generally along Queens Drive and Drivers Road to its intersection with the north-western boundary of the Town Belt Reserve; thence north-easterly along that boundary to Malvern Street and northerly along Malvern Street to the Leith River; thence up the Leith River to and up a tributary flowing through Block XI, Dunedin and East Taieri Survey District, and Sections 93, 91, 89, and 87, Wakari District, to part of the north-western boundary of the said Block XI; thence along that boundary and the south-western boundary of the said Block to Blantyre Road; thence along Blantyre Road, Balmacewen Road, Helensburg Road, and Waikari Road to the north-eastern boundary of Section 51, Wakari District; thence along that boundary to the City Boundary; and including Quarantine Island and all wharves and other extensions seaward.

DUNEDIN CENTRAL

All that area bounded by a line commencing at the outlet of the Leith Canal; thence up that canal to a point in line with the eastern extension of Frederick Street; thence along that extension, Frederick Street, Pitt Street, Heriot Row, and Khyber Pass and along the production of the middle line of Khyber Pass to Queens Drive; thence northerly generally along Queens Drive and Drivers Road to its intersection with the north-western boundary of the Town Belt Reserve; thence north-easterly along that boundary to Malvern Street, and northerly along Malvern Street to the Leith River; thence up the Leith River, to and up a tributary flowing through Block XI, Dunedin and East Taieri Survey District, and Sections 93, 91, 89, and 87, Wakari District, to part of the north-western boundary of the said Block XI; thence along that boundary and the south-western boundary of the said Block to Blantyre Road; thence along Blantyre Road, Balmacewen Road, Helensburg Road, and Waikari Road to the north-eastern boundary of Section 51, Wakari District; thence along that boundary to the generally north-western boundary of the City of Dunedin; thence south-westerly along the city boundary to the north-eastern boundary of Section 19, Lower Kaikorai Survey District; thence along that boundary to the left bank of the Kaikorai Stream; thence up that bank of the stream to the north-eastern boundary of Section 18, Lower Kaikorai Survey District; thence along that boundary to the north-western boundary of Block IX, Dunedin and East Taieri Survey District; thence north-easterly along that boundary to Stone Street; thence easterly generally along Stone Street, Kenmore Road, and Hawthorn Avenue to Maori Road; thence south-easterly generally along Maori Road and Eglinton Road to the South Road; thence northerly along South Road and Princes Street to Andersons Bay Road; thence south-easterly along Andersons Bay Road to Wharf Street; thence along Wharf Street to a point on the production of the southern side of Park Terrace; thence along that production to the shore of Otago Harbour; thence north-easterly generally along that shore including all wharves and other extensions seaward to the point of commencement.

MORNINGTON

All that area bounded by a line commencing at a point on the western shore of Otago Harbour, in line with the middle of Cargill Road; thence along a right line to the intersection of Cargill Road with Anderson's Bay Road; thence along the middle of Anderson's Bay Road, McBride Street, King Edward Street, Macandrew Road, Forbury Road, Holmes Right-of-way, Easter Crescent, Middleton Road, Lockerbie Street, and Hillhead Road to a point in line with the north-eastern side of Isidore Road; thence to and along the north-eastern side of Isidore Road and its production to the sea-coast; thence south-westerly generally along the sea-coast to the mouth of the Kaikorai Stream; thence north-easterly up the left bank of that stream and Abbot's Creek to a point on the northern side of the Main South Road; thence westerly along the said northern side of the Main South Road to the road forming the north-western boundary of Section 77, Block VII, Dunedin and East Taieri Survey District; thence north-easterly generally along the south-eastern side of that road to the north-western boundary of Section 15, Block VI of the aforesaid survey district, north-easterly along that boundary, to and across a public road to the southern side of Wingatui - Half-way Bush Road; thence along the southern side of that road, to and along the southern side of Brunsdon's Road to the northernmost corner of Section 159, Wakari Survey District; thence south-westerly along the north-western boundaries of Sections 159, 158, 157, 156, and 155, all of Wakari Survey District, and Section 52, Block VI, Dunedin and East Taieri Survey District, and south-easterly along the south-western boundary of the said Section 52, to and along the northern side of a public road, across another public road, to and along the northern side of the public road forming the

northern boundaries of Sections 54, 55, 56, and 57, Block VI aforesaid, to a point in line with the eastern boundary of the last-mentioned Section; thence to and along the said eastern boundary of Section 57 aforesaid, the south-eastern boundary of Section 84, the north-eastern boundary of Section 2 of 49, the north-eastern and south-eastern boundaries of Section 1 of 49, all of Block VI aforesaid, and the north-eastern boundary of Section 19, Lower Kaikorai Survey District, to the left bank of the Kaikorai Stream; thence up that bank of the stream to the north-eastern boundary of Section 18, Lower Kaikorai Survey District; thence along that boundary to the north-western boundary of Block IX, Dunedin and East Taieri Survey District; thence north-easterly along that boundary to Stone Street; thence easterly generally along Stone Street, Kenmore Road and Hawthorn Avenue to Maori Road; thence south-easterly generally along Maori Road and Eglinton Road to the South Road; thence northerly along South Road and Princes Street to Andersons Bay Road; thence south-easterly along Andersons Bay Road to Wharf Street; thence along Wharf Street to a point on the production of the southern side of Park Terrace; thence along that production to the shore of Otago Harbour; thence southerly along that shore to the point of commencement.

The existing Electoral District of St. Kilda as described in the *New Zealand Gazette* of 1946, at page 884.

CENTRAL OTAGO

All that area comprising the existing Electoral District of Central Otago together with that part of the existing Dunedin Central Electorate bounded by a line commencing at the junction of McMeakin Road and Mount Grant Road; thence proceeding along McMeakin Road to and along the south-western boundary of Section 52, Block VI, Dunedin and East Taieri Survey District; thence north-easterly along the north-western boundary of the said Section 52 to the boundary of Wakari District; thence northerly and easterly generally along the western and northern boundaries of Wakari District to the north-eastern corner of Section 31, Wakari District, being a point on the boundary of the City of Dunedin; thence southerly generally along the City Boundary to the point of commencement.

CLUTHA

All that area comprising the existing Electoral District of Clutha as described in the *New Zealand Gazette* of 1946, at page 885, together with the Maclellan Riding of the County of Clutha.

INVERCARGILL

All that area comprising the existing Electoral District of Invercargill as described in the *New Zealand Gazette* of 1946, at page 885.

AWARUA

All that area comprising the Boroughs of South Invercargill and Bluff; the Town District of Wyndham; the Toetoes, Waihopai, Awarua, and Wallacetown Ridings of the County of Southland, Stewart Island, Ruapuke Island, Dog Island, Campbell Island, and other adjacent islands, those parts of the City of Invercargill excluded from the existing Invercargill Electoral District, that part of the Matarua Riding of the County of Southland lying generally to the south of a line commencing at a point in the middle of the Mimiha Stream in line with the middle of a road forming the western boundary of Section 20, Block X, Tuturau Survey District; thence to and along the middle of that road forming the western boundaries of Sections 20 and 22, Block X, aforesaid, the western boundary of, and passing through, Section 7, Block X, aforesaid, and passing through Section 20, Block IX, Tuturau Survey District, to its junction with a road forming the north-eastern boundary of the said Section 20; thence north-westerly along the middle of that road passing through Sections 27, 25, 24, and 23, all of Block IX, aforesaid, forming the southern boundaries of Sections 92, 71, 89, 93, 60, and 90, all of Block VI, Tuturau Survey District, the southern boundary of the land as shown on the plan numbered 1206 lodged in the office of the District Land Registrar at Invercargill, the south-western boundary of Section 59, and the southern boundary of Section 94, both of Block VI, aforesaid, the south-western boundary of Section 21, the south-eastern and southern boundaries of Section 19, and the southern boundary of Section 18, all of Block III, Tuturau Survey District, to and along the middle of the road forming the western boundary of, and passing through, Section 63, Block III, Tuturau Survey District, forming the western boundary of Section 31, Block III, aforesaid, passing through, and forming the eastern boundary of, Section 30, Block III, aforesaid, forming the eastern boundary of, and passing through Section 29, Block III, aforesaid, passing through Sections 73 and 72, Block III, aforesaid, and forming the southern boundaries of Sections 68, 69, 70, 34, 53, 35, and 52, all of Block III, and along the production of the middle line of that road to the north-eastern boundary of Section 56, Block III, aforesaid; thence along the north-eastern and southern boundaries of Section 56, aforesaid, the southern boundary of Section 42, Block III, aforesaid, and the production of that boundary across a public road, to and along the southern boundary of Section 47, Block III, aforesaid, and the production of that boundary to the middle of the Mataura River, and including all wharves and other extensions seaward.

WALLACE

All that area comprising the existing Wallace Electoral District together with that part of the Winton Riding of the County of Wallace included in the existing Awarua Electoral District.
