Land Reserved in the Otago Land District

C. W. M. NORRIE, Governor-General

WHEREAS by section 167 of the Land Act 1948 it is enacted that the Governor-General may from time to time set apart as a reserve, notwithstanding that the same may be then held under pastoral lease or pastoral occupation licence, any Crown land for any purpose, which, in his opinion, is desirable in the public interest, and notice thereof shall be published in the *New Zealand Gazette*:

Now, therefore, pursuant to section 167 of the said Act, I, Lieutenant-General Sir Charles Willoughby Moke Norrie, the Governor-General of New Zealand, hereby reserve, subject to the reservations and conditions imposed by section 59 of the Land Act 1948, the land in the Otago Land District described in the Schedule hereunder written, for a site for municipal buildings.

SCHEDULE

OTAGO LAND DISTRICT

SECTION 408, Town of Port Chalmers: Area, 26 perches, more or less. Subject to Grant of Rights created by Deed No. 158825 recorded in Deeds Record Volume 285, folio 463 (Otago Deeds Registry).
