DURSUANT to the Control of Prices Act 1947, the Price Tribunal hereby makes the following amending Price Order:

- 1. This Order may be cited as Price Order No. 1539, and shall be read together with and deemed part of Price Order 1467\* (hereinafter referred to as the principal Order).
  - 2. This Order shall come into force on the 22nd day of March 1954.
  - 3. The principal Order is hereby amended by revoking the First and Second Schedules thereto, and substituting the following Schedules:

PURSUANT to the Control of Prices Act 1947, the Price Tribunal hereby makes the following amending Price
