PURSUANT to the Motor Drivers Regulations 1940, the Minister of Transport hereby orders and declares that the provisions of clause (1) of regulation 7 of the said regulations so far as they relate to the driving of heavy trade motors shall not apply to the persons hereinafter mentioned, but in lieu thereof the following provision shall apply:

A motor driver's licence issued under the Motor Drivers Regulations 1940 to the persons described in Column 1 of the Schedule hereunder may authorize them to drive a heavy trade motor in the course of their employment for the employers described in Column 2 of the said Schedule, but shall not authorize them while they are under the age of eighteen years to drive a heavy trade motor for any other purpose.

Where observations are not available for the whole period, or where the site of the rain-gauge has been changed, the normals are partially interpolated.

NOTES ON THE WEATHER FOR AUGUST 1954

General.—Like the previous month, August was a month of dull, unsettled weather. In most parts of the North Island lambing commenced under reasonably favourable conditions, but in the South Island some farmers reported considerable losses, mainly due to snow.

Heavy rain in the Manawatu-Rangitikei-Wanganui area caused extensive surface flooding on the 26th and 27th.

During the passage of a deep depression across Taranaki and Hawke's Bay on the 14th and 15th, strong gales occurred in most parts of the country north of Timaru, causing some damage. In the Nelson-Buller-Westland area it was reported that hundreds of trees were blown down.

Rainfall.—Over the North Island rainfall was generally somewhat above normal. Most of Canterbury and inland North Otago received at least twice as much rain as usual, but elsewhere in the South Island rainfall was mainly close to the normal value. The only areas with an appreciable deficiency were the Bay of Plenty and parts of Westland, Otago, and Southland.

Temperatures.—Mean temperatures were close to normal over the whole country, though there was much variation from day to day. Severe frosts occurred in the North Island on the 9th and 10th; in parts of the Auckland Province they were the most severe recorded for over twenty years.

Snow fell in the high country of Canterbury and in Central Otago on the 14th and 15th; in the Mackenzie country this was reported to be the heaviest fall for some years. A heavy snowfall also occurred in the Southern Alps on the 27th, and another on the ranges and high country of the North Island as far north as the Gisborne district on the 31st.

Sunshine.—Sunshine was appreciably below normal over almost all the country north of Westport and Ashburton. The deficiency exceeded an hour a day in the cities of Auckland and Wellington; in fact for Auckland the total of 110 hours was the lowest August total in forty-five years of record.

Most east coast districts from Ashburton southward were favoured with an appreciable surplus, while Invercargill received an hour a day more than its usual sunshine.

Weather Sequence.—For the first eight days of the month there was a continuation of the south-easterly conditions which had commenced on 30 July. There was heavy rain at times in Northland, Gisborne, and Hawke's Bay, and persistent showery weather

in eastern districts generally; while south-easterly gales caused some damage in Taranaki on the 2nd and 3rd. Barometers remained high to the south, and a depression which had been centred near North Cape moved south-eastward past East Cape on the 1st and away to the east. Another depression which formed near Lord Howe Island followed a more northward path from west of North Cape on the 4th to Raoul Island on the 8th. At the same time an anticyclone extending on to Southland and Otago from the South Tasman Sea gradually moved on to the whole country.

By the 9th the anticyclone covered New Zealand, and fine frosty weather prevailed generally. However, on the following day a spell of twelve days of fine weather on the West Coast was broken with the approach of a trough of low pressure associated with a deep depression far to the south. With the passage of the trough over the country on the 11th and 12th rain became general, except in eastern districts. A deep depression which had formed over the North Tasman Sea then moved down the west coast of the North Island and across Taranaki and Hawke's Bay on the 14th and 15th. Gales affected most of the country, with considerable damage near Auckland City and in Nelson and Westland Provinces. Rain became heavy, except in the far south and on the West Coast; and snow was reported from the Southern Alps, the Canterbury high country, and Central Otago. Conditions improved on the 16th as the depression moved away, but showers persisted in most districts.

From the 17th to the 22nd westerly conditions prevailed, with deep depressions far to the south and associated troughs of low pressure crossing the country from south-west to north-east. There was considerable rain in western districts from New Plymouth southward, and scattered light falls at times elsewhere. On the 23rd and 24th rain became general again with the formation of a shallow depression in a trough as it moved over the central districts. There was a clearance in eastern districts on the 25th, but the development of another shallow depression west of Taranaki brought heavy rain to the Wanganui-Rangitikei-Manawatu area, with extensive surface flooding on the 26th and 27th. On the following two days the weather was still showery at times in western districts as an anticyclone passed over Northland. Considerable rain accompanied the passage of a trough of low pressure over the country on the 30th and 31st. With the formation of a secondary depression east of the South Island a cold southerly airstream covered the country at the end of the month, and a clearance occurred on the West Coast.

(2) The revocation of the said Order shall not affect the liability of any person for any offence in relation thereto committed before the coming into force of this Order.

APPLICATION OF THIS ORDER

3. This Order applies with respect to all Australian oranges sold by way of retail in New Zealand.

FIXING MAXIMUM RETAIL PRICES OF ORANGES TO WHICH THIS ORDER APPLIES

4. (1) The maximum price that may be charged or received by any retailer for any oranges to which this Order applies shall be determined as follows:

(a) With respect to oranges sold at any place within the metropolitan areas of Auckland, Wellington, Christchurch, or Dunedin as defined in the Schedule hereto or in any of the cities or boroughs of Whangarei, Hamilton, Gisborne, New Plymouth, Stratford, Wanganui, Palmerston North, Napier, Hastings, Blenheim, Nelson, Greymouth, Westport, Timaru, Oamaru, Balclutha, Gore, or Invercargill—

(2) If in respect of any lot of oranges the price calculated in accordance with the foregoing provisions of this clause is not an exact number of pence or half-pence, the maximum price of the lot shall be computed to the next upward halfpenny.

PROVISION FOR SPECIAL PRICES

5. Notwithstanding anything to the contrary in the foregoing provisions of this Order, and subject to such conditions, if any, as it thinks fit, the Tribunal, on application by any retailer, may authorize special maximum prices in respect of any oranges to which this Order applies where special circumstances exist, or for any reason extraordinary charges (freight or otherwise) are incurred by the retailer. Any authority given by the Tribunal under this clause may apply with respect to a specified lot or consignment of oranges or may relate generally to all oranges to which this Order applies, sold by the retailer while the approval remains in force.

DUTY IMPOSED ON RETAILERS

6. Every retailer who offers or exposes for sale in any shop any oranges to which this Order applies shall keep in a prominent position in such proximity to the oranges to which it relates as to be obviously in relation thereto a ticket, placard, or label on which shall be stated in legible and prominent characters the word "Australian" and the retail price per pound of the oranges.

Price Order No. 1570 (Phosphatic Fertilizers)

PURSUANT to the Control of Prices Act 1947, the Price Tribunal hereby makes the following Price Order :

1. This Order may be cited as Price Order No. 1570, and shall come into force on the 1st day of October 1954.
2. (1) Price Order No. 1482* is hereby revoked.
- (2) The revocation of the said Order shall not affect the liability of any person for any offence in relation thereto committed before the coming into force of this Order.

APPLICATION OF THIS ORDER

3. (1) Subject to the next succeeding subclause, this Order applies with respect to phosphatic fertilizers of the following kinds manufactured or prepared in New Zealand and sold for use in New Zealand :

- (a) Superphosphate :
 - (b) Serpentine superphosphate comprising 15 cwt. of superphosphate and 5 cwt. of ground serpentine rock per ton :
 - (c) Superphosphate compound comprising 15 cwt. of superphosphate, 2 cwt. of ground serpentine rock or limestone, and 3 cwt. of finely ground Nauru or Ocean Island rock phosphate per ton :
 - (d) Reverted superphosphate comprising 15 cwt. of superphosphate and 5 cwt. of carbonate of lime per ton :
 - (e) Super Nauru compound comprising 15 cwt. of superphosphate and 5 cwt. of Nauru or Ocean Island rock phosphate per ton :
 - (f) Finely ground Nauru or Ocean Island rock phosphate.
- (2) Nothing in this Order shall apply with respect to any phosphatic fertilizers sold in a quantity of less than one ton.

FIXING MAXIMUM PRICES OF PHOSPHATIC FERTILIZERS TO WHICH THIS ORDER APPLIES

4. (1) The prices for phosphatic fertilizers fixed by this Order are fixed in respect of sales of the following classes, namely :
 - (a) Sales to a user—that is to say, to a person purchasing for his own use and not for the purpose of resale :
 - (b) Sales to a storekeeper—that is to say, to a person (not being a merchant, dairy company, or farmer's organization as hereinafter mentioned), purchasing solely for resale to users :
 - (c) Sales to a merchant—that is to say, to a person purchasing for resale to storekeepers or to users :
 - (d) Sales to a dairy company, as defined in section 2 of the Dairy Industry Act 1908, purchasing solely for resale to persons being suppliers of milk or cream to the company :
 - (e) Sales to an incorporated farmers' organization, having a retail department conducted on a co-operative basis, and purchasing phosphatic fertilizers solely for the purpose of resale to its members.
- (2) The prices for phosphatic fertilizers fixed by this Order are fixed in respect of sales for cash or for credit until a date not later than the 20th day of the month next following the month of delivery.
- (3) Where any sale is made on terms allowing credit for a longer period than that mentioned in the last preceding subclause, the purchaser shall be entitled, notwithstanding anything to the contrary in the contract of sale, to the benefit of the prices fixed by this Order if in fact payment is made not later than the 20th day of the month next following the month of delivery.
- (4) The prices fixed by this Order include the price of the containers.
5. (1) Where any phosphatic fertilizers manufactured in the South Island are sold for delivery "ex works" or "free on rail" at Burnside, Hornby, or Ravensbourne, the maximum price that may be charged or received shall be the appropriate price specified in the First Schedule hereto.
- (2) Where any phosphatic fertilizers manufactured in the North Island are sold for delivery "ex works" or "free on rail" at Aramoho, Otahuhu, Smart Road (New Plymouth), Te Papapa, Westfield, or Awatoto, the maximum price that may be charged or received shall be the appropriate price specified in the Second Schedule hereto.
- (3) In the case of sales in bulk (i.e., not in containers of any kind) the prices for "Twenty to Ton" fixed in the First or Second Schedule hereto, whichever is appropriate, shall be reduced by the sum of £1 4s. 6d. per ton in respect of each class of sale.
- (4) Where any phosphatic fertilizers are sold for delivery elsewhere than at one of the places mentioned in subclauses (1) and (2) of this clause, the maximum price that may be charged or received shall be the appropriate price fixed in the First or Second Schedule hereto, whichever is appropriate, increased by the amount of the freight charges between the place of manufacture and the place of delivery : Provided that the amount added to the price in respect of freight charges shall not in any case exceed the amount that would have been incurred had delivery been effected by the holder of a goods-service licence under the Transport Act 1949, at authorized rates : Provided also that where phosphatic fertilizer manufactured at Smart Road is sold for delivery at a place which is nearer or more convenient of access to Aramoho the freight charge shall not exceed that which would have been incurred had delivery been made from Aramoho to the place of delivery.
- (5) In every invoice, debit-note, or similar document issued by a vendor to a user in respect of the sale of any phosphatic fertilizer, there shall be shown separately—
 - (a) The price of the phosphatic fertilizers fixed in accordance with this Order ; and
 - (b) The additional amount (if any) payable by the purchaser in respect of freight charges.

Price Order No. 1568 (Cheese)

PURSUANT to the Control of Prices Act 1947, the Price Tribunal hereby makes the following Price Order:

PRELIMINARY

1. This Order may be cited as Price Order No. 1568, and shall come into force on the 1st day of October 1954.

2. (1) Price Order No. 1534* is hereby revoked.

(2) The revocation of the said Order shall not affect the liability of any person for any offence in relation thereto committed before the coming into force of this Order.

3. (1) In this Order, unless the context otherwise requires,—

“The said Act” means the Control of Prices Act 1947:

“Export size”, in relation to any cheese, means a cheese weighing or reputed to weigh approximately 80 lb.:

“Medium size”, in relation to any cheese, means a cheese weighing or reputed to weigh approximately 40 lb.:

“Pancake size”, in relation to any cheese, means a cheese weighing or reputed to weigh approximately 20 lb.:

“Standard crate lot”, in relation to a transaction for the sale of cheeses, means a lot consisting of two cheeses of export size, or three cheeses of medium size, or six cheeses of pancake size.

(2) Terms and expressions defined in the said Act and used in this Order have the meanings severally assigned thereto by that Act.

APPLICATION OF THIS ORDER

4. (1) This Order applies only with respect to Cheddar cheese that is sold by a retailer within four months after the date of its manufacture.

(2) For the purposes of this clause the date of the manufacture of any cheese shall be deemed to be the date indicated on the cheese in accordance with the requirements of the Dairy-produce Regulations 1938†.

(3) Every person who sells any Cheddar cheese by retail (whatever the age of such cheese) shall keep, for a period of not less than four months, a record showing the date of the delivery of the cheese to the retailer, and also—

(a) If the whole cheese was sold, without cutting, the date of its sale; or

(b) In any other case, the date on which the cheese was first cut.

FIXING MAXIMUM RETAIL PRICES FOR CHEESE TO WHICH THIS ORDER APPLIES

5. (1) The maximum price that may be charged or received by any retailer for any cheese to which this Order applies shall be determined in accordance with the following provisions, namely—

(a) In the case of cheese sold by a retailer to whom supplies of Cheddar cheese are available, free of freight charges, for delivery at his store from any source whatever, the maximum retail price shall be 1s. 11d. a pound:

(b) In cases to which the last preceding paragraph does not apply, the maximum retail price shall be 1s. 11d. a pound, increased to the next upward halfpenny by the appropriate proportion of the freight charges incurred by the retailer in obtaining delivery at his store:

Provided that where any cheese to which this paragraph applies is obtained by the retailer from a source of supply that is not the most convenient of access to the retailer's store, the increase of the price per pound authorized by this paragraph shall not exceed the appropriate proportion of the freight charges that would have been incurred by the retailer if the cheese had been obtained from the source of supply most convenient of access to his store, and if delivery had been effected by a common carrier at current freight rates.

(2) Where the quantity of cheese sold by a retailer in any one transaction is not an exact number of pounds, the maximum price shall be computed at the rate per pound fixed in accordance with the last preceding subclause.

(3) If in respect of any cheese the retail price charged in accordance with the provisions of this clause is not an exact number of pence or halfpence, the maximum price shall be computed to the next upward halfpenny.

6. (1) Where any person sells by retail to any one purchaser, for delivery at any one time, not less than three standard crate lots of export-size, medium-size, or pancake-size cheeses, whether or not all the standard crate lots contain the same size of cheeses, the maximum price that may be charged or received in respect of any such sale shall be computed as follows:

(2) For the purposes of this clause the weight of any cheeses sold in crates shall be deemed to be their weight as at the time of crating, and the weight of uncrated cheeses shall be deemed to be their actual weight when delivered to the purchaser.

Any authority given by the Tribunal under this clause may apply with respect to a specified lot or consignment of cheese or may relate generally to all cheese to which this Order applies sold by the retailer while the approval remains in force.
