Proposed Boundaries of the Electoral Districts in the North Island and the South Island of New Zealand

The Representation Commission appointed in pursuance of section 15 of the Electoral Act 1956 hereby publishes, in accordance with the provisions of section 18 of the said Act, the proposed boundaries of the electoral districts in the North and South Islands of New Zealand; and further, gives notice that written objections to the same will be received by the undersigned, the chairman of the Commission, at the office of the Surveyor-General, Government Buildings, Wellington, not later than noon on Tuesday, the 8th day of January 1957, for consideration by the aforesaid Commission.

Maps of the proposed districts may be seen at the office of any City or Borough Council, County Council, Town Board, or Road Board; of the Chief Surveyor at Auckland, New Plymouth, Gisborne, Napier, Wellington, Blenheim, Nelson, Hokitika, Christchurch, Dunedin, and Invercargill; of the Chief Electoral Officer at Wellington; and of the Registrars of Electors throughout the Dominion.

All that area being the present Electoral District of Hobson.

MARSDEN

All that area being the present Electoral District of Marsden.

RODNEY

All that area comprising the Counties of Otamatea and Rodney, the Borough of Helensville, the Town District of Warkworth, and that portion of the County of Waitemata bounded by a line commencing at the point of intersection of the western boundary of Puhoi Parish and the northern boundary of Waiwera Parish, in Block I, Waiwera Survey District; thence southerly generally along the northern and western boundaries of Waiwera Parish to the south-western corner of Allotment 34, Waiwera Parish; thence across a public road to and along the northern boundary of Allotment 29, Kaukapakapa Parish, the northern and western boundaries of Allotment 52, the western boundaries of Allotment 57, 58,

and 63, to a point in line with the north-western boundary of Allotment 65, across a public road to and along the last-mentioned boundary and the north-eastern and eastern boundaries of Allotment 64, the aforesaid allotments being of Kaukapakapa Parish; thence along a right line to the confluence of the Waitoki and Waipapakara Streams; thence up the middle of the Waipapakara Stream to the north-eastern corner of Allotment 306, Pukeatua Parish; thence generally along the eastern boundary of the said Allotment 306 to a point in line with the south-western boundary of part Allotment S. 23, Pukeatua Parish; thence along a right line across a public road to and along the south-western boundary of part Allotments 2, 23 aforesaid, the north-western and south-western boundaries of Allotments 25, 26, 27, and 28, the southern boundaries of Allotments 28 and E. 29 to a point due west of the north-eastern corner of Allotment 39, the aforesaid allotments being of Pukeatua Parish; thence due east across a public road to the western boundary of the Pukeatua Riding of the County of Waitemata; thence southerly generally along the western boundary of the Nesaid riding to the south-moundary of the said riding to the south-moundary of Allotment 221, both of Paremoremo Parish, and the production of the last-mentioned boundary to the middle of the Rangitopuni Stream; thence down that stream to and along the western shore of Waitemata Harbour to the middle of the mouth of Henderson Creek; thence up the middle of the mouth of Henderson Creek; thence up the middle of the mouth of Henderson Creek; thence as the middle of the mouth of Henderson Creek; thence as the middle of the mouth of Henderson Valley Road; thence easterly along a public road to Ranui Road; thence south-westerly along Hetherington Road and Candia Road to Henderson Valley Road; thence easterly along Parrs Cross Road to the Waikumete West Coast Main Highway; thence south-westerly along the said highway to Shaw Road; thence southerly along the boundary of the Said riding other adjacent islands.

All that area comprising the Boroughs of Birkenhead, Northcote, and East Coast Bays; that portion of the Borough of Takapuna bounded by a line commencing at a point on the sea coast on the left bank of Wairau Creek; thence up the left bank of the said creek to Kitchener Road; thence north-easterly generally along Kitchener Road and East Coast Road to Stanley Avenue; thence south-westerly along Stanley Avenue to Nile Road; thence north-westerly along Nile Road to the boundary of the Borough of Takapuna; thence northerly, easterly, and southerly generally along the boundary of the said borough to the point of commencement; and that portion of the County of Waitemata bounded by a line commencing at the point of intersection of the western boundary of Puhoi Parish and the northern boundary of Waiwera Parish; thence southerly generally along the boundary of the Electoral District of Rodney hereinbefore described to the middle of the Rangitopuni Stream; thence down that stream to the boundary of the County of Waitemata; thence easterly, northerly, and westerly generally along the boundary of the said County to the point of commencement.

All that area comprising the Borough of Devonport and the Borough of Takapuna, excluding therefrom that portion of the last-mentioned borough included in the Electoral District of Waitemata hereinbefore described.

WAITAKERE

All that area comprising the Boroughs of Henderson, Glen Eden, and New Lynn, and that portion of the County of Waitemata bounded by a line commencing at a point in the middle of the mouth of Henderson Creek; thence southerly generally along the boundary of the Electoral District of Rodney hereinbefore described to the Manukau Harbour; thence north-easterly and northerly generally along the boundary of the County of Waitemata to the point of commencement.

All that area bounded by a line commencing at a point on the shore of Waitemata Harbour in the middle of St. Mary's Road; thence along the middle of St. Mary's Road, Ponsonby Road, and Newton Road to the middle of Symonds Street; thence southerly along the middle of Symonds Street to Khyber Pass Road; thence along the middle of Khyber Pass Road to Park Road; thence along the middle of Park Road to Carlton Road; thence easterly along the middle of Carlton Road and its production to Broadway; thence southerly along the middle of Broadway to the North Auckland Main Trunk Railway; thence southerly generally along the middle of the said railway to the south-western boundary of Allotment 23, Section 4, Suburbs of Auckland; thence along the south-western and south-eastern boundaries of the said allotment to a stream; thence down that stream to Ayr Street; thence south-easterly along the middle of Ayr Street and Shore Road to a stream at the seaward end of Hapua Street; thence down that stream to Hobson Bay to Point Resolution and along a right line to the northern side of Tamaki Drive; thence westerly generally along the shore of Waitemata Harbour, including all wharves and extensions seaward, to the point of commencement; and including Tiritiri, Rangitoto, Motutapu, Rakino, Motuihe, Browns, Waiheke, Ponui, Pokihi, Rotoroa, Pakatoa, and other adjacent islands, and the Kermadec Islands.

All that area bounded by a line commencing at a point on the shore of Waitemata Harbour in the middle of St. Mary's Road; thence along the boundary of the Electoral District of Auckland Central hereinbefore described to a point in Newton Road in line with the south-eastern boundary of Allotment 12, Section 7, Suburbs of Auckland; thence to and along the south-eastern and southern boundaries of Allotments 12, 13, 14, 15, 16, 17, 18, 19, and 20, Section 7, Suburbs of Auckland, to Wexford Street; thence northerly along the middle of Wexford Street; thence northerly along the middle of Ivanhoe Road; thence westerly along the middle of Ivanhoe Road to Great North Road; thence north-easterly along the middle of Great North Road to Bullock Track; thence along the middle of Bullock Track to Old Mill Road; thence along the middle of Old Mill Road to the right bank of Motions Creek; thence down the right bank of Motions Creek and northerly and easterly generally along the shore of Waitemata Harbour, including all wharves and extensions seaward, to the point of commencement. commencement.

GREY LYNN

All that area bounded by a line commencing at a point on the right bank of Motions Creek in the middle of Old Mill Road; thence south-easterly generally along the boundary of the Electoral District of Ponsonby hereinbefore described to the middle of Central Road; thence along the middle of Central Road and across New North Road to the footbridge near Kingsland Railway Station; thence south-westerly along the middle of the North Auckland Main Trunk Railway to and along the middle of New North Road to the middle of Oakley Stream; thence up the middle of that stream to a point in line with the south-eastern boundary of Lot 20 of a subdivision of Allotment 65, Titirangi Parish; thence to and along the south-eastern boundaries of Lots 20, 19, 18, 17, 16, 15, 14, 11, and 10, and the south-western

boundaries of Lots 10 and 9, the said lots being of a subdivision of Allotment 65, Titirangi Parish, and the production of the last-mentioned boundary to the middle of Blockhouse Bay Road; thence southerly along the middle of Blockhouse Bay Road to Chalmers Street; thence along the middle of Chalmers Street to the North Auckland Main Trunk Railway; thence south-westerly along the middle of the said railway to St. Georges Road; thence southerly along the middle of St. Georges Road to Wolverton Road; thence southwesterly along the middle of Wolverton Road to the right bank of an eastern arm of Whau Creek; thence northerly generally along the right bank of Whau Creek and the shore of Waitemata Harbour, including all extensions seaward, to the right bank of Motions Creek; thence up the right bank of Motions Creek to the point of commencement.

All that area bounded by a line commencing at a point on the shore of Manukau Harbour at the southern extremity of the eastern boundary of Allotment 75, Titirangi Parish; thence northerly generally along the eastern boundary of the said Allotment 75 to White Swan Road, along a right line to the middle of Boundary Road, and along the middle of Boundary Road to its junction with a road forming the north-eastern boundary of Allotment 72, Titirangi Parish; thence south-easterly along the middle of the last-mentioned road to a point in line with the north-western boundary of Allotment 71, Titirangi Parish; thence north-easterly to and along the last-mentioned boundary across Richardson Road to and along the north-western boundary of Allotment 90, Titirangi Parish, and the production of the last-mentioned boundary to the middle of Stoddard Road; thence north-westerly along the middle of Stoddard Road; thence north-westerly along the middle of Sandringham Road; thence along the middle of Sandringham Road; thence along the middle of Elphinstone Avenue to Elphinstone Avenue, along the middle of Elphinstone Avenue to Greenville Avenue, and along the middle of Greenville Gifford Avenue, along the middle of Gifford Avenue to Elphinstone Avenue, along the middle of Elphinstone Avenue to Greenville Avenue, and along the middle of Greenville Avenue and a right of way to Mount Albert Road; thence south-easterly along the middle of Mount Albert Road to a point in line with the north-western boundary of Allotment 122, Section 10, Suburbs of Auckland; thence to and along the north-western boundaries of Allotments 122, 123, 124, 125, 126, 127, 128, 129, 130, 131, 132, 133, 134, 135, and 136, Section 10, Suburbs of Auckland, to and across Raleigh Street; thence along the northern side of Raleigh Street to Kowhai Street; thence along the middle of Kowhai Street to A point line with the southern boundary of Kowhai Junior High School; thence to and along the southern and south-western boundaries of the said school and the production of the last-mentioned boundary to the middle of Sandringham Road; thence easterly along the middle of Sandringham Road; thence easterly generally to and along the boundary of the Electoral District of Grey Lynn hereinbefore described to the right bank of Whau Creek; thence southerly generally up the right bank of Whau Creek and up the Avondale Stream to the western side of Portage Road; thence southerly along the western side of Portage Road; thence southerly along the Wanukau Harbour; thence easterly generally along the shore of the Manukau Harbour to the point of commencement.

EDEN

All that area bounded by a line commencing at a point on the seaward side of Tamaki Drive opposite Hobson Point; thence easterly and southerly generally along the shore of Waitemata Harbour and Tamaki River, including all wharves and extensions seaward, to the south-eastern corner of Lot 985 on D.P. 39859, being a point on the boundary of the City of Auckland as described in the Gazette of 1956, at page 1084; thence westerly generally along that city boundary to the middle of College Road; thence north-easterly and north-westerly along the boundary of the Electoral District of Remuera hereinbefore described to the point of commencement.

All that area bounded by a line commencing at the intersection of the south-western side of Great North Road and the right bank of St. Annes Creek, being a point on the boundary of the Mount Wellington Borough as described in the Gazette of 1955, at page 1271; thence northerly generally along that borough boundary to the south-western boundary of Allotment 26A of Section 12, Suburbs of Auckland, being a point on the boundary of the Electoral District of Remuera hereinbefore described; thence south-westerly generally along that electoral district boundary to Manukau Road, being a point on the boundary of the Electoral District of Roskill hereinbefore described; thence southerly generally along that electoral district boundary to the shore of Manukau Harbour; thence easterly along the shore of Manukau Harbour and the right bank of St. Annes Creek to the point of commencement.

All that area comprising the Boroughs of Mount Wellington, Otahuhu, and Howick, and the Pakuranga Riding of the County of Manukau.

MANUKAU

All that area comprising the Boroughs of Papatoetoe and Manurewa, the Mangere and Papatoetoe Ridings of the County of Manukau, and that portion of the Papakura Riding of the County of Manukau lying to the west of the Papakura Stream from its mouth to the southern boundary of the Borough of Manurewa.

Franklin

All that area comprising the Boroughs of Papakura, Pukekohe, and Waiuku; the Turanga and Wairoa Ridings of the County of Manukau; the Hunua, Drury, Karaka, Mauku, Awhitu, Waipipi, and Waiuku Ridings of the County of Franklin; that portion of the Papakura Riding of the County of Manukau lying to the east of the Papakura Stream from its mouth to the southern boundary of the Borough of Manurewa; that portion of the Pukekohe West Riding of the County of Franklin lying to the north of a line along the middle of the road forming the south-eastern boundary of Allotments 15, 31, 47, and 52, Suburban Section 3, Parish of Pukekohe, the south-eastern boundary of Allotment 156, the south-western boundary of Allotment 102, and the south-eastern boundaries of Allotments 102 and 105, Suburban Section 2, Parish of Pukekohe; and that portion of the Pukekohe East Riding of the County of Franklin lying to the north of the Pukekohe-Bombay Main Highway.

All that area comprising the Boroughs of Tuakau, Huntly, and Ngaruawahia; the Mercer Riding of the County of Franklin, the Whangamarino, Huntly, and Taupiri Ridings of the County of Waikato; the Onewhero, Pukekawa, Waikato, Whangape, Pukemiro, Waingaro, and Te Akau Ridings of the County of Raglan; those portions of the Pukekohe West and Pukekohe East Ridings of the County of Franklin not included in the Electoral District of Franklin hereinbefore described; that portion of the Rototuna Riding of the County of Waikato lying to the north-west of a line along the middle of the road forming the south-eastern boundary of Allotments 133, 81, 82, 83, 84, and 85, Komakorau Parish, the south-western boundary of Allotment 59, Komakorau Parish, the south-western and south-eastern boundaries of Lot 7 on D.P. 7516, and the eastern boundaries of Lots 7, 6, and 5 on D.P. 13637; and that portion of the Newcastle Riding of the County of Waipa lying to the north of a line along the middle of the road forming the southern boundary of Allotments 54 and 62, Horotiu Parish, to and along the southern boundaries of Allotments 61, 60, and 38, Horotiu Parish; thence northerly along the middle of the Whatawhata-Ngaruawahia Road to Fullerton Road; thence along the middle of Fullerton Road to Rotokauri Road and northerly along the middle of Rotokauri Road.

HAURAKI

All that area comprising the Boroughs of Thames, Waihi, and Paeroa; the Counties of Great Barrier Island, Coromandel, Thames, Hauraki Plains, and Ohinemuri; the Tahuna Riding of the County of Piako; and those portions of the Waihou and Waitoa Ridings of the County of Piako lying to the north of a line north-easterly along the middle of No. 4 Road, south-easterly along the middle of No. 2 Road, south-easterly along the middle of No. 2 Road, south-easterly along the middle of Eastport Road, northerly down the middle of the Waitoa River, north-easterly along the south-eastern boundary of Lot 2 on D.P. 10528, north-westerly along the middle of Ngutumana Road, and easterly along the middle of Te Kawana Road; and including Arid Island and other islands adjacent to Great Barrier Island, Whanganui Island and other islands adjacent to Coromandel County, Cuvier Island, Great Mercury Island, Slipper Island, and other adjacent islands.

WAIPA

WAIPA

All that area comprising the Borough of Te Awamutu; the Raglan, Karioi, Whaingaroa, Karamu, and Pirongia Ridings of the County of Raglan; the Hamilton, Rukuhia, Tuhikaramea, Kaipaki, Mangapiko, and Kakepuku Ridings of the County of Waipa; that portion of the Newcastle Riding of the County of Waipa not included in the Electoral District of Raglan hereinbefore described; those portions of the Rangiaohia and Orakau Ridings of the County of Waipa lying to the west of a line south-westerly along the middle of the Puahue-Rotorangi Road, south-easterly along the middle of Park Road, Hastie Road, and Lichfield Road, southerly along the middle of Monckton Road, westerly along the middle of the Kihikihi-Arapuni-Putaruru Main Highway, and south-westerly along the middle of Mellsop Road and Andrew Road and its production to the Puniu River; that portion of the Cambridge Riding of the County of Waikato lying to the west of a line westerly along the middle of the Hamilton-Rotorua State Highway, and south-westerly along the middle of the Hamilton-Rotorua State Highway, and south-westerly along the middle of Savills Road and its production to the Waikato River; that portion of the City of Hamilton lying generally to the west of a line southerly up the middle of the Waikato River to Fairfield Bridge, north-westerly along the middle of Great South Road, south-westerly along the middle of the North Island Main Trunk Railway; and that portion of the City of Hamilton lying to the south of a line

south-easterly along the south-western boundary of Lot 3 of a subdivision of land at the intersection of the western side of Ohaupo Road and the north-western side of Tawa Street, north-easterly along the middle of Tawa Street, southerly along the middle of Ohaupo Road, north-easterly along the middle of Lorne Street, northerly generally along the eastern boundary of Lot 3 on D.P. 13590, and the southern and eastern boundaries of Lot 1 on D.P. 31435, easterly generally along north-western boundaries of Allotments 52 and 53, Te Rapa Parish, and up the middle of the Waikato River.

HAMILTON

All that area comprising the City of Hamilton, excluding those portions of the said city included in the Electoral District of Waipa hereinbefore described, and that portion of the said city included in the Electoral District of Piako hereinafter described.

PIAKO

All that area comprising the Boroughs of Te Aroha, Morrinsville, and Matamata; the Ruakura and Tamahere Ridings of the County of Waikato; the Morrinsville, Kiwitahi, Walton, Manawaru, and Te Aroha Ridings of the County of Piako; the Peria and Waharoa Ridings of the County of Matamata; that portion of the City of Hamilton lying to the north-east of a line along the middle of Peachgrove Road; those portions of the Waihou and Waitoa Ridings of the County of Piako not included in the Electoral District of Hauraki hereinbefore described; and that portion of the Rototuna Riding of the County of Waikato not included in the Electoral District of Raglan hereinbefore described.

Tauranga

All that area comprising the Boroughs of Tauranga, Mount Maunganui, and Te Puke, the County of Tauranga, excluding the Maketu Riding of the said County, and including Mayor Island, Motiti Island, and other adjacent islands.

WAIKATO

All that area comprising the Boroughs of Cambridge and Putaruru; the Town District of Leamington; the County of Matamata, excluding the Peria and Waharoa Ridings of the said County; the Pukekura Riding of the County of Waipa; that portion of the Cambridge Riding of the County of Waikato not included in the Electoral District of Waipa hereinbefore described, and those portions of the Rangiaohia and Orakau Ridings of the County of Waipa not included in the Electoral District of Waipa hereinbefore described.

ROTORUA

All that area comprising the Boroughs of Rotorua and Taupo; the County of Rotorua; the Pouakani, Tatua, and Tauhara Ridings of the County of Taupo; and that portion of the Kaingaroa Riding of the County of Taupo lying to the north of a line commencing at the easternmost corner of Tauhara South A Block and proceeding along a right line to the intersection of the middle of the Taupo-Napier Road with the middle of the Rangitaiki River; and thence along a right line in the direction of Te Taumutu Trig.
