Price Order No. 1848 (Meat Retail)

PURSUANT to the Control of Prices Act 1947, the Price Tribunal hereby makes the following price order. PRELIMINARY

PRELIMINARY 1. This order may be cited as Price Order No. 1848 and shall come into force on the 7th day of August 1961. 2. (1) Price Orders Nos. 1800, * 1802, ¹ 1804, ² 1808, ⁸ 1811, ⁴ 1812, ⁶ 1817, ⁷ 1823, ⁸ 1825, ⁹ 1828, ¹⁰ 1830, ¹¹ 1836, ¹² 1839, ¹³ 1841, ¹⁴ 1842, ¹⁵ 1845, ¹⁶ and 1846¹⁷ are hereby revoked. (2) The revocation of the said orders shall not affect the liability of any person for any offence in relation thereto committed before the coming into force of this order. 3. (1) In this order, unless the context otherwise requires,— "Abattoir district" means an abattoir district constituted in accordance with the Meat Act 1939. "Frozen meat" means meat that has been held in a freezing chamber until the major portion of the liquid content of the meat has solidified. "The said specification" means the New Zealand Standard

- - The meat has solidined. "The said specification" means the New Zealand Standard Specification No. N.Z.S.S. 681 and entitled "Grades of Meat for Sale on the Local Market, and Definitions of Joints and Cuts", declared by the Minister of Industries and Commerce under the authority of section 8 of the Standards Act 1941, to be a standard specification, and includes the said specification as from time to time amended.

"Meat pricing districts" mean the districts described in the First Schedule hereto. "Basic prices" mean the prices set out in the Second Schedule

hereto.

hereto. (2) References in this order to the kind, description, or grade of any meat shall be deemed respectively to be references to the kind, description, or grade of such meat within the meaning and for the purposes of the said specification. (3) All fresh meat killed in an abattoir district and sold or delivered to a purchaser during the currency of this order shall be deemed, until the contrary is proved, to be meat of the grade indicated thereon by the distinctive grade marking made pursuant to the said specification. (4) All fresh meat killed elsewhere than in an abattoir district

(4) All fresh meat killed elsewhere than in an abattoir district and sold or delivered to a purchaser during the currency of this order shall be sold at prices not in excess of the appropriate prices fixed in this order for first-grade, second-grade, or third-grade meat had it in fact been killed and graded in an abattoir district.

4. (1) Nothing in this order shall apply with respect to sales of lamb during the period covered by the dates set out in the Fourth Schedule hereto.

(2) Except as provided in subclause (1) hereof this order applies only with respect to all retail sales of meat (whether fresh, frozen, or preparkaged chilled meat) in the meat pricing districts defined in the First Schedule hereto and of the kinds or descriptions specified in the Second Schedule hereto intended for human consumption and whether sold in an abbatoir district or in a non-abbatoir district.

abbatoir district.
(3) All meat sold or delivered to a purchaser during the currency of this order shall be deemed to be intended for human consumption unless it is sold for some other specific purpose.
(4) The maximum prices fixed by this order apply with respect to sales by auction as well as to other sales.
(5) The provisions of this order shall apply notwithstanding that any meat to which this order applies is sold otherwise than by weight.

FIXING MAXIMUM RETAIL PRICES OF MEAT TO WHICH THIS ORDER APPLIES

5. (1) The basic retail prices of meat of the kind and descriptions specified in the Second Schedule hereto shall be the appropriate prices set against the respective kinds and descriptions in that Schedule.

Schedule. (2) The maximum retail prices of meat of the kind and descriptions specified shall be the basic retail prices plus or minus any adjustments resulting from the application of the provisions set out in the Third Schedule. (3) Notwithstanding anything in the provisions of this order and subject to such conditions, if any, as it thinks fit, the Tribunal, on application by any retailer, may authorise special maximum retail prices in respect of any meat to which this order applies where for any reason extraordinary charges (freight or otherwise) are incurred by the retailer. Any authority given by the Tribunal under this subclause may apply with respect to a specified lot or consignment of meat or may relate generally to all meat to which this order applies sold by the retailer while the approval remains in force. in force.

GENERAL PROVISIONS AS TO MAXIMUM RETAIL PRICES

6. (1) No additional charges shall be made by a retailer for wrapping any meat to which this order applies, or for trimming or other incidental and customary services performed in relation to the retailing of any such meat. (2) If in respect of any lot of meat the maximum price calculated

(2) If in respect of any lot of meat the maximum price calculated in accordance with the provisions of this order is not an exact number of pence, the maximum price of the lot shall be computed to the nearest penny.
(3) Where a retailer sells any joint or cut of meat which is not in accordance with any one definition in the said specification because it comprises less than the total meat included in any one definition or comprises meat included in more than one definition, the maximum retail price per pound of such joint or cut shall be computed on the basis that the joint or cut comprises the kind, description, and grade of meat included in the definition of which the joint or cut forms part or to which the greater part of such joint or cut conforms.

RETAILERS TO EXHIBIT PRICE ORDERS AND TICKET MEAT

7. (1) It shall be the duty of every retailer whose business includes the selling of any meat to which this price order relates to keep a copy of the price order or a statement of the retail prices fixed thereby in respect of such meat prominently displayed in his shop in such a position that customers may examine the price order or statement without having to ask for its production or without having to obtain permission to examine it.

(2) Every retailer who offers or exposes for sale any joints or cuts of meat to which this order applies shall affix to each joint or cut a ticket, placard, or label on which the total retail price of the joint or cut shall be stated in legible and prominent characters.

of the joint or cut shall be stated in legible and prominent characters. (3) In the case of any meat to which this order applies which, in accordance with the customary practice within the trade, is offered or exposed for sale otherwise than by the joint or cut, the retailer shall affix to or keep in a prominent position in such proximity to the meat to which it relates as to be obviously in relation thereto a ticket, placard, or label showing in legible and prominent characters the retail price per pound or, where in accordance with the customary practice within the trade the meat is offered or exposed for sale otherwise than by weight, the price per unit. per unit.

(4) In any case where meat to which this order applies is not readily identifiable with the description thereof set out in the price order displayed, the retailer shall affix to the meat a ticket, placard, or label giving a description so that it is readily identifiable with the description set out in the price order.

(a) For "First" grade, the price of 27.699d. per pound:
(b) For "Second" grade, the price of 27.199d. per pound:

3. In the case of New Zealand waxed cheddar cheese to which is assigned one or other of the following respective grades and which is allotted points in grading within the range of the following respective grade points under the said regulations-

(a) For "Finest" grade, 94 points or over, the price of 19.702d. per pound:

(b) For "Finest" grade, ¹93 points or over but under 94 points, the price of 19.452d. per pound:

(c) For "First" grade, 92 points or over but under 93 points, the basic price of 18.452d. per pound:

(d) For "First" grade, 91 points or over but under 92 points, the price of 18.202d. per pound:

(e) For "Graded", 88 points or over but under 91 points, the price of 17 202d. per pound:

(f) For "Seconds", 87 points and under, the price of 14 702d. per pound.

4. In the appropriate cases there shall be deducted from the prices fixed in paragraph 3 hereof the following amounts where cheese finish points have been deducted in the Grader's Certificate:

- $\frac{1}{2}$ point deduction 1s. 8d. per crate. 1 point deduction 2s. 6d. per crate. 1 $\frac{1}{2}$ points deduction 4s. 2d. per crate. 2 points deduction 6s. 8d. per crate. 2 $\frac{1}{2}$ points deduction 10s. per crate.

5. In the appropriate cases the following amounts shall be added to or deducted from the prices fixed in paragraph \mathcal{F} hereof where cheese has been classified by the Department of Agriculture in respect of cheese sediment test:

Classification A – an addition of 0.125d. per pound. Classification B – no alteration. Classification C – a deduction of 0.0625d. per pound. Classification D – a deduction of 0.125d. per pound.

6. Butter shall be packed in boxes each containing a net weight of 56 lb 2 oz of actual butter, excluding wrapping paper. Cheese shall be packed two cheeses to each crate. Every cheese shall weigh not less than 70 lb and not more than 90 lb.

7. In computing the weight of butter for which payment is to be made by the Commission the weight of all butter com-prised in any consignment submitted for grading under the said regulations shall be ascertained as follows:

- (a) Each box of butter containing a net weight of 56 lb 2 oz of actual butter, excluding wrapping paper, shall, subject as hereinafter provided, be computed at 56 lb:
- (b) The weight of all butter in any such consignment shall be determined on the basis of the weight as ascertained by the grader of the several boxes selected by him for weighing and set out in the Grader's Certificate issued in respect of that consignment, and the boxes of butter so weighed shall be taken as fixing the average weight for the whole quantity of butter comprised in such certificate, overweights being averaged with underweights in each such certificate in relation to the prescribed weight of 56 lb 2 oz per box; per box:
- (c) If the average weight ascertained as aforesaid of the butter comprised in any Grader's Certificate be less than 56 lb 2 oz per box, such deficiency shall be deducted from a weight of 56 lb per box for the purpose of computing payment therefor:
- (d) If the average weight ascertained as aforesaid of the butter comprised in any Grader's Certificate exceeds the prescribed weight of 56 lb 2 oz per box, then the amount of such excess shall not be taken into account for the purpose of computing payment therefor therefor.

8. In computing the weight of cheese for which payment is to be made by the Commission, the weight of all cheese com-prised in any consignment submitted for grading under the said regulations shall be ascertained as follows:

- (a) The weight of all cheese in any such consignment shall be determined on the basis of the weight as ascertained by the grader of several crates of cheese selected by him for weighing and set out in the Grader's Certificate issued in respect of that consignment, and the crates of cheese so weighed shall be taken as fixing the average weight for the whole quantity of cheese comprised in such certificate, overweights being averaged with underweights in relation to the respective packed weights as set out in such certificate: certificate :
- (b) If the average weight ascertained as aforesaid of the crates of cheese comprised in any Grader's Certificate be less than the average of the marked weights thereof as set out in such certificate, then payment shall be made for the cheese comprised in that certificate on the basis of the average weight so ascertained. tained:

- (c) If the average weight ascertained as aforesaid of the crates of cheese comprised in any Grader's Certificate exceeds the average of the marked weights thereof as set out in such certificate, then the amount of such excess shall not be taken into account for the purpose of computing payment therefor:
 (d) From the total weight computed as aforesaid of the cheese comprised in any Grader's Certificate there shall be deducted by way of shrinkage allowance such amount in respect of any particular brand or class of cheese as the Commission may from time to time determine. to time determine.

The price to be paid by the Commission for unwaxed cheese shall be the appropriate price payable for waxed cheese as hereinbefore provided reduced by such amount as corre-sponds with the reduced costs incurred in the manufacture of such unwaxed cheese and the allowance for loss in weight due to shrinkage. The reduction referred to in this paragraph shall be computed by the Commission and the computation of the Commission shall be final.
