No person shall introduce into the sanctury or liberate or allow to go at large within the sanctuary any living creature, or the eggs or spawn or any living creature, except pursuant to a written authority in that behalf issued by the Secretary for Internal Affairs and subject to such conditions

4. No person shall introduce or plant in the sanctuary any vegetation of any description or the seeds or spores of any vegetation, and no person shall burn or clear by any means whatsoever any vegetation except pursuant to a written authority in that behalf issued by the Director-General of Forests and subject to such conditions as may be specified in such authority. such authority.
