*Proposed Boundaries of the Electoral Districts in the North Island and the South Island of New Zealand*

THE Representation Commission appointed in pursuance of section 15 of the Electoral Act 1956 hereby publishes, in accordance with the provisions of section 18 of the said Act, the proposed boundaries of the electoral districts in the North and South Islands of New Zealand; and, further, gives notice that written objections to the same will be received by the undersigned, the Chairman of the Commission, at the office of the Surveyor-General, Government Buildings, Wellington, not later than noon on Tuesday, the 17th day of April 1962, for consideration by the aforesaid Commission.

Maps of the proposed districts may be seen at the office of any city or borough council, county council, town board, or road board; of the Chief Surveyor at Auckland, New Plymouth, Gisborne, Napier, Wellington, Blenheim, Nelson, Hokitika, Christchurch, Dunedin, and Invercargill; of the Chief Electoral Officer at Wellington; and of the Registrars of Electors throughout the Dominion.

Counties, ridings, cities, boroughs, and town districts where mentioned in this notice shall, unless otherwise stated, be as existing on 18 April 1961.

## HOBSON

All that area being the present Electoral District of Hobson, the Otonga Riding of the County of Whangarei, and that portion of Mangakahia Riding of the County of Whangarei bounded towards the north-east generally by a line commencing at a point on the northern boundary of the Whangarei County in Block IV, Tutamoe Survey District, in the middle of the Mangakahia River; thence south-easterly up the middle of that river and the Opouteke River to the middle of the Kaikohe-Maungatapere road, along that road to and along the Parakao-Kirikopuni road to the southern boundary of the County of Whangarei on the southern boundary of Block X, Maungakahia Survey District.

## MARSDEN

All that area being the present Electoral District of Marsden excluding the Otonga Riding of the County of Whangarei and that portion of Mangakahia Riding of the County of Whangarei included in the Electoral District of Hobson hereinbefore described.

## RODNEY

All that area comprising the Counties of Otamatea and Rodney, the Borough of Helensville, the Town District of Warkworth, and that portion of the County of Waitemata bounded by a line commencing at the intersection of the eastern boundary of the County of Waitemata and the production of a line on the north-west side of Sunset Road 250 links from and parallel to that road; thence south-westerly along right lines parallel to and distant 250 links from Sunset and Glendhu Roads, to and along the western boundary of Lot 26, D.P. 2093, to Hellyers Creek, being a point on the boundary of the County of Waitemata; thence South-westerly generally along the boundary of the said county to a point in line with the middle of Luckens Road; thence westerly generally to and along the middle of that road, Hobsonville Road, No. 16 Provincial State Highway, Red Hills Road, Sunnyvale Road, McEntees Road, the Henderson-Swanson-Kumeu road, to a point on the boundary of Waitakere Riding of the County of Waitemata and south-westerly along that boundary to the sea coast, being a point on the boundary of the County of Waitemata; thence northerly, easterly, and southerly generally along the boundaries of that county to the point of commencement; and including Herald Island, Little Barrier Island, Kawau and Motuketekete Islands, and other adjacent islands.

## WAITEMATA

All that area comprising the Boroughs of East Coast Bays, Northcote, and Birkenhead, that portion of the Borough of Takapuna not included in the Electoral District of North Shore hereinafter described, and that portion of the Birkenhead Riding of the County of Waitemata not included in the Electoral District of Rodney hereinbefore described.

## NORTH SHORE

All that area comprising the Borough of Devonport and that portion of the Borough of Takapuna lying to the south-east of a line commencing at a point on the western boundary of the said Borough of Takapuna, being the middle line of Marsh Avenue, and proceeding generally north-easterly along the middle of Marsh Avenue, East Coast Road, Castor Bay Road, Seaview Road, Marama Street, Rahopara Street and its production to the sea coast.

## WAITAKERE

All that area comprising the Borough of Henderson and part of the County of Waitemata bounded by a line commencing at a point on the sea coast on the southern boundary of the Waitakere Riding of that county, being also a point on the southern boundary of the Rodney Electoral District hereinbefore described; thence north-easterly along the south-eastern boundary of that electoral district to a point on the shore of the Waitemata Harbour in line with the middle of Luckens Road; thence southerly along the shore of Waitemata Harbour to the boundary of the Borough of New Lynn; thence southerly along the western boundary of that borough to the northern boundary of the Borough of Glen Eden; thence westerly, southerly, and easterly along the boundaries of that borough to the eastern boundary of Waikomete Riding of the County of Waitemata; thence southerly generally along that boundary to and along the middle of the Waitakere Scenic Drive to a point in line with the northern side of Waima Road; thence along the northern side of that road to a point in line with the western boundary of part Allotment 27, Waikomiti Parish, D.P. 18839; thence to and along the western and southern boundaries of the said Allotment 27 and the western and southern boundaries of part Allotment 28, Waikomiti Parish, D.P. 22152, to and along the south-western boundary of part Allotment 44, Waikomiti Parish, in certificate of title 772/148, to and along the north-western side of the Huia Road to the southern boundary of part Allotment 25, Waikomiti Parish, D.P. 26305; thence across the aforesaid road and along the boundary of part Allotment 25 aforesaid to and along the western boundaries of part Allotment 24 and Allotment 39, Waikomiti Parish, D.P. 1988, to the shore of Manukau Harbour; thence generally south-westerly along the shore of Manukau Harbour and northerly along the sea coast to the point of commencement, and including all wharves and extensions seaward.

## NEW LYNN

All that area comprising the Boroughs of Glen Eden and New Lynn, also that portion of the City of Auckland westwards of a line commencing at a point on the boundary of the City of Auckland at the intersection of the shore of Waitemata Harbour and the middle line of Saltaire Street produced and proceeding easterly and southerly generally to and along the middle of Saltaire Street, Great North Road, Blockhouse Bay Road, Holbrook Street, Hertford Street, Margate Road, Whitney Street, and Donovan Street to a point in line with the eastern boundary of Lot 30, Allotment 75, Titirangi Parish; thence to and along that boundary to the boundary of the City of Auckland; also that portion of the Titirangi Riding of the County of Waitemata bounded towards the north and east by the Boroughs of Glen Eden and New Lynn and the City of Auckland, towards the south generally by the Manukau Harbour, and towards the west by the eastern boundary of the Electoral District of Waitakere hereinbefore described.

## AUCKLAND CENTRAL

All that area bounded by a line commencing at a point on the shore of Hobson Bay in line with the middle of Tohunga Crescent; thence generally south-westerly to and along the middle of Tohunga Crescent, to and along the north-western boundaries of Lot 7, D.P. 9448, and Lot 18, D.P. 2032, across Brighton Road, to and along the middle of Kenderdine Lane, to and along the south-eastern and south-western boundaries of Lot 1, D.P. 26703, to and along the southern boundary of Lot 3, D.P. 36074, and along that boundary produced to and along the middle of Cathedral Place, Parnell Road, and Broadway to a point in line with the middle of Carlton Gore Road, being the north-eastern corner of the Electoral District of Eden hereinafter described; thence generally westerly along the northern boundary of the said Electoral District of Eden, to and generally northerly along the eastern boundary of the Electoral District of Westmere hereinafter described, to and generally easterly along the southern shore of the Waitemata Harbour, and including all wharves and extensions seaward, to a point on the northern side of Tamaki Drive opposite Point Resolution; thence southerly along a right line to and along the western shore of Hobson Bay to the point of commencement, and including the islands of Tiritiri, Rangitoto, Motutapu, Rakino, Motuihe, Browns, Waiheke, Ponui, Pakihi, Rotoroa, Pakatoa, and other adjacent islands, and the Kermadec Islands.

## WESTMERE

All that area bounded by a line commencing at a point on the shore of Waitemata Harbour in the middle of Curran Street; thence southerly generally along the middle of that street, Jervis Road, John Street, Richmond Road, Brown Street, Fitzroy Street, Richmond Road, Leighton Street, Turakina Street, Great North Road, Brisbane Street and its production to the boundary of the City of Auckland; thence westerly generally along that boundary to a point on the Oakley Stream in line with the southern boundary of Lot 2 of a subdivision of Allotment 62, Titirangi Parish; thence westerly generally along the southern boundary of the said Lot 2 to the middle of Great North Road; thence along the middle of that road to and along the middle of Saltaire Street and its production to the shore of Waitemata Harbour; thence north-easterly generally along the shore of Waitemata Harbour to the point of commencement.

## MOUNT ALBERT

All that area comprising the Borough of Mount Albert, that portion of the Borough of Mount Roskill generally northward of a line commencing at a point on the boundary of that borough in line with the middle of Waite Avenue; thence along the middle of that avenue, Gifford Avenue, Sandringham Road Extension, and Stoddard Road to the western boundary of the Borough of Mount Roskill, and part of the City of Auckland bounded by a line commencing at a point on the boundary of the City of Auckland in the middle of Oakley Stream in line with the south-eastern boundary of Lot 20 of a subdivision of Allotment 65, Titirangi Parish; thence to and along the south-eastern boundaries of Lots 20, 19, 18, 17, 16, 15, 14, 11, and 10, and the south-western boundaries of Lots 10 and 9, the said lots being of a subdivision of Allotment 65, Titirangi Parish, and the production of the last-mentioned boundary to the middle of Blockhouse Bay Road; thence northerly along the middle of Blockhouse Bay Road and Great North Road to a point in line with the production of the southern boundary of Lot 2 of a subdivision of Allotment 62, Titirangi Parish; thence easterly along the southern boundary of the said Lot 2 to Oakley Stream, being a point on the boundary of the Borough of Mount Albert; thence southerly generally along the boundaries of the aforesaid Borough of Mount Albert to the point of commencement.

## EDEN

All that area bounded by a line commencing at a point in the middle of Newton Road in line with the south-eastern boundary of Allotment 12, Section 7, Suburbs of Auckland; thence to and along the south-eastern boundaries of Allotments 12, 13, and 14, Section 7, Suburbs of Auckland, to the northernmost corner of Allotment 10, Section 5, Suburbs of Auckland; thence south-easterly along the north-eastern boundary of the said Allotment 10 to New North Road, across that road to and along the eastern side of Dominion Road to the westernmost corner of Allotment 2F, Section 10, Suburbs of Auckland, being a point on the boundary of the Borough of Mount Eden; thence southerly and easterly generally along the boundaries of that borough to the northern side of Landscape Road, being a point on the boundary of the City of Auckland; thence easterly and northerly generally along the boundary of the City of Auckland to the western side of Broadway; thence northerly along the western side of Broadway to the northern side of Mortimer Pass; thence easterly generally along the production of the northern side of Mortimer Pass to a point distant 278 links from Broadway; thence northerly along a right line parallel to Broadway to a point in line with the south-western boundary of part Allotment 24, Section 4, Suburbs of Auckland, comprised in certificate of title, Volume 75, folio 256, Auckland Registry; thence along the production of the south-western boundary of the said part Allotment 24 to the south-eastern boundary of the said part Allotment 24; thence along the south-eastern boundary of the said part Allotment 24 and the south-western boundary of Allotment 23, Section 4, Suburbs of Auckland, to the centre line of the railway; thence northerly along the middle of that railway to and along the middle of Broadway to a point in line with the middle of Carlton Gore Road, to and along the middle of that road, Grafton Road, Khyber Pass Road, Symonds Street, and Newton Road to the point of commencement.

## ROSKILL

All that area comprising portions of the City of Auckland and the Borough of Mount Roskill bounded by a line commencing at a point in the middle of Pah Road on the boundary of the Borough of One Tree Hill; thence southerly along the middle of Pah Road to and westerly along the middle of Mount Albert Road to a point in line with the production of the western boundary of Lot 5 of a subdivision of Allotments 3 and 5 of Section 13, Suburbs of Auckland; thence southerly generally along the western and southern boundaries of the said Lot 5, the southern boundary of Lot 9, of a subdivision of Allotment 3 of Section 13, Suburbs of Auckland, to the north-western corner of Lot 10 of a subdivision of Allotments 3 and 4 of Section 13, Suburbs of Auckland; thence along the western boundary of the said Lot 10 and its production to and along the northern and western boundaries of Lot 13 of a subdivision of Allotments 2 and 4 of Section 13, Suburbs of Auckland, the western boundaries of Lots 14 and 15 of a subdivision of Allotments 2 and 4 of Section 13, Suburbs of Auckland, and Lots 19 and 20 of a subdivision of Allotment 4 of Section 13, Suburbs of Auckland, to and along the north-eastern boundary of Lot 7, the north-eastern and north-western boundaries of Lot 8, both lots being of Block XII of a subdivision of Allotment 8 of Section 13, Suburbs of Auckland, to and across Carlton Street to and along the eastern boundary of Lot 9 of Block XII of a subdivision of Allotment 8 of Section 13, Suburbs of Auckland (being a recreation reserve), the western boundaries of Lots 8 and 7 of Block XIII of a subdivision of Allotment 8 of Section 13, Suburbs of Auckland, and the production of the western boundary of the said Lot 7 to the middle of Belfast Road; thence along the middle of Belfast Road and Frederick Street to the shore of Manukau Harbour; thence westerly along the shore of Manukau Harbour to the south-eastern corner of Lot 30 of a subdivision of Allotment 75, Titirangi Parish; thence northerly generally along the eastern boundary of that lot and its production to the middle of Donovan Road; thence along the

middle of that road, Whitney Street, Margate Road, Hertford Street, Holbrook Street, and Blockhouse Bay Road to a point in line with the south-western boundary of Lot 9 of a subdivision of Allotment 65, Titirangi Parish; thence easterly generally along the boundaries of the Electoral Districts of Mount Albert and Eden as hereinbefore described to the point of commencement.

#### REMUERA

All that area bounded by a line commencing at a point on the northern side of Tamaki Drive opposite Point Resolution and proceeding generally south-easterly and south-westerly along the boundaries of the present Electoral District of Remuera to the eastern side of Manukau Road; thence southerly along the eastern side of that road to its intersection with the northern side of Campbell Road; thence along a right line to the intersection of the southern side of Mount Albert Road with the production of the south-eastern side of Campbell Road; thence westerly along the southern side of Mount Albert Road to the middle of Pah Road; thence northerly along the middle of that road to a point in line with the northern boundary of Allotment 13, Section 10, Suburbs of Auckland; thence westerly along a right line to the intersection of that boundary and the west side of Manukau Road, being a point on the eastern boundary of the Electoral District of Eden, hereinbefore described; thence northerly generally along that boundary and the eastern boundary of the Electoral District of Auckland Central hereinbefore described to the point of commencement.

#### TAMAKI

All that area comprising that portion of the City of Auckland bounded by a line commencing at a point on the left bank of Tamaki River and the middle of Point England Road; thence westerly along the middle of Point England Road; southerly along the middle of Riverside Avenue, westerly along the middle of Anderson Avenue, northerly along the middle of Pilkington Road, westerly along the middle of Point England Road to the Auckland-Westfield Loop Railway; thence north-westerly generally along the north-eastern side of the said railway to Purewa Creek, down the right bank of Purewa Creek and along the shore of Hobson Bay to and across Tamaki Drive at Hobson Point; thence easterly and southerly generally along the shore of Waitemata Harbour and the left bank of the Tamaki River to the point of commencement, and including all wharves and extensions seaward.

#### ONEHUNGA

All that area comprising the Boroughs of Onehunga and Ellerslie and portions of the Boroughs of Mount Roskill, One Tree Hill, and Mount Wellington, bounded by a line commencing at a point on the shore of Manukau Harbour in the middle of Frederick Street; thence northerly generally along the boundary of the Electoral District of Roskill hereinbefore described to the intersection of Mount Albert Road and Pah Road; thence easterly along the middle of Mount Albert Road to a point in line with the north-western boundary of Allotment 3, Section 13, Suburbs of Auckland; thence southerly to the north-eastern corner of the said Allotment 3, being a point on the boundary of the Borough of Onehunga; thence easterly generally along the northern boundary of the said borough to and along the south-eastern side of Campbell Road to Great South Road; thence along a right line to a point on the line between Standard Survey Blocks M. 753 (Great South Road) and M. 752 (Wairakei Street) and distant 113 links from the first-mentioned standard, the said point being on the boundary of the City of Auckland; thence easterly generally along the boundary of the City of Auckland to the middle of Gollan Road; thence southerly generally along the middle of that road and the middle of Harding Avenue, Marua Road, Burt Road, Ellerslie-Panmure road, Ferndale Road, Panorama Road, Penrose Road, Mount Wellington Road, and Waipuna Road to a point in the middle of the Auckland-Westfield Loop Railway; thence south-westerly generally along that railway and across No. 1 National State Highway to the boundary of the Borough of Mount Wellington; thence north-westerly along the boundary of that borough to its junction with the boundary of the Borough of One Tree Hill; thence westerly generally along the southern boundaries of the Boroughs of One Tree Hill and Onehunga to the point of commencement.

#### PAKURANGA

All that area comprising the Borough of Howick, those portions of the City of Auckland, the Boroughs of Mount Wellington and Otahuhu, and the Pakuranga Riding of the County of Manukau bounded by a line commencing at a point on the left bank of the Tamaki River in the middle of Point England Road; thence westerly and southerly generally along the boundaries of the Electoral Districts of Tamaki, Remuera, and Onehunga hereinbefore described to a point on the south-eastern side of Great South Road on the boundary of the Borough of Mount Wellington; thence southerly along the middle of the Auckland-Westfield Loop Railway to the boundary of the Borough of Mount Wellington; thence southerly and easterly along that boundary to the middle of Great South Road; thence generally south-easterly along the middle of Great South Road to the right bank of the Tamaki River, being a point on the boundary of the

County of Manukau; thence north-easterly generally along the boundary of the said county to the southern boundary of Pakuranga Riding of the County of Manukau; thence easterly and northerly along the boundary of the said Riding to the mouth of Maungamaungaroa Creek; thence north-westerly to and along the shore of Hauraki Gulf to Musick Point; thence southerly generally along the line of mean high-water mark on the right bank of the Tamaki River to a point in line with the middle of Point England Road in the Borough of Mount Wellington; thence across the Tamaki River to the point of commencement.

#### MANUKAU

All that area comprising the Mangere Riding of the County of Manukau, that portion of the Borough of Otahuhu lying generally south-west of the Great South Road, and that portion of the Borough of Papatoetoe lying to the north-west of a line commencing at a point in the middle of Tui Road on the eastern boundary of the said borough; thence proceeding westerly along the middle of Tui Road to a point in line with the south-eastern boundary of Papatoetoe High School; thence south-westerly generally to and along the south-eastern boundary of the said school, to and across Great South Road, to and along the middle of Allenby Road, York Road, and Puhirui Road to the generally southern boundary of the said Borough of Papatoetoe.

#### MANUREWA

All that area comprising the Turanga, Papakura, and Papatoetoe Ridings of the County of Manukau, the Boroughs of Papakura and Manurewa, and that portion of the Borough of Papatoetoe not included in the Electoral District of Manukau hereinbefore described.

#### FRANKLIN

All that area comprising the Boroughs of Pukekohe, Tuakau, and Waiuku, the County of Franklin, the Wairoa Riding of the County of Manukau, the Port Waikato, Onehero, and Pukekawa Ridings of the County of Raglan, and the Maramarua Riding of the County of Waikato.

#### RAGLAN

All that area bounded by a line commencing at a point being the intersection of the sea coast and the south-eastern boundary of the Electoral District of Franklin hereinbefore described; thence north-easterly generally along that boundary to the western boundary of the Electoral District of Hauraki hereinafter described; thence southerly generally along that boundary and the western boundary of the Electoral District of Piako hereinafter described to the northern boundary of the Electoral District of Waipa hereinafter described; thence westerly generally along that boundary to and along the eastern and northern boundaries of the Electoral District of Hamilton hereinafter described, to and along the northern boundary of the aforesaid Electoral District of Waipa hereinafter described to the shore of Raglan Harbour; thence westerly generally along the northern shores of that harbour and northerly along the sea coast to the point of commencement.

#### HAURAKI

All that area comprising the present Electoral District of Hauraki including that portion of the Waitoa Riding of the County of Piako bounded on the north-east and north-west by the aforesaid Electoral District of Hauraki, on the south-west by the Waiharakeke Stream, and on the south-east generally by the Waihongi Block, Mangatarata Road, and No. 2 Road and also that portion of the Morrinsville Riding of the County of Piako lying generally to the north of a line commencing at the junction of the Waiharakeke and the Mangahaumia Streams and proceeding southerly along the Mangahaumia Stream to and along the southern boundary of Lot 2, D.P. 18319, to and along the middle of Taukoro Road, across Ngatea Road; thence to and westerly generally along the middle of Hangawera Road and Tauhei Motumaoho Road to a point in line with the southern boundary of part Lot 4, D.P. 12470, Hangawera Block; thence to and along that boundary and the southern boundary of Lot 2, D.P. 13235, Hangawera Block, to its south-westernmost corner, being a point on the western boundary of the County of Piako.

#### WAIPA

All that area comprising the Boroughs of Cambridge and Te Awamutu, the Karioi, Whaingaroa, Karamu, and Pirongia Ridings of the County of Raglan, the Tuhikaramea, Rukuhia, Kaipaki, Mangapiko, Pukekura, and Rangiaohia Ridings of the County of Waipa, that portion of the Newcastle Riding of the County of Waipa south of No. 23 Provincial State Highway, that portion of the Kakepuku Riding of that county north-west of a line commencing at a point on the southern boundary of that county in the middle of the Te Awamutu-Bartons Corner road; thence along the middle of that road and Puniu Road to a point in the middle of Puniu Road on the boundary of the Borough of Te Awamutu, and that portion of the Cambridge Riding of the County of Waikato lying to the north-west of a line commencing at the intersection of the Mangaomahu Stream and Pickerings Road and proceeding westerly along the middle of that road, south-easterly along the middle of No. 1 National State Highway, and south-westerly along the middle of Saville Road and its production to the middle of the Waikato River.

## HAMILTON

All that portion of the City of Hamilton bounded by a line commencing at a point in the middle of the Waikato River on the production of the north-western boundary of part Lot 1, D.P. 14466, part Allotment 255, Kirikiriroa Parish, and proceeding down the middle of the Waikato River to a point in line with the northern boundary of Lot 86, D.P. 17643 (recreation reserve); thence westerly generally to and along that boundary and the northern boundaries of Lots 3, 4, 5, 6, and 9, D.P. S. 355, to and across Horne Street, and along the northern boundary of that street, and the northern boundary of Lots 25 and 1, D.P. 17643, produced to the middle of Pembroke Street; thence northerly along the middle of that street to a point in line with the middle of Ruakiwi Street; thence westerly along a right line to a point in the middle of the southern boundary of Domain Drive; thence north-easterly generally along the middle of the said Domain Drive produced to the middle of Lake Road; thence north-westerly generally along the middle of Lake Road, Hall Street, and Norton Road to a point in line with the eastern boundary of Lot 21, D.P. S. 5272; thence northerly to and along that boundary and the eastern boundaries of Lot 10, D.P. 26311, Lots 19, 18, 17, 16, 15, and 14, D.P. S. 330; Lots 13 and 12, D.P. S. 5273, and Lot 19, D.P. 26311, produced to the middle of Waitawhiriwhiri Stream; thence westerly along the middle of that stream, to and northerly along the middle of Roach Street, to and westerly along the middle of Rimu Street, to and north-easterly along the middle of Forest Lake Road, to and north-westerly along Mitcham Avenue to a point in line with the north-western boundary of Lot 1, D.P. S. 6605; thence along a right line to the north-western corner of the said Lot 1; thence north-westerly along the north-eastern boundary of Railway land (part Proclamation 12307), as shown on S.O. Plan 36642, and its production to the boundary of the City of Hamilton; thence easterly and southerly generally along the boundary of the City of Hamilton to the point of commencement.

## PIAKO

All that area comprising the Boroughs of Te Aroha, Morrinsville, and Matamata, that portion of the County of Piko not included in the Electoral District of Hauraki hereinbefore described, the Tamahere Riding of the County of Waikato, that portion of the Ruakura Riding of that county not included in the Electoral District of Raglan hereinbefore described, that portion of the Cambridge Riding of the said County of Waikato not included in the Electoral District of Waipa hereinbefore described, the Lake Karapiro, Peria, Waharoa, Matamata, and Te Poi Ridings of the County of Matamata, and that portion of the Hinuera Riding of that county lying to the east of a line commencing at Okoroire Railway Station and proceeding northerly generally along the middle of No. 27 Provincial State Highway and No. 29 Provincial State Highway, across the Rotorua Branch Railway to and down the Mangawhara Stream to the northern boundary of the aforesaid Hinuera Riding.

## TAUPO

All that area comprising the Boroughs of Putaruru and Taupo, the Tirau, Okoroire, Lichfield, Putaruru, Tokoroa, and Maungaiti Ridings of the County of Matamata, the Pouakani, Tauhara, Rangitoto, and Tongariro Ridings of the County of Taupo; that portion of the Hinuera Riding of the County of Matamata not included in the Electoral District of Piko hereinbefore described, that portion of the Tatua Riding of the County of Taupo not included in the Electoral District of Rotorua hereinafter described, and including Lake Taupo.

## TAURANGA

All that area comprising the Boroughs of Tauranga and Mount Maunganui, the Katikati, Katikati Town, Te Puna, Greerton and Waimapu Ridings of the County of Tauranga, and that portion of the Te Puke Riding of that county lying north-west of a line commencing at a point on the sea coast in the middle of the road between Sections 15 and 16, Block I, Te Tumu Survey District, and proceeding southerly generally along the middle of that road, Papamoa Beach Road, No. 2 National State Highway, Reids Road, Upper Papamoa Road, and Waitao Road to a point in line with the northern boundaries of Lots 1 and 2, D.P. 32121, to and along those boundaries to the western boundary of the said Te Puke Riding.

## ROTORUA

All that area comprising the Borough of Rotorua, the Town District of Murupara, the County of Rotorua, those portions of the Urewera and Galatea Ridings of the County of Whakatane not included in the Bay of Plenty Electoral District hereinafter described, that portion of the Kaingaroa Riding of the County of Taupo lying to the north of a line commencing at the easternmost corner of Tauhara South A Block and proceeding along a right line to the intersection of the middle of the No. 5 National State Highway with the middle of the Rangitaiki River, along a right line in the direction of Te Taumutu Trig. Station to the middle of the road forming the north-western boundary of Section 2, Block XIV, Heruwi Survey District, and that portion of the Tatua Riding of the County of Taupo lying to the east of a line along the middle of No. 5 National State Highway, the middle of the Orakei-Korako road, to and along the north-western boundary of Tutukau East A.

## BAY OF PLENTY

All that area comprising the Boroughs of Te Puke, Kawerau, Whakatane, and Opotiki, the Counties of Mata-kaoa and Opotiki, the Motu Riding of the County of Waikohu, the Matata, Tarawera, Rangitaiki, Omataroa, Taneatua, Ohope, and Waimana Ridings of the County of Whakatane, the Maketu Riding of the County of Tauranga, that portion of the Te Puke Riding of the County of Tauranga not included in the Tauranga Electoral District hereinbefore described, that portion of the Galatea Riding of the County of Whakatane lying to the north of the southern boundaries of Rangitaiki Lower and Ruawahia Survey Districts, and that portion of the Urewera Riding of the said County of Whakatane lying to the north of the southern boundaries of the Urewera and Galatea Survey Districts.

## WAITOMO

All that area comprising the Boroughs of Otorohanga and Te Kuiti, the Town District of Ohura, the Counties of Otorohanga and Waitomo, the Waimiha, Ongarue, Taringamotu, Nihoniho, and Tokirima Ridings of the County of Taumarunui, the Orakau Riding of the County of Waipa, that portion of the Otunui Riding of the County of Taumarunui north-west of the Wanganui River, that portion of the Hunua Riding of the County of Taumarunui north of No. 41 Provincial State Highway, and that portion of the Kakepuku Riding of the County of Waipa excluded from the Electoral District of Waipa hereinbefore described.

## GISBORNE

All that area comprising the present Electoral District of Gisborne and the County of Waipau.

## STRATFORD

All that area comprising the Boroughs of Stratford, Inglewood, and Waitara, the Counties of Clifton, Stratford, and Inglewood, and that part of the County of Taranaki not included in the Electoral District of New Plymouth hereinbefore described.

## NEW PLYMOUTH

All that area comprising the City of New Plymouth together with that portion of the Waitara West Riding of the County of Taranaki lying to the west of a line commencing in the middle of Fitzroy Road on the left bank of the Waiwakaiho River; thence southerly across that river to and along the middle of Smart Road to a point in line with the north-western boundary of Lot 4, D.P. 4244; thence south-westerly generally to and along that boundary, the south-western boundaries of Lot 4, D.P. 4244, and Lots 78 and 79, D.P. 1055, the north-western boundaries of Lot 66, D.P. 1055, the north-eastern side of Queens Road to a point in line with the north-western boundary of Lot 1, D.P. 8588; thence along a right line across Queens Road to and along the north-western boundary of the said Lot 1, D.P. 8588, to and across the Waiwakaiho River to the boundary of the Borough of New Plymouth.

## EGMONT

All that area comprising the present Electoral District of Egmont together with the Borough of Patea and that part of the Otoia Riding of the County of Patea excluded from the Waimarino Electoral District hereinafter described.

## WAIMARINO

All that area comprising the Boroughs of Taumarunui, Raetihi, and Ohakune, the Town Districts of Waverley and Manunui, the Counties of Wanganui, Waitotara, and Waimarino, the County of Patea excepting that portion of the Otoia Riding lying generally to the west of a line commencing at a point on the north-western boundary of the Borough of Patea at its intersection with the right bank of the Patea River; thence along a right line to the middle of the Patea River; thence up the middle of that river to and up the middle of the Ngakotana Stream and the Tenganawhakaruru Stream to its intersection with the north-eastern boundary of Section 571, Patea District thence along that boundary and the north-western boundary of the said section to the middle of the abutment of Clifford Road; thence northerly along the middle of that road and its production across Ball Road to the middle of Makino Stream; thence down the middle of that stream to its confluence with Ingahape Stream, being a point on the boundary of the County of Patea; also the Kuratau, Pungapunga, Owango, and Kaitieke Ridings of the County of Taumarunui, those parts of the Hunua and Otunui Ridings of the County of Taumarunui excluded from the Waitomo Electoral District hereinbefore described, those portions of the City of Wanganui not included in the Wanganui Electoral District hereinafter described, the Rangitoto, Otakapu, and Whangaehu Ridings of the County of Rangitikei, and those portions of the Erewhon and Ruanui Ridings of the County of Rangitikei excluded from the Rangitikei Electoral District hereinafter described.

## WANGANUI

All that area being the present Electoral District of Wanganui together with that part of the City of Wanganui bounded by a line commencing at the south-western corner of part Lot 7A, D.P. 2139, and proceeding generally westerly along the city boundary to the middle of Mosston Road; thence southerly along the middle of that road and its production to the right bank of the Wanganui River; thence easterly along that right bank to the western boundary of the present Electoral District of Wanganui; thence north-westerly generally along that boundary to the point of commencement.

## RANGITIKEI

All that area comprising the Boroughs of Marton, Taihape, and Feilding, the Town Districts of Hunterville and Manga-weka, the Counties of Kiwitea and Pohangina, the Western Riding of the County of Oroua, the Sandon, Mount Stewart, and Waitohi Ridings of the County of Manawatu, the County of Rangitikei, excepting the Otakapu, Whangaehu, and Rangitoto Ridings, and those portions of Ranui and Erewhon Ridings bounded by a line commencing at Trig. Station 28 (Manukaiapu) in Block XVI, Kaimanawa Survey District, being a point on the boundary of the Rangitikei County; thence proceeding westerly and southerly along that county boundary to the northern boundary of Raketapauma No. 11 2 Block; thence easterly along the production of that boundary to the middle of the Hautapu Stream; thence down the middle of that stream to and up the middle of Kaitapu Creek to and along the middle of Waipuna Road to a point in line with the western boundary of Section 5, Block XV, Moawhango Survey District; thence northerly to and along that boundary and the western and northern boundaries of Rangipo Waiu B 4 Block to its intersection with a right line between Trig. Station Kauaekeke in Block XV, Moawhango Survey District, and Trig. Station Auahitotara in Block XI, Moawhango Survey District; thence northerly along that right line to Trig. Station Auahitotara, a right line to Trig. Station Te Rotete, and a right line to the point of commencement.

## HAWKE'S BAY

All that area comprising the Boroughs of Waipawa, Wairoa, and Waipukurau, the Wairoa County, that part of the County of Taupo not included in the Electoral Districts of Taupo and Rotorua hereinbefore described, the County of Hawke's Bay, excepting those parts included in the Electoral Districts of Napier and Hastings hereinafter described, the County of Patangata excepting the Eparaima and Porangahau Ridings, the County of Waipukurau, excepting the Purima Riding, the Waipawa Riding and that part of the Onga Riding of the County of Waipawa lying generally to the east of a line commencing at a point in the middle of the Tuki Tuki River in line with the western boundary of Section 3, Waipukurau Crown Grant District; thence to and along that boundary and its production to the middle of Lindsay Road; thence northerly generally along the middle of that road to its intersection with the Ongaonga Road; thence easterly along the middle of that road to and across the old Waipawa Bridge to the southern boundary of the Borough of Waipawa.

## NAPIER

All that area comprising the City of Napier and the Borough of Taradale, and also that part of the Meeanee Riding of the County of Hawke's Bay bounded on the west by the Borough of Taradale, on the north-west by Kennedy Road, on the north generally by the City of Napier, on the east by the sea coast, and on the south generally by Meeanee Road and by Meeanee-Awatoto road.

## HASTINGS

All that area comprising the City of Hastings and the Borough of Havelock North, and also those portions of the Heretaunga Riding and the Clive Riding of the County of Hawke's Bay bounded as follows; commencing at the mouth of the Ngaruroro River and proceeding south-westerly up the middle of that river to Pakowhai Road bridge, and along the middle of Pakowhai Road to the boundary of the City of Hastings; thence generally south-easterly and south-westerly along the north-eastern and south-eastern boundaries of that city; thence generally southerly along the middle of Norton Road, the Southland Drain, and St. Georges Road to the old course of the Ngaruroro River; thence north-easterly along that river course to and along the generally southern boundary of the Clive Riding to the middle of the Tuki Tuki River; thence northerly down the middle of that river to the sea coast and northerly along the sea coast to the point of commencement.

All that area comprising the Boroughs of Foxton and Shannon, the County of Kairanga, the Eastern Riding of the County of Oroua, the Tokomaru Riding of the County of Horowhenua, the Carnarvon, Rongotea, Kawakawa, Awahou, and Beach Ridings of the County of Manawatu, and that part of the City of Palmerston North not included in the Electoral District of Palmerston North hereinafter described.

## PALMERSTON NORTH

All that area being the present Electoral District of Palmerston North.

## PAHIATUA

All that area comprising the Boroughs of Eketahuna, Pahiatua, Woodville, and Dannevirke, the Counties of Akitio, Mauriceville, Eketahuna, Pahiatua, Woodville, and Dannevirke, (the Purimu Riding of the County of Waipukurau, the Porangahau and Eparaima Ridings of the County of Patangata), the County of Masterton, excepting Te Whiti Riding, the County of Waipawa, excepting the Waipawa Riding, and excepting that portion of the Onga Riding included in the Hawke's Bay Electoral District hereinbefore described.

## OTAKI

All that area comprising the present Electoral District of Otaki excluding that portion lying to the south of a line commencing at the south-western corner of Section 339, Hutt District; thence proceeding north-easterly along the north-western boundaries of that section and Section 340, Hutt District, to the south-western boundary of Section 33, Horokivi Road District; thence north-westerly generally along that boundary and the south-eastern, south-western and north-western boundaries of the northern part of Section 22, Takapu District, the north-western boundary of Section 24, Takapu District, and the south-western boundary of Lot 3, D.P. 2544, to and down the Kenepuru Stream, to and along the middle of National State Highway No. 1 to a point in line with the southern shore of Porirua Harbour; thence along a right line across the North Island Main Trunk Railway to the shore of Porirua Harbour.

## WAIRARAPA

All that area comprising the Boroughs of Masterton, Carterton, Greytown, Featherston, and Martinborough, the County of Featherston, the County of Wairarapa South, and the Te Whiti Riding of the County of Masterton.

## PORIRUA

All that area bounded by a line commencing at the western corner of part Section 9, Kaiwharawhara District, being a point on the boundary of the City of Wellington; thence westerly, north-westerly, and north-easterly generally along the boundary of the present Electoral District of Onslow to the southern shore of Porirua Harbour; thence easterly generally along the southern boundary of the Electoral District of Otaki as hereinbefore described to the south-eastern corner of Section 255, Hutt District; thence easterly and south-westerly generally along the boundary of the Electoral District of Heretaunga hereinafter described to and along the north-western boundaries of the Electoral Districts of Hutt and Petone hereinafter described to a point on the shore of Port Nicholson in line with the north-eastern boundary of Section 19, Harbour District; thence south-westerly along the shore of Port Nicholson to its intersection with the boundary of the City of Wellington; thence northerly, easterly, and south-easterly generally along that boundary to the point of commencement.

## HERETAUNGA

All that area comprising the present Electoral District of Heretaunga, excepting that portion south-west of a line commencing at the intersection of the middle of the Wellington-Napier railway and the middle of the Wingate Overbridge and proceeding northerly generally along the middle of the aforesaid railway to a point in line with the middle of Taine Street; thence to and along the middle of Taine Street, Reynolds Street, and Nash Street and its production to the boundary of the aforesaid Electoral District.

## HUTT

All that area bounded by a line commencing at a point in the middle of the Hutt River in line with the middle line of Whites Line West; thence northerly along the middle of that river to a point in line with the middle of Mills Street; thence due north along a right line to the south-eastern side of Western Hutt Road, being a point on the boundary of the City of Lower Hutt; thence north-easterly generally along that boundary to a point in line with the middle of Nash Street; thence south-easterly generally along a right line to and along the middle of Nash Street, Reynolds Street, Taine Street and its production to and along the middle of the Wellington-Napier railway to the middle of the Wingate Overbridge, being a point on the boundary of the present Electoral District of Hutt; thence south-easterly, south-westerly, and westerly generally along that boundary to a point in line with the middle of Brassell Street; thence westerly generally along the middle of Brassell Street, Junction Road, Fairfield Avenue, to and across Cambridge Terrace to the middle of the Wellington-Napier railway; thence south-westerly along the middle of that railway to and along the middle of Whites Line West to the point of commencement.

## PETONE

All that area bounded by a line commencing at the intersection of the shore of Port Nicholson and the western boundary of the Borough of Petone; thence north-westerly along that boundary to the middle of the Wellington-Napier railway; thence easterly generally along the middle of that railway to the Petone Railway Station; thence along a right line to and along the middle of Main Hutt Road, Udy Street, Nelson Street, Main Hutt Road, Wakefield Street and its production to the middle of the Hutt River, being a point on the southern boundary of the Electoral District of Hutt hereinbefore described; thence along that boundary to the boundary of the present Electoral District of Petone; thence easterly, southerly, and northerly generally along that boundary to the point of commencement.



## KARORI

All that area bounded by a line commencing at the intersection of the western shore of Port Nicholson with the northern boundary of the Electoral District of Wellington Central hereinafter described and proceeding generally westerly and southerly along the northern and western boundaries of the said Electoral District of Wellington Central, to and southerly along the western boundary of the present Electoral District of Island Bay, to and along the southern and western boundaries of the present Electoral District of Karori, to and generally easterly along the southern boundary of the Electoral District of Porirua hereinbefore described, to and southerly along the western shore of Port Nicholson to the point of commencement.

## WELLINGTON CENTRAL

All that area bounded by a line commencing at a point on the shore of Port Nicholson in line with the middle of Westminster Street; thence westerly generally to and along the middle of that street, across Hutt Road, to and along the middle of Fore Street and Winchester Street and its production, to and along the middle of Ngaio Gorge Road East to a point in line with the south-eastern boundary of part Lot 3, plan A. 846; thence to and along that boundary and its production, to and along the middle of Wellington-Johnsonville railway, to and along the north-eastern boundary of Lot 6, D.P. 3932, and Lot 258, D.P. 2644, to and along the middle of the Kaiwharawhara Stream to a point in line with the north-western boundary of Lot 3, D.P. 3932; thence southerly generally to and along that boundary and the western boundary of the said Lot 3 and its production, to and along the middle of Oban Street and Buchanan Street to a point in line with the middle of Moorhouse Street; thence to and along the middle of that street, Lennel Road, Sefton Street, and Wadestown Road to the northern boundary of the Town Belt Reserve; thence south-westerly along a right line to Upper Witako Trig. Station on Tinakore Hill; thence westerly generally along a right line to the middle of the eastern end of Huntingdon Street; thence along the middle of Huntingdon Street, Pembroke Road, Cheshire Street, and Worcester Street to its junction with Wilton Road; thence due west to the middle of the Kaiwharawhara Stream; thence southerly generally along the middle of that stream, to and along the southern boundary of part Lot 31 on Plan A 2267, to and along the middle of Curtis Street, Old Karori Road, Chaytor Street, and Waipapu Road, to and along the eastern boundary of the Wellington Water Supply Area, to and along the western side of Highbury Road, to and again along the eastern boundary of the said Wellington Water Supply Area and the southern boundary of George Denton Park to the western boundary of Section 11, Owhiro District; thence northerly and easterly along the western and northern boundaries of that section to the western boundary of Section 3, Block XVA, Polhill Gully Maori Reserve; thence northerly and easterly generally along the generally western and northern boundaries of that section to and along the middle of Durham Street and Durham Crescent to a point in line with the northern boundary of Lot 1, D.P. 9754; thence to and along that boundary and its production to the middle of Epuni Street; thence along the middle of Epuni Street, Aro Street, Willis Street, Abel Smith Street, Cuba Street, Arthur Street, and Taranaki Street to Hankey Street, being a point on the present boundary of the Electoral District of Wellington Central; thence along that boundary to the middle of Alexandra Road; thence north-easterly generally along the middle of that road, Thane Road, Roseneath Terrace, Palliser Road, Grafton Road, and Maida Vale Road to a point in line with the southern boundaries of Lots 2 and 3, D.P. 4203; thence to and along those boundaries, to and across Evans Bay Road to the shore of Port Nicholson at Little Karaka Bay; thence northerly, westerly, and northerly again generally along the shore of Port Nicholson to the point of commencement, and including Somes Island and all wharves and other extensions seaward.

## ISLAND BAY

All that area bounded by a line commencing at the intersection of the middle of Alexandra Road and the Mount Victoria Traffic Tunnel in the City of Wellington and proceeding northerly along the eastern boundary of the Electoral District of Wellington Central hereinbefore described to the shore of Evans Bay; thence southerly, easterly, and northerly along the shore of the said Evans Bay to Point Halswell; thence southerly and westerly generally along the shore of Port Nicholson and the sea coast to the eastern boundary of the Electoral District of Island Bay hereinbefore described; thence northerly along that boundary to the point of commencement, and including all wharves and other extensions seaward.

## WESTLAND

All that area comprising the Boroughs of Hokitika, Ross, Kumara, Greymouth, Brunner, and Runanga, and the Counties of Murchison, Inangahua, Grey, and Westland.

## BULLER

All that area comprising the Boroughs of Westport and Motueka, the Counties of Golden Bay and Buller, that portion of the County of Sounds not included in the Electoral District of Marlborough hereinafter described, the Pelorus-Havelock Riding of the County of Marlborough excepting that part included in the Electoral District of Marlborough aforesaid, and the County of Waimea excepting those parts included in the Electoral District of Nelson hereinafter described.

## NELSON

All that area comprising the City of Nelson, the Borough of Richmond, the Waimea East Riding of the County of Waimea, excepting that portion generally east and south of a line commencing on the southern boundary of the Waimea East Riding at the confluence of the Lee and Roding Rivers and proceeding northerly up the middle of the Roding River, to a point due east of a road junction in Section 1, Block X, Waimea Survey District, to that junction and along the middle of the road to the north of that river, to a point in line with the eastern boundary of Section 8, Square 1, to and along that boundary and the eastern boundaries of the western parts of Lot 5 and Lot 2, D.P. 332, along the south-eastern and north-eastern boundaries of the south-western part of Section 62, Block X, Waimea Survey District, north-westerly along the middle of Whites Road, north-easterly along the middle of Salisbury Road, to and easterly generally along the boundary of the Borough of Richmond, south-easterly along the south-western boundary of Lot 3, D.P. 2035, north-easterly along the north-western boundary of Section 1, Block VII, Waimea Survey District, to the northern corner of that section, easterly to a point in the middle of a road passing through Section 60, Square 1, in line with the north-eastern boundary of that section, along the middle of that road passing through Section 61, Square 1, and Section 5, Block VII aforesaid, to and up the middle of the Roding River to the eastern boundary of the Waimea East Riding aforesaid, that portion of the Whangamoia Riding of the County of Waimea, west of a line commencing at a point on the eastern boundary of the City of Nelson, being the eastern corner of Section 36, Block I, Maungatapu Survey District, and proceeding northerly along a right line to the eastern corner of part Section 8, Block IX, Wakapuaka Survey District, south-easterly along a prominent spur to the crest of the main ridge, northerly along that ridge to Trig. All that area comprising the Boroughs of Rangiora and Kaiapoi, the Counties of Rangiora, Ashley, Eyre, Oxford, Kowai, and Waipara, and that part of the County of Waimairi not included in the Electoral Districts of Fendalton and Riccarton hereinafter described.

## SELWYN

All that area comprising the Counties of Tawera, Malvern, Selwyn, Springs, and Ellesmere, that part of the County of Halswell excluded from the Electoral District of Lyttelton hereinafter described, the County of Paparua excepting that part included in the Electoral District of Riccarton hereinafter described, and that part of the County of Ashburton not included in the Electoral District of Ashburton hereinafter described.

## FENDALTON

All that area bounded by a line commencing at a point on the right bank of the Avon River and the production of the north-east side of Rossall Street, being a point on the boundary of the City of Christchurch; thence proceeding westerly generally along the boundary of the City of Christchurch and the northern boundary of the Borough of Riccarton to the middle of Clyde Road; thence generally north-westerly, north-easterly, and easterly along the boundary of the present Electoral District of Fendalton to the middle of No. 1 National State Highway, a point on the boundary of the City of Christchurch; thence southerly along that boundary to its intersection with Grants Road; thence southerly generally along the middle of Grants Road, No. 1 National State Highway, Normans Road, and Strowan Road to a point on the boundary of the City of Christchurch; thence south-easterly generally along that boundary to the point of commencement.

## ST. ALBANS

All that area comprising the present Electoral District of St. Albans together with that portion of the City of Christchurch bounded by a line commencing at the intersection of No. 1 National State Highway and Aikmans Road; thence south-westerly along the middle of Aikmans Road to a point in line with the middle of Allister Avenue; thence north-westerly along a right line to the intersection of Allister Avenue and Leinster Road; thence south-westerly along the middle of Leinster Road to the boundary of the City of Christchurch; thence north-westerly along that boundary to the middle Strowan Road; thence northerly generally along the middle of Strowan Road and Normans Road to the middle of No. 1 National State Highway; thence south-easterly along the middle of that highway to the point of commencement.

## CHRISTCHURCH CENTRAL

All that area, being a portion of the City of Christchurch, bounded by a line commencing at the intersection of Tilford Street and Ferry Road; thence westerly along the middle of Ferry Road to a point on the boundary of the present Electoral District of Christchurch Central; thence generally westerly, northerly, and easterly along that boundary to a point in the middle of the Avon River in line with the middle of Banks Avenue; thence down the middle of that river to a point in line with the middle of Ngarimu Street; thence southerly generally along the middle of Ngarimu Street, Woodham Road, Carnarvon Street, Buckleys Road, Rudge Road, McGregors Road, Butterfield Avenue, Hay Street, Linwood Avenue, and Tilford Street to the middle of Ferry Road, the point of commencement.

## AVON

All that area, being a portion of the City of Christchurch, bounded by a line commencing at a point in the middle of Marshland Road on the northern boundary of the City of Christchurch and proceeding generally easterly and southerly along the said city boundary to and westerly along the southern boundary of the present Electoral District of Avon to the south-easternmost corner of the Electoral District of Christchurch Central as hereinbefore described; thence northerly generally along the eastern boundary of that electoral district and the eastern boundary of the Electoral District of St. Albans hereinbefore described to the point of commencement.

## SYDENHAM

All that area, being a portion of the City of Christchurch, bounded by a line commencing at the junction of Moorhouse Avenue and Lincoln Road, being a point on the boundary of the City of Christchurch; thence proceeding easterly, south-westerly, and north-westerly generally along the boundary of the present Electoral District of Sydenham to a point in the middle of Sparks Road in line with the middle of Maryhill Avenue; thence northerly generally along the boundary of the Electoral District of Riccarton hereinafter described to the point of commencement.

## RICCARTON

All that area bounded by a line commencing at a point being the intersection of the middle of Clyde Road and the north-western boundary of the Borough of Riccarton; thence easterly and southerly generally along that boundary to the middle of the junction of Hagley Avenue and Lincoln Road; thence southerly generally along the middle of Lincoln Road, Domain Terrace, and Glynne Crescent to a point in line with the middle of Smartlea Street; thence south-westerly along a right line to the middle of the Heathcote River; thence south-easterly along the middle of that river to a

point in line with the middle of Muirson Avenue; thence south-westerly generally along a right line to and along the middle of Muirson Avenue, Hoon Hay Road, and Maryhill Avenue to the middle of Sparks Road, being a point on the southern boundary of the City of Christchurch; thence westerly and north-westerly generally along that boundary to the middle of Middle Lincoln Road; thence westerly generally along the middle of that road, Halswell Junction Road, and Springs Road to a point in line with the south-western boundary of Rural Section 1239 situated in Block XIII, Christchurch Survey District; thence north-westerly to and along the south-western boundary of that section and its production to the middle of Shands Road; thence generally north-easterly and south-easterly along the middle of Shands Road, Carmen Road, Yaldhurst Road (No. 73 Provincial State Highway), Russley Road, Memorial Avenue, Ham Road, Waimairi Stream, and Clyde Road to the north-western boundary of the Borough of Riccarton, the point of commencement.

## LYTTELTON

All that area comprising the Borough of Lyttelton, the counties of Akaroa, Heathcote, Mount Herbert, Wairewa, and Chatham Islands, those portions of the City of Christchurch lying to the south of the Electoral Districts of Sydenham and Avon hereinbefore described and excluded therefrom, that portion of the County of Halswell excluded from the Electoral District of Selwyn as hereinbefore described, and Ripa and Quail Islands and adjacent islands.

## ASHBURTON

All that area comprising the Boroughs of Ashburton, Geraldine, and Temuka, the County of Geraldine, the Tenga-wai and Point Ridings of the County of Levels, the Opuha, Fairlie, and Albury Ridings of the County of Mackenzie, the Mt. Somers, Rangitata, and Ashburton Ridings of the County of Ashburton, and that portion of the Tekapo Riding of that county east of a line from the summit of the Southern Alps, down the middle of the Rudolf and Tasman Glaciers, the Tasman River, Lake Pukaki, the Pukaki River, and the Tekapo River to the Ohau River, and that portion of the Upper Ashburton Riding of the County of Ashburton lying south-west of the right bank of the North Branch of the Ashburton River.

## TIMARU

All that area comprising the present Electoral District of Timaru and the Upper Pareora, Lower Pareora, and Otao Ridings of the County of Waimate.

## WAITAKI

All that area comprising the Boroughs of Waimate and Oamaru, the Hakataramea, North Waihao, Makikihi, and Deep Creek Ridings of the County of Waimate, that portion of the Tekapo Riding of the County of Mackenzie not included in the Electoral District of Ashburton hereinbefore described, the Ahuriri, Otekaieke, Awamoko, Papakaio, Waiareka, Incholme, Kakanui, and Otepopo Ridings of the County of Waitaki.

## NORTH DUNEDIN

All that area comprising the Boroughs of Port Chalmers and West Harbour, and that portion of the City of Dunedin north of a line commencing at a point on the boundary of the City of Dunedin in line with the middle of the Water of Leith; thence up the middle of the Water of Leith to a point in line with the middle of Parry Street, to and along the middle of that street, Frederick Street, Pitt Street, Royal Terrace, London Street, Stuart Street, and Taieri Road to the boundary of the said city.

## DUNEDIN CENTRAL

All that area comprising that portion of the City of Dunedin north-west of a line commencing at a point on the boundary of the City of Dunedin in line with the middle of Hillside Road; thence to and along the middle of that road and Andersons Bay Road to the middle of the South Island Main Trunk Railway, along the middle of that railway to and along the middle of King Edward Street, Wilkie Road, and again along the middle of the railway aforesaid to a point in line with the south-western side of Surrey Street, to and along that side of Surrey Street and its production to the middle of South Road, along the middle of South Road, David Street, Forbury Road, Easter Crescent, Rainton Road, Murray Street, and Corstorphine Road to Stevenson Road and a right line to the north-western side of that road, being a point on the boundary of the City of Dunedin, also that portion of the Borough of Green Island south and east of the Main South Road and Kaikorai Valley Road and excluding that portion of the City of Dunedin included in the Electoral District of North Dunedin hereinbefore described.

## ST. KILDA

All that area comprising the Borough of St. Kilda, the County of Peninsula, that portion of the City of Dunedin south-east of a line from a point on the boundary of the City of Dunedin in line with the middle of Hillside Road to Stevenson Road as described in the Electoral District of Dunedin Central hereinbefore described, and the islands within Otago Harbour.

## TAIERI

All that area comprising the Boroughs of Hampden, Palmerston, Waikouaiti, Mosgiel, and Milton, the Counties of Maniatoto, Waihemo, Waikouaiti, and Taieri, the Moeraki Riding of the County of Waitaki, the Clarendon, Mount Stuart, Waiholā, Tokomairiro, Glenledi, Crichton, and Kaitangata Ridings of the County of Bruce, and that portion of the Matau Riding of that county lying to the north-east of the Matau Branch of the Clutha River.

## CLUTHA

All that area comprising the Boroughs of Mataura, Kaitangata, Balclutha, Lawrence, Roxburgh, Tapanui, Alexandra, and Cromwell, the Counties of Clutha, Tuapeka, and Vincent, the Balmoral No. 1 Riding and Balmoral No. 2 Riding of the County of Bruce, that portion of the Mataura Riding of the County of Southland generally south-east of the present electoral boundary from Gore to Maitland and eastward to the county boundary, that portion of the County of Lake included in the present Electoral District of Otago Central, and that portion of the Matau Riding of the County of Bruce lying to the south-west of the Matau Branch of the Clutha River.

## AWARUA

All that area comprising the Boroughs of Riverton and Bluff, the Town District of Wyndham, that part of the City of Invercargill not included in the Electoral District of Invercargill hereinafter described, the Pourakino Riding and the Waimatuku Riding of the County of Wallace, the Toetoes, Waihopai, Awarua, and Wallacetown Ridings of the County of Southland, the County of Stewart Island, the Campbell Islands, Dog Island, and Centre Island.

## INVERCARGILL

All that area, being that portion of the City of Invercargill as described in the *Gazette*, of 1958, at page 1263, lying generally north-west of a line commencing at a point in the middle of Oteramika Road on the eastern boundary of the said city and proceeding westerly along the middle of Oteramika Road and Tweed Street East to the generally eastern boundary of the present Electoral District of Invercargill; thence south-westerly generally along that boundary to the middle of Elles Road South; thence southerly along the middle of Elles Road South to and westerly along the middle of O'Hara Street and its production across the Main South Railway to the eastern boundary of Section 10, Block III, Invercargill Hundred, being a point on the generally western boundary of the said City of Invercargill.

## WALLACE

All that area comprising the Boroughs of Gore, Queens-town, Arrowtown, and Winton, the Town Districts of Otautau, Nightcaps, and Lumsden, the County of Fiord, the County of Wallace, excepting the Ridings of Pourakino and Waimatuku, the County of Southland, excepting the Ridings of Wallacetown, Awarua, Waihopai, and Toetoes, and also excepting that portion of the Riding of Mataura included in the Electoral District of Clutha hereinbefore described, and the County of Lake, excepting that portion included in the present Electoral District of Otago Central.
