(2) If in respect of any lot of bananas the price calculated in accordance with the foregoing provisions of this clause is not an exact number of pence or halfpence, the maximum price of the lot shall be computed to the next upward halfpenny.

Notwithstanding anything to the contrary in the foregoing provisions of this order, and subject to such conditions, if any, as it thinks fit, the Tribunal, on application by any retailer, may authorise special maximum prices in respect of any bananas to which this order applies where special circum-stances exist, or for any reason extraordinary charges (freight or otherwise) are incurred by the retailer.
