in subsection (2) thereof.

(c) To repeal section 10 of the said Act and to substitute therefor the following section:

"10. The Wellington City Mission (Church of England) Trust Board shall consist of the Bishop of the Diocese which for the time being shall include the City of Wellington, *ex officio*, or his Vicar-General when the Bishop shall be absent from the said Diocese or when although not absent he shall be prevented by illness or other serious cause from acting personally, and such other number as the Synod of the said Diocese may from time to time determine of other members appointed and to hold office under the provisions of Title F, Canon 1, clauses 10 to 17 (inclusive) and clause 19 of the said Canon or of any Canon or statute enacted by the General Synod of the said Church amending the same or in substitution therefor."
