#### ORDER

1. This order may be cited as the Waitaki Electric Power Board Electric Lines Licence 1958, Amendment No. 1, and shall be read together with and deemed part of the Waitaki Electric Power Board Electric Lines Licence 1958\* (hereinafter referred to as the principal order).

2. The principal order is hereby amended by deleting Clause 5 thereof and substituting the following:

"5. The systems of supply shall be as described in paragraphs (a), (b), (c), (d), (e), (f), (h), and (j) of regulation 21-01 of the Electrical Supply Regulations 1935. The system of supply authorised under paragraph (j) aforesaid shall be a single-conductor earth-return system of 11,000 volts between conductor and earth, and the use thereof shall be subject to such terms and conditions as are from time to time laid down by the General Manager of the New Zealand Electricity Department."

3. The principal order is hereby further amended by adding the following words to the First Schedule:

"and in the Order in Council dated the 28th day of February 1966, and published in the *Gazette* on the 10th day of March 1966, at page 332."

#### ORDER

1. This order may be cited as the Poverty Bay Electric Power Board Electric Lines Licence 1966.

2. Subject to the conditions hereinafter set forth, the Poverty Bay Electric Power Board (hereinafter referred to as the licensee) is hereby authorised to lay, construct, put up, place, and use electric lines and to construct electric works which may from time to time be required for the distribution and supply of electricity within the area described in the Schedule hereto.

3. The conditions directed to be implied in all licences by the Electrical Supply Regulations 1935 and the Electrical Wiring Regulations 1961 shall be incorporated herein and shall form part of this licence, except in so far as they may be inconsistent with the provisions of this licence.

4. The licence hereby conferred is subject to compliance by the licensee with the Electrical Supply Regulations 1935, the Electrical Wiring Regulations 1961, the Radio Interference Regulations 1958, and with all regulations made in amendment thereof or in substitution therefor, except in so far as they may be inconsistent with the provisions of this licence.

5. The systems of supply shall be as described in paragraphs (a), (b), (c), (d), (e), (f), and (h) of regulation 21-01 of the Electrical Supply Regulations 1935.

6. This licence shall, unless sooner lawfully determined, continue in force until the 1st day of November 1968.

thence south-easterly along the middle of that road to a point in line with the north-western boundary of Lot 1, D.P. 10267; thence south-westerly to and along that boundary and the north-western boundary of Lot 2, D.P. 10267 and its production to the middle of Dolbell Street; thence north-westerly along the middle of that street to the eastern boundary of Lot 3, Deeds Plan 325; thence southerly along that boundary to the northern side of O'Dowd Road; thence southerly generally by a right line to and along the western and south-western boundaries of Lot 2, D.P. 7489, the south-western boundary of Lot 2, D.P. 6758, the southern end of a public road to and along the north-western boundary of part Lot 6, D.P. 4846 to the north-eastern boundary of Lot 1, D.P. 4846; thence north-westerly and south-westerly along that boundary and the north-western boundaries of Lot 1 and part Lot 2, D.P. 4846, to the south-western boundary of part Lot 2, D.P. 4846; thence south-easterly along that boundary and its production to the middle of the No. 50 State Highway;
