(g) Two councillors to be elected by the associations of employers in local industries;
(h) One councillor to be appointed by the Otago-Southland

(h) One councillor to be appointed by the Otago-Southland Manufacturers' Association;

(i) One councillor to be appointed by the Dunedin Chamber

(i) One councillor to be appointed by the Dunedin Chamber of Commerce;
(j) One councillor, being a member of the Federated Farmers of New Zealand (Otago Provincial District) Inc., to be appointed by that body;
(k) One councillor, being a member of the Council of the University of Otago or of the Senate of that University, to be appointed by the Council of the University of Otago;
(l) Five councillors to be co-opted by the Otago Polytechnic Council itself, if and when it thinks fit;
(m) One Councillor, who shall be a woman, to be appointed by the Otago Polytechnic Council at any time while there is no other woman member of the council.
(2) The Minister of Education may, from time to time.

(2) The Minister of Education may, from time to time, by notice in the Gazette, amend the list of schools to which paragraph (e) of subclause (1) of this clause applies, and to which the Schedule to this order refers.

3. (1) Subject to the provisions of this clause, the members of the Otago Polytechnic Council shall hold office for a term of three years, but may from time to time be reappointed or re-elected.
