The Controlled (Non-resident) Accounts Notice 1966

PURSUANT to the Exchange Control Regulations 1965\*, the Reserve Bank of New Zealand hereby gives the following

1. (1) This notice may be cited as the Controlled (Non-resident) Accounts Notice 1966.

(2) This notice shall come into force on the 17th day of June 1966.

- 2. In this notice, the expression "non-resident account" means an account kept by any person in the name, or directly or indirectly for the benefit, of any person, or any two or more persons, if that person or any of those persons is—
  - (a) Not ordinarily resident in New Zealand (within the meaning of the Exchange Control Regulations 1965);
  - (b) A trustee for or a nominee or agent of any person not ordinarily resident in New Zealand (within the meaning of the said regulations).
- 3. The non-resident accounts specified in the Schedule hereto are hereby declared to be controlled accounts for the purposes of regulation 4B of the Exchange Control Regulations 1965 (as inserted by regulation 4 of the Exchange Control Regulations 1965, Amendment No. 1).

### **SCHEDULE**

NON-RESIDENT ACCOUNTS DECLARED TO BE CONTROLLED ACCOUNTS
