WHEREAS, by the Order in Council dated the 30th day of July 1923\*, made under the British Settlements Act 1887 of the United Kingdom Parliament, the Governor-General and Commander-in-Chief of New Zealand for the time being (thereinafter and hereinafter called the Governor) was appointed to be the Governor of the Ross Dependency, and all the powers and authorities which by the said order were given and granted to the Governor for the time being of the Dependency were thereby vested in him: And whereas the Governor was thereby further authorized

And whereas the Governor was thereby further authorised and empowered to make all such rules and regulations as might lawfully be made by Her Majesty's authority for the peace, order, and good government of the Dependency:

And whereas, by regulations made by the Governor on the 14th day of November 1923<sup>†</sup>, it was enacted that all persons appointed by the Governor for the time being of the Dependency should have such power and authority as migh-be granted them in due course of law, and might be em-powered to do such things as might be necessary or desirable to ensure that the laws in force in the Dependency are duly observed and complied with in every respect, and to do al

things necessary or expedient for the peace, order, and good government of the Dependency, and to safeguard and preserve Her Majesty's rights and sovereignty over and in respect of the Dependency:

And whereas it is expedient that the persons hereinafter named be appointed officers of the Government of the Dependency:

Now therefore, I, Brigadier Sir Bernard Edward Fergusson, the Governor-General of New Zealand, and as such the Governor of the Ross Dependency, hereby appoint

# Colin Maxwell Clark, Esquire,

as an officer of the Government of the Dependency; and I hereby confer on him all the powers and authorities which may be exercised in New Zealand by a Stipendiary Magistrate and also all the powers and authorities which may be so exercised by a Justice of the Peace, and also the powers and authorities which may be so exercised by a Coroner, and also the powers and authorities which may be so exercised by a Postmater by a Postmaster.

And I also appoint

#### David Hugh Brown, Esquire,

David Hugh Brown, Esquire, as an officer of the Government of the Dependency; and I hereby confer on him all the powers and authorities which may be exercised in New Zealand by a Postmaster. The said Colin Maxwell Clark and the said David Hugh Brown to exercise their functions at such places within the Dependency as may be directed by the officer for the time being appointed as an officer of the Government of the Dependency in whom is vested the general executive and administrative authority in preserving Her Majesty's rights and sovereignty and the laws and regulations in force in the Dependency; and to hold office and exercise the duties thereof during pleasure.

#### Closely Populated Locality and Limited Speed Zones Declared

PURSUANT to the Transport Act 1962, the Minister of Transport hereby gives notice as follows:

1. The Warrant, under regulation 27 of the Traffic Regula-tions 1956\*, dated the 12th day of June 1958†, which re-lates to No. 2 State Highway (Pokeno-Wellington via Gis-borne) and the Akatarawa Road in Hutt County, is hereby revoked.
