*Notice Fixing and Determining Quality Standards and Grades for Eggs (No. Ag. 10090)*

PURSUANT to regulation 59 of the Egg Marketing Authority Regulations 1953, the Egg Marketing Authority hereby fixes and determines that, as from 1 July 1967, the quality, standards, and grades for hen eggs shall be as follows.

1. APPLICATION:

(a) These standards of quality of individual shell eggs and quality grades for eggs, are applicable only to eggs that are the product of the domesticated chicken hen, and are in the shell.

(b) Interior egg quality specifications for these standards are based on the apparent condition of the interior contents of the egg, as it is twirled before the candling light, except as otherwise provided. (Any candling light may be used that is approved by the Egg Marketing Authority.)

(Only eggs of "Top Quality" standard of Large, Standard, and Medium size grade shall qualify for contract payments, authorised by the Authority from time to time.)

2. DEFINITIONS:

(a) "Quality" means the inherent factors which determine the relative degree of excellence of the egg.

(b) "Yolk Colour Range" means range of yolk colour as prescribed by the Egg Marketing Authority.

3. QUALITY STANDARDS OF INDIVIDUAL SHELL EGGS:

(a) *Top Quality*

(1) Shell—clean, unbroken, practically normal.

(2) Air cell—not in excess of  $\frac{3}{16}$  in. in depth, practically regular.

(3) White—clear, reasonably firm.

(4) Yolk—practically free from defects, outline only fairly well defined.

(b) *Commercial Quality*

(1) Shell—moderately stained, unbroken, slightly abnormal.

(2) Air cell—may be over  $\frac{3}{16}$  in. in depth, practically regular.

(3) White—clear, slightly weak.

(4) Yolk—may appear slightly enlarged and slightly flattened, and may show definite but not serious defects, outline well defined.

(c) *Undergrade*

(1) Shell—free from adhering dirt, may be stained, checked, abnormal.

(2) Air cell—may be over  $\frac{3}{16}$  in. in depth, may be free or bubbly.

(3) White—weak and watery, may show blood clots and spots (not due to germ development), which are on the surface of the yolk or floating in the white, but not showing diffusion of blood in the white surrounding them.

(4) Yolk—may appear dark, enlarged, and flattened, and show serious defects that do not render the egg inedible, outline plainly visible.

(d) *No Value (Inedible)*

(1) Incubator reject (or incubator clear)—an egg that has been subjected to incubation, either by natural or artificial means, at any time.

(2) An egg that is cooked, frozen, contaminated, containing a bloody white or unsightly foreign material, a dirty shell, or a shell that is smashed or broken so that the contents are leaking.

(3) An egg described as being a white rot, mixed rot (addled egg), sour egg, egg with green white, egg with stuck yolk, mouldy egg, musty egg, egg showing germ development or blood ring.

(4) Any egg otherwise classed as unfit for human consumption.

4. DESCRIPTIVE TERMS:

(a) *Shell*

(1) Clean—free from foreign material, and from stains or discolourations that are readily visible. An egg may be considered clean if it has only stains or discolourations which are not of sufficient number or intensity to detract from the generally clean appearance of the

egg, and which in the aggregate or localised, do not cover more than  $\frac{1}{2}$  of the shell surface. Only shells of eggs which have been produced clean or dry-cleaned eggs can be classified as clean.

- (2) Moderately stained—free from foreign material but has staining which is not prominent in intensity, and which in the aggregate or localised, covers more than  $\frac{1}{2}$  but not more than one-quarter of the shell surface.
- (3) Stained—free from foreign material but has staining which is not prominent in intensity, and which in the aggregate or localised, covers more than one-quarter of the shell surface, or any staining of prominent intensity (staining which readily detracts from the appearance of the egg), which in the aggregate or localised, covers not more than one-quarter of the shell surface.
- (4) Dirty—staining of prominent intensity (staining which readily detracts from the appearance of the egg), which in the aggregate or localised, covers more than one-quarter of the shell surface; adhering foreign material such as egg yolk, white, or shell, nesting material, manure, soil, or any other similar substance adhering to the shell.
- (5) Practically normal—a shell that approximates the usual shape and that is of good even texture and strength, and is free from rough areas or thin spots. Slight ridges and rough areas that do not readily detract from the appearance of the egg and do not materially affect the texture and strength of the shell are permitted.
- (6) Slightly abnormal—a shell that may be somewhat unusual in shape or that may be slightly faulty in texture or strength. It may show definite ridges but no pronounced thin spots or rough areas.
- (7) Abnormal—a shell that may be decidedly misshapen, or faulty in texture or strength, or that may show pronounced ridges, thin spots, or rough areas.
- (8) Check—a shell that has a blind check, body check, or is cracked, but the shell membranes are intact and contents of egg are not leaking.
- (9) Blind check—a shell that under a candling light exhibits a spider web effect of the shell material.
- (10) Body check—a shell that was checked or cracked while being formed, but repaired in the bird's body.

(b) *Air Cell*

- (1) Depth of air cell (air space between shell membranes, normally at large end of the egg)—the greatest distance between the top of the cell and an imaginary plane passing through the egg where the lower edge of the cell touches the shell.
- (2) Movement of air cell—the distance the air cell moves away from its normal position when the egg, with the air cell uppermost, is twirled.
- (3) Practically regular—an air cell that maintains a practically fixed position in the egg and shows a fairly even outline with not more than  $\frac{1}{4}$  in. movement in any direction as egg is rotated.
- (4) Free air cell—an air cell that moves freely toward the uppermost point in the egg as the egg is rotated slowly.
- (5) Bubbly air cell—a ruptured air cell resulting in one or more separate air bubbles, usually floating beneath the main air cell.

(c) *White*

- (1) Clear—a white that is free from discolourations or from any foreign bodies floating in it. (Prominent chalazae should not be confused with foreign bodies such as spots or blood clots.)
- (2) Reasonably firm—a white that is sufficiently thick or viscous to permit only a fairly well defined yolk outline as the egg is twirled. With respect to a broken-out egg, a reasonably firm white has a Haugh unit value of 64 or higher, when measured at a temperature of between 45° and 60° F.
- (3) Slightly weak—a white that is lacking in thickness or viscosity to an extent that causes the yolk outline to appear well defined when the egg is twirled. With respect to a broken out egg, a slightly weak white has a Haugh unit value of 46 to 64, when measured at a temperature between 45° and 60° F.
- (4) Weak and watery—a white that is thin and generally lacking in viscosity. A weak and watery white permits the yolk to approach the shell closely, thus causing the yolk outline to appear plainly visible and dark when the egg is twirled. With respect to a broken-out egg, a weak and watery white has a Haugh unit value lower than 46, when measured at a temperature between 45° and 60° F.
- (5) Blood clots and spots (not due to germ development)—blood clots and spots on the surface of the yolk or floating in the white. These clots or spots may have lost their characteristic red colour and appear as small spots or foreign material commonly referred to as meat spots.
- (6) Blood clots and spots (due to germ development)—blood clots and spots due to germ development found on the yolk. Such eggs are classified as inedible.
- (7) Bloody white—white which has blood diffused through it. Such eggs are classified as inedible.

(d) *Yolk*

- (1) Outline fairly well defined—a yolk outline that is noticeable but not clearly outlined as the egg is twirled.
- (2) Outline well defined—a yolk outline that is quite definite and distinct as the egg is twirled.
- (3) Outline plainly visible—a yolk outline that is clearly visible as a dark shadow when the egg is twirled.
- (4) Slightly enlarged and slightly flattened—a yolk in which the yolk membranes and tissues have weakened somewhat, causing it to appear slightly enlarged and slightly flattened.
- (5) Enlarged and flattened—a yolk in which the yolk membranes and tissues have weakened and moisture has been absorbed from the white to such an extent that it appears definitely enlarged and flat.
- (6) Practically free from defects—a yolk that shows no germ development but may show other slight defects on its surface.
- (7) Definite but not serious defects—a yolk that shows no germ development but may show slight spots or defects on its surface, or a yolk which is too dark or too pale (not within approved colour range).
- (8) Serious defects—a yolk that shows well-developed spots or areas or other serious defects, such as an off-coloured yolk, which do not render the egg inedible.

5. *QUALITY GRADES:*

(Applicable at point of origin of Quality Grading.)

(a) *Top Quality Grade*

- (1) Shall consist of eggs which are of Top Quality standard. A maximum tolerance of ten (10) eggs of Commercial Quality standard may be permitted in any 30 dozen lot; provided that not more than one egg of Commercial Quality standard is in any one dozen pack of eggs.
- (2) Shall be applied only to eggs of Large, Standard, and Medium size grade.
- (3) Shall consist of eggs which have a Haugh unit of 64 or more.

(b) *Commercial Quality Grade*

- (1) Shall consist of eggs which are of Commercial Quality standard. A maximum tolerance of ten (10) eggs of Undergrade Quality standard may be permitted in any 30 dozen lot.
- (2) Shall be applied only to eggs of Large, Standard, and Medium size grade.

(c) *Pullet Quality Grade*

- (1) Shall consist of eggs which are of Top Quality standard. A maximum tolerance of ten (10) eggs of Commercial Quality standard may be permitted in any 30 dozen lot.
- (2) Shall consist of eggs of Pullet size grade.

(d) *Undergrade*

- (1) Consists of eggs which are of Undergrade Quality standard and all other eggs which are edible and do not qualify under any other grade.

(e) *No Value*

- (1) Shall consist of all eggs classed as inedible.

## NOTES ON THE WEATHER FOR MAY 1967

**General:** May was marked by a higher frequency of south-westerly winds than usual. It was a cloudy month in southern districts of the South Island, and also very wet in Southland; while in Gisborne and Hawke's Bay it was unusually sunny and dry. Rainfall was comparatively low over most of the country; but in only a few areas, mainly Gisborne and Bay of Plenty, was it low enough to retard pasture growth. Generally the spells of settled weather were appreciated and farmers found May a good month.

**Rainfall:** Rainfall was below normal except in Southland and on the West Coast; also around Christchurch, and in parts of Otago and Waikato. In Gisborne and parts of Hawke's Bay it was less than a quarter of the average value, with some totals below an inch. Elsewhere rainfall was mainly about half the average value.

The only area with rainfall well above normal was the Southland plain with South Otago and parts of the Dunedin district, where totals were about double the average value.

In the North Island and northern and western districts of the South Island, a large part of the rain fell between the 23rd and the 26th.

**Temperatures:** Temperatures were close to average in the North Island and northern and western districts of the South Island. They were 2-4 degrees above average over most of Canterbury, Otago, and Southland.

The main cold spells were experienced about the 11th, the 15th, and at the end of the month. The cold spell of the 15th was accompanied by snow to low levels in many eastern districts, and also on the West Coast.

**Sunshine:** Sunshine was above average by 10 to 70 hours in eastern districts from Kaikoura to Gisborne and also about Cook Strait. Gisborne received 191 hours, its highest May sunshine in 30 years of records. The highest total was 198 hours, at Waipukurau.

In Westland, Otago, and Southland, sunshine was 10-30 hours below average, greatest deficiencies being recorded in Otago and Southland.

**Weather Sequence:** With an anticyclone over the Tasman Sea and pressures low far to the south-east, from 1-3 May conditions remained similar to those experienced during 28-30 April. Winds were mainly south-westerly, bringing considerable rain to Southland, with gales there at times. Otago and the West Coast also received some rain, and a few showers were reported in Auckland. On the 4th the weather was generally fine under the influence of a

ridge of high pressure, but freshening westerlies in the south brought rain once again to the West Coast on the following day.

A trough of low pressure which moved on to Southland on the 6th soon became slow-moving, and depressions formed on it. Soon rain covered most of the South Island and extended also to some western districts of the North Island. During the 8th and 9th the trough moved more rapidly, crossing the country; and a depression on it passed close to Southland. The weather cleared temporarily in the east and north of the South Island. However, during the next two days a second depression passed to the east of the South Island, and the associated cold front brought a change to southerlies. Rain became general but soon cleared temporarily on the West Coast. Conditions became westerly again for the 12th and 13th with rain only in Fiordland and south Westland, and on the Southland coast. A second cold front soon crossed the country, with another brief spell of fairly general rain and snow to low levels, in many eastern districts on the 15th.

Three days of settled weather followed as an anticyclone moved across the country. After this, from the 19th to the 22nd the anticyclone was centred to the east of the North Island, and settled weather continued in many districts. However, at first a trough was stationary to the south. The freshening north-westerlies north of the trough brought rain to Fiordland and south Westland; while easterlies brought showers to Northland and Auckland. As the trough moved on to the South Island on the 22nd, light rain spread to Southland, north Westland and Buller, and also Bay of Plenty.

The period from the 23rd to the 26th was the wettest part of the month for the North Island, and western and northern districts of the South Island. A shallow depression which had been moving eastward over the central Tasman Sea became almost stationary, while the trough of low pressure continued its progress across the country. Rain became fairly general, but there was a temporary clearance over the southern half of the South Island on the 24th and 25th. A second depression later formed east of the North Island.

With rising pressures conditions improved on the 27th but some scattered rain was still reported. However, on the following day the weather was settled. On the 29th rain came to Northland and Auckland with the passage of a depression to the north. During the last two days of the month a cold southerly change brought light rain to eastern districts as far north as Wairarapa, and also to Wellington and Taranaki.
