PURSUANT to the Public Works Act 1928, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, hereby grants to the Auckland Regional Authority (hereinafter referred to as the licensee), a licence, subject to the conditions hereinafter set forth, to lay, construct, put up, place, and use the electric lines described in the Schedule hereto.

CONDITIONS
IMPLIED CONDITIONS

1. The conditions directed to be implied in all licences by the Electrical Supply Regulations 1967 and the Electrical Wiring Regulations 1961, shall be incorporated in and shall form part of this licence, except in so far as the same may be inconsistent with the provisions hereof.

LICENCE SUBJECT TO REGULATIONS

Ltd., Launch Proprietors, of Manapouri (hereinafter referred to as the licensee), subject to the conditions hereinafter set forth, to take and use from an unnamed stream (hereinafter referred to as the said stream), situated in the Fiordland National Park, in the Wallace County, for the purpose hereinafter set forth, a stream of water not exceeding 1½ cu. ft. per second at any one time.

(a) Headworks consisting of an intake with a water-race and pipe-line leading across Fiordland National Park to the pelton wheel and powerhouse hereinafter referred to, giving a static head of approximately 266 ft.

(b) Pelton wheel and powerhouse with all necessary equipment for generating electricity, situated in Fiordland National Park.

(c) Tailrace leading from the said powerhouse to Lake Te Anau.

PURSUANT to the Trustee Savings Banks Act 1948, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. This order may be cited as the Wellington Savings Bank Order 1964, Amendment No. 3, and shall be read together with and deemed part of the Wellington Savings Bank Order 1964* (hereinafter referred to as the principal order).

2. (1) The principal order is hereby amended by revoking clause 11 (as substituted by clause 2 of the Wellington Savings Bank Order 1964, Amendment No. 1), and substituting the following clause:

"11. **Investments**—(1) Notwithstanding anything in section 24 of the Act, but subject to subsections (4A) and (5) thereof and to subclause (2) of this clause, the Bank may invest any money deposited in or belonging to the Bank in the following manner only:

"(a) If the total amount of such money (excluding money deposited in investment accounts) does not exceed \$2,000,000, not less than 60 percent thereof shall be invested in New Zealand Government securities:

"(b) If the total amount of such last-described money exceeds \$2,000,000, not less than \$1,200,000 thereof together with not less than 50 percent of so much thereof as exceeds \$2,000,000 shall be invested in New Zealand Government securities:

"(c) Any amount not so invested in New Zealand Government securities (excluding the amount required by subsection (3) of section 24 of the Act to be kept immediately available) may be invested in any of the ways specified in subsection (1) of section 24 of the Act.

"(2) Notwithstanding the provisions of subsection (5) of section 24 of the Act, money invested under paragraph (c) of subclause (1) of this clause on mortgages of estates or interests in land occupied or to be occupied by officers of the bank for residential purposes shall be invested on such terms and conditions as the Minister may approve in writing."

The Indecent Publications Act 1963

IN the matter of the Indecent Publications Act 1963 and in the matter of an application to the Tribunal for a decision regarding the book *Last Exit to Brooklyn* by Hubert Selby junior, published by Calder and Boyars, London.

DECISION OF THE TRIBUNAL

THE Tribunal has considered the application of the Secretary for Justice for a decision in respect of the above-named book—whether it is indecent or not or for some other decision as to its classification. The Justice Department was represented and in a letter made submissions drawing the attention of the Tribunal to paragraph (a) of section 11 (1) of the Indecent Publications Act 1963, and claiming that the dominant effect of the book as a whole “outweighed its acknowledged honesty of purpose”. The publishers made no submissions as their agents hold no stocks in New Zealand at the present time and the book would seem to have “run its course” here. The book submitted is in a hard back edition selling in England at 30s.

Last Exit to Brooklyn describes life in a district of New York where an underprivileged and frustrated population is reduced to the extremes of lawlessness and vice. The dominant effect of the book may well be one of revulsion which could nevertheless evoke salutary compassion and concern; it has the stamp of honesty and anger; such a document should not be ignored.

Its proper use however is not as casual reading for the general public because it deals almost exclusively and in sickening detail with the grossest forms of evil. We therefore classify this book as indecent except in the hands of adults engaged in work or research in sociological and related fields.

- (b) To change the name of the Corporation to "The Scout Association of New Zealand".
- (c) To provide that the said change of name shall not affect any power, rights, interests, securities, investments, or obligations of the Corporation or render defective any legal proceedings by or against the Corporation and that all real and personal property of every description held by the Corporation may be dealt with or disposed of by the Corporation under its new name, subject to all liabilities, charges, obligations, and trusts affecting the same.
- (d) To provide that on the presentation to any Registrar of Deeds or District Land Registrar or any other person of any instrument executed or purporting to be executed under the Seal of the Corporation in its new name and relating to any estate or interest in any land held by the Corporation under its former name be accepted by all persons concerned as conclusive proof that that estate or interest is vested in the Corporation.
- (e) To provide that except with the consent of the Governor-General in Council no association of persons shall exercise the functions for which it is formed under the name "Scout Association" or under a name containing those words or the words "Scouts" or "Boy Scouts"; to permit any registering authority to refuse registration if prohibited by this provision; to provide for penalties for any breach of this provision provided that such provision shall not apply to the Corporation or to any association of persons that is a member of or is affiliated to the Corporation or to any branch of such an association or to any association registered before the passing of the said Bill.
- (f) To provide that the Governor-General, by notice in the Gazette, may define the uniform of the officers and members of the Corporation and the badges that may be worn by such officers and members; to provide that it shall not be lawful for any person who is not an officer or member of the Corporation to wear any such uniforms or badges, and to provide a penalty for any breach of this provision.
- (g) To repeal section 5 of the Military Decorations and Distinctive Badges Act 1918.
