1. (i) This Proclamation may be cited as the Moutoki, Rurima, and Tokata Islands and Adjacent Rocks Wildlife Refuge Declaration.

(ii) This Proclamation shall come into force on the day after the date of its notification in the *Gazette*.

2. The area described in the Schedule to this Proclamation is hereby declared to be a wildlife refuge for the purposes of section 14 of the Wildlife Act 1953.

as relate to the hours of commencing or ceasing work, or to the issue of permits, or to the payment for overtime, or extended hours, or to holidays, and half holidays, or to the closing of shops.

1. Forty hours shall constitute a week’s work, to be worked on five days of the week, and eight hours shall constitute a day’s work in or about the exhibition, and, with the exception set out in clause 2 hereof, the daily hours shall be worked consecutively.

3. (b) Any person employed in or about the exhibition on any day that would, but for the provisions of this order, have been a whole holiday for that person by virtue of any Act or of any award or industrial agreement shall be paid for all work done on that day at not less than twice the ordinary rate, whether the work is performed wholly in or about the exhibition or otherwise: Provided that nothing in this sub-clause shall be deemed to deprive any person of any other payment for the said holiday to which he is entitled under any Act or award or industrial agreement.

4. No male under 18 years of age and no female shall be employed in or about the exhibition after the hour of 10.30 p.m.

5. \*The sunshine recorder is not located at the station but is in the near vicinity.

## NOTES ON THE WEATHER FOR JANUARY 1969

*General*—January weather was mainly average. Farming areas which had experienced rather dry weather in December had rainfall above average in January, and growth was considered to be very good.

*Rainfall*—Rainfall was above average by about 50 percent in Bay of Plenty and Taupo, in North Taranaki, in Manawatu and Wellington, in Nelson and the Marlborough Sounds, and in most of Southland and Otago together with part of South Canterbury.

In the Alps, Fiordland, and South Westland, and also in Northland and parts of Taihape, rainfall was only half the average value. It was also somewhat drier than usual in Gisborne and Hawke's Bay. Parts of Northland received less than a quarter of their average rainfall.

Some unusually heavy hail was reported, notably in Hawke's Bay on the 15th, Canterbury on the 21st, and Wellington on the 22nd. The amount of hail in these storms was sufficient to cover the ground; and in Canterbury the hailstones were up to 2 in. in diameter, causing considerable damage to crops, glasshouses, and windows.

*Temperatures*—Temperatures were mainly close to normal. However, Waikato and Waitomo, the West Coast, Central Otago, and western Southland were a degree cooler than the average.

*Sunshine*—Sunshine was mainly close to normal. Southland and most of Otago were below average by 20–30 hours; and northern Northland was favoured with a similar amount above average.

*Weather Sequence*—The first 3 days of January were mainly fine, under the influence of an extensive belt of high pressure. However, some rain was reported in northern Northland in the easterlies.

From the 4th to the 6th a complex trough of low pressure moved slowly eastward across the country accompanied by a period of rain. The rain became fairly general on the 6th as a small depression formed over the North Island. Considerable falls were recorded in Nelson, Manawatu, North Taranaki, and Bay of Plenty, with

some flooding. Many thunderstorms were reported. Unsettled conditions persisted for 3 more days during the passage of another complex trough, but the rain was lighter. A southerly change on the 10th brought showers to coastal areas from Invercargill to Christchurch besides some western coastal districts of the North Island.

An anticyclone brought generally fair weather on the 11th, but on the following day another southerly change caused fairly heavy downpours in parts of Wairarapa and Bay of Plenty. A trough associated with a small depression crossed the country from the 13th to the 15th, and by the 16th a complex depression covered New Zealand. Rain was fairly general on the 14th and 16th, except in some eastern districts, but mainly scattered on the other days. Thunderstorms with heavy hail were reported in Hawke's Bay on the 15th. A southerly change on the 17th brought rain mainly to Canterbury, Marlborough and Nelson, and Hawke's Bay.

An anticyclone over the North Tasman Sea extended on to New Zealand from the 18th to the 20th. The weather was fine, apart from some rain on the West Coast on the 19th. As pressures fell to the east and south-east a cold front brought heavy showers to eastern districts on the 21st and 22nd. Thunderstorms were reported, with some heavy hail, especially in Canterbury, where hailstones the size of golf balls caused considerable damage to crops and broke some windows. During the 23rd and 24th a small depression over the eastern Tasman Sea moved north-eastward across Auckland, causing rain from North Taranaki to Northland.

An anticyclone passing to the north brought mainly fine weather from the 25th to the 27th. During the last 4 days of the month the weather deteriorated generally once again with the passage of a complex depression from the Tasman Sea. One centre crossed Southland, while the other drifted slowly north-eastward across the North Island. Some considerable falls of rain affected Bay of Plenty on the 29th and 30th.

## Price Order No. 2099 (Butter)

PURSUANT to the Control of Prices Act 1947, the Price Tribunal hereby makes the following Price Order:

## PRELIMINARY

1. This order may be cited as Price Order No. 2099, and shall come into force on the 28th day of February 1969.

2. (1) Price Order No. 2037\* is hereby revoked.

(2) The revocation of the said price order shall not affect the liability of any person for any offence in relation thereto committed before the coming into force of this order.

(3) Notwithstanding the revocation of Price Order No. 2037, any approvals given under clause 14 of that price order shall continue to have effect as if the said order had not been revoked.

3. (1) In this order, unless the context otherwise requires,—“the said Act” means the Control of Prices Act 1947; “the said regulations” mean the Butter and Cheese Marketing Regulations 1948†.

(2) Terms and expressions defined in the said Act, or in the said regulations, when used in this order, have the meanings severally assigned thereto by the said Act or by the said regulations, as the case may be.

4. The grades referred to in this order shall, as the case requires, mean:

(a) Grades assigned at a grading store; or

(b) Grades assigned in a manufacturing dairy as prescribed by regulation 26 of the said regulations; or

(c) Grades constructively assigned pursuant to subclause (4) of regulation 26 of the said regulations.

## APPLICATION OF THIS ORDER

5. This order applies with respect to all sales in New Zealand by way of wholesale, or retail, of any butter (within the meaning of the said regulations) manufactured in New Zealand, except butter sold for use in the manufacture of ice cream or ice cream mix, or butter sold as ships' stores for vessels sailing beyond New Zealand.

MAXIMUM PRICES FOR SALES OF BUTTER BY WAY OF WHOLESALE, OR BY A MANUFACTURER TO A WHOLESALE DISTRIBUTOR, TO WHICH THIS ORDER APPLIES

6. Subject to the provisions of this order, the several maximum prices at which butter prepared in 1 lb pats or smaller portions may be sold by way of sale by wholesale shall be the following:

(a) In the case of salted creamery butter the standard of quality of which is not lower than First Grade, the price of 26.75c per pound:

(b) In the case of salted creamery butter, the standard of quality of which is Second Grade, the price of 26.54c per pound:

(c) In the case of whey butter the standard of quality of which is not lower than Second Grade, the price of 26.75c per pound.

7. The price of butter sold in bulk by way of sale by wholesale, being butter of one of the kinds and standards of quality set out in clause 6 of this order, shall be 0.104 of a cent per pound less than the respective price prescribed for butter of that kind and standard of quality by the said clause 6 hereof.

8. The price of unsalted creamery butter the standard of quality of which is not lower than First Grade, and which is sold, whether in bulk or pats, by way of sale by wholesale as aforesaid shall be 1c per pound more than the respective price prescribed for salted creamery butter by the foregoing provisions of clause 6 of this order.

9. Notwithstanding anything in the foregoing provisions of this order, the price for any parcel of butter sold, whether in bulk or in pats, in a quantity of less than 48 lb, by way of sale by wholesale as aforesaid, being butter of one of the kinds and standards of quality set out in clause 6 of this order, may (at the option of the vendor) be the sum of 5c per parcel more than the appropriate price prescribed for butter of that kind and standard of quality by the foregoing provisions of this order, and the said sum of 5c shall be added to the rate of 0.792 of a cent per pound or portion of a pound referred to in clause 10 of this order for the purpose of that clause.

10. In the case of sales by a manufacturer to a wholesale distributor, the prices at which butter shall be so sold shall be 0.792 of a cent per pound or portion of a pound less than the respective prices hereinbefore specified.

11. Any butter sold in pursuance of the provisions of clauses 6, 7, 8, 9, or 10 of this order shall be delivered freight free into the purchaser's premises.

## MAXIMUM RETAIL PRICE OF BUTTER TO WHICH THIS ORDER APPLIES

12. (1) The maximum retail price of butter to which this order applies shall be computed at the rate of:

(i) 28c per pound for salted creamery butter.

(ii) 29c per pound for unsalted creamery butter.

(iii) 28c per pound for whey butter.

(iv) 27c per pound for dairy butter.

(2) If, in respect of any lot of butter sold by a retailer, the maximum price calculated in accordance with the foregoing provisions of this clause is not an exact number of cents, the maximum price of the lot shall be computed to the nearest whole cent.

**SPECIAL PRICES WHERE EXTRAORDINARY CHARGES INCURRED**

13. Notwithstanding anything in the foregoing provisions of this order and subject to such conditions, if any, as it thinks fit, the Tribunal, on application by any trader, may authorise special maximum prices in respect of any butter to which this order applies where special circumstances exist or for any reason extraordinary charges are incurred by the trader. Any

authority given by the Tribunal under this clause may apply with respect to a specified lot or consignment of butter or may relate generally to all butter to which this order applies sold by the trader while the approval remains in force.
