- (e) The desirability of any action to further control the extent of overseas ownership or investment or their development along any particular line;
- (f) The methods by which any such action deemed desirable could be put into effect;
- (g) Any other matters considered to be relevant.

4. The Committee is hereby authorised to—

- (a) Hold public meetings at which evidence can be presented;
- (b) Hold closed meetings at which evidence of a confidential nature can be heard;
- (c) Request reports and other information from Government departments and other interested parties.
