KEITH HOLYOAKE, C.H., PRESIDING IN COUNCIL PURSUANT to section 274 of the Public Works Act 1928 and to Part I of the Public Works Amendment Act 1960, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. This order may be cited as the Lower Waitaki Irrigation

District Order 1970.

2. The Minister of Works is hereby authorised to construct, maintain, and control the water supply works described in the First Schedule hereto, to serve the district described in the

Second Schedule hereto.

3. The area of land described in the Second Schedule is hereby constituted as an irrigation district, to be known as the Lower Waitaki Irrigation District (herein referred to as "the district")

4. It is hereby declared that the water quota shall be 24 in. over the land in the district commanded by supply points and not exempted pursuant to section 13 of the Public Works Amendment Act 1960.

5. It is hereby declared that the irrigation charge which will be payable for half the water quota shall be \$1.84 per acre of land in the district commanded by supply points and not exempted as aforesaid, reducible over the first nine irrigation seasons of supply to the charges set out in the Third Schedule hereto.

6. It is hereby declared that the charge which will be payable for such water as may be supplied in excess of half the water quota but not in excess of the total water quota shall be at the rate of \$0.92 per acre-foot.

FIRST SCHEDULE

WATER SUPPLY WORKS

THE Lower Waitaki Irrigation Works (for the irrigation of the district) by means of water drawn from the Waitaki River and from any dam or dams which are or may be constructed or acquired on the said river or any other river or stream, such water being conveyed into the district by a race or races constructed or acquired by the Minister of Works, or by any enlargement or extension thereof; the said works, including all dams, weirs, reservoirs, tunnels, fluming, siphons, piping, gates, and races, and all other works incidental to or required for the construction, maintenance, and control of the said works for the irrigation of the district.

PURSUANT to the Control of Prices Act 1947, the Price Tribunal hereby makes the following price order:

PRELIMINARY

- 1. This order may be cited as Price Order No. 2129 and shall come into force on 20 April 1970.
- 2. (1) Price Order No. 2080* shall be revoked on the coming into force of this order.
- (2) The revocation of the said order shall not affect the liability of any person for any offence in relation thereto committed before
 - (3) Notwithstanding the revocation of Price Order No. 2080: (i) any approvals given under clause 10 of that price order shall continue to have effect as if the said order had not been revoked.

- 18 lb of wet gluten, and no less than 6 lb of fat with either dried milk or condensed milk.
- 6. Subject to the provisions of this order, the prices set out in the Second and Fourth Schedules to this order shall be the maximum prices which may be charged or received for any bread described in clauses 4 and 5 of this order which is sliced or unsliced and enclosed and securely wrapped at the bakehouse in clean unused paper.
- 7. The wholesale prices fixed by this order apply to bread delivered to the retailer's premises. In any case where bread is not so delivered the prices shall be such as are agreed upon between the baker and the retailer, or failing such agreement, as may be approved by the Tribunal.

GENERAL

- 8. A booking fee at the rate of one quarter cent (½c) per loaf for loaves of not more than 1 lb weight and one half cent (½c) per loaf for loaves exceeding 1 lb weight may be made for any bread sold by a retailer to which this order applies, provided that payment for the bread so sold has not been made prior to, or at the time of, the customer's taking delivery of the bread at the shop.
- 9. The maximum retail selling prices provided for in this order shall include the service of wrapping where this service is provided by the retailer.

SPECIAL PRICES WHERE EXTRAORDINARY CHARGES INCURRED

10. Notwithstanding anything in the foregoing provisions of this 10. Notwithstanding anything in the foregoing provisions of this order, and subject to such conditions, if any, as it thinks fit, the Tribunal, on application by any wholesaler, or retailer, may authorise special maximum prices in respect of any bread to which this order applies where special circumstances exist or for any reason extraordinary charges (freight or otherwise) are incurred by the wholesaler or retailer. Any authority given by the Tribunal under this clause may apply with respect to a specified lot or consignment of bread or may relate generally to all bread sold by the wholesaler or retailer, while the approval remains in force. force.
