GREETING:

WHEREAS it is deemed expedient that inquiry should be made into New Zealand merchant shipping operations for the general purpose of recommending what changes are necessary and what things should be done to promote a soundly based, adequate, and efficient sea transport system, and matters inci-dental thereto:

therefore, pursuant to the Commission of Inquiry Now. Act 1908, I, the Right Hon. Sir Herbert Richard Churton Wild, the Administrator of the Government of New Zealand, acting by and with the advice and consent of the Executive Council, hereby appoint you, the said Raymond Douglas Jamieson, Carleton Hunter Perkins, and Ian Douglas Stevenson, to be a Commission to inquire into, report upon, and make recommendations on the following matters:

 (c) the improvement of maritime operational efficiency; and, further, having regard primarily to (a), (b), and (c) above, to consider:
 (d) the information available within New Zealand and evidence from New Zealand sources, with a view to recommending on New Zealand participation in sea transport: transport:
- (e) matters relating to legislation and administration affecting the efficiency of sea transport.

And with the like advice and consent I do further appoint you, the said Raymond Douglas Jamieson, Esquire, Stipendiary Magistrate, to be Chairman of the said Commission:

And you are hereby strictly charged and directed that you shall not at any time publish or otherwise disclose, save to me in pursuance of these presents or by my direction, the contents or purport of any report so made or to be made by you or any evidence or information obtained by you in exercise of the powers hereby conferred upon you except such evidence or information as is received in the course of a sitting open to the public:

And it is hereby declared that the powers hereby conferred shall be exercisable notwithstanding the absence at any time of any one of the members hereby appointed:

And it is hereby further declared that you have liberty to report your proceedings and recommendations under this Com-mission from time to time if you shall judge it expedient so to do:

And, using all due diligence, you are required to make an interim report to me in writing under your hands not later than the 31st day of July 1970 about your findings and opinions on the matters coming under subparagraphs (a) and (b) of the terms of reference and, in particular, to include specific recommendations on the matters set out in subparagraph (a).

Amendments to the Rules of the Royal Society of New Zealand

PURSUANT to the Royal Society of New Zealand Act 1965 the Fellows of the Royal Society of New Zealand Act 1905 the Fellows of the Royal Society of New Zealand, at the annual general meeting held on 20 May 1970, passed resolutions amending the rules of the Society published in the *Gazette* on 22 December 1965, 29 June 1967, and 13 June 1968: the effect of such resolutions being:

SECTION J II-HECTOR MEMORIAL RESEARCH FUND Rule 6 was amended to read:

The medal and prize shall be awarded in rotation for the sciences; (c) human sciences; (d) solid earth sciences; (e) physical, mathematical, and engineering sciences; (f) animal sciences

SECTION J III—HAMILTON MEMORIAL FUND

Rules J III 3-10 were amended to read:

Rule 3

The memorial shall be a bronze medal and prize to be called "The Hamilton Memorial Medal and Prize", the object of which shall be the encouragement of beginners in scientific research in New Zealand.

Rule 4

It shall be a first charge upon the fund to procure each ear a bronze medal to be known as "The Hamilton Memorial Medal".

Rule 5

The fund, or such part thereof as shall not be used as aforesaid, shall be invested in such securities as may be approved by the Council, and the interest arising from such investment, after the payment of all expenses legally incurred by the Council in the investment and administration

of the said fund, shall be used for the furtherance of the objects of the fund by providing thereout a prize for the encouragement of such scientific research in New Zealand of such amount as the Council shall from time to time determine. The Council may supplement the money available for the prize with money derived from other sources.

Rule 6

The medal and prize shall be awarded annually by the Council but in no case shall an award be made unless, in the opinion of the Council, there is evidence of scientific work of great merit.

Rule 7

The medal and prize shall be awarded for scientific research carried out in New Zealand or in the islands of the South Pacific Ocean which has been published within 5 years preced-ing the last day of January prior to the Council meeting at which the award is made. Such publication may consist of which the award is made. Such publication may consist of one or more papers, and shall include the first investigation published by the author. No candidate shall be eligible for the medal and prize who prior to such period of 5 years has published the results of any scientific investigation in a recognised scientific journal. A notice or advertisement of the award shall be distributed to Fellows and member bodies and other appropriate organisations in October of each year. Rule 8

At the first meeting after the annual general meeting the Council shall appoint a Hamilton Award Committee to recommend the award for the coming year; the committee shall consider candidates for the medal and prize in the following categories :

- (a) Candidates for the medal and prize who send to the General Secretary, on or before December 31 preceding the Council meeting at which an award is to be considered, an intimation of his or her candidature, together with at least two copies of each publication
- (b) Candidates nominated by Fellows or members of the Society who shall send such nominations to the General Secretary on or before 31 December preceding the Council meeting at which an award is to be considered, and shall send at least two copies of each publication on which the nomination is based based.
- (c) Candidates nominated and recommended by the Hamilton Award Committee, even if they have not applied under rule J III 8 (a) and have not been nominated under rule J III 8 (b), provided that they are eligible under rule J III 7.

Rule 9

Whenever possible the medal and prize shall be presented in some public manner.

Rule 10

There shall be published in each volume of the proceedings a complete list of awards of the Hamilton Memorial Medal and Prize.

Decision of the Indecent Publications Tribunal

No. 205

In the matter of The Indecent Publications Act 1963, and in The matter of an application by the Comptroller of Customs for a decision in respect of the book Sex Manners for Advanced Lovers by Robert Chartham, published by the New English Library Ltd., Barnard's Inn, London.

DECISION OF THE TRIBUNAL

THERE was no appearance on behalf of the Comptroller of Customs nor of the publisher's representative in New Zealand. Accordingly no submissions were made to the Tribunal.

Accordingly no submissions were made to the Iribunal. The curious word "Manners" in the title of a manual of instruction on erotic techniques not commonly practised may be noted with uncritical semantic interest; but the author's honesty of purpose comes into question for other reasons. It is claimed the author deals with "new forms of erotic behaviour", but this titillating claim is not in fact substantiated. The author may not be blame-worthy; but if he is not, his publishers are. Also the author's qualifications are summarily described as those of a "marriage counsellor", but no academic or institu-tional authority for the use of this title is mentioned. Second, the treatment and style of this manual are not consonant with its purported scientific purpose. The treatment is emotionally its purported scientific purpose. The treatment is emotionally directed; the style is loose, slick, and sentimentally tendentious. Third and finally, the jacket carries a picture that sustains the first critical objection stated above. There is room for books on this subject but for the reasons stated above the Tribunal decides this book to be indecent.

Decision of the Indecent Publications Tribunal

No. 206-219

IN the matter of The Indecent Publications Act 1963, and in the matter of an application by the Comptroller of Customs in respect of 14 paper backs enumerated below.

DECISION OF THE TRIBUNAL

THE Tribunal has been called upon to consider an application made by the Comptroller of Customs in respect of 14 books enumerated below—for a decision regarding each whether it is indecent or for a decision as to its classification.

The books submitted are:

- The Sex Framer, by Stacey Clubb.
 The Colour of Love, By Kevin McLeod.
 A Girl Must be Loved, by G. G. Fickling.
 His Private Pleasure, by Joseph Hilton Smyth.
 The Murky Underground, by Sylvia Sharon.
 The Man Who Played with Dolls, by Paul Clay.
- 6. The Man Who Played with Dolls, by Paul C
 7. Nurses Wild, by Florence Stonebreaker.
 8. Chris, by Randy Salem.
 9. The Exhibitionist, by Lillian Preston.
 10. One Hot Winter, by Dixie Chappell.
 11. Liz, by Frank Kane.
 12. Community of Women, by Sheldon Lord.
 13. The Overnighters, by Brian Black.
 14. Many Men for Rosetta, by Karol Thomas.

There was no appearance on behalf of the Comptroller of Customs nor of the publisher's representative in New Zealand. Accordingly no submissions were made to the Tribunal.

These 14 second-rate paper backs, all issued by the Softcover Library, London, rely on sex, perversion, crime, or violence as themes. In the first four these themes are handled in a realistic fashion, with some pretence of plot, setting, and credible motivation. There are no grounds in the statute for judging such books, however poor in quality, to be indecent. The next six however, there is no story but only a repetition of incidents and no characters, but merely perpetrators of perverted, violent, or criminal acts. To make such obsession appear admirable or even normal could do harm to persons of limited experience and we classify these books as indecent in the hands of persons under 18 years of age. In the remaining four the obsession is unrelieved and the books are nothing more than vicious and crude in the extreme and we decide them to be indecent.

The Tribunal notes that several books in the series exhibit a certain dishonesty in presentation, being described as "fully illustrated throughout", when in fact the illustrations consist of a central insert of six or eight photographs of nudes and semi-nudes quite irrelevant to the text.

The Sex Framer

Sex relations and problems diversify a novel which develops the unusual theme of the recovery of a lost work of art and the rise to celebrity of a young artist. We do not think it is indecent.

The Colour of Love

This is a sentimental story of a young man's successive love affairs with negro, white, and Chinese girls. It is harmless.

A Girl Must be Loved

This rather silly romantic story exhibits some emphasis on sex but not excessively or offensively.

His Private Pleasure

An unusual book, because it suggests how researches into sex mores may be promoted and conducted. Such research provides the theme of this book, but its treatment of its copious sexual episodes is not such as to justify any restriction.

The Murky Underground

This story pursues the sexual trials of a girl who ends happily in the arms of a faithful lover. The treatment is sexually obsessed but the Tribunal is of the opinion that the book does not warrant complete exclusion.

The Man Who Played with Dolls

This is a story of sex and big business and its rivalries, carried not very objectionably to the point when the previously triumphant man of affairs in both senses is knocked out by his chief engineer and successor, but its sexual content is morbidly emphasised.

Nurses Wild

This novel about sex problems and professional rivalry in a hospital staff and outside is so over-wrought in sexual emphasis as to make it unsuitable for young readers.

Chris

The heroine of this story is divided in lesbian relations with two very different girls and in different ways. Events take her to the rupture of both relations and to a crisis in her profes-sional career. The theme and its development make the book undesirable for young readers.

The Exhibitionist

This is a rather stupid novel about a man who turned from his affair with a girl who strip-teased in his room and went from that to his falling in love with another girl, whom he watched with binoculars as she performed before the windows across the court. Because the theme and treatment are somewhat unwholesome an age restriction on its distribution is warranted.

One Hot Winter

The plot and development of this story of sex and crime are so toned as to justify a restriction on its distribution. Liz

In this story an unscrupulous career girl, advancing from solo crime to gang leadership, uses sex all the way. The treatment of sex and violence is of such nature as to be injurious to the public good.

Community of Women

The tone and emphasis of this novel about the drift of idle women into sex diversions, normal or deviant, make it more than objectionable.

The Overnighters

The crude and pervasive emphasis on sex in this novel is varied only by its emphasis on profits but not redeemed by that.

Many Men for Rosetta

This story writes wild sex and crime, planned and callous. The treatment of both is sufficient to justify the conclusion that its distribution would be injurious to the public good.

The Tribunal accordingly decides that the first four listed above are not indecent, the next six are decided to be indecent in the hands of persons under 18 years of age, and the remaining four are decided to be indecent.
