Alteration to the Scale of Charges Upon the New Zealand Government Railways

[1/70]

GENERAL SCALE OF CHARGES

PURSUANT to the Government Railways Act 1949, the Minister of Railways hereby makes the following alterations to the General Scale of Charges made on the 23rd day of March 1967 and published in the Supplement (dated the 17th day of April 1967) to the *New Zealand Gazette* of the 13th day of April 1967, in force on the New Zealand Government Railways, and hereby declares that such alterations shall come into force on the 13th day of July 1970.

GENERAL SCALE OF CHARGES PASSENGERS

8. Miscellaneous Concession Fares

1. General-Paragraph (a) Omit this paragraph and substitute:

(a) Subject to the conditions specified hereafter, tickets may be issued at the special excursion fares specified in section 6, or as otherwise provided in this section. Fares issued under the provisions of section 6 will not, however, be available for travel on "Southerner" express services on the South Island main trunk route. Fares as specified in section 27 less 10 percent will be granted to approved organisations for travel on this service. Such tickets issued will have the same availability (both as to period of time and break of journey) as ordinary tickets (section 2). The Department reserves the right to decline any application for tickets under the provisions of this section.

12. Railway Employees' Privilege Tickets

1. Privilege Single or Return Tickets-Omit this paragraph and substitute:

1. **Privilege Single or Return Tickets**—Privilege tickets at one-fourth the ordinary fares (section 2), fares as specified in section 27, or local fares (section 32), where applicable, may be issued to railway employees and their wives and children in terms of the regulations made pursuant to the Government Railways Act 1949, and orders of the Government Railways Industrial Tribunal. Children 4 years of age and over will be charged the adult privilege fare. 1229

Insert new section No. 27:

27. Special Fares for South Island Limited

1. Fares—The following fares will be charged for travel on Nos. 143 and 144 "Southerner" express services on the South Island main trunk route.

3. Bulk Travel Vouchers—Where bulk travel vouchers are presented for tickets to travel on the "Southerner", mileages to be deducted are to be calculated on actual mileage.
