Price Order No. 2142 (Spirits and Beer)

PURSUANT to the Control of Prices Act 1947, the Price Tribunal hereby makes the following Price Order:

PRELIMINARY

1. Price Order No. 2139* is hereby revoked.

2. This order may be cited as Price Order No. 2142 and shall come into force on 29th day of September 1970.

3. In this order, unless the context otherwise requires

- "Ounce" means fluid ounce as defined in the Weights and
- Measures Proclamation 1946[†]: "Standard Measure" means five-eighths of an ounce: "Quart" means a bottle customarily referred to in the licensed trade as a quart bottle, and having a capacity of approximately 26³ oz.
- 4. In this order, unless the context otherwise requires-
- (a) The Act means the Control of Prices Act 1947; and
 (b) Terms and expressions defined in the Act have the meanings so defined.

APPLICATION OF THIS ORDER

- 5. This order shall apply-
- (a) To all intoxicating liquor sold in public bars of hotels, taverns, or other premises licensed under the Sale of Liquor Act 1962, and
- bottles containing 1 quart, sold in hotels, taverns, or other premises licensed under the Sale of Liquor Act 1962 for consumption off the premises. (b) To

FIXING MAXIMUM PRICES OF BEER SOLD IN PUBLIC BARS

6. (1) Subject to the provisions of this order, the maximum price that may be charged by the licensee of licensed premises for beer sold in public bars shall be-

- (a) Where the beer is served in a container of a capacity of 20 oz. 25 cents:
- (b) Where the beer is served in a container of a capacity of 12 oz. 16 cents:
- (c) Where the beer is served in a container of a capacity of 8 oz, 11 cents:
- (d) Where the beer is served in a container of a capacity of 7 oz, 10 cents:
- (e) Where the beer is served in a container of a capacity of 5 oz, 7 cents:
- (f) Where the beer is served in jugs of a capacity of 35 oz, 43 cents:
- (g) Where the beer is sold in bottles or cans containing less than 1 quart: the price per bottle or can ruling at the particular premises on 7 August 1970, increased by 1 cent per bottle or can:
- (h) Where the beer is sold in bottles containing 1 quart: the price per bottle ruling at the particular premises on 7 August 1970, increased by 2 cents per bottle:
- (i) Where beer is served in a container or jug having a capacity other than those specified in (a) to (f) above, the maximum prices that may be charged for beer so sold shall be the price ruling on 7 August that the served is a solution of the served of the price rule of the served of the ser 1970, provided, however, that the Tribunal, on appli-cation by the licensee of the licensed premises, may authorise an amended maximum price.

FIXING MAXIMUM PRICES OF SPIRITS SOLD IN PUBLIC BARS

7. Subject to the provisions of this order, the maximum price that may be charged by the licensee of licensed premises for each standard measure of spirits sold in public bars shall be-

8. A licensee of licensed premises shall not make an addi-tional charge for aerated water or cordial added to spirits sold in public bars, but may sell aerated water by the bottle as a separate transaction but not otherwise.

FIXING THE MAXIMUM PRICES OF BEER SOLD FOR CONSUMPTION OFF THE LICENSED PREMISES

9. (1) Subject to the provisions of this order, the maximum price that may be charged by the licensee of licensed premises for beer sold for consumption off the licensed premises shall he

- (a) Beer sold in bottles containing 1 quart: the price per bottle ruling at the particular premises on 7 August 1970 increased by 2 cents per bottle:
 (b) Beer sold in flagons, 80 cents:
 (c) The additional premises on flagons purplied by the the second present of the second present
- (c) The additional charge for flagons supplied by the licensee shall be the amount that was charged at the
- (d) No additional charge shall be made where an empty flagon is supplied by the customer.

GENERAL

10. Notwithstanding anything in the foregoing provisions of the order and subject to such conditions, if any, as it thinks fit, the Tribunal, on application by the licensee of any licensed premises may authorise special maximum prices in respect of any beer or spirits to which this order applies where special circumstances exist or for any reason extraordinary charges (freight or otherwise) are incurred by the applicant. Any authority given by the Tribunal under this clause shall be exhibited in the manner prescribed by clause 11 hereof.

11. Every licensee of licensed premises, shall keep a statement of the retail prices fixed thereby prominently displayed-

- (a) In the public bar, and
- (b) In every place on the premises where draught beer in flagons, and bottled beer in bottles containing 1 quart, is sold for consumption off the premises, in such a position as to be easily read by customers without having to ask for its production and without having to obtain permission to examine it.

The Control of Prices (Positive List) Notice 1966-Amendment No. 18

PURSUANT to the Control of Prices Act 1947, the Minister of Industries and Commerce hereby gives the following notice.

1. This notice may be cited as the Control of Prices (Posi-tive List) Notice 1966, Amendment No. 18, and shall be read together with, and deemed to be part of, the Control of Prices (Positive List) Notice 1966 (hereinafter referred to as the principal notice)

2. This notice shall come into force on 28 September 1970. 3. The principal notice is hereby amended by adding under the general heading FOODSTUFFS AND RELATED COMMODITIES a subheading "Intoxicating liquor" and adding under that subheading the following description:

- "(a) All intoxicating liquor sold in public bars of hotels, taverns, or other premises licensed under the Sale of Liquor Act 1962, and
 "(b) All draught beer in flagons, and bottled beer in bottles containing 1 quart, sold in hotels, taverns, or other premises licensed under the Sale of Liquor Act 1962, for consumption off the premises."
