Declaring an Area in the North Canterbury Acclimatisation District to be a Wildlife Refuge

ARTHUR PORRITT, Governor-General

A PROCLAMATION

PURSUANT to section 14 of the Wildlife Act 1953, I, Sir Arthur Espie Porritt, Baronet, the Governor-General of New Zealand, hereby proclaim as follows:

1. (i) This Proclamation may be cited as the Te Oka Bay Wildlife Refuge Declaration. (ii) This Proclamation shall come into force on the day

after the date of its notification in the Gazette.

2. The area described in the Schedule to this Proclamation is hereby declared to be a wildlife refuge for the purposes of section 14 of the Wildlife Act 1953.

Amendment to Rules of the Waimarino Acclimatisation Society

PURSUANT to section 29 of the Wildlife Act 1953, the Minister the following new rules made by the Waimarino Acclimatisa-tion Society to stand in place of rules 9, 10, and 19 respectively which were originally approved by the Minister of Internal Affairs on 24 April 1957:

COUNCIL

9. (1) The society shall be governed by a Council of 12 members. All shall be elected from and by the general membership and shall not be eligible for election unless they have their principal place of residence within the district.

(2) The Council shall elect from Council a President and two Vice-Presidents, to hold office for a term of 1 year. They shall be eligible for re-election. If for any reason the position of President or Vice-President becomes vacant, the Council shall elect one of its members for the unexpired term.

(3) The President and Vice-Presidents shall be elected at the first Council meeting after the annual general meeting.

(4) At each annual general meeting, subject to subclause (5) of this rule, the four councillors who have been longest on the Council without being re-elected shall retire, but shall be eligible for re-election.

(5) In the event of any member of the Council dying, resigning, or vacating his office, the Council shall appoint to the vacancy the unsuccessful candidate who obtained the most votes at the previous election, or failing his availability, any member of the society who is available and eligible; such appointment shall expire when the member so replaced would have retired according to rule.

(6) The President, Vice-Presidents, or any member of the Council shall vacate his office if he has absented himself from three consecutive meetings of the Council without leave of absence having been granted by the Council.

(7) Where the President, Vice-Presidents, or any member of the Council ceases to have his principal place of residence within the district he shall cease to be a member of the Council as from the date of his leaving the district.

(8) The President, Vice-Presidents, or any member of the Council shall vacate his office if he ceases to be a member of the society.

ELECTION OF COUNCIL

10. The election of members of the Council shall be conlucted by ballot in the following manner:

All nominations for office, accompanied with the written onsent of the person nominated, must be lodged with the secretary at least 28 days before the annual general meeting. Should more than the required number of nominations be received an election shall be held at the annual general neeting. Voting papers shall be prepared containing the names f such required and the and one woting namer shall be of such nominated candidates, and one voting paper shall be upplied to each member present. Each voting paper shall be tamped with the corporate seal of the society. Each member hall leave uncancelled the name of the candidate for whom he desires to vote, and shall strike out the name of any candi-

date for whom he does not desire to vote. No member shall vote for more than the requisite number for any position, and any voting paper containing more than that number shall be any voting paper containing more than that number shall be invalid. Two scrutineers shall be appointed by the Council. The requisite number of candidates receiving the highest number of votes shall be declared duly elected. In the event of tie, lots shall be drawn by the chairman. No proxies shall be allowed. After the declaration of the ballot the scrutineers shall hand over to the Secretary all the ballot papers under cover. The ballot papers may be destroyed at the expiration of 3 months from the date of the annual general meeting. 3 months from the date of the annual general meeting.
