*Royal Commission to Inquire Into and Report Upon Handling of Containers, Seafreighters, and Unitted Cargo*

ELIZABETH THE SECOND, by the Grace of God of the United Kingdom, New Zealand, and Her Other Realms and Territories Queen, Head of the Commonwealth, Defender of the Faith:

To Our Trusty and Well-beloved LAURENCE HENRY SOUTHWICK, of Auckland, one of Her Majesty's Counsel; the HONOURABLE ARNOLD HENRY NORDMEYER, C.M.G., of Wellington, retired member of Parliament; and FRANK ANDREW REEVES, C.B.E., of Auckland, retired general manager:

GREETING:

KNOW YE that We, reposing trust and confidence in your integrity, knowledge, and ability, hereby nominate, constitute, and appoint you, the said

LAURENCE HENRY SOUTHWICK,  
THE HONOURABLE ARNOLD HENRY NORDMEYER, and  
FRANK ANDREW REEVES

to be a Commission to receive representations upon, inquire into, investigate, and report upon:

1. All matters (other than the question of which ports are to be container ports) relating to the packing, unpacking, stowing, stacking, storing, and general handling of containers, seafreighters, and unitted cargo in respect of both existing and projected services by sea for New Zealand coastal, inter-Island, trans-Tasman, and international cargo transportation with the objective of ensuring the most efficient and economic operation under New Zealand conditions.

2. Such other associated matters as may be brought to the notice of the Commission or initiated by it which the Commission considers relevant to its functions as defined in clause 1 hereof.

And We hereby appoint you the said

LAURENCE HENRY SOUTHWICK

to be the Chairman of the said Commission.

And for the better enabling you to carry these presents into effect you are hereby authorised and empowered to make and conduct any inquiry or investigation under these presents in such manner and at such time and place as you think expedient, with power to adjourn from time to time and place to place as you think fit, and so that these presents shall continue in force and any such inquiry may at any time and place be resumed although not regularly adjourned from time to time or from place to place:

And you are hereby strictly charged and directed that you shall not at any time publish or otherwise disclose, save to His Excellency the Governor-General, in pursuance of these presents or by His Excellency's direction, the contents of any report so made or to be

made by you, or any evidence or information obtained by you in the exercise of the powers hereby conferred on you, except such evidence or information as is received in the course of a sitting open to the public:

And it is hereby declared that the powers hereby conferred shall be exercisable notwithstanding the absence at any time of any one of the members hereby appointed so long as the Chairman and the other member are present and concur in the exercise of the powers:

And using all due diligence you are required—

- (a) To give priority in conducting your inquiry and investigation to the matters specified in clause 1 hereof so far as they relate to the services already existing, and to report to His Excellency the Governor-General in writing under your hands, as soon as practicable, your findings and opinions on those matters, together with such recommendations as you think fit to make in respect thereof:
- (b) To report to His Excellency the Governor-General in writing under your hands, not later than the 31st day of December 1971, your findings and opinions on the other matters aforesaid, together with such recommendations as you think fit to make in respect thereof:

And We do further ordain that you have liberty to report your proceedings and findings under this Our Commission from time to time if you shall judge it expedient to do so:

And, lastly, it is hereby declared that these presents are issued under the authority of the letters patent of His Late Majesty King George the Fifth, dated the 11th day of May 1917, and under the authority of and subject to the provisions of the Commissions of Inquiry Act 1908, and with the advice and consent of the Executive Council of New Zealand.

In witness whereof We have caused this Our Commission to be issued and the Seal of New Zealand to be hereunto affixed at Wellington this 24th day of May 1971.

ORDER IN COUNCIL

At the Government House at Wellington this 24th day of May 1971

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Electric Power Boards Act 1925, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

#### ORDER

1. (i) This order may be cited as the Grey Electric Power District Representation Order 1971.

(ii) This order shall come into force on the date of the next general election of members of local authorities.

2. The part of the Charleston Riding of the Buller County and the part of the Lyell Riding of that county situated within the Grey Electric Power District shall each be a separate constituent district of the said electric power district.

3. The constituent districts of the Grey Electric Power District which are bracketed together in the first column of the Schedule hereto shall be combined districts for the purposes of the said Act.

4. The local authorities of the constituent districts distinguished in the first column of the Schedule hereto by the letter "(P)" shall be the principal local authorities of the said combined districts.

5. The number of representatives of each constituent district or combined district of the Grey Electric Power District on the Grey Electric Power Board shall be the number specified in the Schedule hereto opposite the name of that constituent district or combined district.

6. The Order in Council dated the 30th day of September 1959, and published in the *Gazette* on the 1st day of October 1959, at page 1381, reappportioning representation on the Grey Electric Power Board is hereby revoked.

## Tariff and Development Board Notice No. 226—New Zealand - Australia Free Trade Agreement—Elimination of Margins

1. In an exchange of letters associated with the New Zealand - Australia Free Trade Agreement, the New Zealand Government expressed the intention of eliminating the margins by which the rates of duty applicable to certain goods imported from Australia exceed those applicable to goods imported under the same Tariff item from other countries.

2. The Minister of Overseas Trade has requested the Tariff and Development Board to make recommendations from time to time on the progressive implementation of this policy and in this regard the Board now intends to consider the goods listed in the following Schedule.

3. If no representations are received to the contrary, the Board proposes to recommend that, in respect of these goods, the rates of duty applicable to imports from Australia be reduced to the level of the present British Preferential Tariff rates. Any person or firm desiring to make representations regarding an item or items should send to the under-named, not later than Friday, 20 August 1971, twelve copies in the form in which it would be intended to submit them as evidence under oath at a public inquiry and in this connection the "Notes for Guidance of Witnesses" prepared by the Board may be found of assistance. Copies of these notes may be obtained from the Board's office.

4. If public inquiries are found to be necessary in respect of any item or items notice to this effect will be given.
