Proposed Boundaries of the Electoral Districts in the North Island and South Island of New Zealand

The Representation Commission appointed in pursuance of section 15 of the Electoral Act 1956 hereby publishes, in accordance with the provisions of section 18 of the said Act, the proposed boundaries of the Electoral Districts in the North and South Islands of New Zealand; and, further, gives notice that written objections to the same will be received by the undersigned, the Chairman of the Commission, at the office of the Surveyor-General, Government Buildings, Wellington, not later than noon on Friday, the 14th day of January 1972, for consideration by the aforesaid Commission. Maps of the proposed districts may be seen at the office of any city or borough council, county council, or town board; or the office of the Chief Surveyor at Auckland, Hamilton, New Plymouth, Gisborne, Napier, Wellington, Blenheim, Nelson, Hokitika, Christchurch, Dunedin, and Invercargill, or the office of the Chief Electoral Officer at Wellington; and all Registrars of Electors.

HOBSON

ALL that piece comprising the Counties of Mangonui, Whangaroa, Hokianga, Bay of Islands, and Hobson; the Boroughs of Kaitaia, Kaikohe, and Dargeville; the Town District of Kawakawa; and the Otonga and Mangakahia Ridings of the County of Whangarei; and including Motuopao, Murimotu, Moturoa, and Stephenson Islands, the Cavalli Islands, the Poor Knights Islands, the Three Kings Islands and other adjacent islands.

WHANGAREI

ALL that piece comprising the City of Whangarei the Town District of Hikurangi, and the Kiripaki, Hikurangi, Wairua, and Manaia Ridings of the County of Whangarei; and including the Hen and Chicken Islands, the Mokohinau Islands, Fanal Island, Pataua Island, and other adjacent islands.

RODNEY

ALL that piece comprising the Maunu, Maungakaramea, Mangapai, Ruakaka, and Waipu Ridings of the County of Whangarei; the Counties of Otamatea and Rodney; the

Borough of Helensville; the Town District of Warkworth; that portion of the County of Waitemata being the Riding of Whangaparaoa and that portion of the Riding of Kaukapa-kapa to the north of a line commencing at a point on the mean high-water mark of the sea on the northern boundary of the Borough of East Coast Bays and proceeding generally South-westerly along that boundary to the middle of Albany-Browns Bay Road; thence south-westerly along the middle of that road, No. 1 and No. 18 State Highways, and Mill Flat Road to the middle of the Rangitopuni Stream; thence Flat Road to the middle of the Rangitopuni Stream; thence generally south-westerly along the middle of that stream to the middle of No. 18 State Highway; thence generally southerly along the middle of that highway to the boundary of the Riding of Kaukapakapa aforesaid; thence generally south-westerly along that boundary to the mean high-water mark of the sea; and including the Tiritiri Matangi, Kawau, Motuora, and other adjacent islands.

WAITEMATA

WAITEMATA

ALL that piece comprising portions of the Kaukapakapa, Glenfield, Waitakere, and Te Atatu Ridings of the County of Waitemata bounded by a line commencing at Te Waharoa Bay where the southern boundary of the Electoral District of Rodney meets the mean high-water mark of the sea and proceeding generally north-easterly along that southern boundary to the boundary of the Borough of East Coast Bays; thence generally southerly along that boundary and the boundary of Glenfield Riding to the middle of Glenfield Road; thence southerly along the middle of that road to the middle of Roberts Road East; thence generally north westerly along the middle of that road, Stanley and Seaview Roads and its extension to Kaipatiki Creek; thence generally westerly along the shore of that creek and the generally morthern shore of Waitemata Harbour to Brighams Creek; thence generally southerly along the shore of Waitemata Harbour and Huruhuru Creek to a point in line with Rathgar Road; thence easterly to and along the middle of that road and along the western boundaries of the Borough of Henderson to the southern boundary of Waitakere Riding; thence generally westerly along that boundary and northerly along the mean high-water mark of the sea to the point of commencement, including that portion of Te Atatu Biding the mean high-water mark of the sea to the point of commencement, including that portion of Te Atatu Riding north of No. 18 State Highway and that portion of Waitakere Riding north of No. 18 State Highway near the Lincoln Road interchange.

EAST COAST BAYS

ALL that piece comprising the Borough of East Coast Bays part of the City of Takapuna and part of the Glenfield Riding of the County of Waitemata bounded by a line commencing at the intersection of the mean high-water mark

of the sea with the production of the middle line of Rahopara Street, and proceeding generally westerly to and along that street and the middle of Marama Street, Seaview Road, Parr Terrace, Dewsbury Terrace, and along the common back boundary of the sections between Richards Avenue and Selwyn Crescent to the boundary of the City of Takapuna; thence generally south-westerly along that boundary and the middle of Archers Road to Glenfield Road; thence generally northerly along the middle of that road to the boundary of Glenfield Riding; thence north-easterly along that boundary to the boundary of the Borough of East Coast Bays; thence generally northerly and easterly along that borough boundary to the mean high-water mark of the sea; thence generally southerly along that high-water mark to the point of commencement.

BIRKENHEAD

ALL that piece comprising the Boroughs of Birkenhead and Northcote and that portion of Glenfield Riding of the County of Waitemata not included in the Electoral Districts of Waitemata and East Coast Bays, hereinbefore described.

NORTH SHORE

ALL that piece comprising the Borough of Devonport and portion of the City of Takapuna after excluding that part contained in the Electoral District of East Coast Bays, hereinbefore described.

HENDERSON

ALL that portion comprising the Borough of Henderson, that portion of Waitakere and Te Atatu Ridings of the County of Waitemata not included in the Electoral District of Waitemata, hereinbefore described; Waikumete Riding and that portion of Titirangi Riding of the County of Waitemata west of a line commencing at the south-western corner of the Borough of Glen Eden, and proceeding along a line bearing 220° true to the middle of Shaw Road; thence southerly along the middle of that road to Waitakere Scenic Drive; thence easterly along that drive to and along the western boundaries of the County Town of Titirangi to the mean high-water mark of the sea.

NEW LYNN

All that piece comprising the Boroughs of Glen Eden and New Lynn, that portion of Titirangi Riding of the County of Waitemata not included in the Electoral District of Henderson, hereinbefore described, and portion of the City of Auckland bounded by a line commencing at the mouth of the Avondale Creek where it meets the Whau River and proceeding up that river to the middle of Wolverton Street; thence generally easterly along the middle of that street and Miranda Street to Blockhouse Bay Road; thence southerly along the middle of that road and its production to the boundary of the City of Auckland; thence generally westerly and northerly along that boundary to the point of commencement. commencement.

GREY LYNN

ALL that piece comprising portion of the City of Auckland ALL that piece comprising portion of the City of Auckland and portion of the Borough of Mount Albert bounded by a line commencing at the intersection of the mean high-water mark of the sea and the production of the middle line of Fairlands Avenue and proceeding generally north-easterly along the boundary of the City of Auckland to a point in line with the middle of New Street; thence south-westerly to and along that street and the middle of College Street, Ponsonby Road, Richmond Road, Cockburn Street Williamson Avenue and south-easterly along No. 16 to and along that street and the Ponsonby Road, Richmond Road, Cockburn Street, Dryden Street, Williamson Avenue, and south-easterly along No. 16 State Highway (Great North Road) to a point bearing 218° true from the middle of School Road at its northernmost point; thence south-westerly along that bearing and the middle of School Road, Western Springs Road, New North Road, and Argyle Street to the middle of the Newmarket-Opua Railway; thence generally westerly along the middle of that railway to a point in line with the middle of Guardwell Street; thence north-westerly to and along that street to the boundary thence north-westerly to and along that street to the boundary of the City of Auckland; thence south-westerly along that boundary to a point in line with the middle of Fairlands Avenue; thence westerly to and along that middle line to the point of commencement.

MOUNT ALBERT

ALL the piece comprising portion of the City of Auckland and portion of the Borough of Mount Albert bounded by a line commencing at the intersection of the mean high-water mark of the sea with a line produced from the middle of Fairlands Avenue and proceeding generally easterly along the boundary of the Electoral District of Grey Lynn, hereinbefore

described, and the middle of the Newmarket-Opua Railway described, and the middle of the Newmarket-Opua Railway to the boundary of the Borough of Mount Albert; thence generally southerly and westerly along that boundary to the middle of Bollard Avenue; thence generally southerly along the middle of that street, New Windsor Road, Whitney Street and its production to the middle of Margate Road; thence generally westerly along the middle of that road, Blockhouse Bay Road, Miranda Street, and Wolverton Street to the Whau River; thence generally northerly along the northern shore of that river and the mean high-water mark of the sea to the point of commencement.

ROSKILL.

ALL that piece comprising portion of the City of Auckland and portion of the Borough of Mount Roskill bounded by a line commencing at the intersection of the mean high-water mark of the sea with a line produced from the middle of Blockhouse Bay Road and proceeding generally northerly along the boundary of the Electoral District of New Lynn, along the boundary of the Electoral District of New Lynn, hereinbefore described, and northerly and easterly along the boundary of the Electoral District of Mount Albert hereinbefore described, to and along the middle of Mount Albert Road to the middle of Hillsborough Road; thence generally southerly along the middle of that road and Clifton Road to the mean high-water mark of the sea; thence generally westerly along that water mark to the point of commencement. commencement.

AUCKLAND CENTRAL

ALL that piece comprising the Borough of Newmarket and portion of the City of Auckland and portion of the Borough of Mount Albert, bounded by a line commencing at the intersection of the mean high-water mark of the sea with a line produced from the middle of New Street, and proceeding generally easterly along that water mark to a point in line with the middle of Seaview Road; thence generally southerly to and along that road and the middle of Bassett Road, Remuera Road, and Dilworth Avenue to the boundary of the City of Auckland; thence north-westerly and southerly along that boundary to the middle of Epsom Avenue; thence westerly along the middle of that avenue to the boundary of the City of Auckland; thence northerly and westerly along that boundary and south-westerly along the boundary of the Borough of Mount Albert to the boundary of the Electoral District of Mount Albert, hereinbefore described; thence south-westerly along that boundary and northerly along the boundary of the Electoral District of Grey Lynn, hereinbefore described to the point of commencement; and including described, to the point of commencement; and including Browns, Kaikoura, Little Barrier, Motuihe, Motutapu, Pakatoa, Ponui, Rakino, Rakitu, Rangitoto, Rangiahau, and Rotoroa Islands, the counties of Great Barrier Island and Waiheke, other adjacent islands, and the Kermadec Islands.

ALL that piece comprising the Borough of Mount Eden and of Mount Albert Pools the Borough of Mount Eden and portion of the City of Auckland and portion of the Borough of Mount Roskill bounded by a line commencing at the south-eastern corner of the Electoral District of Auckland Central, hereinbefore described, at Epsom Avenue and proceeding generally southerly along the boundary of the City of Auckland and the Borough of Mount Roskill to the middle of Mount Albert Road; thence generally westerly along the middle of that road to the boundary of the Electoral District of Mount Albert, hereinbefore described; thence generally northerly along that boundary and generally easterly along the boundary of the Electoral District of Auckland Central, hereinbefore described, to the point of commencement.

REMUERA

ALL that piece comprising portion of the City of Auckland and portion of the Borough of One Tree Hill bounded by a line commencing at the intersection of the mean high-water mark of the sea with a line produced from the middle of Seaview Road and proceeding generally south-easterly along the boundary of the City of Auckland, the middle of Purewa Creek, and the middle of the Auckland Westfield deviation to the boundary of the City of Auckland; thence generally westerly along that boundary, the middle of Whitley Avenue, Abbots Way, Ladies Mile, and again along the boundary of the City of Auckland to a point in line with the middle of Campbell Road; thence south-westerly to and along that road, and the boundary of the Borough of One Tree Hill to the boundary of the Electoral District of Eden, hereinbefore described; thence northerly along that boundary and the boundary of the Electoral District of Auckland Central, hereinbefore described to the point of commencement. line commencing at the intersection of the mean high-water

ALL that piece comprising portion of the City of Manukau and portion of the City of Papatoetoe bounded by a line commencing at the north-eastern corner of Allotment 91, Manurewa Parish, and proceeding southerly along the eastern boundary of that allotment and its production to the northern boundary of Clendon's Grant shown on D.P. 515; thence south-easterly along that boundary and its production to the middle of Manurewa Road; thence south-westerly along the middle of that road, Manurewa-Brookby Road, Ranfurly Road, and Alfriston Road to the middle of the Auckland-Wellington Railway; thence north-westerly along the middle of that railway, the middle of James Road, Jellico Road, Julland Road, and again along the middle of the railway to the middle of Browns Road; thence south-westerly along the middle of that road and its production to the mean highwater mark of Manukau Harbour; thence generally westerly water mark of Manukau Harbour; thence generally westerly along that water mark to the boundary of the Electoral District of Mangere, hereinbefore described; thence generally northerly along that boundary, the right bank of the Tamaki River, and the south-western boundary of the Electoral District of Pakuranga, hereinbefore described, to the point of commencement.

ALL that piece comprising the Borough of Papakura and portion of the City of Manukau bounded by a line commencing at the intersection of Manurewa Brookby Road and Mill Road and proceeding south-easterly along the middle of Mill Road and Cosgrove Road to the boundary of the Borough of Papakura; thence generally southerly, westerly, and northerly along the boundaries of that borough to the mean high-water mark of the Pahurehure Inlet, thence generally porth-westerly along that water mark to the Flectoral ally north-westerly along that water mark to the Electoral District of Manukau, hereinbefore described; thence generally easterly along that boundary to the point of commencement.

ALL that piece comprising portion of the City of Manukau, the Boroughs of Pukekohe, Tuakau, and Waiuku, the County of Franklin, portion of the County of Waikato, portion of the County of Hauraki Plains bounded by a line commencing at the intersection of the mean high-water mark of the sea and the projection of the south-sectors boundary of Waikana at the intersection of the mean high-water mark of the sea and the projection of the south-eastern boundary of Waiomaru Block as shown on D.P. 24411 (near Duders Beach) and proceeding generally south-easterly along the mean highwater mark of the sea to the boundary of the County of Hauraki Plains at the Waihou River; thence generally southerly along that county boundary to the southern boundary of Turua Riding; thence westerly and north-westerly along that boundary and the southern boundary of Horahia Riding to a point in line with the middle of Orchard West Road; thence westerly to and along the middle of that West Road; thence westerly to and along the middle of that road and its production to the eastern boundary of Waitakaroad and its production to the eastern boundary of Waitaka-ruru Riding; thence southerly and south-westerly along that boundary and northerly along the boundary of the County of Hauraki Plains to the southern boundary of the Mara-marua Riding of the County of Waikato; thence generally westerly along that boundary and the northern boundary of the County of Raglan to the mean high-water mark of the sea; thence generally northerly and easterly along that mean high-water mark and the mean high-water mark of Manukau Harbour to the boundary of the Electoral District of Manu-rewa, hereinbefore described; thence generally north-westerly along that boundary and the south-eastern boundaries of the along that boundary and the south-eastern boundaries of the Electoral Districts of Manukau and Pakuranga, hereinbefore described, to the point of commencement.

COROMANDEL

ALL that piece comprising the Counties of Coromandel and Thames; portion of the Counties of Ohinemuri and Tauranga; the Boroughs of Thames, Waihi, and Te Puke, and portion of the Borough of Mount Maunganui bounded by a line commencing at the mouth of the Waihou River and proceeding generally northerly, easterly, and southerly along the mean high-water mark of the sea crossing the entrance of Mount Maunganui Harbour to the boundary of the Borough of Mount Maunganui thence generally southerly along that of Mount Maunganui; thence generally southerly along that boundary to Aerodrome Wharf; thence westerly along a right boundary to Aerodrome Wharf; thence westerly along a right line to Sulphur Point and generally westerly, southerly, and north-easterly aong the boundary of the City of Tauranga to its intersection with the middle of State Highway No. 2 at Maungatapu Bridge; thence generally north-easterly along the middle of that State Highway and Maunganui Road to a point in line with the north-western boundaries of Lot 2, D.P. 34214; thence north-easterly to and along that point in line with the north-western boundaries of Lot 2, D.P. 34214; thence north-easterly to and along that boundary and Lot 1, D.P. 34214, to the south-western boundary of Lot 135, D.P. 35625; thence along the south-western boundary of Lot and its production to and along the south-eastern boundary of Lot 38, D.P. 35625, and the production of that boundary to the mean high-water mark of the sea; thence south-easterly along that water mark to the eastern boundary of Te Puke Riding of County of Tauranga; thence generally south-westerly along that boundary and the boundary of Waimapu Riding to the boundary of County of Tauranga; thence north-westerly along that boundary and the boundary of the County of Ohinemuri to the middle of Paeroa-Tahuna Road; thence easterly along the middle of that road to the middle of the Frankton-Thames Railway; thence north-easterly along the middle of that road to the middle of the railway and the generally southern, eastern, and northern boundaries of the Borough of Paeroa to the middle of No. 2 State Highway; thence north-easterly along the middle of State Highway; thence north-easterly along the middle of that highway to the middle of the Waihou River; thence down that river to the point of commencement; including Mercury Island, Cuvier Island, The Aldermen Islands, Whanganui Island, and other adjacent islands.

RAGLAN

ALL that piece comprising the Boroughs of Huntly, Ngarua-wahia and Te Awamutu; the County of Raglan; and portion of the County of Waipa excluding therefrom that portion of Orakau Riding bounded by a line commencing at the northernmost corner of Orakau Riding and proceeding generally southerly and north-westerly along the boundary of the County of Waipa and Orakau Riding to a point in line with the middle of Brotherhood Road; thence generally north-easterly to and along the middle of that road, Kihikihi Arapuni Road, and the road which forms the south-eastern boundaries of Allotments 56, 53, and 52 Puniu Parish to the boundary of the Orakau Riding; thence generally south-easterly and north-easterly along that boundary to the point of commencement.

HAMILTON WEST

ALL that piece comprising portion of the City of Hamilton lying to the west of the middle of the Waikato River.

HAMILTON EAST

ALL that piece comprising portion of the City of Hamilton bounded by a line commencing at the junction of the middle of the Waikato River and the north-eastern boundary of the City of Hamilton near the mouth of the Kirikiriroa the City of Hamilton near the mouth of the Kirikiriroa Stream and proceeding generally south-easterly along that city boundary, the middle of Silverdale Road, Carrington Avenue, Masters Avenue, Morris Road, Morrinsville Road, Cambridge Road, and Cobham Drive to a point in line with the north-eastern boundary of Hamilton Domain; thence south-easterly along the production of that boundary to the middle of the Waikato River; thence generally north-westerly down the middle of that river to the point of commencement.

WAIKATO
