PURSUANT to the Local Government Commission Act 1967 and the Harbours Act 1950, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. This order shall come into force on the day after the date of its notification in the *Gazette*.

2. On the commencement of this order, all those functions exercised by the Kaikoura County Council, pursuant to section 165 of the Harbours Act 1950, shall be transferred to and exercised by the Marlborough Harbour Board.

3. All bylaws of the Kaikoura County Council that relate to that Council's functions, under section 165 of the Harbours Act 1950, and are in force immediately before the commencement of this order shall continue in force after the commencement of this order as if they were made by the Marlborough Harbour Board, until bylaws are made by that Board in substitution therefor, and shall after the commencement of this order be enforceable by the Marlborough Harbour Board accordingly.

4. (1) On the commencement of this order, all the assets, liabilities, rights, and engagements of the Kaikoura County Council, in respect of its functions under the Harbours Act 1950 (including all the property vested in the Kaikoura County Council by paragraph (2) of the Order in Council dated the 24th day of September 1956 and published in the *Gazette* of that year at page 1324), that have not been disposed

of before the commencement of this order, shall become the assets, liabilities, rights, and engagements of the Marlborough Harbour Board without the necessity of any instrument of transfer, assignment, or other assurance.

(2) Where any asset vested in the Marlborough Harbour Board, pursuant to subclause (1) of this clause, consists of an estate or interest in land, under the Land Transfer Act 1952, the provisions of section 99A of that Act (as inserted by section 11 of the Land Transfer Amendment Act 1966) shall apply accordingly.

5. All proceedings pending by or against the Kaikoura County Council in respect of its functions, under the Harbours Act 1950, immediately before the commencement of this order may be carried on or prosecuted by or against the Marlborough Harbour Board.

*Change in New Zealand Standard Time and Radio Frequency
Standard*

FOR several years the internationally adopted definition of the second, which governs all time and frequency measurements, has been based on a particular resonant frequency of the caesium atom. To keep civil time in close agreement with astronomical time, as determined by the rotation of the Earth, it has been necessary to maintain the civil second slightly longer than the atomic second, and to make occasional changes in its length, and periodic step adjustments in civil time. At present the civil second is 300 parts in 10^{10} longer than the atomic second, and frequency standards are offset from the atomic standard by a similar amount.

The Bureau International de l'Heure, after international consultation, has decided that from 1 January 1972, the time interval used throughout the world will be the atomic second, and frequency standards will be permanently based on the atomic second, without any offset. Future adjustments to keep civil time close to astronomically derived time will be made by periodically omitting one exact second from the reckoning of civil time. These adjustments will be made only on 1 January or 1 July, in any year as required. It is anticipated that adjustments will normally be needed once a year.

From 1 January 1972, New Zealand Standard Time, as kept and transmitted by the New Zealand Time Service, Geophysics Division, D.S.I.R., will be based directly on the atomic second, and the New Zealand radio frequency standard, as maintained and transmitted by the Physics and Engineering Laboratory, D.S.I.R., will be adjusted accordingly to a new, slightly higher, frequency by removing the present offset of 300 parts in 10^{10} .
