Appointment of Committee of Inquiry Under Section 13 of the Industries and Commerce Act 1956, to Inquire into the Distribution of Meat, Fish, Fruit, and Vegetables

1. Pursuant to section 13 of the Industries and Commerce Act 1956, the Minister of Industries and Commerce hereby appoints

James Noel Laurenson (Chairman);
Keith Robert Congreve,
Margaret Mary Hutchinson,
Beryl Dorrien Ibbotson, and
John Joseph O'Dea

to be a committee to inquire into, investigate, and report on the distribution of meat, fish, fruit, and vegetables.

2. The committee shall be called the Committee of Inquiry into the Distribution of Meat, Fish, Fruit, and Vegetables.

3. In the inquiry into the distribution of meat the committee shall have regard to the following matters:

- (1) The extent of competition in the wholesaling and retailing of meat, and whether in the interests of restraining price increases steps should be taken to increase that competition.
- (2) The changes which have taken place over the past 10 years, in the service rendered to the consumer by meat retailers and whether any further specific changes are now seen to be desirable.
- (3) The changes in patterns of trade, which have taken place over the past 10 years in the retail butchery trade—with particular reference on the sales side to movements in consumer demand, density of retail outlets, the entry of supermarkets into the trade, and the development of pre-packaging; and on the purchase side with particular reference to the method of procurement of meat supplies.
- (4) The increases which have taken place in retail meat prices over the past 10 years and the relationship which they have shown to increases in:
 - (a) Other items in the Consumers Price Index;
 - (b) Wholesale prices of meat in New Zealand;
 - (c) Export realisations;
 - (d) Retail prices of meat in other meat producing countries;
 - (e) Nominal wage rates (N.B. show changes in the purchasing power of wages in relation to meat price over the 10-year period).
- (5) The comparison of the gross profits, operating costs, and net profits currently being achieved or incurred by wholesale and retail butchers as compared with such profits and expenses, achieved or incurred, at the time the retail price of meat was released from price control in December 1961. (N.B. It is desired that variations in margin yield emanating from different methods of procurement of supplies should also be examined.)
- (6) The reasonableness or otherwise of movements in net profit rewards of meat wholesalers and retailers since the retail price of meat was removed from control in December 1961; having regard to the current level of profitability and to improvements experienced over the past ten years by wholesale and retail industry in general, and by specific trade in particular.
- (7) The steps, if any, which in the light of your findings on the preceding terms of reference should be taken to achieve greater stability in meat prices.

4. In the inquiry into the distribution of fruit and vegetables the committee shall have regard to the following matters:

- (1) The extent of competition in the wholesaling and retailing of fruit and vegetables and whether in the interests of restraining price increases steps should be taken to increase that competition.
- (2) The changes which have taken place over the past 10 years in the services rendered by retailers of fruit and vegetables to consumers and whether any further specific changes are now seen to be desirable.
- (3) The present system of distribution of fruit and vegetables from the point of producer sales to consumer purchase; the changes which have taken place over the past 10 years; and any improvements which may now be called for in the interests of consumers, and of those engaged in the industry.
- (4) The increases which have taken place over the past 10 years in the prices of fruit and vegetables in comparison with movements in:
 - (a) Other items in the Consumers Price Index;
 - (b) Producers realisations;
 - (c) Prices of comparable fruits and vegetables in selected overseas countries;

(d) Nominal wage rates. (N.B. Show changes in the purchasing power of wages in relation to movements in prices of fruit and vegetables.)

(N.B. It is desired that an indication should be given of any significant differences in price movements as between items which traditionally pass through the auction system and those which do not—noting in the case of the latter the effect of any changes in export realisations where appropriate.)

- (5) The comparison of gross profits, operating costs, and net margins currently being enjoyed or incurred by wholesalers and retailers of fruit and vegetables with such profits and expenses, enjoyed or incurred, 10 years ago.
- (6) The reasonableness or otherwise of movements in net profit rewards of wholesalers or retailers of fruit and vegetables over the past 10 years; having regard to the current level of profitability and to improvements experienced over the period in question by wholesale and retail industry in general and by specific trades in particular.
- (7) The steps if any which in the light of your findings on the preceding terms of reference should be taken to achieve greater stability in the prices of fruit and vegetables.

5. In the inquiry into the distribution of fish the committee shall have regard to such matters as may from time to time be notified to it by the Minister of Industries and Commerce.

6. The Committee is authorised to—(1) Hold public meetings at which evidence can be presented;

(2) Hold closed sessions at which evidence of a confidential nature can be heard;

(3) Require any person carrying on any business relating to or affecting the subject-matter of the investigation to produce for the inspection of the committee any papers, books, or documents which are in the possession of that person, or to set down in writing any facts relating to the subject-matter of the investigation which are within the knowledge of that person, or to allow copies of or extracts from any such papers, books, or documents to be made by or on behalf of the committee.

7. (1) Meetings of the committee shall be held at such times and places as the committee or the Chairman from time to time appoints.

(2) At any meeting of the committee, a member appointed by the Chairman may preside in the absence of the Chairman.

(3) At any meeting three members of the committee shall constitute a quorum.

(4) Subject to the provisions of this clause, the committee may regulate its procedure in such manner as it thinks fit.

8. The committee shall submit its report and recommendations to the Minister of Industries and Commerce by 30 September 1972.

1. TITLE AND COMMENCEMENT

This order may be cited as Price Order No. 2195, and shall come into force on the 9th day of June 1972.

2. REVOCATIONS

(1) Price Orders No. 2091*, 2101†, 2128‡, 2152§, and 2187|| are hereby revoked.

(2) The revocation of the said orders shall not affect the liability of any person for any offence in relation thereto committed before the coming into force of this order.

3. APPLICATION OF ORDER

This order applies to flour and wheatmeal.

4. INTERPRETATION

In this price order—

“Agent” means an agent appointed by the New Zealand Wheat Board to effect sales of flour and wheatmeal on its behalf:

“Wholesaler” means any person who sells flour or wheatmeal to a manufacturer or retailer in the pack sizes sold by the New Zealand Wheat Board:

“Retailer” means any reseller other than a wholesaler:

“Flour levy” means the amount payable to the Wheat Research Institute:

“Excess railage” means the difference between the amount actually charged and the amount calculated at Class E rate according to the Railways Standard Schedules:

“Minimum quantity lots” means the minimum quantities of flour and wheatmeal which will be supplied at the New Zealand Wheat Board's list prices, but in no case exceeding 250 kilogrammes (551.15 lb):

“Wheatmeal” includes wholemeal.

5. NEW ZEALAND WHEAT BOARD'S AND AGENTS' SELLING PRICES

Subject to the following provisions of this order, the maximum prices that may be charged or received by the New Zealand Wheat Board or its agents at the approved points of sale for any flour or wheatmeal to which this order applies, which is sold in not less than minimum quantity lots, shall not exceed the sum of the following amounts (provided that the prices charged shall include only that part of the following amounts which relates to the quantity sold):

(a) The price for the pack concerned calculated at the following rates:

(b) The flour levy.

(c) The cost (if applicable) of sacks.

(d) For areas where the terms of sale are “on rail”:

(i) The amount (if incurred) of “excess railage”:

(ii) Sorting, unloading, or tallying (if incurred) at the rate for the station concerned.

(e) For areas where the terms of sale are “on wharf”:

(i) Railage (if incurred) where the buyer is situated within 20 miles of the port:

(ii) Sorting or tallying (if incurred) at the rate for the port concerned.

(f) Where the flour or wheatmeal is sold “ex New Zealand Wheat Board's or its agent's store”:

(i) The amount of any cartage incurred for delivery from mill, wharf, or rail to a store of the New Zealand Wheat Board or its agent, provided the amount so included shall not exceed the amount of the charges that would have been incurred had delivery been effected at current transport rates:

(ii) Storage or through store charges at the approved rate for the area concerned.

(g) Any transport charges beyond the New Zealand Wheat Board's point of sale, which are paid by the Board or its agent on behalf of the buyer:

Provided that if the maximum price so calculated is not an exact number of cents, the maximum price shall be calculated to the nearest whole cent.

6. WHOLESALERS' PRICES IN RESPECT OF SALES TO MANUFACTURERS AND RETAILERS

Subject to the following provisions of this order, the maximum prices that may be charged or received by any wholesaler for any flour or wheatmeal to which this order applies, shall not exceed the sum of the following amounts (provided that the prices charged shall include only that part of the following amounts which relates to the quantity sold):

(a) The cost to the wholesaler that would have been incurred had the wholesaler purchased the flour or wheatmeal from the New Zealand Wheat Board or its agents, less the 1½ percent early payment discount allowable by the New Zealand Wheat Board whether or not the discount is obtained.

(b) The flour levy.

(c) The cost (if applicable) of sacks.

(d) The amount of sea freight or wharfage charges, incurred in obtaining delivery to wholesale store.

(e) Railage charges actually incurred in obtaining delivery to wholesale store, provided the amount so added may not exceed the charge that would have been incurred had railage been charged at Class E rates.

(f) The amount of any cartage charges actually incurred in obtaining delivery to wholesale store, provided that the amount so added may not exceed the proportionate amount of the charge that would have been incurred had delivery been effected at current transport rates for delivery in not less than tonne lots, or at the authorised average charge for the area concerned.

(g) The amount of any bridge or tunnel toll charges incurred in obtaining delivery to wholesale store.

(h) An amount calculated as follows:

(i) for flour and wheatmeal which is delivered to manufacturing or retail premises without charge for delivery—
7 percent of the sum of the foregoing items (a) to (g):

(ii) for flour and wheatmeal which is sold “ex wholesaler's store”—
4 percent of the sum of the foregoing items (a) to (g) plus any amount for transport charges which are paid by the wholesaler on behalf of the buyer:

Provided also that if the maximum price calculated in accordance with this clause is not an exact number of cents, the maximum price shall be calculated to the nearest whole cent:

Provided further that an additional sum may be added to the total so calculated to provide for any discount which is customarily deducted for payment within a specified time.

7. RETAILERS' PRICES FOR FLOUR AND WHEATMEAL

Subject to the following provisions of this order, the maximum prices that may be charged or received by any retailer for any flour or wheatmeal to which this order applies, shall not exceed the sum of the following amounts (provided that the prices charged shall include only that part of the following amounts which relates to the quantity sold):

- (a) The cost to the retailer that would have been incurred had the retailer purchased the flour or wheatmeal from the New Zealand Wheat Board or its agents in minimum quantity lots, less the 1½ percent early payment discount allowable by the New Zealand Wheat Board whether or not the discount is obtained.
- (b) The flour levy.
- (c) The cost (if applicable) of sacks.
- (d) The cost of sea freight or wharfage charges incurred in obtaining delivery to retail store.
- (e) The amount of any railrage charges actually incurred in obtaining delivery to retail store, provided that for quantities of less than 254 kg (5 cwt) the amount shall not exceed the proportionate amount of the charge that would have been incurred on a 254 kg (5 cwt) lot.
- (f) The amount of any cartage charges actually incurred in obtaining delivery to retail store, provided that the amount so added may not exceed the proportionate amount of the charge that would have been incurred had delivery been effected at current transport rates for delivery in not less than 254 kg (5 cwt) lots, or at the authorised average charge for the area concerned.
- (g) An amount calculated at the following rates:
 - (i) For flour or wheatmeal weighed out and packaged by a retailer—
33½ percent of the sum of the foregoing items (a) to (f):

Provided that the retail price shall be computed as if the retailer had purchased flour in 36 kg or 40 kg bags and wheatmeal in 20 kg bags:

Provided also that if the price calculated in accordance with this clause is not an exact number of cents, the maximum price for the lot shall be calculated to the nearest whole cent.

- (ii) For flour and wheatmeal sold in the original packages specified in clause 5 of this order—
10 percent of the sum of the foregoing items (a) to (f):

Provided that if the maximum selling price calculated in accordance with this clause is not an exact number of cents, the maximum price for the pack shall be calculated to the nearest whole cent.

- (iii) For flour or wheatmeal purchased by a retailer in other than the original packages specified in clause 5 hereof, the retail selling prices shall be computed as if the retailer had weighed out and packaged the quantity himself from purchases of flour in 36 kg or 40 kg bags and wheatmeal in 20 kg bags:

Provided that if the maximum selling price calculated in accordance with this clause is not an exact number of cents, the maximum price for the pack shall be calculated to the nearest whole cent.

8. SPECIAL PRICES

Notwithstanding anything in the foregoing provisions of this order and subject to such conditions (if any) as it thinks fit, the Tribunal, on application by the New Zealand Wheat Board or by any agent, wholesaler, or retailer, may authorise alterations in prices or percentage margins in respect of any flour or wheatmeal to which this order applies if special circumstances exist or if for any reason extraordinary charges (freight or otherwise) are incurred by the New Zealand Wheat Board or by an agent, wholesaler, or retailer.

Any authority given by the Tribunal under this clause may apply with respect to a specified lot or consignment of flour or wheatmeal or may relate generally to all flour or wheatmeal to which this order applies that is sold while the order remains in force.

PRELIMINARY

1. This order may be cited as Price Order No. 2194 and shall come into force on the 9th day of June 1972.
2. (1) Price Orders No. 2177*, 2178*, and 2181† shall be revoked on the coming into force of this order.
- (2) The revocation of the said orders shall not affect the liability of any person for any offence in relation thereto committed before the coming into force of this order.
- (3) Notwithstanding the revocation of Price Orders No. 2177 and 2178, any approvals given under clauses 10 and 6 respectively of those price orders shall continue to have effect as if the said orders had not been revoked.

APPLICATION OF THIS ORDER

3. This order applies to all bread referred to in clauses 4, 5, 6, and 7 of this order sold in New Zealand by a wholesaler or by a retailer, but does not apply to bread sold on Stewart Island or to bread sold as part of a meal.

FIXING MAXIMUM WHOLESALE AND RETAIL PRICES OF BREAD TO WHICH THIS ORDER APPLIES

4. Subject to the provisions of this order, the prices set out in the First Schedule to this order shall be the maximum prices which may be charged or received for any bread to which this order applies and which is customarily known as:

- (a) Standard white bread.
- (b) Standard brown bread.
- (c) Wholemeal bread.
- (d) Vienna bread.
- (e) Wheat-germ bread.

5. Subject to the provisions of this order, the prices set out in the Third and Fourth Schedules to this order shall be the maximum prices which may be charged or received for any bread to which this order applies and which is customarily known as starch-reduced bread, that is, bread in the making of which there is for each sack of flour (160lb) used not less than 6lb of dry gluten, or 18lb of wet gluten, and no less than 6lb of fat with either dried milk or condensed milk.

6. Subject to the provisions of this order, the prices set out in the Fifth Schedule to this order shall be the maximum prices which may be charged or received for any bread which was authorised in terms of Price Order No. 2178, as amended by Price Order No. 2181, to be sold at maximum prices as follows:

- (a) A wholesale price of 17c per loaf less 10 percent.
- (b) A retail price of 17c per loaf.

7. Subject to the provisions of this order, the prices set out in the Second, Fourth, and Fifth Schedules to this order shall be the maximum prices which may be charged or received for any bread described in clauses 4, 5, and 6 of this order which is sliced or unsliced and enclosed and securely wrapped at the bakehouse in clean unused paper.

8. The wholesale prices fixed by this order apply to bread delivered to the retailer's premises. In any case where bread is not so delivered the prices shall be such as are agreed upon between the baker and the retailer, or failing such agreement, as may be approved by the Tribunal.

GENERAL

9. A booking fee at the rate of one quarter cent ($\frac{1}{4}$ c) per loaf for loaves of not more than 1lb weight and one half cent ($\frac{1}{2}$ c) per loaf for loaves exceeding 1lb weight may be made for any bread sold by a retailer to which this order applies, provided that payment for the bread so sold has not been made prior to, or at the time of, the customer's taking delivery of the bread at the shop.

10. The maximum retail selling prices provided for in this order shall include the service of wrapping where this service is provided by the retailer.

SPECIAL PRICES WHERE EXTRAORDINARY CHARGES INCURRED

11. Notwithstanding anything in the foregoing provisions of this order, and subject to such conditions, if any, as it thinks fit, the Tribunal on application by any wholesaler, or retailer, may authorise special maximum prices in respect of any bread to which this order applies where special circumstances exist or for any reason extraordinary charges (freight or otherwise) are incurred by the wholesaler or retailer. Any authority given by the Tribunal under this clause may apply with respect to a specified lot or consignment of bread or may relate generally to all bread sold by the wholesaler or retailer, while the approval remains in force.
