Commission of Inquiry Into Auckland Civil Defence Émergency

### DENIS BLUNDELL, Governor-General ORDER IN COUNCIL

To all to whom these presents shall come, and to:

WHERAS it is expedient that an inquiry should be made into the matters and events surrounding and consequent upon the declaration made on the 28th day of February 1973 by Grahame Oliver Sims, a Local Controller, under section 22 of the Civil Defence Act 1962 of a state of local civil defence emergency in respect of a specified area in the City of Auckland (hereinafter referred to as Parnell) and matters incidental thereto: incidental thereto:

Now therefore, pursuant to the Commissions of Inquiry Act 1908, I, Sir Edward Denis Blundell, the Governor-General of New Zealand, acting by and with the advice and consent of the Executive Council, hereby appoint you, the said Ronald Keith Davison, William Ivan Glass, and Percival James Comfort Clark to be a Commission to inquire into and report upon the said declaration of a state of emergency in Parnell, and in particular upon— Parnell, and in particular upon(a) The events-

(i) Leading up to and resulting in the said declaration, their causes and origins; and

(ii) Occurring during the continuance of the said state of emergency; and

(iii) To be anticipated as a consequence of the said state of emergency, and including any disabilities to the persons affected:

(b) The persons responsible for the events at each of the

three stages referred to in paragraph (a) hereof: (c) The manner in which individuals and organisations generally reacted to the said state of emergency, and whether individuals and organisations which either were or might have been expected to play a part in dealing with the said emergency did so to the extent that they were required so to do or might have been expected to do:

(d) Whether the administrative machinery and arrangements

for dealing with such states of emergency were ade-quate and appropriate, and whether they functioned

properly and effectively:

(e) The nature of the substance involved and the dangers inherent in it in the event of its escape from proper

containers:

(f) Whether there were any breaches of the law at either of the first two stages referred to in paragraph (a) hereof, and whether the law provides adequate sanctions and remedies at all stages, both to the community and the individual:

(g) The desirability or otherwise of the use of the said substance in New Zealand and the extent to and conditions under which it should be permitted transit through New Zealand:

(h) The adequacy of the law relating to the giving of notice of the dangers inherent in such or like substances, and the requirements as to the affixing or displaying of warning signs on such or like substances and their containers during manufacture, distribution, or use in or transit through New Zealand:

(i) Suggestions for the prevention as far as possible of any similar incident, whether by means of any additional legislation or administrative or procedural stepsand generally to inquire into and report upon such other
matters arising throughout as may come to your notice in
the course of your inquiries and which you consider should
be investigated in connection therewith, and any matters
affecting the premises which you consider should be brought
to the attention of the Government.

And, with the like advice and consent, I do hereby appoint you the said RONALD KEITH DAVISON to be Chairman of the said Commission:

And for the better enabling you to carry these presents into effect you are hereby authorised and empowered to make and conduct any inquiry under these presents, in accordance with the Commissions of Inquiry Act 1908, at such times and places as you consider expedient, with power to adjourn from time to time and place to place as you think fit, and so that these presents shall continue in force and the inquiry may at any time and place be resumed although not regularly adjourned from time to time or from place to place: And you are hereby strictly charged and place to place: And you are hereby strictly charged and directed that you shall not at any time publish or otherwise disclose, save to me in pursuance of these presents or by my direction, the contents or purport of any report so made or to be made by you or any evidence or information obtained by you in the exercise of the powers hereby conferred upon you except such evidence or information as is received in the course of a sitting open to the public:

And it is hereby declared that the powers hereby conferred shall be exercisable notwithstanding the absence at any time of any one of the members hereby appointed so long as the Chairman or a member deputed by the Chairman to act in his stead and one other member are present and concur in the exercise of such powers:

And it is hereby further declared that you have liberty to report your proceedings and findings under this Commission from time to time if you judge it expedient so to do:

And, using all due diligence, you are required to report to me in writing under your hands not later than the 1st day of June 1973 your findings and opinions on the matters aforesaid, together with such recommendations as you think fit to make in respect thereof.

Tariff and Development Board Notice No. 339—Inquiry Concerning Protection for the New Zealand Industry Producing the Chlorotriazine Chemicals, Simazine, Atrazine, and Propazine (Ex Tariff Item 29.35.009)

1. Following the receipt by the Minister of Customs of a report from the Emergency Protection Authority, the Minister advised the Board that, while Government has decided not to accept the Authority's recommendation to impose a temporary additional duty equal to five-sixths of the amount by which the f.o.b. value is less than \$1.65 per lb on imports of atrazine and simazine from all sources except Australia, it will, pending inquiry and report by the Board, protect the local manufacture of simazine, atrazine, and propazine by the temporary re-imposition of import licensing with a "C" allocation. However, as the goods are included in Schedule A of the NAFTA they will remain exempt licensing when of Australian origin. In accordance with the provisions of the Tariff and Development Board Act, the Minister of Customs has asked the Board to undertake an inquiry and report on the form of permanent protection, if any, it considers necessary to protect New Zealand industry in relation to the importation of the chlorotriazine chemicals simazine, atrazine, and propazine in their "technical material" form, as classified within Tariff item 29.35.009.

- 2. Decision of the Indecent Publications Tribunal

In the matter of the Indecent Publications Act 1963, and in the matter of an application by the Comptroller of Customs for a decision in respect of the book *Boys are Boys Again II* published by Book Adventures, England.

There was no appearance of the applicant. Mr Campbell appeared on behalf of the publishers' representative in New Zealand and made submissions.

### DECISION OF THE TRIBUNAL

This is a book of photographs taken by the well-known youth leader Hajo Ortil. The book would retail in New Zealand at approximately \$12 and is a hardback. The pictures are of nude German boys who, according to Ortil, take nudity as a matter of course, whether in the open air, in a studio, or in the gymnasium. There is an introduction to the book but no other text. The book is similar to Sons of the Sun which the Tribunal classified as not indecent in decision No. 188. The Tribunal feels that the poses of the boys in many cases are contrived, which tends to bring into question the honesty of the purpose of the book, but there is nothing harmfully suggestive in the book and the Tribunal can see no reason for the imposition of a restriction.

The Tribunal classifies this book as not indecent.

Decision of the Indecent Publications Tribunal

In the matter of the Indecent Publications Act 1963, and in the matter of an application by the Comptroller of Customs for a decision in respect of the magazines *Boys International*, 1, 2, and 3, published by S. and H. Publications, England.

There was no appearance of the applicant. Mr Campbell appeared on behalf of the publishers' representative in New Zealand and made submissions.

### DECISION OF THE TRIBUNAL

THESE magazines are described as journals for nudist youth. The author and photographer is Haja Ortil. The content of each magazine is a short story, a semi-serious article, and photographs both coloured and black-and-white of nude boys of all shapes and sizes. Most of the photographs, and there are many, are taken front on so that the emphasis, and perhaps an over-emphasis, is on the display of the penis. On the whole the photographs are naturally posed and there is no suggestion of indecent postures. In Volume 1 the semi-serious article is entitled "That myth of black sexual power", in Volume 2, "Love Life in the Pacific", in Volume 3, "Phallic Cults". The title of these magazines implies that they are designed for the younger reader and one questions the integrity of the author when he includes such articles in a magazine of this kind.

However, considering the magazines as a whole it cannot be said that they are indecent within the meaning of the Act and it is questionable whether a restriction is necessary or would be of any advantage.

The Tribunal classifies these magazines as not indecent.

Decision of the Indecent Publications Tribunal

In the matter of the Indecent Publications Act 1963, and in the matter of an application by the Comptroller of Customs for a decision in respect of the book Fanny Hill's Cook Book by L. H. Braun and William Adams, published by the Odyssey Press, London.

There was no appearance of the applicant nor of the publishers' representative in New Zealand. Accordingly no submissions were made.

### DECISION OF THE TRIBUNAL

This is an attractively produced book of 138 pages and 70 recipes. It is obviously intended to excite and provoke the satisfaction of appetites that are not exclusively alimentary. The idea it uses is not new and it is not the culinary art that is its central theme. In fact it seems more appropriate for the bedroom shelf than the kitchen.

The recipes are named, introduced, and, in some cases, prescribed, with varying degrees of suggestiveness. The line drawings intended to illustrate the text are almost all of the nude female figure in a variety of poses and while many are provocative they could not be classed as pornographic.

Although the double-talk in the recipes is sophisticated, sometimes amusing, and often coarse and vulgar, it is not, in our judgment, likely to corrupt. The recipes themselves appear genuine and we see no grounds for restricting the availability of this book to mature readers. While it is not a book which one would deliberately wish to place in the hands of young adolescents, we cannot see it doing harm to those of an age to understand it.

The Tribunal classifies this book as not indecent.

There was no appearance of the applicant. Mr Campbell appeared on behalf of the publishers' representative in New Zealand and made submissions.

#### DECISION OF THE TRIBUNAL

This publication, which we were told would retail in New Zealand at around \$11, has been described as a show-and-tell encyclopaedia of sex. The text is objective and explicit. It does of course identify and define terms relating to sexual activities which are not socially or legally acceptable in New Zealand, but it does so in an informative, unemotional, and restrained manner which makes it comprehensive without any suggestion of obscenity.

The emphasis of a few of the illustrations, however, may, in the New Zealand setting, appear to go beyond the purpose of the book. These few illustrations, looked at out of the context in which they appear, might be judged indecent, and if set out on public display would undoubtedly offend. This factor led us to consider whether some age restriction was desirable, but we have decided against this. Similar illustrations can be seen in some medical works, and looked at as a whole the book cannot be judged as likely to corrupt.

The Tribunal classifies this book as not indecent.
