The Tribunal classifies these three books as indecent.

These two paperback productions of photographs with stories can be distinguished by the fact that the former has more text as a proportion of the whole and the latter has only brief insets with the photographs. However the text in *Naked House Parties* does not correlate very well with the photographs and both productions have a heavy emphasis on group sex and lesbianism. They appear to be designed to appeal to prurient tastes and possess no redeeming features of literary merit or social significance.

The Tribunal classifies these books as indecent.

The book has literary merit and the dominant effect is a rather laboured satire on scientific method but it is not devoid of some humour. We see no grounds for denying it to mature readers.

The Tribunal classifies this book as indecent in the hands of persons under the age of 18 years.

Tariff and Development Board Notice No. 359—Inquiry Concerning Protection for New Zealand Industry Producing Pine Oil and Terpeneol

1. In its report No. 125 of 8 July 1970 to the then Minister of Customs, the Tariff and Development Board recommended, *inter alia*, that the Minister refer to the Board for further inquiry in 1972 the question of what form of protection, if any, should be provided at that time in respect of pine oil classified in T.I. 38.07.09 (now 38.07.009) and terpeneol classified in T.I. 29.05.03 (now 29.05.003). This recommendation was accepted by Government and the Board was requested to undertake this further inquiry at a date convenient to it.

2. However, in response to representations by the sole party to the 1970 inquiry, the Board requested, in a letter dated 25 May 1972, that the then Minister of Customs approve a deferment of the proposed inquiry until the latter part of 1973. The Minister, in a letter dated 31 May 1972, agreed that it would be desirable to postpone the inquiry.

3. Accordingly, the Board will conduct a public hearing into the question of protection for the New Zealand industry producing pine oil classified in Tariff item 38.07.009 and terpeneol classified in Tariff item 29.05.003, in the Hearing Room, Eighth Floor, Cumberland House, Upper Willis Street, Wellington, on Tuesday, 25 September 1973, commencing at 10.30 a.m.

4. Parties intending to make representations or requests about appropriate rates of customs duty are asked to take into account the statement by the Minister of Overseas Trade of 7 May 1973 about the phasing out of British preferences from the New Zealand Tariff. Copies of this statement can be obtained from the undersigned. In a letter dated 6 April 1973 the Minister of Trade and Industry has indicated that, while Government has asked the Board to consider the question of a single tariff rate, for trade policy reasons the Board's recommendations on this aspect will not necessarily be made public for the time being. Parties intending to make representations or requests about the exemption from import licensing of goods at present not so exempt are asked to take into account the statement in the 1972 Financial Statement (page 19) that "the Government has also decided that where the industry is to be exempted from import licensing there should be provision in appropriate cases for a phase-out period which in general will be for up to three years".

Tariff and Development Board Notice No. 361—Inquiry Concerning Protection for New Zealand Industry Producing Soya Beans of Tariff Item 12.01.400, Soya Bean Meal and Flour of Tariff Item 12.02.001, and Soya Bean Oil and Certain Other Vegetable Oils Included in Tariff Headings 15.07, 15.08 and 15.12

1. In Tariff and Development Board Notice No. 349 (*New Zealand Gazette*, dated 19 April 1973) the Board advised that the taking of evidence affecting soya beans, of Tariff item 12.01.400, had been deferred and would be taken in conjunction with any evidence on soya bean oil at the public hearing scheduled to commence on 2 July 1973. At the time the request was made for the deferment of the hearing of the evidence on soya beans, the Board was also asked to include soya bean meal in the forthcoming inquiry. As it did not have this latter item currently under reference, the Board requested the Minister of Customs to add these goods to its current references and the Minister has now agreed to do so. Accordingly the Board has now included soya bean meal and flour of Tariff item 12.02.001 in the hearing set down for 2 July 1973.

2. The purpose of this notice is to clarify the content of the public hearing set down for 2 July 1973 and it takes into account and supersedes the following earlier notices:

Schedule E, Notice No. 323, *New Zealand Gazette*, dated 7 December 1972.
 Notice No. 340, *New Zealand Gazette*, dated 22 March 1973.
 Notice No. 349, *New Zealand Gazette*, dated 18 April 1973.

A revised list of the Tariff provisions pertaining to the forthcoming public hearing is set out in the attached Schedule to this notice. In the case of Notice No. 340, the reference to the proposed New Zealand production of soya bean oil still stands and applies similarly to soya beans and to soya bean meal and flour.

3. For the purpose of taking evidence in respect of the goods set out in the attached Schedule the Board will hold a public hearing commencing at 2 p.m. on Monday, 2 July 1973, in the Hearing Room, Eighth Floor, Cumberland House, Upper Willis Street, Wellington.

4. The public hearing will be conducted in three stages. Stage I, evidence relating to soya beans of Tariff item 12.01.400, will be taken at the commencement of the hearing; Stage II which will include evidence relating to soya bean meal and flour of Tariff item 12.02.001 and soya bean oil of Tariff items 15.07.001 and 15.07.009 will immediately follow Stage I; and Stage III, which will be heard after the completion of Stage II, will relate to the balance of the items included in the attached Schedule. Representations where possible should be prepared in conformity with this staging.

5. Parties intending to make representations or requests about appropriate rates of customs duty are asked to take into account the statement by the Minister of Overseas Trade of 7 May 1973, about the phasing out of British preferences from the New Zealand Tariff. Copies of this statement can be obtained from the undersigned. In a letter dated 6 April 1973, the Minister of Trade and Industry indicated that, while Government has asked the Board to consider the question of a single tariff rate, for trade policy reasons the Board's recommendations on this aspect will not necessarily be made public for the time being. Parties intending to make representations or requests about the exemption from import licensing of goods at present not so exempt are asked to take into account the statement in the 1972 Financial Statement (page 19) that "the Government has also decided that where the industry is to be exempted from import licensing there should be provision in appropriate cases for a phase-out period which in general will be for up to three years".

6. Any person who intends to tender evidence should lodge, in typewritten form, 14 copies of public evidence and 12 copies of confidential evidence, to be presented under oath at the public hearing, at the Board's office no later than Monday, 11 June 1973. In preparing this evidence the "Notes for Information and Guidance of Interested Parties" prepared by the Board may be of assistance. Copies of these notes may be obtained from the Board's office.

Where the extremes of temperature and rainfall have occurred more than once during the month, the date of the first occurrence is given.

NOTES ON THE WEATHER FOR APRIL 1973

General—The main feature of April was a continuation of the dry weather of the previous 5 months until Easter on the 20th to the 23rd, which was the wettest part of the month. However, the rain received at this time still left the soil much too dry in many areas. Conditions were particularly poor in Marlborough and North Canterbury, where the drought which had developed about 2 months previously persisted. Hay and silage were being fed to stock in these areas, while some animals were sold.

On the 22nd a tornado caused considerable damage at Opunake. This was one of the very few New Zealand tornadoes in which life was lost, one man being killed.

Rainfall—Rainfall was below normal, mainly by 25-50 percent, over most of the North Island, also in Nelson, Marlborough, North and central Canterbury. The only area where it was more than 50 percent above normal was most of Otago with part of Southland.

For the period November-April the total rainfall at Blenheim was 106 mm, which was the lowest ever recorded during these 6 months of the year in this area in nearly 70 years of observation.

Temperatures—Temperatures were mainly above normal but only by $\frac{1}{2}$ °C.

Sunshine—Sunshine totals for the month were below normal in eastern and southern districts of the North Island and on the Southland coast, by 15-40 hours. They were above normal in Otago and Canterbury and in Northland, by a similar amount.

Weather Sequence—At the beginning of April a trough of low pressure associated with a depression to the south crossed the North Island, bringing a change to southerlies. Rain covered the North Island but was light in Taranaki; some falls were also reported in Canterbury. A depression formed off East Cape, and cool southerlies persisted over the North Island for the next 5 days, while an anticyclone moved on to the South Island. Rain continued at first in eastern districts of the North Island but conditions soon improved, except in Gisborne.

From the 7th to the 9th a depression moved over Campbell Island, and the associated weak trough of low pressure brought rain mainly to Fiordland, South Westland, and the Southland

coast. During the next 3 days this trough became slow-moving over the North Island with the formation of a small depression near Northland. Rain covered the greater part of the North Island with considerable falls on the 11th in Coromandel, Auckland, and eastern Northland. By the 13th the depression lay to the east of the North Island and there was a change to southerlies. Rain persisted in Northland and was also reported in some eastern districts of both Islands. On the 14th and 15th pressures remained high to the north and a deep depression was passing far to the south-west, while westerly to south-westerly winds predominated over New Zealand. Another trough of low pressure brought rain to most of the South Island with scattered falls also in the North Island.

During the 16th and 17th the weather was mainly fine under the influence of an anticyclone moving rapidly across the country; however, some showers were reported in Southland and also in Northland. For the next 2 days a small depression west of Auckland moved slowly southward with an associated warm front. Rain persisted in Northland with some heavy falls on the 19th, and other areas of both Islands were also affected. As the depression moved on to the North Island on the 20th and 21st, rain became fairly general, especially in western and northern districts. The unsettled weather persisted on the 22nd and 23rd, with a very deep depression passing close to Campbell Island and the associated trough of low pressure crossing the country. Some exceptionally strong gales were reported around Cook Strait.

The weather improved in most districts on the 24th and 25th with an anticyclone over the North Tasman Sea and pressures still low to the south. Rain was reported at times in Fiordland, south Westland, and coastal Southland, with isolated showers elsewhere. Conditions deteriorated again over the South Island from the 26th to the 29th during the passage of a warm front and the formation of a small depression to the south. Most of Nelson, Marlborough, and Canterbury were not affected but elsewhere considerable rain was reported, and there were also scattered falls in the North Island. On the last day of the month an anticyclone was centred over the eastern Tasman Sea and there were only isolated showers in both Islands.
