GENERAL SCALE OF CHARGES

PURSUANT to the Government Railways Act 1949, the Minister of Railways hereby makes the following alterations to the General Scale of Charges, published in the *Supplement* dated the 13th day of September 1971, to the *New Zealand Gazette* of the 9th day of September 1971, and hereby declares that such alterations shall come into force on the 16th day of July 1973.

GOODS

75. Class K

Paragraph 2—Omit the rate shown for each additional 15 miles or fraction thereof beyond 450 miles and insert the following:

LOCAL RATES SCALE OF CHARGES

PURSUANT to the Government Railways Act 1949, the Minister of Railways hereby makes the following alterations to the Local Rates Scale of Charges, published in the *Supplement* dated the 30 day of August 1971, to the *New Zealand Gazette* of the 26th day of August 1971, and hereby declares that such alterations shall come into force on the 16th day of July 1973.

SOUTH ISLAND

29. Through Booking of Parcels and Goods from the South Island to the North Island via Cook Strait Rail Ferries or Rail/Air—

Paragraph 2— Omit the following—

Plywood, veneer, and other processed timber products including particle board and joinery but excluding posts, poles, logs, and sawn timber—
and insert the following—

Beekeepers' woodware and comb foundations (honey frames).
Buildings, pre-cut or prefabricated.
Cable and wire for electrical or communication purposes.
Fungicides.
Herbicides.
Leather, semi-tanned, fully tanned, or dressed.
Leather products.
Pesticides.

Timber and Timber Products as Under—

Timber, dressed (exotic or indigenous), including processed framing.

Timber, sawn, undressed, indigenous, for use in framing.

Timber, laminated.

Timber products, including chip-board, dowelling, fibre-board, floorboards, frames, gang-nail trusses, handles, hardboard, joinery (pre-cut or assembled), mouldings, particle-board, plywood, veneer, weatherboards, and wood-composition building materials.

NOTE—Undressed timber (except indigenous framing timber) and posts, poles, and logs are excluded.
