DECISION OF THE TRIBUNAL

This is another cheap paperback novel by the author of Hitler Needs You. Like Hitler Needs You, this story is also extremely disjointed and has no literary merit.

The novel is ostensibly a mystery involving murder, blackmail, and large sums of illgotten money, but these are merely subplots; the central theme being the seduction by a precocious young girl of an all too eager middle-aged man. The girl herself claims she is 12 years old, and while there is some debate about it, her true age is never established. The story culminates in the last few pages, with the sexual union of the central character and the girl. The rest of the book forms the prelude to this act and is told in a manner intended to titillate the reader.

Taken over all, this book is thoroughly unwholesome and without any redeeming features.

The Tribunal classifies this book as indecent.

There is a mixture of material in this magazine, but the emphasis given in it to illustrations which go well beyond any requirements of the informative content of the text, and the presence of a cheap narrative of a couple's lovemaking accompanied by a sequence of photos with a striptease appeal, undermine any claim it has as an educational publication with honesty of purpose. The magazine seems to be primarily concerned with exploiting interest in sex and, taken as a whole, is indecent.

The recital is so full in its description of sexual encounters that restriction of the book to adult readers is required.

The sensational sex, violence, and crime of the gang are offered in tones of excited pleasure and the treatment of the gang's viotims is likewise devoid of any restraint or humanity.

Mr Rabone and Mr Trendle appeared on behalf of the Police. Mr P. J. Downey put in written submissions on behalf of Seven Seas Publishing Pty. Ltd. subsequent to the hearing to which Mr Rabone made written submissions for the Police in reply.

DECISION AND REPORT

Hello Sex is a straightforward descriptive book of instruction on most aspects of human sexuality. The purpose of the book is stated in the opening sentence of the last chapter as being "intended to indicate the facts, and some of the problems, of becoming a sexually capable young person".

Mr Downey, in his submission correctly so, draws attention to the chapter on abortion and the fact that the law given in that chapter is the law that applies in England. The text of that chapter is well balanced and objective and a reader would probably realise that the legal position stated refers to the English law. We do not raise any objection to the book on this score.

The Tribunal does not basically find fault with the text of the book and, in fact, is of the view that taken as a whole the text is unobjectionable. But it is some of the photographs which are of concern to the Tribunal. Mr Rabone in his submission suggested these were chosen for their sensational and salacious appeal, and hence there was no honesty of purpose in their inclusion in the book. Some of the photographs, and in particular those on pages V, VI, and VII, are not strictly relevant to the text and in the view of the Tribunal are offensive and indecent. The photographs on the book cover are also deliberately designed to appeal to the prurient. Mr Downey submitted that they might be held to be objectionable by some people but that they are in accord with the general informative nature of the book and not given any undue emphasis. We cannot agree with this contention but rather with Mr Rabone who submitted that the photographs have no purpose other than to act as an inducement to beguile the customer to purchase the book. The Tribunal does not basically find fault with the text the book.

We consider that the inclusion of some of the photographs in the book displays a lack of honesty of purpose on the part of the publishers. Section 111 (1) (f) of the Act requires us to take this fact into consideration.

The Tribunal classifies this book as indecent.

While the magazine does not have the more extreme character of some which have been rejected, it is dubious enough not to be entitled to circulate freely, and, because the material readily lends itself to improper use, an age restriction is inappropriate.

The Tribunal classifies this magazine as indecent.
