Alteration of Boundaries of Hawke's Bay County and Hastings City

THE HON. R. D. MULDOON PRESIDING IN COUNCIL

PURSUANT to the Local Government Act 1974, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- 1. This order shall come into force on 1 April 1976.
- 2. The boundaries of Hawke's Bay County and Hastings City shall be altered by excluding from the district of Hawke's Bay County and including in the district of Hastings City the areas described in the Schedule to this scheme.

SCHEDULE

ALL that area in the Hawke's Bay Land District, County of Hawke's Bay.

Firstly, containing 8.9 hectares, more or less, bounded by a line commencing at the northernmost corner of Lot 3, DP 3266, and proceeding south-easterly along the north-eastern boundary of that Lot 3 and its production to the south-eastern side of Maraekakaho Road; thence south-westerly along that roadside to a point in line with the north-eastern boundary of Lot 40, DP 3400; thence north-westerly to and along that boundary and north-easterly along the north-western boundary of Lot 39, DP 3400 to the south-western side of Oliphant Road; thence north-westerly along that roadside to a point in line with the south-eastern boundary of Lot 34, DP 3400; thence north-easterly to and along that boundary and south-easterly along the north-eastern boundary of Lot 23, DP 3400; thence north-easterly along that boundary for a distance of 68.8 metres and its production

to the north-eastern side of Kaiapo Road; thence south-easterly along that roadside to the north-western boundary of Lot 14, DP 3266; thence north-easterly along the north-western boundaries of Lots 14, 9, 8, 7, 6, 5, 4, and 3, DP 3266, to the point of commencement.

Secondly, containing 1.8 hectares, more or less, bounded by a line commencing at a point in the middle of Williams Street in line with the north-western boundary of Lot 51, DP 1977 and proceeding north-easterly to and along that boundary of Lot 51 to its northernmost corner; thence south-easterly along the north-eastern boundaries of Lots 51, 50, 49, 48, 47, and 46, DP 1977, along a right line to and along the north-eastern boundaries of Lots 44, 43, 42, 41, 40, and 39, DP 1977, and Lot 1 DP 4334, to the eastern boundary of Lot 1, DP 4334; thence southerly along that boundary and its production to the middle of Williams Street; thence north-westerly along the middle of that street to the point of commencement.

Thirdly, containing 7.6 hectares, more or less, bounded by a line commencing at the westernmost corner of Lot 1, DP 2986, and proceeding north-easterly along the north-western boundaries of Lots 1 to 17 inclusive. DP 2986 to the north-eastern boundary of Lot 17, DP 2986; thence south-easterly generally, along that boundary, the north-western boundaries of Karamu GD1 and GD2, the north-eastern and south-western boundary of Karamu GD1, and the south-western boundaries of Karamu Part GD and GE1 to the middle of Jellicoe Street; thence south-westerly along the middle of Jellicoe Street to a point in line with the south-western boundary of Lot 1, DP 7594; thence north-westerly along a right line to a point 10.06 metres from the north-eastern side of Collinge Road in line with the north-western boundary of Lot 1, DP 2986; thence north-easterly along a right line to the point of commencement.

Fourthly, containing 18.5 hectares, more or less, bounded by a line commencing at the intersection of the north-eastern side of Ada Street and the southern boundary of Lot 23, DP 9854 and proceeding south-westerly along a right line at right angles to the north-eastern side of Ada Street to the middle of Ada Street; thence south-easterly along the middle of Ada Street to a point in line with the middle of Louie Street; thence south-westerly and north-westerly to and along

the middle of Louie Street to a point in line with the north-western boundary of Lot 30, DP 3146; thence south-westerly to and along the north-western boundaries of Lots 30 and 29, to and along the north-western boundaries of Lots 30 and 29, DP 3146 and their production to the middle of Howard Street; thence north-westerly along the middle of Howard Street to a point in line with north-western boundary of Lot 34, DP 1938; thence north-easterly to and along that boundary, the north-western boundary of part Lot 1, DP 1938, along a right line to and along the south-eastern boundary of Lot 3, DP 7638 and its production to the south-western boundary of Lot 2, DP 4384; thence south-easterly along that boundary and the south-western boundary of Lot 3, DP 10931 to the north-western boundary of Lot 2. DP 8090: DP 10931 to the north-western boundary of Lot 2, DP 8090; thence north-easterly along that boundary to the north-western boundary of Lot 1, DP 8090 and its production to the north-eastern side of Ada Street; thence south-easterly along that roadside to the point of commencement.

Fifthly, containing 7.7 hectares, more or less, bounded by a line commencing at the intersection of the south-western side of Murdoch Road and the southern boundary of Lot 1, side of Murdoch Road and the southern boundary of Lot 1, DP 8304 and proceeding westerly and north-easterly along the southern and north-western boundaries of Lot 1, DP 8304 to the left bank of the Southland Drain as shown on DP 2998; thence westerly along that left bank to the south-eastern side of the Wellington-Napier railway; thence north-easterly along that side to the south-western side of Murdoch Road; thence south-easterly along that roadside to the point of commencement. to the point of commencement.

Sixthly, containing 1.5 hectares, more or less, bounded by a line commencing at the intersection of the production of the line commencing at the intersection of the production of the north-eastern and south-eastern boundaries of Lot 15, DP 7643 and proceeding south-westerly to and along the south-eastern boundary of Lot 15, DP 7643 to the south-western boundary of that lot; thence north-westerly along the south-western boundaries of Lots 15, 14, 13, 12, 11, and 10, DP 7643, along a right line to and along the south-western boundaries of Lots 9, 8, 7, 6. 5, and 4, DP 7643, and along a right line to and along the south-western boundaries of Lots 3, 2, and 1, DP 7643 to the north-western boundary of Lot 1, DP 7643; thence north-easterly along that boundary to the south-western side of Murdoch Road; thence south-easterly along that roadside to and along the north-eastern boundary of Lot 15, DP 7643 and its production to the point of commencement. of commencement.

Seventhly, containing 11.1 hectares, more or less, bounded by a line commencing at the intersection of the south-western by a line commencing at the intersection of the south-western side of Murdoch Road and the south-eastern boundary of Lot 2, Deeds Plan 937, and proceeding south-westerly generally, along the south-eastern and south-western boundaries of Lot 2 and the north-western boundary of Lot 1, both Deeds Plan 937 to and along the north-eastern and north-western boundary of Lot 23, Deeds Plan 118 to the south-western boundary of Lot 2, DP 13854; thence north-westerly along that boundary, the south-western boundaries of Lot 1, DP 13854, Lot 1, DP 8148 and Lot 2, DP 13893 and the production of the last-mentioned boundary to the middle of Southland Road: thence north-easterly along to the middle of Southland Road; thence north-easterly along the middle of that road to a point in line with the south-western side of Murdoch Road; thence south-easterly to and along that roadside to the point of commencement.

Eighthly, containing 2300 square metres, more or less, bounded by a line commencing at a point on the original north-western boundary of Lot 1, DP 1949, in line with the north-eastern boundary of Lot 2, DP 12845 and proceeding south-westerly along the north-western boundary of Lot 1, DP 1949 to the north-eastern boundary of part Lot 194, DP 1695; thence north-westerly along that boundary to the south-eastern boundary of Lot 2, DP 12845; thence north-easterly along that boundary and south-easterly along the production of the north-eastern boundary of Lot 2, DP 12845 to the point of commencement.

Ninthly, containing 180 hectares, more or less, bounded by a line commencing at the southernmost corner of Lot 1, DP a line commencing at the southernmost corner of Lot 1, DP 12863 and proceeding north-westerly, north-easterly and north-westerly along the south-western, north-western, and south-western boundaries of Lot 1, DP 12863 to the northernmost corner of Lot 1, DP 11528; thence north-easterly along a right line to and along the south-eastern boundary of Lot 2, DP 13512 and its production to and along the middle of Kirkwood Road and the latter's production to the middle of Omahu Road: thence south-easterly along the middle Kirkwood Road and the latter's production to the middle of Omahu Road; thence south-easterly along the middle of Omahu Road to a point in line with the south-eastern boundary of Lot 1, DP 2276; thence south-westerly to and along that boundary and the south-eastern boundary of Lot 4, DP 7785 to the south-most corner of that Lot; thence north-westerly along the south-western boundaries of the said Lot 4 and part Lot 3, DP 7785 to the easternmost corner of Lot 2, DP 13653; thence south-westerly along the south-eastern boundary of the said Lot 2, along a right line to and along the south-eastern boundary of Lot 1, DP 12863 to the point of commencement.

Union of Whakatane County and Whakatane Borough: Dissolution of Whakatane Harbour Board

THE RIGHT HON. R. D. MULDOON PRESIDING IN COUNCIL PURSUANT to the Local Government Act 1974, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order

ORDER

1. This order shall come into force on 1 April 1976.

Constitution

2. The districts of the County of Whakatane and the Borough of Whakatane shall be united into one district under the name of "The Whakatane District" (in this Order referred to as the "district").

Order referred to as the "district").

3. The Whakatane County Council and the Whakatane Borough Council shall be dissolved.

4. The Whakatane Harbour Board shall be dissolved and the Whakatane Harbour District shall be abolished.

5. The Council of the Whakatane District shall be a district council under the name of "The Whakatane District Council" (in this Order referred to as the "district council").

6. The communities, and community councils of the County of Whakatane shall enure as if they had been constituted and appointed by the district council.

REPRESENTATION

7. For the purpose of representation only, the district shall be divided into 8 wards, having the names and boundaries described in the schedule to this Order.

8. The mayor of the district shall be elected by the electors of the district, and the district council shall comprise, in addition to the mayor, 14 members to be elected by the electors of each ward as follows:

Whakatane Ward: 7 councillors. Matata Ward: 1 councillor. Omataroa Ward: 1 councillor. Edgecumbe Ward: 1 councillor. Tarawera Ward: 1 councillor. Tanatua Ward: councillor. Galatea Ward: 1 councillor. Waimana Ward: 1 councillor.

Provided that, until the mayor and councillors of the Provided that, until the mayor and councillors of the district council to be elected at the 1977 triennial general election of councillors come into office, the district council shall comprise the mayor and councillors of the Borough of Whakatane and the councillors of the County of Whakatane of the Whakatane Harbour Board appointed by and from the members of that Board; and the mayor of the district shall be chosen by the district council from amongst its members at its first meeting:
Provided further, that in the event of any vacancy occur-

ring in the district council prior to the 1977 triennial general election of councillors, such vacancy may either be filled by appointment, or be left vacant, as the district council shall determine.

9. The electors' lists and electors' rolls in force in the County of Whakatane and the Borough of Whakatane shall continue in force in the district until new electors' lists and electors' rolls are made for that district.

10. The first meeting of the district council shall be convened by the Town Clerk of the Whakatane Borough

Council.

POWERS AND FUNCTIONS

11. Except as otherwise provided in this Order, the pro-11. Except as otherwise provided in this Order, the provisions of Part III and Part XIX of the Municipal Corporations Act 1954 shall apply to the district as if it were a borough and to the district council as if it were a borough council; and the provisions of the Counties Act 1956, except those of Part IV and Part XX, shall apply to the district as if it were a county and to the district council as if it were a county council, and as if references therein to "ridings" were references to "wards". 12. The following sections of the Municipal Corporations Act 1954 shall apply to the district as if it was a borough, and to the district council as if it was a borough council; section 61 (which makes special provision where the same person is elected to be both mayor and councillor), section 108A (which relates to the consolidation of special rates), section 219A (which relates to betterment contributions when water courses are covered), section 237A (which relates to tree roots obstructing public drains), section 302, 303, and 304 (which relate to the prevention of overcrowding in buildings, the illegal occupation of buildings and the removal of buildings illegally erected), and section 330A (which relates to the erection and sale of blocks of flats by a local authority.)

13. For the purposes of any other enactment the district shall be a county and the district council shall be a county

council.

14. The functions of the Whakatane Harbour Board shall become functions of the district council.

HARBOUR COMMITTEE

15. The district council shall forthwith establish and maintain a committee of the council, to be known as the "Whakatane Harbour Committee", to exercise such powers and duties as may be delegated to it by the council pursuant to Part V of the Counties Act 1956 (which relates to committees).

16. Until the 1977 triennial general election of councillors, the Whakatane Harbour Committee shall comprise the members of the Whakatane Harbour Board holding office immediately prior to its dissolution, together with two other persons to be appointed by the district council, and the Chairman of the Whakatane Harbour Board then holding office shall be the Chairman of that Committee.

RATING

17. The system of rating within the district shall be the land value system.

18. All the valuation rolls and rate records in force in the County of Whakatane and the Borough of Whakatane shall continue in force in the district until new valuation rolls and rate records are made for that district.

FINANCE GENERALLY

19. All that assets, liabilities, and engagements of the County of Whakatane, the Borough of Whakatane, and the Whakatane Harbour Board shall become the assets, liabilities, and engagements of the district; and all proceedings pending by or against the Whakatane Borough Council, the Whakatane County Council, and the Whakatane Harbour Board shall be carried on by or against the corporation of the district.

Provided that the assets and liabilities of the municipal electricity undertaking of the Borough of Whakatane shall be applicable only for the benefit of or chargeable only against the residents and consumers within the area of supply of the Whakatane Borough Council (Electric Lines Licence 1963 as described in New Zealand Gazette No. 26 of 2 May 1963 at p. 580) and as may from time to time be amended pursuant to the Electricity Act 1968.

20. Money and income as may from time to time be derived

20. Money and income as may from time to time be derived from the assets of the Whakatane Harbour Board succeeded to by the district council or from the proceeds of the realisation of any such assets, shall be applied to: the maintenance and development of the Whakatane Harbour; to the maintenance and improvement of the endowment lands succeeded to by the district council; and for such other purposes as the district council may decide.

21. For accounting purposes, the harbour functions of the Whakatane Harbour Board succeeded to by the district council shall be a separate activity; and the income derived from the endowment lands succeeded to by the district council shall be deemed to be revenue derived from that activity.

BYLAWS

22. All the bylaws in force in the County of Whakatane and the Borough of Whakatane shall continue in force in the district; but every such bylaw shall remain in force in the area only in which it was in force prior to the union and every such bylaw, the application of which cannot be restricted to either such area, shall be deemed to have been revoked.

23. All bylaws of the Whakatane Harbour Board in force on the date of its dissolution shall, to the extent that they do not conflict with any other bylaw of the district council, be deemed to be bylaws of the district council.

DISTRICT PLANNING SCHEMES

24. The district planning schemes and scheme statements and codes of ordinances in force in the County of Whakatane and the Borough of Whakatane shall be deemed to be the district planning scheme and scheme statement and code of ordinances of the district council, and the district council shall not be required forthwith to prepare a new district.

HARBOUR LIMITS

25. All harbour limits in force on the date of dissolution of the Whakatane Harbour Board shall become the harbour limits for the purposes of the harbour functions of the district council.

PETROLEUM TAX

26. For the purposes of the Local Authorities (Petroleum Tax) Act 1970, the district council shall be the successor of the Whakatane Borough Council and the Whakatane County Council.

ALL that area in the South Auckland Land District Whakatane County, containing 321 square kilometres, more or less, bounded by a line commencing at the intersection of the western boundary of the Whakatane County, as described in New Zealand Gazette 1970, page 198, with the sea coast in Block IV, Waihi South Survey District, and proceeding south-easterly along that coast to the middle of the mouth of the Rangitaiki River in Block V, Awaateatua Survey District; thence generally south-westerly along the middle of that river to a point in line with the north-eastern boundary of Lot 3, D.P. 11085; thence generally westerly to and along that side and the north-western boundary of the said Lot 3, the northern boundary of Lot 1, D.P. 13868, the generally western boundaries of Lots 1 and 2, D.P. 13868 to a point in line with the northern boundary of part Lot 1, D.P.S. 1069; thence north-easterly to and of part Lot 1, D.P.S. 1069; thence north-easterly to and along that boundary and its production to the middle of the Omeheu Canal in Block III, Awaateatua Survey District; thence generally southerly up the middle of that canal to a point in Block II, Rangitaiki Upper Survey District in line with the south-eastern boundary of Lot 1, D.P. 21027, to and along that boundary and the south-eastern boundaries of Lots 2 and 3, D.P. 21027, and the last-mentioned boundary produced to the middle of the Matata-Edgecumbe Road, thence south-easterly along the middle of that road to a produced to the middle of the Matata-Edgecumbe Road; thence south-easterly along the middle of that road to a point in line with the northern boundary of Lot 1, D.P. 24954, situated in Block II, Rangitaiki Upper Survey District; thence westerly, southerly, and south-easterly along the said northern boundary and the western and south-western boundaries of the said Lot 1 to and south-westerly along the generally south-eastern boundaries of part Lot 2, and Lots 3 and 5, D.P. 19552 to the southern corner of the said Lot 5; thence south-easterly and south-westerly along the porthand 5, D.P. 19552 to the southern corner of the said Lot 5; thence south-easterly and south-westerly along the north-eastern boundary of Lot 1, D.P. 21931 and the south-eastern boundaries of that Lot 1, and Lot 2, D.P. 21931 to the southern corner of the said Lot 2; thence south-easterly and south-westerly along the north-eastern and south-eastern boundaries of Lot 2, D.P. 12850, and the last-mentioned boundary produced to the middle of Otokiri Road; thence boundary produced to the middle of Otakiri Road; thence eastwards along the middle of that road to a point in line with the western boundary of Lot 2, D.P. 14867; thence southerly to and along the said western boundary to and easterly along the southern boundary of that lot to and southerly along the eastern boundary of Lot 3, D.P. S. 4182, to the southeastern corner of that lot; thence generally westerly along the southern boundaries of the said Lot 3 and Lot 2, D.P. S. 4182 to the south-western corner of the said Lot 2; thence north-westerly along a right line across Grieve's Road to the south-eastern corner of Allotment 307, Parish of Matata, situated in Block VI, Rangitaiki Upper Survey District; thence westerly along the southern boundary of the said Allotment 307 to the north-western corner of Allotment 308, Parish of Matata; thence southerly along the western boundaries of Allotments 308 and 309, Parish of Matata to the southernmost corner of the said 309; thence southwesterly along the south-eastern boundaries of part Lot 4, and Lots 5, 20 and 6, D.P. 7474, crossing Military Road and the Awakaponga-Kawerau Railway, to the southernmost corner of the said part Lot 6; thence north-westerly along the north-eastern boundary of Section 31, Block V, Rangitaiki Upper Survey District, and its production to the middle of Tarawera River; thence north-westerly down the middle of the said river to a point in line with the southern boundary of Lot 1, D.P. S. 17767; thence westerly to and along the said southern boundary to the middle of the end of a public road; thence generally south-westerly along the middle of the said road to a point in line with the northern boundary of part Allotment 164, Parish of Matata, to and along that northern boundary and the north-western boundary of the said part Allotment 164 and its production to the middle of Braemar Road; thence north-westerly along the middle of that road to a point in line with the northern boundary of Section 21, Block V, Rangitaiki Upper Survey District; thence westerly to and along the northern boundaries of that Section and Sections 23, 19, part section 2, and Section 18, Block V, Rangitaiki Upper Survey District, twice crossing McIvor Road, to the north-western corner of the said Section 18; thence northerly and westerly along the eastern and northern boundaries of Section 22. Rlock

VIII, Rotoma Survey District, and the northern boundary of Section 7, Block VIII, Rotoma Survey District to the north-western corner of the said Section 7; thence southerly along the western boundary of the said Section 7 and its production to the middle of McIvor Road; thence westerly along the middle of that road to a point in line with the north-western boundary of Section 11, Block VIII, Rotoma Survey District; thence generally south-westerly to and along the said north-western and south-western boundaries of that Section 11, the south-western boundaries of Sections 4 and 37, Block XI, Rotoma Survey District, the north-western boundary of Lot 1, D.P. S. 13687, the north-western boundary of part Section 11, Block XI, Rotoma Survey District, and the north-western and western boundaries of Section 27, Block XI, Rotoma Survey District and the lastmentioned boundary produced to the middle of State Without 20, 12 and 13 and 14 and 15 Highway 30; thence generally north-westerly along the middle of the said State Highway to its intersection with the western boundary of the Whakatane County, aforesaid; thence northerly along the said County Boundary to the point of commencement.

OMATAROA WARD

ALL that area in the South Auckland Land District, Whakatane County, containing 132 square kilometres, more or less, bounded by a line commencing at the middle of the mouth of the Rangitaiki River Block V, Awaateatua Survey District, of the Rangitaiki River Block V, Awaateatua Survey District, and proceeding south-easterly along the seacoast to the middle of the end of Eastern Boundary Road in Block IA, Whakatane Survey District, thence generally south-easterly along the middle of that road, State Highway Number 2 and Paroa Road to a point in line with the south-eastern boundary of Lot 6, D.P. 20328, to and along that boundary and its production to the middle of Board Mills Road, along the middle of that road to a point in line with the south-eastern middle of that road to a point in line with the south-eastern boundary of Allotment 29V3B, Parish of Rangitaiki, to and along that boundary and its production to the middle of Fortune Road and along the middle of that road to its intersection with the middle of the afore-mentioned Paroa Road; thence north-westerly along the middle of that road to a point in line with the north-western boundary of Lot 3, D.P. S. 10213; thence north-easterly to and along that boundary, and its production to the middle of the Whakatane River; thence generally south-easterly up the middle of that river to a point in line with the southern boundary of Allotment 31J, Parish of Rangitaiki, situated in Block IX, Altotnent 311, Parish of Rangitaiki, situated in Block IX, Whakatane Survey District; thence westerly to and along that southern boundary crossing Taneatua Road and the East Coast Main Trunk Railway, and the northern boundary of part Allotment 32N, Parish of Rangitaiki, to the northwestern corner of that allotment; thence generally southerly along the eastern and southern boundaries of part Allotment 32O, Parish of Rangitaiki, the western and southern boundaries of part Allotment 32E5A, Parish of Rangitaiki and the western houndaries of parts Allotments 32E5R and 32G, Parish of Rangitaiki to the south-western corner of the said part Allotment 32G; thence generally south-westerly along the southern boundary of Allotment 32F, westerly along the southern boundary of Allotment 32P, Section B, Parish of Rangitaiki, the eastern and southern boundaries of part Allotment 32H1, Parish of Rangitaiki and the last-mentioned boundary produced to the middle of a public road; thence generally north-easterly along the middle of that road to a point in Block VIII, Whakatang Survey District, in line with the northern boundary of Omatarea Rangitaiki I Block; thence north-westerly to and along the generally northern boundaries of the said Omatarea along the generally northern boundaries of the said Omataroa Rangitaiki 1 Block, south-western boundaries of Allotment 11. Parish of Rangitaiki, situated in Block VII, Rangitaiki Upper Survey District, and the last-mentioned boundary produced to the middle of State Highway 30; thence north-easterly along the middle of that State Highway to a point in line with the south-western boundary of part Lot 3, D.P. 18069; thence generally north-westerly to and along that boundary and the south-eastern and north-eastern boundaries of Lot 1, D.P. 18069 and the last-mentioned boundary produced to the middle of Western Drain Road: thence north-easterny along the middle of that Drain Road; thence north-easterly along the middle of that road to its intersection with the middle of McLean Road; to a point in line with the middle of Western Drain; thence north-easterly along the middle of Western Drain; thence north-easterly along the middle of that drain to a point in line with the north-western boundary of Section 8S, Orini Settlement, situated in Block IV, Rangitaiki Upper Survey District; thence generally south-westerly to and along that boundary, and the north-eastern boundary of Lot 1, D.P. S. 7761, and its production to the middle of Reid's Central S. 7761, and its production to the middle of Reid's Central Canal; thence generally north-easterly down the middle of that canal to a point in line with the north-eastern boundary of part Lot 4, D.P. 36720; thence north-westerly to and along that boundary, the south-eastern and south-western boundaries of part Lot 1, D.P. 34739 and the last-mentioned boundary produced to the middle of East Bank North Road; thence south-westerly along the middle of that road to a point in line with the north-eastern boundary of Lot 1, D.P.
