Constitution of the Tasman Electric Power Board

ORDER IN COUNCIL

At the Government Buildings at Wellington, this 22nd day of March 1976

Present:

THE RIGHT HON. R. D. MULDOON PRESIDING IN COUNCIL

WHEREAS by Proclamation, dated the 16th day of June 1925, and published in the *Gazette*, on the 18th day of June 1925, the Golden Bay Electric Power District as therein described was duly constituted as an electric power district within the meaning of the Electric Power Boards Act 1925:

And whereas by Proclamation, dated the 1st day of May 1929, and published in the *Gazette*, on the 2nd day of May 1929, the Waimea Electric Power District as therein described was duly constituted as an electric power district within the meaning of the Electric Power Boards Act 1925:

And whereas the districts controlled by the Golden Bay Electric Power Board and the Waimea Electric Power Board have since the respective dates of the constitution of the Boards been extended, modified, and amended:

And whereas it is desirable to amalgamate the electric undertakings and districts of the Golden Bay Electric Power Board and the Waimea Electric Power Board under a new electric power board to be hereby constituted under the Electric Power Boards Act 1925:

And whereas by special order of the Golden Bay Electric Power Board, confirmed on the 21st day of August 1975, and by special order of the Waimea Electric Power Board, confirmed on the 20th day of August 1975, it was resolved that the amalgamation of the two Boards be recommended:

And whereas the Local Government Commission has recommended the amalgamation in terms of the Local Government Act 1974:

Now, therefore, pursuant to the Electric Power Boards Act 1925 and the Local Government Act 1974, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. The Tasman Electric Power District—

(i) The area defined in the First Schedule to this order is hereby constituted as the Tasman Electric Power District.

(ii) The outer area of the district so formed shall consist of the area described in the Second Schedule hereto.

2. The Tasman Electric Power Board—The Tasman Electric Power Board is hereby constituted for the purpose of administering the supply of electricity in the Tasman Electric Power District.

3. Representation—

(i) The constituent districts which are bracketed together in the first column of the Third Schedule to this order shall be a combined district, and the local authority of the constituent district, distinguished by the letter "(P)", shall be the principal local authority of the combined district.

(ii) The number of representatives of each constituent district or combined district shall be the number specified in the Third Schedule to this order opposite the name of that constituent district or combined district. Provided that until the next triennial local body elections the total number of the present members of the Waimea Electric Power Board and the Golden Bay Electric Power Board shall be the number of representatives of the Tasman Electric Power Board.

(iii) The first representatives of the constituent districts and combined districts shall be the present members of the Golden Bay and Waimea Electric Power Boards and shall hold office until the next triennial local body election. All subsequent representatives of the constituent districts and combined districts shall be elected by the electors of the said constituent districts and combined districts.

4. First Meeting of Board—The first meeting of the Tasman Electric Power Board shall be held at the office of the Board in Richmond, at 11 a.m., on the 24th day of March 1976.

5. Functions, Powers, and Responsibilities of Board—The Tasman Electric Power Board shall have all the powers, rights, duties, obligations, and responsibilities of an electric power board constituted under the Electric Power Boards Act 1925, and the provisions of the Electric Power Boards Act 1925, in so far as they are not contrary to this order shall apply to the board.

6. Staff—In accordance with the Local Authorities (Employment Protection) Act 1963, and under such terms and conditions as may be agreed upon, the board shall continue to employ all permanent employees of the Golden Bay and Waimea Electric Power Boards, who elect to transfer to the board, provided the conditions of employment shall be no less favourable than those enjoyed formerly.

7. Tariffs.—The tariffs charged by each of the Golden Bay and Waimea Electric Power Boards, as at the date of this order, shall remain in force until new tariffs are fixed by the Tasman Electric Power Board. The equalisation of tariffs throughout the area shall be effected by the Tasman Electric Power Board within three (3) years from the date of this order.

FIRST SCHEDULE

TASMAN ELECTRIC POWER DISTRICT

ALL that area in the Nelson Land District containing all the Counties of Waimea and Golden Bay and part of the County of Inangahua, all the Boroughs of Motueka and Richmond, and part of the City of Nelson, bounded by a line commencing at Pukerau Point on the eastern sea coast of Tasman Bay and proceeding south-easterly along a right line to North Castor Peak; thence generally southerly and south-westerly along the summit of the Bryant Range through the Rai Saddle and Mount Duppa to the source of Heringa Creek on Saddle Hill; thence south-easterly down the middle of that creek to the middle of the Pelorus River; thence generally south-westerly up the middle of that river to its source on the summit of the Bryant Range, approximately 2 kilometres south-east of Slaty Peak; thence generally south-easterly along the summit of the said Bryant Range to the summit of the Richmond Range; thence generally south-westerly along the summit of the said Richmond Range passing through Old Man, Mount Rintoul, Bishops Cap, and Bushy Top to Wards Pass; again south-westerly along a right line to Trig. Top 2; thence south-easterly along the north-eastern boundary of Section 3, Square 34, and that boundary produced across Provincial State Highway No. 63 to its southern side; thence south-westerly along the southern side of that highway to the westernmost corner of Section 6, Square 34; thence south-easterly along the south-western boundary of the said Section 6 to the south-eastern corner of Section 11, Block XIV, Motupiko Survey District; thence generally south-westerly along the south-eastern boundary of the said Section 11 and the summit of the St Arnaud Range to Trig. St Arnaud; again generally south-westerly along the summit of the St Arnaud Range and the summit of the Spenser Mountains, passing through Camel, Mount McKay, Mount Humbolt, and Faerie Queen to the junction of the said Spenser Mountains with the Freyberg Range, approximately 1 kilometre south-west of Gloriana Peak; thence generally south-westerly, north-westerly, and northerly along the summit of the said Freyberg Range and the summit of the watershed between the Maruia and Glenroy Rivers, passing through Trig. FZ and Trig. EZ, to Mount Cann; thence south-westerly along the south-eastern boundary of Section 10, Block XIII, Matakītiki Survey District, and that boundary produced across the eastern end of a public road to its southern side; thence generally westerly along the southern side of the said public road to and along the southern boundary of the said Block XIII, Matakītiki Survey District, to the north-eastern corner of Block IV, Rahu Survey District; thence generally southerly along the eastern boundaries of Blocks IV, VIII, XII, and XVI, Rahu Survey District, to the north-western corner of Block I, Travers Survey District; thence due east and due south along the northern and eastern boundaries of the said Block I and the eastern boundary of Block IV, Travers Survey District, to a point on the Main Divide approximately 1.5 kilometres north-east of Lucretia; thence generally south-westerly and north-westerly along the summit of the Main Divide and the southern watershed of the Maruia River, passing through Lucretia and Trig. C, to the southernmost corner of Section 2, Block VII, Lewis Survey District; thence generally north-westerly along the south-western boundary of the said Section 2, and the southern end of a public road to the southern corner of Section 1, Block VII, Lewis Survey District; thence north-westerly and north-easterly along the south-western and north-western boundaries of the said Section 1 to a point on the south-western boundary of Section 20, Block III, Lewis Survey District; thence north-westerly along the south-western boundaries of the said Section 20 and Section 7, Block III, Lewis Survey District, and the last-mentioned boundary produced across a public road to its north-western side; thence north-easterly along the north-western side of the said public road to a point on the southern watershed of the Maruia River; thence generally north-westerly along the said watershed passing through Mount Alexander to the western boundary of Block II, Lewis Survey District; thence generally northerly along the western boundary of Block II, Lewis Survey District, and Blocks XIV, X, VI, and II, Rahu Survey District, and Blocks XIV, X, VI, and II, Burnett Survey District, to the intersection of the last-mentioned boundary with the summit of the Brunner Range; thence generally northerly along the summit of the said Brunner

the junction of the said Brunner Range with the Deepdale Ridge; thence generally north-easterly along the summit of the said Deepdale Ridge passing through Trig. K to a point due south of the confluence of the Eight Mile or Boundary Creek with the Buller River; thence due north along a right line to the mouth of the said Eight Mile or Boundary Creek; thence generally northerly along a leading spur on the western side of the said creek to Bald Hill; thence generally north-easterly along the summits of the Lyell Range and Matiri Range, passing through Rocky Tor, Thousand Acre Plateau, the Haystack, and Nugget Knob to the Whangapeka Saddle; thence generally north-easterly along the summit of the Arthur Range passing through Mount Luna and Mount Star to Mount Arthur; thence generally northerly and westerly along the summit of Pyramid Ridge passing through Gordons Pyramid to Trig. Tableland; thence generally north-westerly along the summit of the Peel Range passing through Mount Peel and Mount Ranolf to Aorere Peak, thence generally westerly and north-westerly along the summit of the Domett Range passing through Mount Centre and Aorere Saddle to Amohia Peak; thence generally north-easterly along the summit of the Goulard Range passing through Flanagan and Mount Goulard to Goul; thence generally westerly and northerly along the summit of the Tubman Range passing through Tubman Hill to the saddle approximately 1 kilometre south-east of Mount Teddy; thence generally northerly and westerly along the summit of Saxon Ridge passing through Mount Teddy to the source of the northern branch of the Kahurangi River; thence generally northerly down the middle of that river to the sea coast; thence generally north-easterly and easterly along the sea coast to the easternmost point of Farewell Spit; thence generally westerly, southerly, and north-easterly along the sea coast of Golden Bay to Separation Point; thence generally southerly and north-easterly along the sea coast of Tasman Bay, crossing the mouths of all harbours and inlets, to a point on the high-water mark at Nelson City on the north-western side of Rocks Road bearing 303° 42' from a point on the north-western side of Princes Drive, bearing 333° 26' 17" distance 16.73 metres from Standard Survey Mark CLXIV (S.O. 8460); thence south-easterly along a right line to the said point on the north-western side of Princes Drive; thence generally south-westerly along the north-western side of the said Princes Drive to the northernmost corner of Lot 2, D.P. 5769; again south-westerly along the north-western boundary of the said Lot 2 and the north-western side of Princes Drive to a point in line with the south-western side of Boundary Road; thence south-easterly to and along the south-western side of the said Boundary Road and its production to the south-eastern side of Waimea Road; thence north-easterly along the south-eastern side of the said Waimea Road to the south-western side of Boundary Road; thence south-easterly along the south-western side of the said Boundary Road to a point in line with the south-western boundary of Section D. 3, District of Wakatu; thence south-easterly to and along the south-western boundary of the said Section D. 3, the south-western end of Tukuku Street, the south-western boundary of Section D. 21, District of Wakatu, the south-western end of Gramplan Road, and the south-western boundaries of Sections D. 28, and D. 29, District of Wakatu, to the northernmost corner of Section 7, District of Brook Street and Maitai; thence south-westerly along the north-western boundaries of the said Section 7 and Sections 8, 10, and 3 of 8, District of Brook Street and Maitai, to the westernmost corner of the said Section 3 of 8; thence south-easterly along the south-western boundary of the said Sections 3 of 8, and that boundary produced to a point in line with the south-eastern boundary of Rural Section 1, District of Brook Street and Maitai; thence generally north-easterly to and along the south-eastern boundary of the said Rural Section 1, and the south-eastern boundary of Section 35, District of Brook Street and Maitai, to the easternmost corner of the said Section 35; thence north-westerly along the north-eastern boundary of the said Section 35 to the southernmost corner of Section 36, District of Brook Street and Maitai; thence north-easterly, north-westerly, south-westerly and again north-westerly, along the south-eastern, north-eastern, north-western, and north-eastern boundaries of the said Section 36, and the north-eastern boundary of Section 44, District of Brook Street and Maitai, to the northernmost corner of the said Section 44; thence north-westerly, north-easterly and again north-westerly along the north-eastern, south-eastern, and north-eastern boundaries of the aforesaid Section 36, and Section 1, District of Brook Street and Maitai, to the south-eastern boundary of Section B. 21, District of Wakatu; thence north-easterly along the south-eastern boundaries of the said Section B. 21 and Sections B. 20 and B. 19, District of Wakatu, the last-mentioned boundary produced across Manuka Road and the south-eastern boundaries of Sections B. 11 and B. 10, District of Wakatu, to the eastern boundary of the said Section B. 10;

Section B. 10 and Sections B. 9 and B. 8, District of Wakatu, the last-mentioned boundary produced across Nile Street East and Section B. 7, District of Wakatu, to the north-eastern corner of the said Section B. 7; thence westerly and northerly along the northern and eastern boundaries of the said Section B. 7 and the eastern boundary of the said Section B. 7, produced to the left bank of the Maitai River; thence generally easterly, northerly, and southerly along the said left bank to a point in line with the north-eastern boundary of Section A. 8, District of Wakatu; thence north-westerly and westerly to and along the north-eastern and northern boundaries of the said Section A. 8 to the north-westernmost corner of the said Section A. 8; thence westerly and southerly along the northern and western boundaries of Section 1160, City of Nelson, to the north-eastern corner of Section A. 7, District of Wakatu; thence westerly and southerly along the northern and western boundaries of the said Section A. 7, and again southerly along the western boundary of Section A. 6, District of Wakatu, to the north-eastern corner of Section A. 4, District of Wakatu; thence westerly along the northern boundaries of the said Section A. 4 and Section A. 10, District of Wakatu, to the south-eastern corner of Section 1166, City of Nelson; thence northerly along the eastern boundary of the said Section 1166 to the easternmost corner of Section A. 9, District of Wakatu; thence westerly along the northern boundary of the said Section A. 9 to the south-eastern corner of Section A. 1, District of Wakatu; thence northerly and westerly along the eastern and northern boundaries of the said Section A. 1 to the south-eastern corner of Section 1204, City of Nelson; thence northerly along the eastern boundaries of the said Section 1204 and Section 1203, City of Nelson, to the north-eastern corner of the said Section 1203, thence easterly, northerly, and westerly along the southern, eastern, and northern boundaries of Section 270A, City of Nelson, to a point in line with the south-eastern boundary of Section 269A, City of Nelson; thence north-easterly across the eastern end of Cambria Street, to and along the south-eastern boundary of the said Section 269A, to the easternmost corner of the said Section 269A; thence north-westerly along the north-eastern boundary of the said Section 269A, that boundary produced across Atawhai Drive and along the north-eastern boundary of Section 259A, City of Nelson, to the south-eastern side of North Road; thence north-easterly along the south-eastern side of the said North Road to a point in line with the northern boundary of Section H. 9, District of Wakatu; thence westerly across North Road, to and along the northern boundary of the said Section H. 9 to the easternmost corner of Section 1167, City of Nelson; thence north-westerly along the north-eastern boundary of the said Section 1167 to its northernmost point; thence north-westerly along a right line to a point on the south-eastern boundary of Section 1132, City of Nelson, in line with the centre of the lighthouse tower; thence north-easterly and north-westerly along the south-eastern and north-eastern boundaries of the said Section 1132 to its northernmost point; thence generally north-easterly along the sea coast of Tasman Bay, crossing the mouths of all harbours and inlets, to the point of commencement.

5. **Functions, Powers, and Responsibilities of Board**—The Waitomo Electric Power Board shall have all the powers, rights, duties, obligations, and responsibilities of an electric power board constituted under the Electric Power Boards Act 1925, and the provisions of the Electric Power Boards Act 1925, in so far as they are not contrary to this Order shall apply to the board.

6. Staff—In accordance with the Local Authorities (Employment Protection) Act 1963, and under such other terms and conditions as may be agreed upon, the board shall continue to employ all permanent employees of the present Waitomo and Wairere Electric Power Boards, who elect to transfer to the board, provided the conditions of employment shall be no less favourable than those enjoyed formerly.

7. Tariffs—The tariffs charged by each of the present Waitomo and Wairere Electric Power Boards, as at the date of this order, shall remain in force until new tariffs are fixed by the Waitomo Electric Power Board. The equalisation of the tariffs throughout the area shall be effected by the Waitomo Electric Power Board within five (5) years from the date of this order.

8. Date of Merger—The merger shall come into force on the 1st day of April 1976.

Import Control Exemption Notice (No. 4) 1976

PURSUANT to regulation 17 of the Import Control Regulations 1973*, the Minister of Trade and Industry hereby gives notice as follows:

1. (a) This notice may be cited as the Import Control Exemption Notice (No. 4) 1976.
(b) This notice shall come into force on the day after the date of its notification in the *New Zealand Gazette*.
2. Goods of the classes specified and for the purposes of the Customs Tariff falling within the tariff items in the First Schedule hereto imported from and being the produce or manufacture of any country, are hereby exempted from the requirement of a licence under the said regulations.
3. The exemptions from the requirement of a licence under the said regulations in respect of the goods of the classes set forth in the Second Schedule hereto, included in the exempting notice shown in the Second Schedule, are hereby withdrawn.
