Pursuant to the Public Works Act 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. This order may be cited as the Greenstreet Irrigation

Order 1976.

2. The Minister of Works and Development is hereby authorised to construct, maintain, and control the water supply works to serve the district described in the Schedule hereto, with the execution and administration being carried out by the Ashburton County Council.

3. There will be no annual basic charge payable on the

irrigable land within the scheme boundaries.

4. The annual water availability charge will be \$0.75 per

irrigable hectare.

5. There will be no exemptions or reductions during the development period.

6. The water availability charge is based on the estimated costs of operation and maintenance of the scheme, and shall be subject to annual adjustment.

7. The object of the scheme is to provide a reliable water supply for irrigation of land within the scheme boundaries.

8. The scheme will be capable of fully irrigating 2,400 hectares of land during most seasons.

9. A water use roster for the scheme compatible with the scheme of irrigation for each farm will be implemented and scheme of irrigation for each farm will be implemented and administered by the Ashburton County Council.

10. The water supply will be subject to the conditions of the water right granted by the South Canterbury Regional

Water Board.

11. The acceptability of the scheme has been ascertained by an inquiry in writing of all the occupiers of land in the proposed district and all have given the Minister of Works and Development notice in writing of their approval.

DIRECTIONS FOR EDUCATIONAL DEVELOPMENT

A REPORT PREPARED BY THE ADVISORY COUNCIL ON EDUCA-TIONAL PLANNING

This report marks the culmination of the activities of the Educational Development Conference The Advisory Council has recommended the directions it considers New Zealand education should go in the next 5 or 10 years.

Five principal areas are identified as requiring attention. Education is seen as a lifelong activity, and emphasis is therefore placed on the "foundations"—early childhood education, the school curriculum and special provision for special needs, and parent education.

Special attention is given also to the relationships between the school and the community, the need for close mutual support and co-operation, including understanding and respect

A key to the quality of education is the people involved in it. Teacher education, the availability of advisory and ancillary staff, as well as resources for materials and research, have a chapter devoted to them.

Since education is seen as a lifelong activity, this is considered at some length. Facets such as accessibility, transfer of credits, and the role of existing institutions are discussed, together with ways in which continuing education could be provided for the whole community.

In discussing the administration and organisation of education, the principle followed is the maximum devolution of authority and responsibility to the agencies and the community, at for instance, school committee and district level.
