The captions, however, which appear to be intended as a child's comment as viewer of the people or actions in the photographs, are supposed to be amusing to adult readers and are trivial. The text at the end of the book is slight and no better than in other more serious and valuable guides.

Considering the book as a whole, its stated purpose, and the persons at whom it is aimed, we can see no particular merit or importance, in categories mentioned in section 11 of the Act, but do suspect the honesty of purpose and the integrity of the whole. The appeal overall is to the prurient rather than to the educator.
