Authorisation of 1977 New Zealand Easter Show

PURSUANT to the Exhibitions Act 1910, the Minister of Trade and Industry hereby gives notice as follows:

1. In this notice, unless the context otherwise requires—

"The Act" means the Exhibitions Act 1910;

ne promoter" means the Auckland Agricultural and Pastoral Association and the Auckland Manu-"The Agricultural facturers Association.

- The exhibition" means a public exhibition of works of industry and art to be conducted by the promoter at the Epsom Showgrounds, Auckland, from 31 March 1977 to 12 April 1977 (except on 8 April 1977 when the exhibition will be closed), and to be known as the New Zealand Easter Show 1977.
- 2. The exhibition is hereby authorised and declared to be an exhibition within the meaning of the Act.
- 3. Subject to the conditions set out in the Schedule hereto, the following provisions are hereby suspended in so far as they relate to work done or business conducted or services rendered in the said premises during the period of the exhibition, by or on behalf of the promoter, or by or on behalf of any exhibitor at the exhibition, or by any person employed in or about the exhibition, namely—such of the provisions of—
 - (a) The Industrial Relations Act 1973 and all collective agreements and awards in force thereunder;
 (b) The Shops and Offices Act 1955; and

(c) The Factories Act 1946

as relate to the hours of commencing or ceasing work, or to the issue of permits, or to the payment for overtime, or extended hours, or to holidays and half-holidays, or to the closing of shops.

SCHEDULE

1. Forty hours shall constitute a week's work, to be worked on 5 days of the week, and 8 hours shall constitute a day's work in or about the exhibition, and, with the exception set out in clause 2 hereof, the daily hours shall be worked consecutively.

2. No person shall be employed in or about the exhibition for more than 4 hours without an interval of at least three-

quarters of an hour for a meal.

3. (a) Any person employed during any day in or about the exhibition who is employed on that day for more than 8 hours, or before the hour of 8 a.m., or after the hour of 10.30 p.m., or on any day in excess of 5 days per week (whether the excess employment is in or about the exhibition or otherwise) shall be paid for the excess employment at not less than half as much again as the ordinary rate for the first 2 hours and at not less than twice the ordinary rate there-

(b) Any person employed in or about the exhibition on any (b) Any person employed in or about the exhibition on any day that would, but for the provisions of this order, have been a whole holiday for that person by virtue of any Act, or of any collective agreements or awards, shall be paid for all work done on that day at not less than twice the ordinary rate, whether the work is performed wholly in or about the exhibition or otherwise. Provided that nothing in this subclause that he described any person of any other resument. shall be deemed to deprive any person of any other payment for the said holiday to which he is entitled under any Act or collective agreements or awards.

4. No assistant under 18 years of age shall be employed in or about the exhibition after the hour of 10.30 p.m.

- 5. For the purposes of the enforcement of any collective agreements or awards, any provision of which has been suspended by this order, any officer of the industrial union or association concerned who is authorised in writing in that behalf by the union or association shall be entitled to interview at his place of employment any person employed in or about the exhibition under those collective agreements or awards at such time or times as may be agreed upon between the officer and the employer of that person, and for this the officer and the employer of that person, and for this purpose any such officer shall be entitled at any time to have access to the register of passes issued by the promoter.
- 6. Nothing in this notice shall be deemed to affect any provisions in any collective agreements or awards requiring workers subject to such collective agreements or awards to be members of a union.

Price Order No. 32 (Ecuadorian Bananas)

PURSUANT to the Commerce Act 1975, I, Peter Edward Donovan, pursuant to a delegation from the Secretary of Trade and Industry, hereby make the following price order:

- This order may be cited as Price Order No. shall come into force on the 5th day of November 1976.
 - 2. (1) Price Order No. 30* is hereby revoked.
- (2) The revocation of the said order shall not affect the liability of any person for any offence in relation thereto committed before the coming into force of this order.
- 3. References in this order to metropolitan areas are references to the metropolitan areas described in the Schedule hereto.

APPLICATION OF THIS ORDER

4. This order applies with respect to all Ecuadorian bananas sold by way of retail in New Zealand.

MAXIMUM RETAIL PRICES OF ECUADORIAN BANANAS

- 5. (1) The maximum price that may be charged or received by any retailer for any Ecuadorian bananas to which this order applies shall be:
 - (a) When sold by a retailer carrying on business in any of the metropolitan areas of Auckland, Wellington, Christchurch, or Dunedin, or in any of the Cities or Boroughs of Whangarei, Takapuna, Hamilton, Tauranga, Rotorua, Gisborne, New Plymouth, Stratford, Hawera, Wanganui, Palmerston North, Napier, Hastings Mosterton Riesbalm Nelson Greywooth Hastings, Masterton, Blenheim, Nelson, Greymouth, Timaru, Westport, Oamaru, Balclutha, Gore, or Invercargill-

31 cents per lb.

Or where the scales used by the retailer weigh in metric weights-

68 cents a kilogram.

- (b) When sold by a retailer carrying on business elsewhere-

 - 1 lb, 32 cents; 2 lb, 63 cents; 3 lb, 95 cents;

 - 4 lb, \$1.26;
 - 5 lb, \$1.58; 6 lb, \$1.89.

Fractions of a pound shall be calculated at the rate of 32 cents per lb. Quantities in excess of 6 lb shall be calculated at the rate of 31.5 cents per lb.

Or where the scales used by the retailer weigh in metric weights-

69 cents a kilogram.

(2) If in respect of any lot of bananas the price calculated in accordance with the foregoing provisions of this clause is not an exact number of cents, the maximum price of the lot shall be computed to the nearest whole cent.

PROVISIONS FOR SPECIAL PRICES

6. Notwithstanding anything to the contrary in the foregoing provisions of this order, and subject to such conditions, if any, as he thinks fit, the Secretary, on application by any retailer, may authorise special maximum prices in respect of any Ecuadorian bananas to which this order applies where special circumstances exist, or for any reason extraordinary charges (freight or otherwise) are incurred by the retailer. Any authority given by the Secretary under this clause may apply with respect to a specified lot or consignment of bananas, or may relate generally to all Ecuadorian bananas to which this order applies sold by the retailer while the approval remains in force. in force.

DUTY IMPOSED ON RETAILERS

- 7. Every retailer who offers or exposes for sale in any shop any Ecuadorian bananas to which this order applies shall keep in a prominent position, in such proximity to the bananas to which it relates as to be obviously in relation thereto, a ticket, placard, or label on which shall be stated in legible and prominent characters the following particulars:
 - (a) The retail price per pound of the bananas. Retailers to whom clause 5 (1) (b) of this order applies shall state at least the prices for 1 lb and 2 lb lots.

Or where the scales used by the retailer weigh in metric weights the prices for 1 kg and 2 kg lots.

(b) The word "Ecuadorian".
