Proposed Boundaries of the Electoral Districts in the North Island and South Island of New Zealand

THE Representation Commission appointed in pursuance of section, 15 of the Electoral Act 1956, hereby publishes, in accordance with the provisions of section 18 of the said Act, the proposed boundaries of the electoral districts in the North and South Islands of New Zealand; and, further, gives notice that written objections to the same will be received by the undersigned, the chairman of the commission, at the office of the Surveyor General, Charles Fergusson Building, Wellington, not later than Thursday, the 17th day of February 1977, for consideration by the aforesaid Commission.

Maps of the proposed districts may be seen at the office of any city or borough council, district or county council, or town board; or the office of the Chief Surveyor at Auckland, Hamilton, Gisborne, Napier, New Plymouth, Wellington, Blenheim, Nelson, Hokitika, Christchurch, Dunedin, and Invercargill or the office of the Chief Electoral Officer at Wellington; all Electorate Officers and Magistrates' Courts.

Counties, districts, ridings, cities, boroughs, and town districts, where mentioned in this notice shall, unless otherwise stated, be existing on 23 March 1976.

SCHEDULE

BAY OF ISLANDS

ALL that piece comprising the Counties of Mangonui, Whangaroa, Hokianga and Bay of Islands; the Boroughs of Kaitaia and Kaikohe; the Town district of Hikurangi; that portion of the County of Whangarei being the Otanga, Hikurangi, and Wairua Ridings and that portion of the Kiripaka Riding to the north of a line commencing at the south-east corner of Section 5, Block I, Whangarei Survey District, and proceeding generally easterly along the northern boundaries of the Tititihi Block and northern and eastern boundaries of Lot 1, D.P. 45058 to and along the centre of the Ngunguru River, to and along the western and northern boundaries of Block XIII, Opuawhanga Survey District, to and along the western boundary of Lot 1, D.P. 43116, to and along the south-east boundary of Section 23, Block X, Opuawhanga Survey District and the extension of that boundary to the mean high-water mark of the sea; and including the Poor Knights, the Three Kings Islands, and other adjacent islands.

WHANGAREI

ALL that piece comprising the City of Whangarei and that portion of the County of Whangarei being the Manaia Riding and that portion of the Kiripaka Riding not included in the Electoral District of Bay of Islands hereinbefore described and including the Hen and Chickens Islands, the Mokohinau Islands, and other adjacent islands.

KAIPARA

ALL that piece comprising the Mangakahia, Maungakaramea, Mangapai, Ruakaka, Waipu, and Maunu Ridings of the County of Whangarei; the Counties of Hobson and Otamatea; the Borough of Dargaville; the Town District of Warkworth; and the Albert-Arai, Wellsford, Hoteo, Omaha, Matakaua, Kourauwhere-Tauhoa, and Kaipara-Puhoi Ridings of the County of Rodney and including Kawau, Motuora, and other adjacent islands.

HELENSVILLE

ALL that piece comprising the Borough of Helensville; that portion of the County of Rodney being the Kaukapaka and Kumeu Ridings and that portion of the Wainui Riding to the North-west of the middle line of Bawdens Road and its extension south-easterly along the middle of State Highway No.1 to and along the middle of the road through the land on D.P. 65508 and the continuation of that road to the riding boundary; and that portion of the City of Waitemata to the north of a line commencing at the mouth of Anawhata Stream in Block I, Waitakere Survey District and continuing up the middle of that stream to and along the southern boundary of Allotments M44, NE44, SW45 and 1, Waitakere Parish and the extension of the lastmentioned boundary across Ridge Road to and along the northern boundary of Allotment 52 and the southern boundary of Allotment 103 of the said Waitakere Parish and the extension of the lastmentioned boundary to the centre line of the Waitakere Scenic Drive; thence continuing generally south-easterly along that centre line to and along the middle of Waikumete West Coast Road, Forest Hill Road, Holdens Road, Parrs Cross Road to and along the middle of Oratia Stream, and along the western boundary of the Borough of Henderson to and along the middle of Rathgar Road and its extension to the mean high-water mark of Waitemata Harbour, and including Herald Island.

EAST COAST BAYS

ALL that piece of the existing Electoral District of East Coast Bays, as described in N.Z. Gazette, 1972, p. 565, north-east of the middle line of the proposed Auckland-Waiwera Motorway.

NORTH SHORE

ALL that piece being the existing Electoral District of North Shore as described in N.Z. Gazette, 1972, page 565.

ALL that piece comprising that portion of the City of Takapuna not included in the Electoral Districts of East Coast Bays, North Shore, and Birkenhead and that portion of the County of Rodney being the Hibiscus Coast Riding and that portion of the Wainui Riding not included in the Electoral District of Helensville hereinbefore described.

BIRKENHEAD

ALL that piece comprising the Boroughs of Birkenhead and Northcote and those portions of the City of Takapuna south of a line commencing at the intersection of the boundary of the Borough of Birkenhead with the centre line of Eskdale Road; thence proceeding south-easterly along that centre line and its extension to centre of Glenfield Road; thence along a right line to the southern corner of Lot 1, D.P. 40090; thence along the southern boundary of the said Lot 1, the southern boundaries of Pt Lot 2, D.P. 3046, Lot 4, D.P. 54271 and the south-eastern boundaries of Lots 17, 16, 15, 14, 84 54271 and the south-eastern boundaries of Lots 17, 16, 15, 14, 84, 13,12 and 10, D.P. 55687 to and north-easterly along the boundary of the Borough of Northcote to and along the north-western boundaries of Lots 21, 22, 23, 24, 25, 26, 27, and 29, D.P. 54371 and the extension of that last-mentioned boundary across Sunnybrae Road to and along the south-east boundary of Part Lot 4, D.P. 48028 to and southerly along the boundary of the North Shore Electorate hereinbefore described to Shoal Bay.

TE ATATU

ALL that piece comprising the Borough of Henderson and that portion of the City of Waitemata bounded by a line commencing at the north-westernmost corner of the Borough of Henderson and proceeding northerly along the middle of Rathgar Road and its extension to the mean high water mark of the Waitemata Harbour; thence generally northerly and southerly along the mean high water mark to (Wairau Creek) the southern boundary of Lot 26, D.P. 78576 then north-westerly along the south-west boundaries, Lot 26 aforesaid, Lots 25, 11, 10, 9, 8, 7, 6, 5, 4, and 3, D.P. 78583 and Lot 2, D.P. 73503 to the centre line of Hepburn Road; thence southwesterly along that centre line to and northerly along the middle of the Great North Road to and along the north-eastern boundary of the Borough of Henderson to the point of commencement.

WAITAKERE

ALL that piece comprising that portion of the City of Waitemata not included in the Electoral Districts of Helensville and Te Atatu and excluding that portion to the east of a line commencing at the southernmost boundary of the Borough of New Lynn and proceeding westerly along the middle of Golf Road to and along the middle of Lynn and plans the middle of Codley Road to and along the westerly along the middle of Golf Road to and along the middle of La Rosa Street to and along the middle of Godley Road to and along the middle of Avonleigh Road to a point in line with the north-eastern boundary of Allotment 293, Waikomiti Parish to and along that last mentioned boundary and its extension to the mean high water mark of Manukau Harbour.

NEW LYNN

ALL that piece comprising the Borough of New Lynn; that portion of the City of Waitemata not included in the Electoral Districts of Helensville, Waitakere, and Te Atatu as hereinbefore described, and that portion of the City of Auckland to the south-west of a line commencing at the mouth of Oakley Creek and proceeding up the middle of that creek to and along the south-western boundary of the Borough of Mt. Albert to and along the middle of Bollard Avenue, New Windsor Road, Whitney Street, and Mary Dreaver Street to and diagonally across Boundary Road to the western boundary of the Borough of Mt. Roskill.

MT. ALBERT

MT. ALBERT

ALL that piece comprising portions of the City of Auckland and the Borough of Mt. Albert bounded by a line commencing at the mouth of Oakley Creek and proceeding southerly along the boundary of the Electorate of New Lynn hereinbefore described, to and southeasterly along the southern boundary of the Borough of Mt. Albert to and along the middle of Euston Road, Haverstock Road, Sandringham Road, and Lambeth Road, to and northerly along the eastern boundary of the Borough of Mount Albert, to the northern end of Alexander Street; thence by right line to and along the middle of Brisbane Street to and south-westerly along the middle of the Great North Road, to and along the middle of Premier Avenue to its westernmost point, thence by right line to and along the northern boundary of a reserve to the mean high-water mark of the Waitemata Harbour; thence northerly and southerly along that mean high-water mark to the point of commencement.

ROSKILL

ALL that piece comprising that portion of the Borough of Mt. Roskill south of the middle line of Mt. Albert Road; that portion of the Borough of Mt. Albert not included in the Electoral District of Mt. Albert, hereinbefore described and that portion of the City of Auckland to the west of the said Borough of Mt. Roskill not included in the Electoral District of New Lynn hereinbefore described.

AUCKLAND CENTRAL

ALL that piece comprising that portion of the City of Auckland bounded to the south by the northern boundary of the Electorate of New Lynn hereinbefore described; to the west and north by the mean high water mark of the Waitemata Harbour and to the east by a line commencing at the junction of the boundaries of the City of Auckland and the Boroughs of Mt. Albert and Mt. Eden, thence Auckland and the Boroughs of Mt. Albert and Mt. Eden, thence proceeding easterly along the boundary of the aforesaid Borough of Mt. Eden to a point in line with the centre line of Nugent Street, thence by right line to and along that centre line and its extension across Khyber Pass Road, to and along the centre lines of Grafton Road, Stanley Street, Gittos Street and the Strand and along the extension of that last-mentioned centre line to the northern boundary of Tamaki Drive, thence easterly along that boundary to the mean high water mark of Waitemata Harbour; and including all wharves and other extensions seaward; Little Barrier and Browns Islands, the Counties of Great Barrier Island, Waiheke Island, and other adjacent islands and the Kermadec Islands.

EDEN

ALL that piece comprising the Borough of Mount Eden, portion of the City of Auckland and portion of the Borough of Mount Roskill, bounded by a line commencing at the intersection of the centre line of Manukau Road and the centre line of Epsom Avenue and proceeding Manukau Road and the centre line of Epsom Avenue and proceeding southerly, westerly, northerly, and easterly along the boundary of the Electoral District of Eden, as described in N.Z. Gazette, 1972, page 573, to the intersection of the western side of Mountain Road and the north-western side of Clive Road; thence along the western side of Mountain Road, the middle of Owens Road, and the middle of Manukau Road to the point of commencement.

REMUERA

ALL that piece comprising the Borough of New Market and portion of the City of Auckland bounded by a line commencing at Point Resolution and proceeding generally south-easterly along the mean high-water mark of Waitemata Harbour, Hobson Bay, Orakei Basin, and the middle of Purewa Creek to its intersection with the North Island Main Trunk Railway; thence easterly along the middle of that railway to a point in line with the western boundary of Lot 77, D.P. 58798; thence southerly to and along that boundary and its projection to the middle of Gowing Drive; thence generally south-westerly along the middle of Gowing Drive, Ripun Crescent, Archdell Street, Dorchester Street, St. Johns Road, Norman Lesser Drive, Grand Drive, and Abbotts Way to a point in line with the western boundary of Lot 1, D.P. 42429; thence southerly to and along that boundary to the boundary of the City of Auckland; thence westerly and north-westerly along that boundary and the boundary of the electoral districts of Eden and Auckland Central hereinbefore described to the point of commencement. railway to a point in line with the western boundary of Lot 77, D.P.

ONEHUNGA

ALL that piece comprising the Boroughs of Onehunga, One Tree Hill, and Ellerslie.

Tamaki

ALL that piece comprising portion of the City of Auckland bounded by a line commencing at the intersection of the middle of Kotae Road and the mean high-water mark of Waitemata Harbour and proceeding along the middle of that road, Tauiwha Street and its production to the middle of the North Island Main Trunk Railway; thence southerly along that railway to the boundary of the City of Auckland; thence westerly along that boundary to the boundary of the Electoral District of Remuera hereinbefore described; thence northerly along that boundary and easterly and southerly along the mean high-water mark of Waitemata Harbour to the point of commencement.

OTAHUHU

ALL that piece comprising the Boroughs of Mount Wellington and Otahuhu and that portion of the City of Auckland bounded by a line commencing at Omaru Creek and proceeding generally southerly and westerly along the boundary of the City of Auckland to the boundary of the Electoral District of Tamaki hereinbefore described; thence generally northerly and easterly along that boundary to the point of commencement.

PAKURANGA

ALL that piece comprising portion of the City of Manukau and portion of the borough of Howick bounded by a line commencing at the eastern corner of Lot 4, D.P. 25717 and proceeding southerly along the eastern boundary of the said Lot 4 and its projection to the middle of Beach Road; thence generally southerly along the middle of Beach Road, Glen Fern Road, Park Hill Road, Picton Street, Ridge Road, and Botany Road to its intersection with the boundary of the Borough of Howick; thence westerly and generally southerly along that borough boundary, and the middle of Bradburys Road, and Cascades Road to the mean high-water mark of the sea at Pakuranga Creek; thence generally westerly, northerly, and easterly along that boundary to the point of commencement.

MANGERE

ALL that piece comprising portion of the City of Manukau bounded by a line commencing at the intersection of Portage Road and the North Island Main Trunk Railway and proceeding southerly along that railway line to Massey Road; thence along Massey Road, Buckland Road, Portage Road, the southern boundary of the proposed south-western motorway, to the northern side of Puhinui Road, thence generally north-easterly along that roadside and the boundary of the City of Papatoetoe to the middle of Puhinui Stream; thence down the middle of that stream to the boundary of the City of Manukau; thence generally north-westerly and easterly along the boundary of that city to the point of commencement, including Puketutu Island.

PAPATOETOE

ALL that piece comprising the City of Papatoetoe and portion of the City of Manukau bounded by a line commencing at the intersection of Massey Road with the North Island Main Trunk Railway; thence proceeding along the southern boundary of the Borough of Otahuhu to the mean high-water mark of Tamaki River: thence along that mean high-water mark to a point in line with the middle of Raleigh Place; then south-easterly along the projection of that line to the middle of Hills Road; thence southerly along the middle of Hills Road and East Tamaki Road to the boundary of the City of Papatoetoe; south-easterly and westerly along that boundary to the boundary of the Electoral District of Mangere hereinbefore described; thence westerly and northerly along that boundary to the point of commencement.

MANUREWA

All that piece comprising portion of the City of Manukau, bounded by a line commencing at a point in the middle of the Auckland Hamilton Motorway in line with the southern boundary of the City of Papatoetoe and proceeding southerly along the middle of that motorway to Alfriston Road; thence south-easterly along the middle of that road; Mill Road, and Cosgrave Road, to the boundary of the City of Papakura; thence generally north-westerly along that boundary, the mean high-water mark of Manukau Harbour, and the boundaries of the Electoral Districts of Mangere and Papatoetoe hereinbefore described and the production of the last boundary to the point of commencement.

PAPAKURA

ALL that piece comprising the Boroughs of Papakura and Waiuku, the Awhitu, Waipipi, Waiuku, Mauku and Karaka Ridings of Franklin County and that portion of the Drury Riding bounded by a line commencing at the intersection of the eastern boundary of Karaka Riding with the boundary of the County of Franklin and proceeding northerly and easterly along that county boundary to Hunua Riding; thence southerly along that boundary and along the southern boundary of Section 63, Opaheke Parish, to the middle of Quarry Road; thence along the middle of that road, Dale Road, Pratts Road, and State Highway No. 1 to a point in line with the southern boundary of part Section 47, Opaheke Parish; thence to and along that boundary and the southern boundaries of Section 41, Section 255, and Section 41, all Opaheke Parish to and along the northern boundaries of Lot 1, D.P. 29929, to a right line across Runciman Road to and along the northern boundaries of Lots 10, 8, 7, and 6, D.P. 57252 to the boundaries of Drury Riding; thence northerly along that riding boundary to the point of commencement.

HUNUA

ALL that piece comprising portions of the City of Manukau, the Borough of Howick and the County of Franklin, bounded by a line commencing at the intersection of the southern boundary of the said County of Franklin with the mean high-water mark of Hauraki Gulf; and proceeding generally westerly along the said boundary to the middle of State Highway No.1; thence generally northerly along the middle of that highway and Orams Road to a point in line with the southern boundary of Section 143, Koheroa Parish; thence northwesterly to and along that boundary to the eastern boundary of Section 99, Koheroa Parish; thence northerly along that boundary and the eastern and northern boundaries of section 98; thence along the western boundary of Lot 60, D.P. 7275 to a point in line with the northern boundary of Section 248, Koheroa Parish; thence to and

along that boundary to the eastern boundary of Section 122, Koheroa Parish; thence along the eastern and northern boundaries of the said section 122 and the production of the last-mentioned boundary to the boundary of Manatawhiri Parish; thence northerly along that boundary to the middle of Serpell Road; thence northerly along the middle of that road to a point in line with the southern boundary of Section 193, D.P. 13163 thence to and along the southern boundaries of the said section 193, northerly along its eastern boundary and its production to the middle of State Highway No 2; thence generally northerly along the middle of that highway, and Pinnacle Hill Road to the southern boundary of Drury Riding of the county of Franklin; thence westerly along that southern boundary to the middle of a legal road fronting sections 155 and 181, Mangatawhiri Parish; thence northerly along the middle of that road to and along the middle of Main Road, Paparata Road, Totara Road, and westerly along Dunn Road, Ararimu Road, Otto Road, and Pratts Road to the boundary of the Electoral District of Papakura; thence generally northerly along the boundaries of the Electoral Districts of Papakura, Manurewa, Papatoetoe hereinbefore described to the mean highwater mark of Tamaki River; thence continuing generally northerly along that mean high-water mark to the Electoral Districts of Pakuranga, hereinbefore described, thence northeasterly along the south-eastern boundary of that electorate to the mean high-water mark of the Hauraki Gulf; thence generally easterly and southerly along that mean high-water mark to the point of commencement.

RANGIRIRI

ALL that piece comprising the Boroughs of Pukekohe, Huntly, and Ngaruawhahia, and Port Waikato, Onewhero, Pukekawa, Whangape, Teakau, Waingaro, and Pukemiro Ridings of the county of Raglan; that portion of the County of Franklin not included in the Electoral Districts of Hunua and Papakura hereinbefore described, Waerenga and Huntly Ridings and that portion of the Riding of Maramarua of the county of Waikato, to the west of a line commencing at the mouth of the Kopuku Stream being a point on the northern boundary of the said Maramarua Riding, and proceeding up the middle of that stream to a point in line with eastern boundary of Lot 3, D.P. 11622; thence to and along that boundary and its production to the middle of Finlayson Road; thence along the middle of that road to a point in line with the eastern boundary of Lot 2, D.P. 11622; thence by to and along that boundary to the northern boundary of Section 1, Block VIII, Maramarua Survey District; thence along that boundary and the eastern and south-eastern boundaries of the said section to the western boundary of Section 4, Block VIII, aforesaid; thence along that boundary and its production to the middle of Drakes Road; thence along the middle of that road to a point in line with the eastern boundary of Section 6, Block VIII, aforesaid; thence to and along that boundary to the southern boundary of Block VIII aforesaid; thence southerly along that block boundary and its extension to the middle of the Whangamarino River; thence westerly along the middle of that river to southern boundary of Maramarua Riding aforesaid.

Hauraki

ALL that piece comprising the Boroughs of Paeroa, and Te Aroha; the County of Hauraki Plains; the District of Thames-Coromandel; the Komata, Paeroa, and Mangaiti Ridings of the County of Ohinemuri; that portion of the Maramarua Riding, of the County of Waikato not included in the Electoral District of Rangiriri hereinbefore described; the Tahuna Riding, those portion of the Morrinsville, and Waitoa Ridings within the Electoral District of Waikato as defined in New Zealand Gazette, 1972, page 565, and that portion of the Waihou Riding, of the county of Waihou, to the north of a line commencing at the intersection of the middle lines of Thomas Road and Bailey Road and proceeding north-easterly and southerly along the middle of Bailey Road, Ngutumanga Road, and its production to the middle of the Thames Branch Railway; thence north-easterly along the middle of that railway to the boundary of the Borough of Te Aroha

HAMILTON WEST

ALL that piece comprising that portion of the City of Hamilton bounded by a line commencing at the northwestern corner of Lot 6, D.P.S. 9015 and proceeding generally easterly along the northern boundaries of that lot and its production to the middle of Newcastle Road; thence generally north-easterly along the middle of that road, Ellicott Road, and Tui Avenue to a point in line with the south-easterly to and along that boundary, the eastern boundaries of the soundaries of Lot 1, D.P. 8639; thence generally north-easterly to and along that boundary, the eastern boundaries of Micham Avenue to the eastern boundaries of Lot 1, D.P. 17179; thence generally northerly along the boundaries of Lot 1, D.P.S. 17179 and its production to a point in line with the middle of Vardon Road; thence generally north-easterly to and along the middle of Vardon Road, Taylor Terrace, and Minchin Crescent, the northern boundary of Lot 11, D.P.S. 379, and its production to the middle line of the Waikato River; thence generally south-easterly up the middle of that river to the boundary of the City of Hamilton; thence generally south-westerly, and north-westerly along that boundary to the point of commencement.

HAMILTON EAST

ALL that piece comprising that portion of the City of Hamilton bounded by a line commencing at the intersection of Hillcrest Road with the boundary of the City of Hamilton and proceeding generally south-westerly, south-easterly, and south-westerly again along the middle of that road, Cambridge Road, and Cobham Drive to a point in line with the eastern boundary of the proposed motorway; thence south-easterly along that boundary, to the middle of the Waikato River; thence generally north-westerly down the middle of that river to the boundary of the City of Hamilton; thence generally south-easterly along that boundary to the point of commencement.

WAIKATO

ALL that piece comprising the Hamilton, Newcastle, Tuhikaramea, and Rukumia Ridings of the County of Waipa; that portion of the County of Waikato not included in the Electoral Districts of Rangiriri and Hauraki, that portion of the County of Raglan not included in the Electoral District of Rangiriri and those portions of the City of Hamilton not included in the Electoral Districts of Hamilton East and Hamilton West hereinbefore described.

MATAMATA

ALL that piece comprising the Boroughs of Morrinsville, Matamata, and Putaruru; that portion of the County of Piako not included in the Electorate District of Hauraki, hereinbefore described; the Waharoa, Matamata, Te Poi, Hinuera, Lake Karapiro, Tirau, Okoroire, Putaruru, and Lichfield Ridings of the County of Matamata.

KAIMAI

ALL that piece comprising the Boroughs of Te Puke and Waihi; that portion of the County of Ohinemuri not included in the Electoral District of Hauraki, hereinbefore described; that portion of the Borough of Mount Maunganui not included in the Electoral District of Tauranga, hereinbefore described; the Katikati, Te Puna, Te Puke, Katikati Town, Waimapu and that portion of the Maketu Riding of the County of Tauranga bounded by a line commencing at the intersection of the Waiari Stream and the middle line of the the intersection of the Waiari Stream and the middle line of the Paeroa Taneatua Railway; thence proceeding generally easterly along the middle of that railway and No. 2 State Highway to Kaikokopu Road; thence generally north-easterly along the middle of Kaikokopu Road and the Kaikokopu Canal to the County boundary; thence generally westerly and southerly along the county and riding boundary to the point of commencement; together with Mayor, Motiti, and other adjacent islands.

TAURANGA

ALL that piece comprising the City of Tauranga and that portion of Mount Maunganui Borough and Tauranga County bounded by a line commencing at a point on the shore of Tauranga Harbour, in line with the middle of Hull Road and proceeding easterly to and along that road and south-easterly along the middle of Maunganui Road to its intersection with the south-eastern boundary of Mount Maunganui Borough; thence south-westerly along that boundary and its extension to the shore of Tauranga Harbour; thence generally south-westerly along that shore to Maungatapu Road; thence south-westerly along the middle of that road to the boundary of Tauranga City; thence generally north-westerly along that boundary to Sulphur Point; thence easterly along a right line to Whareroa Point and northerly along the boundary of Mount Maunganui Borough to the point of commencement.

TARAWERA

ALL that piece comprising that portion of the City of Christchurch bounded by a line commencing at the intersection of the middle lines of Moorhouse Avenue and Deans Avenue, and proceeding northerly along the middle of Deans Avenue and its production to the middle of the Avon River; thence generally north-easterly down the middle of that river and the middle of Bealey Avenue, and Papanui Road to the boundary of the Electoral District of St. Albans hereinbefore described; thence generally easterly along that boundary to a point in line with the middle of Kerrs Road; thence generally southerly to and along the middle of Kerrs Road, Buckleys Road, Butterfield Avenue, McGregors Road, and Keighleys Road to a point in line with the production of the western boundary of Lot 1, D.P. 8825, thence southerly to and along that boundary and its production to the middle of Linwood Avenue; thence south-easterly and southwesterly along the middle of that street and St. Johns Street to the middle of Ferry Road; thence north-westerly along the middle of that street and Ensors Road to the middle of the Lyttelton Bluff Railway; thence north-westerly along that railway line to the middle of Waltham Road; thence northerly along the middle of that street and westerly along Moorhouse Avenue to the point of commencement.

ALL that piece comprising the Counties of Mount Herbert and Heathcote, the Borough of Lyttelton, portion of the City of Christchurch and the County of Paparua bounded by a line commencing at Cave Rock near Sumner and proceeding generally easterly along the MHWM of the sea to the eastern boundary of Mount Herbert County; thence generally westerly along the southern boundary of Mount Herbert County to the eastern boundary of the Paparua County; thence northerly and westerly along the eastern and northern boundaries of Tai Tapu Riding of the County of Paparua to the middle of the Halswell River, thence up the middle of that river to the north-eastern corner of Section 950, Block II, Halswell Survey District and proceeding northerly along a right line across Tai Tapu Road to the eastern boundary of Part Section 1350, Block II, Halswell Survey District; thence north-easterly along that boundary to and easterly along the southern boundaries of Part Sections 1592, and 1081, Block II, Halswell Survey District and the production of the last-mentioned boundary to the middle of Kennedys Bush Road; thence generally north-easterly along the middle of that road and Cashmere Road to the boundary of the Electoral District of Sydenham hereinbefore described; thence easterly along the boundaries of the Electoral Districts of Sydenham, Christchurch Central, and Avon to the point of commencement.

SELWYN

ALL that piece comprising the Counties of Malvern, Ellesmere, Wairewa, and Akaroa; the South Rakaia Riding of the County of Ashburton; that portion of the County of Paparua not included in the Electoral Districts of Papanui, Yaldhurst, Sydenham, and Lyttelton, hereinbefore described.

ASHBURTON

ALL that piece comprising the Ashburton, Temuka, and Geraldine, Boroughs; the Mt. Peel, Rangitata, Geraldine, Temuka, and Tengawai Ridings of the Strathallan County; the Mt. Somers, Mt. Hutt, Ashburton, Upper Ashburton, Wakanui, and Rangitata Ridings of the Ashburton County; and the Opuha and Fairlie Ridings of Mackenzie County.

TIMARU

ALL that piece, comprising the City of Timaru, and the Hadlow, Otipu, Seadown, and Point Ridings of the County of Strathallan.

WAITAKI

ALL that piece comprising the County of Waimate; the Boroughs of Oamaru and Waimate; the Tekapo and Albury Ridings of the County of Mackenzie, and the Waiareka, Papakaio, and Kakanui Ridings of the County of Waitaki.

OTAGO

ALL that piece comprising the Boroughs of Alexandra, Naseby, Roxburgh, Lawrence, Cromwell, Queenstown, and Arrowtown; the Counties and portions thereof of Vincent, Maniototo, Waihemo, Waitaki, Tuapeka, Taieri, Lake, Southland, and Waikouaiti as bounded by a line commencing at the easternmost point of Deep Stream Riding of the County of Taieri and proceeding westerly along the southern boundary of that riding to the boundary of the County of Tuapeka, thence generally south-westerly along that boundary to the eastern boundary of the Tapanui Riding of the County of Tuapeka; thence northerly and westerly along the eastern and northern boundaries of that riding, the northern and western boundaries of the Glenkenich Riding of the County of Clutha to East Maitland Road; thence generally westerly along the middle of that Road, Chatton-Maitland Road, and Chatton-Pyramid Road to the middle of Okapua Creek; thence generally southerly down the middle of that creek to the middle of the Mataura River; thence generally north-easterly up the middle of tha triver, the southwestern boundary of the Waikaia Riding of the County of Southland, and the southern boundary of the County of Lake to Eyre Peak; thence generally north-easterly along the watershed of Eyre Creek, Thomson Mountains, Livingstone Mountains, Ailsa Mountains, and the Barrier Range to the southern boundary of the Electoral District of West Coast hereinbefore described; thence generally easterly and north-easterly along that boundary to the boundary of the Electoral District of South Canterbury; thence generally south-easterly along that MHWM to the north-eastern corner of the Borough of Port Chalmers; thence westerly along the northern boundary of the

electoral district of Dunedin North as described in New Zealand Gazette, 1972, p. 565 and northerly along the western boundary of the County of Waikouaiti to the point of commencement.

LEITH

ALL that piece being the former Electoral District of Dunedin North as described in NZ Gazette, 1972, p.565.

DUNEDIN CENTRAL

ALL that piece being the existing Electoral District of Dunedin Central, as described in NZ Gazette, 1972, p. 1972, p. 565.

ST. KILDA

ALL that piece being the existing Electoral District of St. Kilda, as described in NZ Gazette, 1972, p. 565.

CLUTHA

ALL that piece comprising the Counties of Bruce and Clutha; the Boroughs, of Mosgiel, Milton, Balclutha, Kaitangata, and Tapanui; the Tapanui Riding of Tuapeka County; the Maungatui, Outram, Otokia, East Taieri, North Taieri Ridings, and that portion of Kaikora Riding not included in the Electoral District of St. Kilda hereinbefore described.

WALLACE

ALL that piece comprising the Counties of Fiord and Wallace; the Town District of Otautau; the Boroughs of Gore, Mataura, Winton, and Riverton; the Oreti, Hokonui, and Winton Ridings of the County of Southland; that portion of Wallacetown Riding, to the north of a line commencing in the middle of Oreti River, at a point in the line with the north-eastern boundary of Lot 10, D.P. 2162, in Block I, Oreti Hundred and proceeding south-easterly to and along that boundary, the south-eastern boundary of Lot 10 aforesaid and its production to the middle of Oporo Flat Road; thence generally westerly along the middle of that road, Drain Road, and Calcium Spar Bush Road and its production to the boundary of the Wallacetown Riding, County of Southland; and that portion of the Greenstone Riding, and County of Lake, bounded by a line commencing at the junction of the northern boundary of that riding with the summit of the Olivine Range; thence proceeding generally south-westerly and south-easterly along the summit of the Olivine Range, Barrier Range, Thomson Mountains, and the north-eastern watershed of the Mararoa River to the southern boundary of the Greenstone Riding, County of Lake; thence generally north-westerly, and south-easterly along the south-western, north-easterly, and south-easterly along the south-western, north-easterly, and south-easterly along the south-western, north-eastern, and north-eastern boundaries of that riding to the point of commencement.

Invercargill

ALL that piece comprising a portion of the City of Invercargill, bounded by a line commencing at the intersection of Stead Street and Curran Road and proceeding generally north-easterly along the boundary of the City of Invercargill to Bay Road; thence generally easterly along the middle of that road and North Road to and along the middle of the Waihopai River to its intersection with the boundary of the City of Invercargill; thence generally easterly and southerly along that boundary to the middle of Mason Road, thence westerly along the middle of that street to a line parallel to and 50 metres distant from the eastern side of Rochdale Road; thence southerly along that line and its production to the middle of Tramway Road; thence westerly and southerly along the middle of Tramway Road; thence westerly and southerly along the middle of that road and Boundary Road to a point parallel to and 50 metres distant from the southern side of Tramway Road; thence westerly along that line and to the middle of McMillan Street; thence northerly along the middle of Regent Street; thence generally north-easterly along the middle of that street and westerly along the middle of that street and westerly along the middle of Martin and Janet Street and its production to the shore of New River Estuary; thence northerly along that shore-line to Stead Street; thence westerly along the middle of that street to the point of commencement.

AWARUA

ALL that piece comprising the Borough of Bluff; the Town district of Wyndham; those portions of the City of Invercargill not included in the Electoral District of Invercargill, hereinbefore described; the Awarua, Mataura, Toetoes, and Waihopai Ridings of the County of Southland and that portion of the Wallacetown Riding of the County of Southland and that portion of the Wallacetown Riding not included in the Electoral District of Wallace, hereinbefore described; and Stewart, Ruapuke, Dog, Campbell, and other adjacent islands.
