Price Order No. 50 (Amendment No. 2 of Price Order No. 28 (Eggs))

PURSUANT to the Commerce Act 1975, I, Peter Edward Donovan, pursuant to a delegation from the Secretary of Trade and Industry, hereby make the following price order:

1. This order may be cited as Price Order No. 50 and shall be read together with and deemed part of Price Order No. 28* (hereinafter referred to as the principal order).
2. This order shall come into force on the 19th day of March 1977.
3. The principal order is hereby amended by revoking the Schedule thereto, and substituting the following Schedule.
