*Honours and Awards*

His Excellency The Governor-General has announced that The Queen has been graciously pleased to approve the award of The Queen's Gallantry Medal (Q.G.M.) to the under-mentioned:

Kenneth Trevor PENNIALL, of Auckland.

David Alexander Jethro HADLEY, of Auckland.

On 4 November 1976, an armed man robbed the National Bank of New Zealand Ltd., at East Tamaki, Auckland.

At the time Mr Penniall was a customer in the Bank and when the offender made off Mr Penniall followed in his utility vehicle accompanied by Mr Hadley, who had been in a near-by shop. They followed the offender for some distance and at Pakuranga they found him sitting on his motor-cycle in a parking area. The offender attempted to flee but was foiled by Mr Penniall driving into the motor-cycle and knocking it to the ground. Mr Hadley then alighted and tackled the offender.

At this stage the offender produced the loaded sawn-off shotgun used in the hold-up and threatened to shoot Mr Hadley. This did not deter Mr Hadley who threw himself at the offender, deflecting the weapon in the process. Mr Penniall joined in the scuffle and together they were able to overpower the offender and hold him until the Police and the ambulance arrived at the scene.

Penniall and Mr Hadley were in danger of death at the hands of the offender. The courage they displayed in a dangerous armed offender being held at bay and \$14,000 recovered in a matter of minutes is a fine example of gallantry.

His Excellency The Governor-General has announced the following awards:

*The Queen's Commendation for Brave Conduct*

Constable Douglas Robert SMITH (3403), New Zealand Police, of Taupo

for services leading to the arrest of a 17-year-old youth who was in possession of a .303 rifle which he had twice fired with serious intentions of causing injury if not death to the persons present. The incident occurred at Taupo on 13 February 1977.

Constable Miles Hearn PAIGNTON (3986), New Zealand Police, of Rotorua.

Constable Paignton is a Police dog handler stationed at Rotorua. On the night of 2 September 1977 when attempting to apprehend an offender, he became separated from his dog and in an ensuing violent fight was severely injured. The offender, with assistance from some patrons from a nearby hotel, was able to make his escape and was not recaptured until the following day.

John William REID, M.B.E., of Nelson. General Manager, Helicopters (N.Z.) Ltd.

for services leading to the successful rescue of 13 seamen from the Japanese squid boat, "Maru Daimaru Nr 2", that grounded on the rocks to the north of the Heaphy River mouth on the West Coast of the South Island on 4 January 1977.

*Notice Restricting the Issue of Fishing Licences, Permissions, or Fishing Permits for Rock Lobsters in New Zealand Fisheries Waters (Notice No. 1851 Ag. 42/14/0/1)*

PURSUANT to section 119 of the Fisheries Act 1908, as inserted by section 2 of the Fisheries Amendment Act 1977, the Minister of Fisheries hereby declares that as from the date of publication of this notice no further licences, permissions, or fishing permits shall be granted or given, under Part I of this Act, in respect of rock lobster fisheries within New Zealand fisheries waters.

*Notice Restricting the Issue of Fishing Licences, Permissions, or Fishing Permits for Eels in Lake Ellesmere (Notice No. 1852 Ag. 42/21/0/1)*

PURSUANT to section 119 of the Fisheries Act 1908, as inserted by section 2 of the Fisheries Amendment Act 1977, the Minister of Fisheries hereby declares that as from the date of

publication of this notice no further licences, permissions, or fishing permits shall be granted or given, under Part I of this Act, in respect of the eel fisheries within New Zealand fisheries waters of Lake Ellesmere.

Lake Ellesmere is defined as the lake proper and all inflow rivers and streams in an area bounded to the north by the main north-south railway line extending from Templeton Railway Station to where the line crosses the north bank of the Rakaia River, and to the south by the seaward side of Kaitorete Spit. The spit is defined as extending from the westernmost point of Ohahoa Bay, Banks Peninsula, to the seaward side of the northern bank of the outlet of the Rakaia River. If the lake is open to the sea the spit can be considered as extending across the seaward side of the opening in a line from bank to bank. To the west the area is bounded by the northern bank of the Rakaia River, extending from the seaward side of the northern bank of the outlet to the main north-south railway line, and to the east by a line extending from Templeton Railway Station to the westernmost point of Ohahoa Bay.
