PURSUANT to the Local Government Act 1974, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Waipawa District and Waipawa Community Constitution Order 1978, Amendment No. 1, and shall be read together with and deemed part of the Waipawa District and Waipawa Community Constitution Order 1978* (hereinafter referred to as the principal order).

(2) This order shall come into force on the 1st day of May 1978.

2. Transitional members of district council—The principal order is hereby amended by revoking clause 6, and substituting the following clause:

"6. Notwithstanding the provisions of clause 5 of this order, until the members of the district council, to be elected at the next triennial general election of members of local authorities (to be held on the 2nd Saturday in October in the year 1980) come into office, the district council shall consist of 9 members of whom—

(a) Six shall be the persons who held office as Councillors of the County of Waipawa immediately before the commencement of this order; and

(b) Three shall be persons who held office as Councillors of the Borough of Waipawa and who, before the commencement of this order, were elected as members of the district council by the Waipawa Borough Council."

3. Petroleum tax—Clause 19 of the principal order is hereby amended by omitting the words "the Local Authorities (Petroleum Tax) Act 1970", and substituting the words "Part XI of the Local Government Act 1974 (as enacted by section 2 of the Local Government Amendment Act (No. 3) 1977)".
