PURSUANT to the Commerce Act 1975, I, Desmond James Gasson, pursuant to a delegation from the Secretary of Trade and Industry, hereby make the following price order:

- 1. This order may be cited as Price Order No. 97 and shall be read together with and deemed part of Price Order No. 76* (hereinafter referred to as the principal order).
- 2. This order shall come into force on the 3rd day of July 1978.
- 3. The principal order is hereby amended by revoking clause 7 of the principal order and substituting the following
 - 7. Subject to the provisions of this order, the maximum price that may be charged shall be—
